2005 PROCEEDINGS DEDICATION:

Mary Ann Johnson, 2005 Chairman of the Board of Supervisors, stated the following:

"Welcome everyone to this 2005 Proceedings dedication, and special thanks to the people who have come from the Town of Day to show their support and gratitude for the three people being recognized today.

"I was trying to think of a one liner that I could open my speech with, and the firs thing that came to mind was 'better late than never', and I'll tell you why. Normally, the book dedication is done around April, but the County was getting deeply involved with the Vietnam Moving Wall program, so the work on the book got postponed until after that was over with. A date was set for an October dedication and about one week before that date, I got a call from Barb that it was being postponed as the book was not ready. After calling my three distinguished guests that I was recognizing, a date was set for November.

"About a week before the November dedication, I received a call saying the book was in but there was a printing problem and it had to go back to the press. So I called my three friends again, and we decided to bypass December because of the busy holidays, and we set the date for January 16th.

"So January 16th arrived, and that morning I received a call from Barb saying the dedication was being cancelled because there were no lights or heat at the County building. Well, needless to say, I had to call my three friends again, and at this time I really don't think I was their friend any more, but we rescheduled it for today. So, here we are, after three times and out, and I'm here today to dedicate this book to the three individuals that have spent the last 2 ½ years completing a major revision to our land use regulations. I'm going to give you a little history of what that involved.

"They started out in August of 2004 as volunteers at my request to study the landscape and the geological features around the Great Sacandaga Lake to determine if our land use regulations were set up to preserve and protect the areas around the Lake that would eventually be called 'the view shed protection area' for their special scenic, aesthetic and historical values. The visual appearance of the forests in that area was also considered to be a valuable natural resource.

"Their planning efforts were very detailed. Their dedication was impressive. They identified the visual impact of hillside development and of excessive clear-cutting of trees and then began their proactive approach with numerous meetings with APA, the County Planning Board, DEC, Finch & Pruyn, International Paper, local groups and local loggers. They made site visits with foresters to get their perspective on different logging aspects. After the public hearing, they made a decision to pull the logging requirements from the proposed law and proceed with the view shed protection area changes. This part of the revision passed Town Board and APA approval and is now a local law.

"The logging aspect was much more contentious, but they didn't give up on their responsibilities, and they continued to meet with all the affected parties, and everyone made concessions along the way. They didn't get all they wanted, but they have not denied anyone from making a living through the forestry of land. This

local law has passed through the Town Board and is now before the APA awaiting their stamp of approval which we expect to happen.

"Speaking of the APA, they were very helpful in working with this committee from start to finish especially Brian Grisi who is their local Planning Assistant Specialist. If this had been held last week, he would have been here.

"Now it is my privilege to introduce the three people who worked so diligently on this major project and who I have chosen to dedicate the 2005 Proceedings Book to: David Cox; He is here with his wife, Diane; Ted Mirczak who is here with his wife, Judy; and Ken Metzler who is our CEO and Zoning expert. He was one of the original writers of our zoning regulations, and I believe he knows every word by heart." She then presented each of them with a copy of the 2005 Proceedings of the Board of Supervisors dedicating her term as Chairman to them for all of the work they have done in their land use regulations.

Mrs. Johnson said one thing they all agreed on when the project was all over was do not raise your hand when Mary Ann asks you to volunteer.

RECOMMENDING THE STATE CONDUCT RESPONSIBLE & COST-EFFECTIVE FISH MONITORING FOR THE DISEASE VHS IN PRIVATE NYS FISH HATCHERIES

WHEREAS, a fish disease known as Viral Hemorrhagic Septicemia (VHS) has been identified in New York State and poses a significant threat to both the wild and cultured fisheries resources of the State; and

WHEREAS, the Department of Environmental Conservation is proposing emergency changes to Part 10 of Title 6 of the Codes, Rules and Regulations of the State of New York (NYCRR) to require all hatchery fish in NYS to be tested for VHS and eight (8) other fish diseases; and

WHEREAS, the cost of the proposed fish testing regimen, which would be required of all private fish hatcheries under the aforementioned emergency rule change, is extremely expensive and could amount to several thousands of dollars annually for each privately owned fish hatchery; and

WHEREAS, it is believed that the cost of this new fish testing requirement will force many private fish hatcheries out of business, causing a reduction in the supply of fish stocked in streams throughout Saratoga County and the State of New York; and

WHEREAS, public sport fishing is responsible for generating many millions of dollars annually to Saratoga County's local economy and a reduction of the stocking of private hatchery fish will damage sport fishing; and

WHEREAS, the State of New York will be testing its own hatchery fish under the proposed emergency rule and is currently paying for private hatchery fish testing for Whirling Disease, one of the nine required fish tests under the proposed rulemaking; now, therefore, be it

RESOLVED, the Saratoga County Board of Supervisors requests New York State, in its proposed emergency rulemaking for fish testing, give consideration to the serious negative financial impact this action will have on New York State's private fish hatcheries and to New York State's sport fishing industry; and be it further

RESOLVED, that New York State, to assure the long-term protection and viability of the State's sport fishing industry, assume all costs for the testing of fish raised at privately owned fish hatcheries within New York State which will be required pursuant to the proposed changes to Part 10 of Title 6 of the Codes, Rules and Regulations of the State of New York (NYCRR) to control the fish disease VHS; and be it further

RESOLVED, this resolution be transmitted to Governor Eliot Spitzer, all Saratoga County NYS legislative representatives, the Chairs of the NYS Senate and Assembly Environmental Conservation Committees, and to the Commissioner of the New York State Department of Environmental Conservation.

Discussion on Res. 26:

Mr. Gutheil said every year for a number of years he has been approached by Supervisors for discussion on how we do this and when we do it, and it normally comes up during budget time. He said he has looked at the salaries for these certain individuals. He said the two part timers on this list are the Coroners with the lowest salary, and the salaries for the full timers run from \$66,457 to \$131,619. He said the straight across the board cost of living increase creates a bigger spread year after year. He said he was of the understanding that in certain years, we would do a flat amount. He said since the public hearing on this, Personnel has provided him with additional information. This particular local law affected 11 or 12 people, and some of them had a Step plus a COLA. We need to work on this in advance and have more discussion at budget time. We have to determine if this is a true cost of living or if we are using what the last union contract's COLA number was, he said. He stated the union contract ones were negotiated items, and there were no negotiations for this particular group of the work force and others. He said he wanted to make a point that there is a fairer way of doing it, or we need to do an increase by a flat amount more frequently so that the spread does not become greater amongst these people. In some cases, someone gets a \$1,200 raise, and another gets a \$4,000 raise, he said. Later this year, before we pass another resolution in December, we should have Law & Finance review this or we set up a standing Personnel Committee, he added. He said he is not against a cost of living increase, we just should know what we are going to base it on. Is it a cost of living put out by the Feds or that according to the union contract, he asked. He said it costs each employee the same for a gallon of gas, a loaf of bread, the electric bill. He said the cost of living on a flat amount for each one more frequently would be fairer to everybody.

Ms. Raymond said it is important, particularly to some of the newer Supervisors, to understand better how our payroll and compensation works. She said she does not think a lot of people are aware there are Steps plus raises. She said it would be quite helpful if we could get a list of each person with last year's salaries and the proposed new salaries in advance of when we are asked to vote on it. Some people don't understand that the budget you get in 2007 actually has everybody's 2006 salary on the line with their title because they have not yet been given an increase. I hope when it gets closer to budget time, we move forward with that kind of proposal, she said.

Mr. Lawler said we have done it like this, and to try to change it today is probably not a wise thing to do. He said the issue he has with this is it is being called a COLA, and it has nothing to do with a COLA. The rate of the increase simply mirrors the negotiated increase in the union contract, he said. A salary adjustment is appropriate for the small term employees who are at the high end of their salary structure, because if we don't adjust those salaries as inflation goes up, the value of their paycheck goes down. He said it should be fixed to whatever cost of living index we want to use. He said he would like to get the language straight for next year. Presenting this as a cost of living allowance is not exactly accurate, he said. If the union said they were going to forego a raise for a year, I think it would still be appropriate to give some of the employees who are at the high end of their Step some kind of a cost of living allowance, he stated.

Chairman Barrett said we will certainly look at that for next year.
