Mr. Grattidge stated in each Supervisor's mailbox is a report from the Legislative & Research Committee on the impact of the State Budget for 2007/2008. He said he wanted to thank Senator Bruno and the Legislators for providing quite a better standing to the County compared to what the Governor had initially presented. One of our top issues we were discussing with the Legislature was the VLT issue that has been restored in the budget. That would have had a devastating effect on the City of Saratoga Springs' budget and would have taken a million dollars out of the County's revenue stream. He said under the nursing home stability, the Governor had proposed stripping one million dollars out of the Medicare reimbursement formula, and the County is already running a deficit for the nursing home. About 80% of that money was restored, he said. Other items that came through in the budget were the \$30 million assistance program for dairy farmers and money for some rural Internet access. Thank you again to our Legislators for fighting for us at the State level, he added.

Reverse 9-1-1 Policy and Procedures for Community Alert System General Intent Statement

The primary purpose of the reverse 9-1-1 system is to provide a fast and comprehensive method of notifying residents of Saratoga County to an emergency situation or for the dissemination of important public information to residents relating to their safety.

It is the intent of the Board of Supervisors that system be made available to local municipalities throughout Saratoga County for their use in accordance with these policy and procedures. Each municipality shall be responsible for maintaining compliance with these procedures.

System Use

The system's primary purpose shall be for the purpose of alerting residents to an emergency situation and providing them with instructions or vital information. Examples of emergency situations are, but not limited to, the following:

- Flooding
- Hazardous materials incident
- Drinking water emergencies
- Large scale power outages
- Serious weather conditions
- Evacuation information
- Other public health emergencies
- Notification of critical or emergency workers to respond to a situation or condition

The system shall not be used for the purpose of disseminating local non-emergency information such as community events or other non-public safety related events.

In event a local municipality has activated the system, it shall within 24 hours of the activation, notify the System Administrator (Director of Emergency Services) of the activation and the purpose for the activation. Said notification can be faxed to the Office of Emergency Services at 884-4707 or via email - saremer@govt.co.saratoga.ny.us

System Operation

Only trained and qualified individuals may initiate the operation of the system. The county shall provide appropriate training through the use of system contractors or fully qualified county staff.

Each municipality or county department that has access to the system shall be responsible for sending appropriate staff to training sessions.

Reverse 9-1-1/Community Alert System Policy and Procedures

Administration

The system administrator shall be the Director of Emergency Services. For the purposes of administering the contract between the contractor and the county the primary point of contact shall be the Director of Emergency Services.

All system users will coordinate any technical issues that need to be resolved between the contractor and the end user with the Director of Emergency Services.

Contractor Contact Information

There are two ways to initiate the use of the reverse 9-1-1 system.

- Users may access the system via on-line computer connection.
- Users may call XXX-XXXX and receive on-line assistance via the contractor for system initiation.

The county will issue appropriate passwords and security clearance for use of the system.

Costs

Use of the system for purpose of disseminating emergency information conforming to these policies and procedures are at no cost.

Should a municipality or county department use the system for other than appropriate emergency notification and the county is charged for that use, such costs will be levied against the appropriate municipality or department.

If costs are levied and not paid in a timely manner the county may suspend the municipality or department from use of the system.

Acknowledgement

Each municipality and/or county department having access to the reverse 9-1-1 system shall retain a copy of these policies and procedures and will be responsible that all with access to the system have read and understand them.

Each chief elected municipal leader and/or county department shall sign a copy of these policies and procedures acknowledging and certifying compliance with them.

WHEREAS, notice of that public hearing was duly published and posted as required by law; and

WHEREAS, the scheduled public hearing was held and all persons appearing or desiring to be heard have been heard by this Board; now, therefore, be it

RESOLVED, that this Board of Supervisors, on this 17th day of April, 2007 hereby adopts a Local Law identified as Introductory No. 1, Print No. 1 of 2007.

BUDGET IMPACT STATEMENT: No budget impact.

COUNTY OF SARATOGA COUNTY LOCAL LAW 3 - 2007

A LOCAL LAW directing all wireless phone service providers operating in Saratoga County to send all wireless 911 calls to the Saratoga County Sheriff's Dispatch Center.

BE IT ENACTED, by the Board of Supervisors of the County of Saratoga as follows:

SECTION 1. Name. This Local Law shall be known as the Saratoga County Wireless 911 Call Routing Law.

SECTION 2. <u>Authority</u>. This Local Law is enacted under authority of Section 10 of the Municipal Home Rule Law of the State of New York, Article IX of the State Constitution of New York, the County Law, and other applicable statutory and decisional law.

SECTION 3. <u>Findings and Declaration of Intent</u>. This Board of Supervisors recognizes the paramount importance of the health, safety and welfare of the citizens of the County and further recognizes that when the lives or property of its citizens are in imminent danger that appropriate assistance must be rendered as expeditiously as possible.

This Board of Supervisors recognizes further that such assistance is increasingly summoned by wireless communications including but not limited to cellular phones and that unintentional, though avoidable, delays in reaching appropriate emergency aid can and do occur to the detriment and jeopardy of life and property when such wireless 911 calls from within Saratoga County are rerouted to anywhere other than directly to the single countywide Saratoga County Public Safety Answering Point (PSAP) which is under the jurisdiction of the Saratoga County Sheriff's Department.

The Board of Supervisors further finds that a major obstacle to the prompt response to emergency wireless requests for assistance in Saratoga County is the failure of one or more wireless telephone service suppliers to directly route such calls to the Saratoga County Public Safety Answering Point (PSAP).

The Board of Supervisors further finds that the Saratoga County Public Safety Answering Point (PSAP) has the most accurate, current and extensive knowledge of Saratoga County's geography, roadways, landmarks, emergency service resources and similar information of critical importance in emergent situations and can immediately dispatch the number and type of emergency services the situation requires.

The Board of Supervisors further finds and declares that by the enactment of the provisions of this Local Law, it is the intent of the Board of Supervisors to fulfill its obligation to provide for the health, safety and welfare of the people of this County by mandating the direct routing of all 911 calls, including wireless calls, by service suppliers directly to the Saratoga County Public Safety Answering Point (PSAP) so as to facilitate the rendering of emergency services as expeditiously and effectively as possible.

SECTION 4. <u>Definitions</u>. For the purpose of this law.

- a) "Wireless telephone service" means all commercial mobile services, as that term is defined in section 332(d) of title 47, United States Code, including all broadband personal communications services, wireless radio telephone services, geographic area specialized and enhanced specialized mobile radio services, and incumbent wide area specialized mobile radio licensees, which offer real time, two-way voice service that is interconnected with the public switched telephone network.
- b) "Wireless telephone service supplier" means any corporation or person as defined in Section ten hundred eighty of the Tax Law, which provides wireless telephone service in New York State.
- c) "Saratoga County Public Safety Answering Point" or "Saratoga County PSAP" means the site designated and operated by the County of Saratoga through its Sheriff's Department for the purpose of receiving emergency calls including those from a wireless telephone service and dispatching needed emergency services.

SECTION 5. <u>Routing</u>. All wireless telephone service suppliers doing business in Saratoga County shall route all 911 emergency calls to the Saratoga County Public Safety Answering Point (PSAP).

SECTION 6. Prohibited Acts.

- a) No wireless telephone service supplier shall knowingly fail to route wireless 911 telephone calls originating within Saratoga County to the Saratoga County PSAP as required by Section 5 above.
- b) No owner, official, employee, or agent of a wireless telephone supplier shall design, implement, arrange or cause, either directly or indirectly, a process or activity whereby 911 calls are routed other than as provided in Section 5 above.
- c) No person or entity shall either directly or indirectly solicit, suggest, implore, agree, or otherwise take action so as to cause or seek to cause a wireless telephone service supplier to route wireless 911 calls from within Saratoga County to other than the Saratoga County Public Safety Answering Point) PSAP.

- a) Any person or entity violating this Local Law shall be guilty of an unclassified misdemeanor and shall be subject to a fine not exceeding Five Hundred Dollars (\$500) or imprisonment for a period not to exceed three (3) months or both such fine and imprisonment for each offense. For purpose of this law each improperly routed 911 call shall constitute a separate offense.
- b) The Board of Supervisors is authorized to pursue any appropriate legal remedy including but not limited to injunction to effectuate the purposes of this Local Law.

SECTION 8. <u>Separability and Saving Provisions</u>. This Local Law is separate and apart from any other Local Law and each provision hereof is separate from any other provision. If this law or portion thereof is found to be invalid, no other law or unaffected portion of this law shall be affected thereby and shall remain in full force and effect.

SECTION 9. <u>Effective Date</u>. This law shall be effective immediately upon filing with the Secretary of State as provided by law.
