EQUALIZATION & ASSESSMENT COMMITTEE MINUTES

MAY 7, 2007

Present: Chairman Hunter; Supervisors Hargrave, M. Johnson, Keyrouze, Trottier, and Wood; Spencer Hellwig, Mgmt. Analyst; Cindy Baker, Sam Pitcheralle, Treasurer; Mark Rider, County Attorney; Joanne Bosley, Carol Holley, Real Property; Jason Kemper, Planning.

Chairman Hunter called the meeting to order and welcomed all in attendance.

On a motion made by Mr. Hargrave, seconded by Mr. Wood the minutes of the April 9, 2007 meeting were approved unanimously.

Mr. Pitcheralle requested a resolution to accept two tender offers in the town of Greenfield for a total of \$9,565.35.

A motion was made by Mr. Hargrave, seconded by Mrs. Keyrouze approving a resolution to accept two tender offers in the Town of Greenfield totaling \$19,565.35 for taxes owed in 2004-2006. Unanimous.

Mr. Rider requested a resolution to cancel taxes on parcels in the following towns:

- 1. Clifton Park 8 Parcels
- 2. Ballston 1 Parcel
- 3. Malta 3 Parcels
- 4. Stillwater 1 Parcel
- 5. Wilton 1 Parcel

Mrs. Keyrouze asked if Mr. VanPatten had paid all the back taxes owed on the sewer pipelines in Clifton Park? Mr. Rider said, no, many times these systems are turned over with large sums of money owed.

A motion was made by Mr. Wood, seconded by Mr. Hargrave to cancel taxes on parcels in the Towns of Clifton (8), Ballston (1), Malta (3), Milton (1), Stillwater (1), Wilton (1). Unanimous.

Ms. Holley said she is here today to discuss a grant that was applied for between Jason Kemper, Fountain Spacial, and herself. This is a real property services grant that has been available for two years now and it is doubtful whether it will continue to remain. She is therefore requesting a resolution to authorize the Chairman to enter into an agreement with NYS Office of Real Property Service to accept a \$110,000 Technology Improvement Grant. This is a way to get tax maps into a new GIS data base system, allowing for the sharing of information with other counties and municipalities within the county.

A motion was made by Mrs. Johnson, seconded by Mr. Hargrave to authorize the Chairman to enter into an agreement with NYS Office of Real Property Service to accept a \$110,000 Technology Improvement Grant. Unanimous.

On a motion made by Mrs. Johnson, seconded by Mr. Wood the meeting was adjourned.
