# ADJOURNED SESSION WEDNESDAY, DECEMBER 12, 2007 AT 4:45 P.M., E.S.T.

Board called to order by Chairman Barrett for the purpose of adopting the 2008 Saratoga County Budget and to introduce a local law regarding the allocation of zone lands for the proposed expansion of AMD, Inc. manufacturing project as a regionally significant project of the Saratoga County Empire Zone.

Roll call was taken. PRESENT –Alan Grattidge, Philip C. Barrett, Anita Daly, Richard Lucia, Mary Ann Johnson, Jean Raymond, George J. On a motion by Mr. Hargrave, seconded by Mr. Lucia, Resolutions 229 and 230 were removed from the table by a unanimous vote.

Chairman Barrett said if there is an interest to amend the budget dealing with any positions, we must amend and have a separate vote on Resolutions 231 and 234.

On a motion by Mrs. Johnson, seconded by Mr. Hargrave, all resolutions were adopted by a unanimous vote, with the exception of Resolutions 231, 233 and 234, and including Resolutions 229 and 230.

Mrs. Daly moved to approve Resolutions 231 and 234. Mr. Hargrave seconded. Discussion:

Mr. Grattidge moved to amend the 2008 budget to add 1 Road Patrol Officer and 1 Desk Officer for the Sheriff's Department due to the additional transporting of prisoners and the additional workload happening with a number of popular programs and the cellular 9-1-1 impact. The impact on the budget is \$64,571 for the Road Officer, and \$49,476 for the Desk Officer for a total of \$114,047. He proposed the impact would come from fund balance. Mr. Thompson seconded.

Ms. Daly said she supports this amendment, as she has been informed of some situations that she believes would not be positive in the interest of public safety without these new positions.

Mr. Gutheil asked if the cost-of-living increases were in Resolution 234. County Administrator David Wickerham said it is in both Resolutions 233 and 234.

Mr. Wood said he likewise supports this amendment recognizing the value of these positions and the impact of providing services to the residents of Saratoga County and making the County a safer place.

The amendment was adopted by a unanimous vote.

On a motion by Mr. Lucia, seconded by Mr. Connors, Resolution 231, as amended, was adopted by a unanimous vote.
