On a motion by Mr. Hargrave, seconded by Mr. Lucia, the minutes of the meeting of March 12, 2008 were approved unanimously.

REPORT FROM THE SARATOGA COUNTY COUNCIL ON AUTISM

Anita Daly, Chairman of the Saratoga County Council on Autism, thanked Chairman Hargrave for extending her the time with this Council. She said she wanted to give an update today on what the Council has done. She said April is Autism Awareness Month, and on behalf of the County, she requested the Chairman of the Board to declare April as Autism Awareness Month in Saratoga. County. She pointed out one child in 150 born today may fall on the autism spectrum. It affects 1 to 1½ million Americans. It is the fastest growing developmental disability. It is expected to cost \$90 billion. The cost of life long care can be reduced by two-thirds with early diagnosis and intervention. In ten years, the projected cost is between \$200 billion and \$400 billion. Programs underwritten by our County fall well into the millions. No money would be invested if there wasn't a population out there that needed our attention and needed service.

Ms. Daly stated this Council started very small, and we had a big job in front of us. In order to get a mission statement put together, we had to do a lot of reading, writing and arithmetic. We had to get some monies in the door in order to get our feet planted. The Council looked at what we should be doing. We didn't want to reinvent the wheel, as we have so many services that we currently provide, but we wondered what the missing links were. The lonliest day for a family with autism is the day they receive their diagnosis. A diagnosis of autism comes from a developmental pediatrician. Once you receive that diagnosis, then you open the door, and then you leave. The family is then caught in the dark wondering what to do. The Council decided one of its first initiatives is to design and develop a brochure that can be distributed to doctors in our area that provides contacts in Saratoga County. Services for this population are covered through our Public Health and Youth Bureau. She passed around a draft copy of this brochure. The one thing you will see in all of the information we are putting together is the word "promise." The Council decided the one thing government can do is promise to be a resource, promise to be a support, promise to be aware and promise to advocate for this population in Saratoga County. That will be our theme as we move forward, she said. She stated the poster on this brochure is a symbol of a bigger poster. In honor of April and Autism Awareness Month, we have partnered with Saratoga Bridges, and starting now, we are beginning a poster contest where a poster will be designed by a person with a spectrum disorder, and the chosen poster will serve as the front of this brochure and will serve as our marketing tool. We will have that poster framed and put on display here, she said.

Ms. Daly said part of the ongoing effort and resource information, we looked at the Community Resource Guide handbook that Public Health has that was created by Public Health and the Youth Bureau. We have redesigned this handbook that is just about ready to go to print to include the Council on Autism, designated services and providers related to autism, and this will be made available in several locations throughout the County.

Ms. Daly said as we move into the summer, one of the greatest activities the County does is run Youth Summer activities. The Council is going to find ways to integrate activities, specifically designed for children with autism and some just designed to better accommodate a child with autism, but be inclusive to all those who would like to participate. Another one of our initiatives has to do with public safety. She said

Assemblyman McDonald identified some sort of training needs to be done to educate our public safety volunteers on how to recognize a person with a developmental disability such as autism. We would like to take some time and invest in a little training to promote ways our volunteers can go about working with these individuals. There will be more information coming on this, and we hope to target Fire Prevention Week in early fall.

Mr. Veitch said he attended the autism forum that was held on Saturday in the Town of Malta. He thanked everyone who attended. He said Assemblyman McDonald suggested that some type of an Autism Expo be held somewhere in the County, and he said he volunteered to work on that. He said he will try to get together service providers, doctors, nutritionists, etc. to try to put on this Expo. He said he will try to get the City Center for this, but if not, it will be held someplace else in the County. He said hopefully, this will be held sometime in the fall. He said he will keep everyone up to date as things move forward on this.

Ms. Daly said we have had discussions with our web site provider, and we will be providing more user-friendly links on our website. She said there are many people out there who are looking to join the Autism Council. We feel we are in a position to forward names to Chairman Hargrave to review and recommend what areas he would like to work with this Council and to set forth initiatives we have planned out for this year, she said. We will need help to make this successful, as we have taken on quite a bit, she stated. I am sure the Chairman will be looking to send us some more help very soon, she added. She thanked Wes Carr, of the Youth Bureau for handling the budget aspects for the Council and Cathy Duncan of Early Intervention in Public Health, for helping with the handbook. We are proud to move forward with what we have accomplished, she said.
