Board called to order by Chairman Hargrave.

On a motion by Mr. Peck, seconded by Mr. Johnson, Resolutions 226 and 227 were removed from the table by a unanimous vote.

Resolutions 230 through 234 were presented to the Board.

Discussion on Res. 230:

Chairman Hargrave said he is calling for a separate vote on Resolution 230. That is the resolution that finally adopts changes to the original tentative budget. He said he is aware there is a needed amendment to that resolution, and there may be other amendments proposed.

Mr. Thompson said while he understands the importance of the history of Saratoga County, he is not convinced this is the most appropriate time to add another new position to the County payroll. None of our neighboring counties has established a full-time Historian position. We should be very sure of the necessity of this position before placing an additional burden on the long-suffering property taxpayers, he said. He stated the idea has merit, but it needs more study, and it should be returned to the Personnel Department for further review. He moved to amend Res. 230 to eliminate the expanded funding for a full-time Historian. Mr. Lawler seconded. Mr. Grattidge said while he appreciates the Board entertaining the idea of making the Historian a full-time position, he recognizes that a number of Supervisors would like to get more information on this before we go forward. He said he will support this amendment. The amendment was adopted by a unanimous vote.

Mr. Veitch said he was impressed by the presentation made by the Saratoga Rowing Association at the public hearing last Wednesday. They made an excellent case for their proposal in terms of economic development and tourism, he said. He moved that \$15,000 be taken from the Tourism budget, under the Clerk of the Board, specifically from the I Love New York contract, to be made available to the Saratoga Rowing Association as a matching grant. He said we will match the new dollars they raise on a dollar per dollar basis up to \$15,000 for the attraction of the national scholastic rowing championship. Mr. Thompson seconded. Mr. Lawler thanked the Supervisors for moving this forward. This is a very reasonable compromise, he stated.

Ms. Yepsen stated for the Rowing Association, there are 152 kids and 64 adults throughout the County who take advantage of this program. She said 4500 athletes come to the nationals; 10,000 spectators; \$47,000 of SRA money is being appropriated towards this that they have already raised privately. The match is a good solution because it will leverage an opportunity for them to go out and further fund raise for this event. She stated the positive effects will trickle through all of our towns, and she appreciates the support on this.

Ms. Daly said she is beginning to see a common denominator in some of the other requests that have come before this Board in previous years. Perhaps in the future as these requests come through for these types of national events, we continue to channel them through our tourism budget, she said. I would like to see that as we move forward for our budgeting purposes, she stated.

The amendment was adopted by a unanimous vote.

Mr. Johnson stated the County Treasurer has advised him that State auditing standards require that the County budget must include all sales tax revenue collected by the County, including that portion that we distribute to

the towns and cities. Accordingly, we need to amend the budget to include as a revenue the \$50,848,100 we estimate we will collect for the municipalities, and a like amount for its distribution. He moved to amend the 2009 budget as follows:
