PRESENTATION OF SARATOGA GAMING AND RACEWAY FOUNDATION AWARDS

Matthew Veitch, Chair of the Saratoga Gaming and Raceway Foundation, said the Foundation board consists of himself as Chair, Mayor Scott Johnson, Vice-Chair, George Hargrave as Secretary, and Skip Carlson, from the Racino, as Treasurer. George Karam was the representative from the Harness Horseperson's Association.

Mr. Veitch stated this year, they granted \$27,490 in funds to 15 organizations. In order to receive funds, all applicants must meet certain criteria: Applicant organizations must be classified as not-for-profit; Applicant organizations must carry out services and activities that benefit Saratoga County residents; Activities that address problem gambling, support youth, senior citizens, recreation, arts and community benefit are preferred. He said it has been a great experience taking part in granting these funds to organizations that deserve them. It is good to know that what they are doing is making our communities better and stronger, he said. Organizations such as these are what makes this County such a great place. He presented the following awards from smallest award amount to largest:

Mr. Veitch congratulated all of the award recipients for 2008.

SEWER EXPANSION PROGRESS REPORT

Bill Davis, Sewer Commissioner, said people forget about sewer until they can't flush. He stated the treatment plant has been impacted by the storm between Thursday and Sunday. He said 45 of the 80 pump stations were without commercial power operating with emergency standby generators. Our people had to go from pump station to pump station and carry generators to keep them going, he said. There were over 550 overtime hours. He state District employees, including management, supervisory and laboratory staff, contributed to the operating

of the system. The District, with assistance and support from personnel from the Wilton Water and Sewer Authority, Heritage Springs Sewer Works, and the County DPW, under Joe Ritchey, gave us a lot of help, he stated.

Mr. Davis said in 2009, they will rehab Grooms Road Pump Station and Burning Bush Pump Station. We have 90,000 feet of interceptor sewer line which is about 17 miles. So far, we have done about 7,000 feet of repair of it, and we are scheduled for another 2,000 feet of repair in 2009. Both projects will take about 10 years to do and will cost \$40 million. Right now, our system has 84 pump stations, 350 grinder pumps, 17 miles of interceptor sewers, and 80 miles of trunk sewers. He said this year 100 grinder pumps were replaced under their Capital Plan. We are at a \$50 million expansion, and we are about 13% complete. So far, we have expended about \$5.2 million. There are about 50 construction workers on site, and this will go up to 150 before the expansion is completed, he said.

Mr. Davis said in looking to the future, 15 years from now, you will have to look at more capacity. We will only be able to handle about 43 million gallons per day. Within 15 years, we should start looking at another sewer plant, and my recommendation is to look to the north, as that will relieve the pressure down here, he said. He stated Supervisors should form a study committee and pick a site while things are cheap, because before you know it, 15 years will be upon you. Thank you for all the support you have given in my past 24 years, he stated.

REPORT NO. 13

Saratoga County Board of Supervisors

Legislative & Research Committee 2008 Year-End Report

February 2008

- Outlined 2008 Legislative ProgramRejecting the provisions in the Governor's 2008 budget that would eliminate assistance to Saratoga Springs and Saratoga County.
- 1. Opposing the Department of Corrections proposal to close the Minimum Security Prison Camp at Mount McGregor.
- 2. Supporting a seamless change of the racing franchise that will allow the Saratoga Racecourse to remain the premier racing facility in the nation.
- 3. Calling on the State to address the short term and long term fiscal stability of County operated nursing homes.
- 4. Supporting a constitutional amendment barring the imposition of unfunded mandates on local government.
- 5. Requesting special member items for local emergency service organizations to acquire equipment compatible with the new County Radio System.
- 6. Supporting Saratoga County municipalities in their requests for special State Assistance.
- Supported Assembly Bill A-0733 Passed a resolution in support of this bill which would allow towns and cities to impose a real estate transfer tax and create community preservation funds.

March 2008

- Met with State Legislators to discuss 2008 Legislative Program on March 5th
- Supported the Fire/Ambulance Tax Exemption for Emergency Response Volunteers Passed a resolution supporting this program that creates incentives for volunteer firemen and ambulance workers, enabling towns, by resolution, to provide a property tax exemption for volunteers. Forwarded to the Public Safety Committee. September 2008
- Heard a Presentation from Ken Crannell, Legislative Director of NYSAC and Peter Savage, Legislative Coordinator of NYSAC Presentation included praise to the Board of Supervisors for continuing to get its message out to the Senate and Assembly as well as distribution and review of the NYSAC's Preliminary 2008 Legislative Summary.
- Recommended that NYS Repeal or Modify the New NYS Contract Surcharge Tax Law The committee passed a resolution recommending that NYS either repeal or modify the law which imposes a 1/2% surcharge tax outside of the vendor bid process for any purchases off a State contract. This tax would cost the County over \$130,000/year (based upon 2007 purchases). The committee was notified at the October meeting that Senator

Hugh Farley is recommending the rejection of this fee and that NYS OGS is reinterpreting the bill so that the fee is internalized in the bidding process.

October 2008

Heard a Presentation from Pamela Mann about Go21 (Growth Options for the 21st Century) & Passed a Resolution against Economic Re-Regulation of Railroads - Go21's mission is based principally on recommendations from the American Association of State Highway and Transportation Officials (AASHTO) which is an umbrella organization over DOT's in all 50 states. There will be a 67% increase in tonnage of freight that will have to be moved in our country in the next 20 years which can not be currently handled by roads. The committee passed a resolution from New York State and the Regional Council of State Governments in support of increased freight rail hauling capacity and against economic re-regulation of the railroads. November 2008

Heard a Presentation from Jan VanDecarr, legal council representing the Firemen's Association of the State of New York (FASNY) - Mr. VanDecarr presented and the committee discussed six items relating to recruitment and retention of volunteer firefighters from FASNY's legislative agenda: a health insurance program for volunteer firefighters; volunteer recruitment scholarship program; length of service award program; tax credits; tax exemptions; and job protection.

December 2008

Passed a Resolution Championing Property Tax Relief - After reviewing the NYS Commission on Property Tax Relief's recently released recommendations, the committee passed a resolution championing property tax relief and recommending the passage of State laws and policies to lift the tax burden for schools from the shoulders of property owners. The recommendations released from the Commission included: a cap on property tax increase; a "circuit breaker" to limit taxes on lower income property owners; new policies for school cost containment and improvement of school management systems; and the elimination of State unfunded mandates.

WHEREAS, several counties located wholly or partly in the Adirondack Park have authorized common litigation to challenge the legality of the new regulations; and

WHEREAS, it is in the best interest of Saratoga County and its residents to join with other counties in a legal challenge to these regulations; now, therefore, be it

RESOLVED, that authorization is granted to join with other Adirondack Park counties to commence legal action against the Adirondack Park Agency to challenge the legality of new APA regulations which restrict and limit the rights of owners of shoreline property within the Adirondack Park to modify existing structures along the shoreline setback, and it is further

RESOLVED, that the County Administrator is authorized to execute a retainer agreement with the attorney chosen by the counties for an amount not to exceed \$3,000, the form and substance subject to the approval of the County Attorney.

<u>BUDGET IMPACT STATEMENT</u>: The County cost will not exceed \$3,000 and is included in the County Attorney's budget.

WHEREAS, pursuant to County Law §266, the Commissioners of Saratoga County Sewer District No. 1 adopted a scale of charges for its 2009 services; and

WHEREAS, this scale was duly published in the official newspapers of the County and of each political subdivision within the District and was duly filed with our Clerk of the Board; and

WHEREAS, the New York State Office of Parks, Recreation and Historic Preservation timely filed an appeal dated December 1, 2008, with this Board requesting that Section 3, paragraph (h), of the proposed 2009 Scale of sewer charges be amended to delete the requirement that the rate charged the Saratoga Spa State Park be adjusted to accommodate the Park's peak flow discharge rates; and

WHEREAS, after due consideration of said appeal, this Board deems it appropriate to grant said appeal and amend the proposed scale of charges accordingly; and

WHEREAS, after further consideration, and upon the District's recommendation, this Board finds that it is in the public interest to adopt the scale of charges for collection, conveyance, treatment and disposal of sewage, as amended; now, therefore, be it

RESOLVED, that the following 2009 scale of charges for the Sewer District, as amended, be, and the same hereby is, confirmed, namely:

PROPOSED 2009 SCALE OF CHARGES FOR SARATOGA COUNTY SEWER DISTRICT #1

SECTION 1 - SEWER CHARGES IMPOSED

Pursuant to County Law §266(1)(a), Saratoga County Sewer District No. 1 hereby imposes sewer charges for 2009 upon all premises and real property, within or without District boundaries, connected to, the District's sewer system.

SECTION 2 - ESTABLISHMENT AND CONFIRMATION OF SEWER CHARGES

Subject to confirmation by the County Board of Supervisors, this scale of charges may, from time to time, be amended by the District's Commission.

SECTION 3 - CRITERIA FOR ESTABLISHING SEWER USER CHARGES

The scale of sewer user charges shall use the following criteria:

- (a) A user is defined as any piece of land upon which a building or buildings stand and is connected to an interceptor, trunk or collector sewer served by the District.
- (b) The annual cost of debt service, administration, operation and maintenance for the District's treatment facilities will be generally allocated to all users.
- (c) The annual cost of debt service and operation and maintenance associated with the interceptor sewer, will be generally allocated to all users connected to and/or discharging into the system.
- (d) The annual cost of debt service and operation and maintenance associated with each major trunk sewer system will be generally allocated to all users connected to and/or discharging into the system.
- (e) A connection unit is defined as a single-family dwelling unit. Units include, but are not limited to, a single family house, each apartment unit (e.g. an apartment building with six apartments is six units), each half of a duplex, a cottage, a camp, a mobile home, and each unit of a condominium or townhouse. A "unit" as used for

10

billing purposes will be 200 gallons per day of sewer discharge, or any portion thereof. No user will be rated at less than one unit. Users will be rated in terms of whole connection units. Each tenant with sanitary facilities within a commercial complex will be defined as an individual user.

(f) For all users, including single-family dwelling units, equivalent connection units (e.c.u.) will be determined, based on the following schedule which accommodates peak demand and potential flow needs:

USER & COLLECTOR CHARGES:

Single parcel:

A. Vacant - no charge unless a lateral was requested and installed; if lateral installed a collector fee shall be charged for each lateral.

- B. Occupied Residential
 - Single Family Residence (1)
 - a. 1 user, 1 collector as applicable.
 - Multiple Family Residence Each separate dwelling unit in a two family, three family or multiple (2) dwelling, which is not an apartment
 - a. 1 user per dwelling unit
 - b. 1 collector per dwelling unit as applicable
 - (3) **Apartments**
 - Each dwelling unit is assigned 1 user and 1 collector as applicable a.
 - Subsidized senior housing For complexes receiving Federal, State or municipal rent subsidies for dedicated senior housing, each 2 dwelling units will be assigned 1 user and 1 collector as applicable
 - Proof of entitlement to the designation as senior subsidized housing will need to be provided by the user and will be subject to approval of the Sewer Commission; confirmation of continuance of the subsidy will need to be provided to the Sewer District by September 1st of each year.
 - Trailer Parks
 - a. 1 user for each trailer
- C. Occupied Commercial
 - 1 Collector for each user

For all commercial users: where actual sewer flow is measured, that flow (one year's record data) shall be used for determining an e.c.u. count with adjustments for discharge strength and content. The data is to provide cumulative and daily peak flow volumes; the methodology is subject to approval of the Executive Director.

Users generating higher annual sewer flows than above schedule, the following rate table applies:

For each additional 75,000 gallons or any part thereof, the number of connection units shall be increased by one.

- (g) When there is a substantial increase in sewer flows during the current year, the District may adjust the number of connection units charged and bill the user directly for that additional sum pursuant to Section 8.
- (h) Saratoga Spa State Park and Mount McGregor will be charged based on their 2008 measured waste expressed in E.C.U.'s discharged to District facilities.
- (i) Wastewater from wet processing and other operations is subject to the restrictions, prohibitions and surcharges outlined in the District's rules and regulations covering the discharge of sewage, industrial waste and other waste into the Saratoga County sewer system and all sewers tributary thereto.
- (j) A user discharging B.O.D. or T.S.S. to the District facilities exceeding the amount allowed in the District's rules and regulations will be charged \$700 per dry ton for that excess per conditions of their discharge permit.
- (k) All costs of the District's pretreatment and spill response program including, but not limited to, laboratory testing, labor, equipment, materials, consultants and subconsultants, contractors and subcontractors, and fines, shall be reimbursed by the individual or user.
- (l) Outside non-residential users will be charged two and one-half times the rate established for the trunk system servicing that user, residential housing will be one and one-half times that rate.

- (m) Collector sewer rates are generally based on the overall construction costs of the collector system together with debt service and operation and maintenance costs of the collector system.
- (n) Users of collection sewers turned over to the District will be charged for that portion of the District facilities utilized and at the same rate as the other users of the particular system.

SECTION 4 - SCALE OF CHARGES

The following is the 2009 scale of charges for the trunking and treatment of sewage.

SECTION 6 - PAYMENT OF SEWER USER CHARGES

All sewer charges, excepting those for Saratoga Springs, Saratoga Spa State Park and Mount McGregor shall be collected pursuant to Real Property Tax Law Article 11. The assessor of each municipality utilizing the town and county tax bills for the collection of taxes shall properly code the assessment roll as to the number of connection units for each particular property and for those properties utilizing the collector system. The assessor shall use the District's formula to determine the units for multiple dwellings and commercial users of the trunk and collector systems.

The City of Saratoga Springs, which includes the Geyser Crest, Geyser Road and a portion of the Saratoga Lake trunk sewer systems; as well as the Kirby Road, Loughberry Lake, Crescent Avenue and a portion of the Saratoga Lake collector systems shall each be considered as a single-bulk user and shall be so billed by the District. The city's collecting officer shall determine the appropriate method of assessing and collecting its sewer user charge. This single-bulk user charge may be passed on to city residents as a city sewer rent and enforced pursuant to General Municipal Law §452.

City payments shall be due quarterly by March 31, June 30, September 30 and December 31, 2009. A late payment charge of one percent (1%) per month shall be added for each month or portion thereof until paid.

The District shall bill Saratoga Spa State Park their 2009 user charges payable no later than May 1, 2009.

Mount McGregor shall be billed directly by the District and payment shall be on a quarterly basis.

Payments by single-bulk users shall be made to the County Treasurer who shall reject any untimely or insufficient payment. The postmark date of a payment shall be evidence of payment.

SECTION 7 - PENALTIES FOR LATE PAYMENTS

Sewer charges shall be subject to the same penalties and interest applicable to County taxes generally.

SECTION 8 - PAYMENT OF SEWER CHARGES NOT ON TOWN/COUNTY TAX ROLLS

The District shall bill directly those users of the collector sewer system and the trunk sewer system not appearing on the town and county tax rolls. Payments shall be made to the District and forwarded to the County Treasurer. Partial payments will not be accepted and will be returned.

The District shall also bill directly those users that have had an increase in connection units during the year.

The County Treasurer shall prepare and transmit to the Board of Supervisors, on or before December 1, a list of District residents or property owners within the District who are in arrears in the payment of such trunk or collector charges for a period of 30 days or more. The list shall contain a brief description of the properties for which the services were provided, the names of the persons or corporations liable to pay for same and the amount chargeable to each including penalties and interest computed to December 31.

The Board of Supervisors shall levy such sums against the properties liable and shall state the amount thereof in a separate column in the annual tax rolls of the various municipalities under the name of "county sewer charges". Such amounts, when collected by the several municipal collectors or receivers of taxes, shall be paid over to the County Treasurer. All of the provisions of the tax laws of the State of New York covering the enforcement and collection of unpaid taxes or assessments for special improvements not inconsistent herewith shall apply to the collection of such unpaid charges. Such amounts, when received by the County Treasurer, shall be credited to the County Sewer District fund for the District's exclusive use.

SECTION 9 - PROCEDURES

Resolution 174-77 shall govern the Commissioners' consideration, adoption and publication of this proposed scale of charges. After the Commissioners' actions, the Board of Supervisors shall act upon the published scale and any appeals there from as follows:

- (a) Confirmation thereof by a general resolution;
- (b) Amendment and confirmation by a general resolution; or
- (c) Recommitment to the District Commissioners for further study and consideration.
