WHEREAS, the cost of Dr. Feldman's services in 2008 exceeded the authorized \$10,000, and an amendment to his contract is required to authorize payment of an additional \$875 for his services; now, therefore, be it

WHEREAS, the United States Environmental Protection Agency (EPA) plans to conduct the largest dredging operation ever attempted, to remove PCBs, a suspected carcinogen, from the bed of the Hudson River in the area of Fort Edward and the Town of Moreau; and

WHEREAS, samples of the drinking water of municipalities along the Hudson River below the proposed dredging sites have revealed the presence of PCBs, even prior to dredging; and

WHEREAS, there is no evidence that dredging operations will not increase PCB contamination of these public water sources through resuspension of PCBs; and

WHEREAS, EPA has failed to propose actions to be taken prior to commencement of dredging which can be demonstrated to protect the safety, health and welfare of the consumers of these water supplies; and

WHEREAS, by Resolution 122-07 authorized a contribution of up to \$100,000 towards legal fees of the Towns of Halfmoon and Waterford for litigation that may be brought by them against EPA to require it to take adequate steps to guarantee the safety of their water supplies; and

WHEREAS, the Towns of Stillwater, Halfmoon and Waterford and the Villages of Stillwater and Waterford and the City of Mechanicville intend to commence action against the EPA for such purpose; and

WHEREAS, it is in the best interests for the safety, health and welfare of residents of Saratoga County that the County join the said municipalities as a party in the said action; and

WHEREAS, an amendment to the 2009 County budget is needed to include the funds originally appropriated in the 2007 budget in the 2009 budget; now, therefore, be it
