Mr. Wickerham said we believe this will be slightly over \$10,000, so it will no longer be a minor contract.

Mr. Wickerham said funding for those have been cut by 8% by the State.

Mr. Wickerham stated there is an increased demand for home delivered meals.

Authorizing the Chairman to enter into a renewal agreement with GTL Inc. for personal emergency response systems at a cost of \$34.95 per unit per month at a total cost not to exceed \$15,000. (Sandi Cross, Office for the Aging Director)

2008 Annual Report of the Saratoga County Public Health Department.

Received and filed.

Ms. Daly, Chairman of the Saratoga County Council on Autism, said as you remember, last month we passed a resolution honoring April as Autism Awareness Month. She said she wanted to report on the emergency preparedness conference that the committee put together that was held in Clifton Park on March 27. The event was well attended. We had a target audience of the people we had hoped to come - - first responders, law enforcement, firefighters; anyone who may come in contact with a person with autism in emergency situations. She said from the feedback she received, Mr. Debbaudt did an excellent job in preparing these people to better handle an emergency involving a person with autism. She stated the evening before was for caregivers, parents, anyone who has to work with a child of autism who was interested in making sure they could secure the highest level of protection they could for the person they encounter. While although the room wasn't overcrowded, the 20 or so people who were there were more compassionate and more concerned about people than she had ever

seen, she said. Besides everyone learning something that they didn't know previous, the room was filled with people who were not necessarily in the first line of care giving, she said. There were grandparents, cousins, uncles, and it was inspiring for her to see the amount of support these people have, she said. Unless you have support and members of a community who are willing to come together and offer these people an opportunity to learn and to go on, we are really robbing ourselves of an important quality of life for these people, she said. She thanked everyone for helping her and supporting her in her request to move forward with this conference and she also thanked the committee. She stated Senator McDonald's quote in the newspaper pretty much summed up the core of that conference when he said "Special people need special love, and special love in emergencies need special attention." It could not have been said better as to what the intent, the purpose, the goal, and the achievement was of that conference, and I thank all of you, she said.

Ms. Daly introduced a person who has reached out to her as a volunteer professional, as a person who is willing to commit time in his community and as a parent, and she welcomed executive chef, Jay Maxwell from Hell's Kitchen. Mr. Maxwell said he is happy to be a part of this. He said he is here to help out. He said his son was diagnosed almost two years ago, and it's a difficult thing coming to accept that in your life. As a parent, it's one of the hardest things he has ever had to deal with, he said. He said he being diagnosed two weeks before he went to Hell's Kitchen is a whole other story. He said Ms. Daly and he have bounced around a lot of different ideas - fundraiser events and different cooking demos, and he has support from FOX and a lot of other people. Today is a great day, and tomorrow will be a better one, he stated.

Ms. Daly stated we will be doing great things together, and to begin with, we can design recreation opportunities. Not only does the chef want to teach people how to cook, but he would also like to teach about nutrition, and what an excellent opportunity this will be for all of us. We have spoken in particular about activities at the Fair this summer, she said. In honor of Autism Awareness Month, she provided all of the Supervisors with a pen that looks like the character on the winner poster that one of the children had designed for the publications that they have.

RESOLVED, that Saratoga County Board of Supervisors does hereby urge the State of New York to resolve the issue of VLT operations at Aqueduct in an expeditious manner, in order to continue to preserve Thoroughbred Racing operations within the State; and be it further

REQUESTING STIMULUS FUNDING FOR REPLACEMENT OF THE BATCHELLERVILLE BRIDGE

WHEREAS, the Batchellerville Bridge was constructed by the New York State Hudson River Regulating District in 1927 as part of the construction of the Sacandaga Reservoir; and

WHEREAS, the Regulating District was created by an act of the New York State Legislature to construct dams for the purpose of regulating rivers to prevent flooding, provide low flow augmentation and inexpensive and clean hydropower; and

WHEREAS, the state acquired over 42 square miles of land, constructed the dam and the 3000 foot long Batchellerville Bridge to connect the two sides of the town of Edinburg and access for the entire region; and

WHEREAS, the reservoir has saved the residents of New York State countless millions of dollars over the years by preventing flooding downstream and the low flow augmentation in the summer months has allowed businesses to operate, sewage treatment plants to avoid shutting down and kept the salt front below Poughkeepsie; and

WHEREAS, low cost power has been generated for 80 years from the water released from the impoundment which has benefited the entire state; and

WHEREAS, the current bridge is now 80 years old and has reached the end of its useful life and needs to be replaced; and

WHEREAS, if the current bridge has to be closed it will result in a severe economic crisis for the entire region (Saratoga, Fulton and Hamilton Counties), would compromise fire and emergency services, would require long and cost prohibitive commutes, result in increased costs of goods and services, cause businesses to lose customers and maybe be forced to close resulting in job loses and even higher unemployment rates in these depressed Adirondack communities; and

WHEREAS, New York State has designed a replacement bridge, obtained all the necessary permits and acquired all the lands needed for the construction; and
