PUBLIC HEALTH COMMITTEE MINUTES

MAY 6,2009 - 3:30 P.M.

Present: Chairman Lucia; Supervisors Barrett, Connelly, Richardson, Southworth, Wood, Wormuth and Yepsen; Spencer Hellwig, Mgmt. Analyst; Janet Glenn, Terrayne Stortz, Public Health; Dale Angstadt, Hans Lehr, Mental Health; Diane Brown, Maplewood Manor; Charles Brown, Deputy Supervisor and Emergency Coordinator for the Town of Corinth; Linda McAllister, Resident Saratoga Springs; Press.

Chairman Lucia called the meeting to order and welcomed all in attendance.

On a motion made by Mr. Woods, seconded by Mr. Richardson the minutes of the April 1, 2009 meeting were approved unanimously.

Mrs. Brown said every year the employee meal program has to be approved by the committee. The program is being phased out with six people qualifying for the program and only two participants. The charge for the employee is based on the food costs. The charge is currently \$2.50/per meal. It is recommended that the cost of the meal increase to \$2.75/per meal.

A motion was made by Mr. Barrett, seconded by Mr. Richardson to increase the cost of employee meals from \$2.50 to \$2.75 per meal. Unanimous. (Committee Approval Only)

Mrs. Glenn said on April 26th, Public Health received an alert from the NYS Department of Health that there was potential for an outbreak of the swine flu. At the time there were eight confirmed cases in New York State, all in New York City from a school in Queens.

The County health department has the final determination as to when to send a specimen. Counties were restricted to 2-3 specimen submissions per day. Public Health authorized one specimen be submitted to the Wadsworth Lab, which tested negative.

An incident command center was established per the Pandemic Plan at Public Health. Contact was made with health care providers, school nurses and Saratoga Hospital asking them to assess and monitor flu like illnesses and absenteeism, and report back to Public Health. The goals during an emergency such as this are to reduce transmission, illness severity, and provide information to assist providers and the public in addressing challenges that arise from this newly identified virus.

On a daily basis Public Health was in conference with the NYS Department of Health with regard to various topics such as epidemiology and surveillance; media issues;

updates from the Commissioner of Health; changes in case definition and school closings.

Public Health fielded phone calls from providers and the public, providing them with the NYS Department of Health question hotline. A press release was issued on April 28th informing the public about what Public Health was doing in the county during the outbreak and information was updated on the County website.

Mrs. Glenn gave a brief update on Lyme Disease as follows:

Lyme disease is a bacterial disease caused by the bite of an infected deer tick. At it's mildest, it causes a rash. At its worst, it can cause disabling joint and neurologic problems. A significant percentage of individuals that are diagnosed with the disease have no recollection of a tick bite.

If treated in the early stages with antibiotics, there is usually a rapid and complete recovery. Symptoms to look for include: a rash resembling a bull's eye; chills, fever, headache, fatigue, stiff neck, muscle/joint pain and swollen glands. Symptoms usually occur within three to thirty days after a tick bite.

Early treatment calls for antibiotics usually, Doxycycline. The chances of a complete recovery are decreased if treatment is delayed.

In New York State there have been 77,000 confirmed cases since 1986. Diagnosed cases in Saratoga County have been rising steadily:

2004 - 42 cases

2005 - 69 cases

2006 - 81 cases

2007 – 159 cases out of 254 reported cases

2008 – 393 cases confirmed from over 700 reported

Education is the key to prevention of the disease. When in wooded or grassy areas where deer may inhabit, wear light colored clothing, and tuck pants into socks, covering as much exposed skin as possible. Check for ticks frequently, and if in areas where there might be ticks, do a final full body tick check at the end of the day.

If you find a tick, remove it carefully and place it in a zip lock bag. Bring it to the Public Health Office, which is open Monday through Friday from 8am to 4pm. The tick will be sent to the lab for identification. Results take approximately four days.

Ms. Yepsen said she has received many calls about Lyme Disease and inquiries as to what the county is doing and general awareness about the disease.

Ms. Yepsen asked if the Public Health Committee would be interested or willing to take this on as one of the issues that we can do a little bit more awareness.

Mr. Lucia said Mrs. Glenn distributes a packet to the committee on a yearly basis and always has the information on hand. The information is given out at town board meetings, as well.

Mr. Lucia said that Public Health already does a good job with Lyme Disease.

Mrs. Glenn said pamphlets on, "How to Remove a Tick" are available on line at the New York State Department of Health website.

Ms. Yepsen introduced Linda McAllister, who has been a long time victim of Lyme Disease and lives in Saratoga Springs.

Ms. McAllister said there are two treatment positions on Lyme Disease. The Infectious Disease Society of America and the International Lyme and Associated Disease Society. The Infectious Disease Society of America says that Lyme Disease is easy to treat and easy to cure. For many reasons it is not. If it is not treated in a very short length of time it goes into your system.

Ms. McAllister said she would like the community to work on the other side of the story. The Infectious Disease Society of America guidelines have been challenged by Attorney General Blumenthal, as they have been involved with non-claim boards for Lyme Disease.

Ms. McAllister said that Lyme Disease can be passed from mother to child, so those children will never know what it is to be normal. The affects are to the central nervous system and can be life threatening.

It is not really just a disease of the joints and aches and pains. When they say it is easy to treat and easy to cure it really is what they call the dormant phase and when your body is stressed or the time is right it starts the disease again.

Ms. McAllister said that if she had not had the means to step out of the guidelines of the IDSA, she would not be here today. The International Lyme and Associated Diseases Society considers treatment for two months after symptoms.

Mrs. Glenn said that treatment is up to the physician.

Mr. Lucia said the information that was presented would be given to Mrs. Glenn to look over to see what needs to be done from here.

Mrs. Southworth said a lot stems on education. The physicians that are doing the diagnosing, the problem is whether they are able to pick it up soon enough. The educational effort should stress the responsibilities of the heath care provider, which is where we are really going to be able to make a difference.

Mr. Lucia said Public Health distributes Tick and Lyme Disease information every year throughout the county.

Mr. Angstadt requested the following resolutions:

To change the language in the existing contract, page 1, item 2B, to "one-half unit is defined as any respite that is between four and less than eight hours of respite." It currently reads, "One-half unit is defined as any respite that is between one and less than eight hours of respite."
