Mr. Wickerham said this will be from Route 4 & 32 to Route 29 to the City of Saratoga Springs.

EQUALIZATION AND ASSESSMENT

Rescinding Resolution No. 93-2009 relative to the corrected tax bill for a parcel in the Town of Wilton and authorizing a refund of \$9,353.12 in erroneous taxes. (Carol Holley, Real Property Director)

Rescinding Resolution No. 224-2008 which relevied unpaid Sacandaga Lake Maintenance assessment. (Mark Rider, County Attorney)

Mr. Wickerham said there has been a lawsuit challenging the ability of the Hudson River-Black River Regulating District to actually relevy that amount.

Waiving penalties/interest on a parcel in the Town of Stillwater due to the Town's error in collection of taxes. (Mark Rider, County Attorney)

Accepting a tender offer in the Town of Malta in the amount of \$15,069.95. (Sam Pitcheralle, County Treasurer)

Mr. Wickerham stated the money is in the budget and is a 14% increase in funding.

Mr. Wickerham said this is an 11% increase.

Mr. Wickerham said this is all federal money and is the same as last year.

LAW AND FINANCE

Authorizing Blanket Official Undertaking for County Officers Required by Law to Execute and File Official Undertakings. (Mark Rider, County Attorney)

Mr. Wickerham stated we recently changed insurance carriers, and we have to acknowledge that.

Chairman Johnson stated there was a press conference today in Malta to announce a closing on lands in Luther Forest Technology Campus. At that event, I was presented a copy of the closing memorandum between LFTC and GlobalFoundries, he said. He stated the Board of Supervisors was recognized for making that happen; in particular, with the financial assistance this Board has given to the Saratoga County Water Authority. Anita Daly, Chairman of the Economic Development Committee and Jack Lawler, Chairman of the Water Authority, were instrumental in making this project happen, he said.

Ms. Daly congratulated GlobalFoundries and LFTC. They do have a bright future, she said. She stated those not thanked were all of the people in the County who stood behind us, and people all across New York State truly needed to be thanked today. She said there were night sweats we went through in this process, and Jack Lawler shared the brunt of this in Saratoga County. He is the reason this project is happening now, she added.

Vice-Chairman Peck said Supervisors Connelly and Sausville have gone through many hours of work to approve this project in their towns.

Mr. Lawler said he was at the press conference, and a lot of people can step up and take great pride and credit as to what took place. When times were at their darkest, the buzz around the project was not all that great, he said. It looked like an insurmountable mountain after mountain, he said. He stated supporters were not that easy to find 18 months ago. He said when this project was at its lowest, this Board stepped up in a bi-partisan way to pull together and show leadership. I wish the people in Albany would look a little north, he said. We did what was in the best interest of the people in this County and in this region. We invested money when no one else was willing to do so. It was the people in this room who made the press conference possible today, he said. He stated everybody in this room deserves congratulations and praise. I thank each and every one of you for the support and encouragement you showed me and the Water Authority, he said.

Mr. Grattidge invited the Supervisors to Cooperative Extension's chicken barbecue at the 4-H Training Center right after this meeting.

Ms. Daly said the Saratoga County Council on Autism introduced Chef J. Maxwell who will present to this Board a sneak preview of an opportunity he will offer to people with disabilities at the Fair this year.

Ms. Daly stated Supervisor Rowland shared with her the rules and regulations of the Fair's demolition derby featuring the Supervisors, and she intends to win. Get ready, there will be a derby, and we will attract a crowd, she said. See Dick Rowland to get the rules, she added.

URGING SIGNIFICANT PUBLIC INPUT IN ANY PROCESS FOR NEW RULES FOR ACCESS PERMITS FOR THE GREAT SACANDAGA LAKE

WHEREAS, for the last 76 years, an arrangement has existed between the Hudson River-Black River Regulating District (HRBRRD) and owners of property adjacent to or near the lands owned by HRBRRD along the shore of Sacandaga Lake such that HRBRRD has issued permits to the owners, giving them the exclusive right to occupy a portion of HRBRRD land, and improve it by clearing, planting lawns, installing fireplaces, picnic tables, stairs and docks; and

WHEREAS, this permit system has increased the value and purchase cost of properties which have a permit associated with them, and engendered a lake oriented life style which the owners have relied on in purchasing their land and making valuable improvements; and

WHEREAS, in the process of reviewing and revising the existing rules of the HRBRRD, proposed revised rules were forwarded to the New York State Department of Environmental Conservation for comment; and

WHEREAS, the Department of Environmental Conservation returned proposed rules with substantial changes to those rules proposed by HRBRRD, including a change which would terminate the owner's exclusive rights under the permit system, prohibit improvement of permit areas, and allow unrestricted public access to areas which have heretofore allowed to be used solely by the permit owner; and

WHEREAS, the proposed rule would have turned the shoreline area into a ungoverned, uncontrolled, unregulated and unsupervised public park; and

WHEREAS, the potential for misuse and abuse of the shore side property by activities of persons having no stake in the maintenance of the land increases the liability and endangers the safety of adjacent property owners arising from negligent and criminal activity of visitors; and

WHEREAS, HRBRRD met on May 12, 2009 and accepted the substantial changes to the rules DEC had proposed, without discussion, comment, or any opportunity for the public to be heard, and forwarded the DEC proposed rules to the Governor's Office of Regulatory Reform for review, only after which is there a 30 day written comment period available for the public; and

WHEREAS, these rules will have a substantial negative impact on the character and environment of Sacandaga Lake, leading to increased traffic and parking problems, noise, littering, accidents and crime; and

WHEREAS, the process of promulgating this extreme alteration of a long standing arrangement upon which thousands of residents have relied on was done without any opportunity for public comment and inquiry and no opportunity was afforded to the public to comment on and question the rules, and offer suitable alternative methods of addressing the concerns which gave rise to the changes; and

WHEREAS, Governor Paterson has withdrawn the proposed rules, with further study to be done regarding any new regulations; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors expresses its opposition to any further action to be taken in regard to proposed rules concerning the Sacandaga Lake permit system without a full and meaningful opportunity to the public to comment, inquire and otherwise participate in the process, and to offer reasonable alternatives; and be it further

WHEREAS, to officially rename these highways requires home rule legislation to amend the Highway Law of the State of New York; and

WHEREAS, Assembly Bill number 8942 and Senate Bill number LBD 14383-02-9 would name these highways in accordance herewith; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors requests the enactment of Assembly Bill number 8942 and Senate Bill number LBD 14383-02-9 entitled "An Act to Amend the Highway Law in Relation to the Designation of the Saratoga County Veterans Memorial Highway"; and be it further

RESOLVED, that a necessity exists for the enactment of such legislation as it is in sole discretion of the Legislature to officially designate the names of state highways.

RESOLVED, That the Saratoga County Board of Supervisors requests the enactment of Assembly Bill No. 4703-A and Senate Bill LBD 14415-01-9 entitled "An Act Authorizing the County of Saratoga to Discontinue For Reforestation Purposes The Use Of Certain Lands And To Convey Such Lands"; and, be it further

RESOLVED, That a necessity exists for the enactment of such legislation due to the fact that Section 219 of the County Law requires the approval of the New York State Legislature for the discontinuation of reforestation purposes for county reforestation lands.
