OVERVIEW

The 2009 Green Committee is proud to submit for your approval these recommendations on how the County can operate in a more environmentally friendly and potentially cost effective manner. The committee was formed in early 2009 upon a recommendation from Senator Roy J. McDonald. We have worked diligently to fulfill our mission set forth by the Chairman of the Board of Supervisors: To study various environmentally friendly initiatives, and to report to the Board of Supervisors with recommendations on implementing these initiatives. The committee has worked hard, holding public meetings in the communities of Stillwater, Saratoga Springs, South Glens Falls, Milton, and Ballston Spa. In each of our public meetings, we heard from experts in the field of Green technology, to provide the committee with guidance as to what steps Saratoga County should take to operate in a more environmentally friendly manner. The ultimate goal of these recommendations is to provide a cost savings to the taxpayers Saratoga County, as well as reducing the County's impact on the environment.

These recommendations have been organized into three categories: Short-term; Intermediate; and Longrange programs. The short-tem programs are those that the County can undertake at little or no cost; some of these recommendations can be done immediately. The intermediate programs are those that are done with potentially a greater cost, and may not be feasible to be done immediately. Long-term programs would be those at greatest cost to Saratoga County, and are arguably not immediately feasible. Of note is that some of our long-term recommendations could save the most taxpayer dollars in the long term.

The committee wishes to thank all who have assisted us with our meetings, and to all of those who took time out of their busy schedules to help set up the locations for meetings, and for all those who made presentations to our committee. Our presenters came from as far away as Long Island. Their dedication and passion for green initiatives is commendable.

Section One: Short-Term Recommendations

This section details short-term programs that Saratoga County should begin to implement for immediate cost savings to Saratoga County taxpayers. These recommendations can be undertaken at little or no cost, are easy to achieve, and will reduce the County's fuel and energy consumption.

Undertake an Energy Audit on all County-owned facilities and vehicle fleet.

Work with NYSERDA to audit County Complex, Jail and DPW facility, Sheriff Substations and Public Health Building, parking lots, and other facilities to create a baseline of County usage at the County and identify problem areas.

Audit vehicle fleet to find opportunities for fuel and maintenance savings.

Train staff on how to think 'Green' in their day-to-day activities.

Encouraging positive employee behavior can be easily implemented and can realize immediate cost savings for the County.

Install motion-sensitive light switches in all County buildings if not already installed.

Begin a program of mowing reduction on County properties.

Expand and promote recycling education and compliance.

SECTION TWO: INTERMEDIATE RECOMMENDATIONS

This section details intermediate programs that Saratoga County should implement for cost savings to Saratoga County taxpayers. These recommendations are more likely to be completed over time, and some are dependent on the Buildings & Grounds and Department of Public Works schedules for repair and replacement of County facilities. These recommendations are of higher cost to implement, but can result in a substantial cost savings in the long-term.

Replace lighting with LED street lighting on County properties.

Replace lighting on County lighting replacement schedule.

Purchase Hybrid and other alternative fuel vehicles, as test vehicles for County's vehicle program.

Replace fleet dependent upon cost savings.

Purchase new vehicles on County vehicle replacement schedule.

Continue to explore rehabilitation or re-use of 50 West High Street solar installation.

Continue to implement proposals contained in the Green Infrastructure Plan.

SECTION THREE: LONG-TERM RECOMMENDATIONS

This section details long-term programs that Saratoga County should implement for cost savings to Saratoga County taxpayers. These recommendations are likely to be undertaken as new initiatives of the County, and are not currently a part of the normal operation of the County. These recommendations are the most costly to implement, and each of the below proposals should be thoroughly investigated before implementing, to make sure that the technology is sound and cost savings can be effectively realized by the County.

Install Photovoltaic Solar panels on building roofs.

Install Photovoltaic Solar array at County Farm property.

Install a rainwater collection system for County DPW needs.

Install Net-metering devices on County buildings.

Net meters are devices that can run in reverse when a facility is making more power than it is using, thereby 'selling' unused power back to the power grid.

LEED certification for all new County buildings.

Investigate potential benefits of Green Roof technology.

LEGISLATIVE & RESEARCH COMMITTEE 2009 YEAR-END REPORT

February 2009

- Outlined 2009 Legislative Program
 - 1. Requesting a portion of the federal stimulus funding being distributed through the Governor's office for infrastructure projects in Saratoga County.
 - 2. Supporting mandate relief as a necessary component of any state sponsored attempt to control property taxes.
 - 3. Supporting Saratoga County municipalities in their requests for special State Assistance.
 - 4. Supporting Senate Bills S255 & S266 to require market-based assessments of real property owned or leased by a cooperative corporation or on a condominium basis which is converted or constructed on or after January 1, 2011.
 - 5. Opposing the disproportionate reduction in Consolidated Highway Improvement Funding (CHIP's) currently being proposed in the Governor's budget.
 - 6. Urging the New York State Legislature to support the State's Farmland Protection Program and the Environmental Protection Fund.
 - 7. Providing additional funding and awarding the construction contract to honor the State's promise to replace the 78 year old Batchellerville Bridge in the Town of Edinburg.
 - 8. Rejecting any provisions in the Governor's 2009 budget that would eliminate the sharing of VLT revenues with Saratoga Springs and Saratoga County.

- 9. Opposing certain proposed Empire Zone Program reforms that would result in the elimination or downsizing of businesses in Saratoga County that have lived up to their commitment to create and foster economic prosperity within the existing program guidelines.
- 10. Supporting various health care reform initiatives including the permanent reinstatement of the Intergovernmental Transfer Program (IGT) and the restructuring of the funding mechanisms for mandated medicaid services.
- 11. Urging the restoration of \$453,000 in funding for NYS County Fairs agricultural exhibits and opposing the imposition of a sales tax on admission gate fees.
- Opposed funding cuts to the State's Farmland Protection Program Passed a resolution urging state lawmakers not to cut funding to this program which protects and nurtures our agricultural economy and valuable farmland.
- Supported Senate Bill S255/S256 to remove inequities in the assessment of new condominium units Passed
 a resolution to end the inequitable assessment of new condominium units by allowing taxing jurisdictions to
 assess these units according to their fair market value.

April 2009

- Met with State Legislators on April 20th to discuss our 2009 Legislative Program. The Supervisors attending this meeting were told by our State representatives to be as "program specific" as possible when requesting relief from State mandates. We'll be passing this advice along to the 2010 committee.
- Supported resolution passed by Racing Committee urging the State to permit the installation of Video Lottery Terminals (VLT's) at Aqueduct Racetrack.

May 2009

 Supported the continued operation of the DEC Tree Nursery in Saratoga Springs – Passed a resolution recommending that instead of closing the tree nursery changes in the operation of the nursery be formulated to make it more financially self-supporting.

June 2009

Urged Governor Patterson, the NYS Legislature, and the Hudson River/Black River regulating district to suspend the process for establishing new rules for lake access permits on Sacandaga Lake – Passed resolution opposing rules concerning the Sacandaga Lake permit system without a full and meaningful opportunity to the public to comment, inquire, and otherwise participate in the process.

October 2009

• Urged New York State and County Governments to purchase personal computers built with computer chips manufactured by AMD/Global Foundries – Passed resolution alerting governmental entities, in New York, that their purchase of computers with processors manufactured by AMD/Global Foundries was a key component of the economic success of this company which ultimately would benefit all New York residents.

December 2009

- Amended Local Law #1 of 1991 which established the E911 Surcharge Passed resolution introducing an amendment to Local Law #1 of 1991 which would require companies providing Voice Over Internet Protocol (VoIP) phone service to collect the E911 surcharge from its clients who are receiving the benefits of the County's Enhanced 911 emergency dispatch system.
- Sent letter to Governor Patterson and our State representatives requesting that they support the current level of funding provided under the New York State Tobacco Control Program, which is a vital part of various Stop-Smoking programs in Saratoga County.

REPORT NO. 14

2009 RACING COMMITTEE YEAR-END REPORT

2009 was a busy year for the Racing Committee. There were several Racing related issues facing Saratoga County from the beginning to the end of 2009. This committee worked hard to tackle those issues, for the

greater good of the County and for our residents. This report will summarize a few of the highlights from 2009, and to pass along to future committees a few recommendations.

In 2008, the Racing Franchise was awarded to NYRA for a 25-year term. As a part of the franchise agreement, NYRA was to relinquish their property rights, and all NYRA-owned property would revert to State ownership. This created a problem for Saratoga County and Saratoga Springs, which had been collecting property tax from NYRA since the franchise began in 1955. The committee faced several issues: How would the State pay their tax? Would the State make payments? How did this process differ from the way the City of Saratoga Springs and Saratoga County received payments in the past? By asking the pertinent questions, and monitoring the situation closely, it was determined that the State had made its payment to both City and County in 2009, and the distribution processing practices have been established for future years.

Another issue the Committee worked diligently on was the VLT distribution issue. Early on, this Committee, along with the Legislative and Research Committee, lobbied all State leaders to preserve VLT revenues at their 2008 levels for Saratoga County and Saratoga Springs. We understood the economic necessity of keeping these revenues coming to our County, as assistance for the impact on municipal services that a Gaming facility can have. Unfortunately, despite our best efforts, the State decided, through their statute, to remove the funding for 2009 based on a poverty-level formula that excludes Saratoga Springs and Saratoga County from receiving the distribution.

In addition, the Racing Committee put forth a resolution, urging the State to institute VLT operations at Aqueduct Race Track. As part of the NYRA franchise agreement, the State was to build a gaming facility at Aqueduct, to provide a stream of revenue for the State, and for NYRA. Estimates put the value of a gaming facility at \$1 million per day, and this is important to the County because having a fiscally sound NYRA helps to keep racing viable at Saratoga, and the impact of racing operations for our region is estimated at approximately \$250 million per year. We thank the Board of Supervisors for unanimously passing this resolution.

2009 was the fifth year that Saratoga Gaming and Raceway has been in existence. In 2002, the Board of Supervisors voted to allow gaming at the facility, and this committee felt that the County should receive a 5-year report update from the facility. Mr. Skip Carlson of Saratoga Gaming and Raceway presented the Committee with a report showing excellent increases in revenue, purses, and charitable giving from the organization. In all, having gaming operations in our County has been successful for our County.

The Committee had several guests at our meetings to talk about the various aspects of Racing in Saratoga County, and organizations that are there for the public to join who have an interest in Racing. We heard from ThoroFan, NYRA President Charles Hayward, Ed Lewi Associates, and The Racetrack Chaplaincy of NY. All these guests continued to emphasize the importance of Racing to our Community, and we thank them for taking time out of their busy schedules to meet with the Committee. We also held the first Saratoga County Day at the Races, where County residents received free admission to the Racetrack for the day, and we had a race named for the County this year.

Looking forward to a successful 2010, this Committee recommends that the issues of VLT operations at Aqueduct continue to be monitored, and to keep urging action from the State on this issue. In addition, monitoring the property tax payments from the State should also be continued, and if necessary, the Committee should take action to make sure the County receives its proper share of property tax. The Saratoga Day at the Races should be continued and expanded in future years.

REPORT NO. 15

Explore! Saratoga County Quadricentennial Commemoration Committee Summary Report

The Explore! Saratoga County Quadricentennial Commemoration Committee successfully completed a series of events and activities that composed the county wide program. There were four county wide events and over 20 events sponsored by our towns, cities, and villages.

The first county event was our participation in the Saratoga National Historical Park National Trails Day "Tales from the Trails" conducted on June 6th at the Saratoga National Historic Park. At this event, the county highlighted the comprehensive trail system and open space areas that county residents and visitors could enjoy in 2009 and in the years to come. A county trail brochure and online component were created to inform people of hiking opportunities that were available to them as they explored Saratoga County.

The second event was Explore! Saratoga County exhibit at the Saratoga County Fair from July 14th to 19th. Towns and village prepared an exhibit which illustrated ways and means of travel in Saratoga County and its municipalities and how travel has changed and grown over the past 400 years. This was a huge success and thousands of people viewed the exhibit.

The third county event was the Great Champlain Hudson Paddle conducted in Saratoga County from August 3rd to 4th. In this activity a group of over thirty canoeists paddled down the Hudson from the Town of Moreau to the tip of Manhattan. The group camped at Fort Hardy Park in Schuylerville the afternoon and night of August 3rd. While in Schuylerville they hiked to many of the Revolutionary War historical sites. Throughout the afternoon and evening Saratoga County sponsored a Community Festival featuring exhibits promoting various aspects of Saratoga County and in the evening a free Community wide diner and concert were provided to over three hundred people.

The fourth and final event was county sponsorship of the interactive children's tent for the Saratoga Native American Festival at the Saratoga Performing Arts Center in October. The event highlighted the County's rich Native American History educating the public on the history and culture of our regions first inhabitants.

The second extremely successful component of the Explore! Saratoga County program was the two round municipal grant program to assist town, villages and cities in their celebration of the Quadricentennial. Each municipality that received a round one grant of \$250. passed a Quadricentennial Resolution, Quad-branded all Quad municipal sponsored activities, flew the state Quad flag, and forwarded event information to the county for promotion. The second round of the grant program was a matching grant up to \$750. to municipalities to develop a new Quadricentennial program or add a significant Quadricentennial portion to an existing program. A total of 18 municipalities received round one grants of \$250. and 16 municipalities received a round two grant of up-to \$750. In total \$15,867 was distributed to municipalities for their celebrations.

Saratoga County received a state Quadricentennial grant for \$45,000 which was used to conduct the program. As a result of receiving the grant, there was no net cost to Saratoga County.

Sincere thanks are extended to all municipalities and committee members for their cooperation and participation in the program. Thanks to Barbara Plummer for her follow up support and state grant assistance, to Kristina Saddlemire for her participation, help and guidance, and to Board Chairman Art Johnson for his support and participation in the program. A special, genuine heartfelt expression of thanks is extended to Jennifer Ciulla without whose hard work, organization, commitment, and follow through this program would not have succeeded.

REPORT NO. 16

BUILDINGS & GROUNDS COMMITTEE 2009 END-OF-YEAR REPORT

This report offers an overview of the accomplishments of the Committee and the Public Works Department. The Buildings & Grounds Committee and DPW take pride in the following projects that have begun, continued and completed this year.

At the committee level, the bulk of our discussions were based on the Animal Shelter project. After last year's determination to move ahead with a 5.2 million dollar project, we agreed to construct a new facility. With C.T. Male as the Architect/Engineer, we moved to have Bishop Beaudry, the Project Manager, hire eight (8) separate contractors to date to do the work and authorized construction to proceed. As we all know, September 30, 2009 was the ground breaking and construction will continue through the winter. To make the project happen, Public Works personnel had to do some road work, do a new electrical service to our Milton Recycling and demolish an active storage building to clean the area where the new facility is being built. Public Works personnel are completing the replacement storage building at the time of this report.

At the airport, \$3,000,000 of improvements has been completed this pas year.

Outside contracts completed:

- 1. Taxiway/apron reconstruction
- 2. Waterline and fire hydrants installation
- 3. Replaced Automated Weather Observation System

Public Works Personnel:

- 1. Paved 5 miles of perimeter roads
- 2. Reconstructed the visitors' parking lot

Ongoing Projects:

- 1. Hangar replacement to be completed in 2010
- 2. Aviation easements multi year
- 3. Off Airport obstruction removal multi year

With our office buildings, the Public Works Department moved the County's Treasurer's office into new office space in Building #1. This area was made available after a multi-year project where our Public Works personnel created a records storage area in the old Jail. After the Treasurer moved, their vacated space was filled by the D.A.'s personnel; this alleviates an overcrowded condition in the D.A.'s office.

In addition to the work involved in the move, our staff is being utilized in added support services needed by the Public Health Department. These services include movement of H1N1 flu and seasonal flu clinic supplies and the receiving and stockpiling of potential epidemic supplies that could be needed.

The department moved and Public Health support were done in addition to the 2,750 separate department requests responded to and our daily need to keep our heating, ventilating and air conditioning equipment in operation throughout our 650,000 sq. ft. of facilities that we are responsible for. All of these items are part of our mission to provide a reasonably safe, comfortable work place for our employees and public that utilizes services that the County provides.

Saratoga County Public Works Committee - 2009 End-of-Year Report

This report offers an overview of the accomplishments of this Committee and the Public WorksDepartment over the past 12 months. The Public Works Committee and Department takes pride in thefollowing projects that have been completed this year:

Highway Projects:

- Reconstructed 20.50 miles of county-owned highways. Reconstruction work includes but is not limited to such tasks as reconstructing the drainage system, roadside ditches, road-base, asphalt pavement and resurfacing. Supplementary tasks include upgrading traffic signage and guiderail, as well as installing new shoulder fill and new roadway striping.
- Replacement of Bridge # 192.00 on County Road 7 (South Shore Road) over the Daly Creek inthe Town of Day.

NEW BRIDGE: COUNTY ROAD 7 OVER DALY CREEK

• Replacement of Bridge # 229.00 on North Road over the Snook Kill in the Town of Wilton

NEW BRIDGE: NORTH ROAD OVER THE SNOOK KILL

• Replacement of Culvert # 229.19 on County Road 70 at Deans Corners – Wayville Road overan un-named tributary to Saratoga Lake. (see photo page 3)

Engineering Projects:

- Progressed the engineering for the rehabilitation of Culvert # 390.00 on County Road 4 (NorthShore Road) over Glass House Creek. The rehabilitation is scheduled for 2010.
- Progressed the engineering for the federally and state funded rehabilitation of the County Road 43 (Geyser Road) Bridge over the D & H Railroad in the Saratoga Springs. The construction of this project is currently scheduled for 2010.
- Progressed the engineering for the federally and state funded replacement of the County Road 7 (South Shore Road) Bridge over the Sacandaga Reservoir (at Stewart's Dam) in the Town of Hadley. The construction of this project is currently scheduled for 2010.
- Our engineering staff continues to examine and study traffic issues as requested by towns or county residents. These requests may be as simple as the request for the installation of a sign or be as complex as the request for a traffic signal. Studies completed this year involved; Two (2) on CR 12 (Lake Desolation Road), CR13 (Fayville Road), CR 52 (Jockey Street), Two (2) on CR 55 (Sweetman Road), and CR 75 (Mechanicville/Stillwater Road).

NEW CULVERT: COUNTY ROAD 70 OVER UNNAMED TRIBUTARY

- Our engineering staff continues to draft and design construction plans for various D.P.W. projects. Plans completed in 2009 include; Culvert # 229.19 on County Road 70 (Deans Corners Wayville Road) in the Town of Stillwater as well as the rehabilitation of the Saratoga Springs Recycling Center.
- Comprehensive inspections of over thirty (30) county owned culverts (culverts have a span range of 5 ft. -20 ft.) were completed by our engineering staff.
- Our staff completed the design and administered the construction of the improvements to the D.P.W. fuel island in Ballston Spa.
- Our engineering staff also plays a key role in providing guidance and assistance to the maintenance and construction crews.

Maintenance Projects:

- Our department continues to complete various maintenance projects as required along our entire highway system. Maintenance projects are typically scheduled and completed based upon priority and need.
- In 2009, the majority of our maintenance projects included areas along the highway system that were experiencing deterioration of the asphalt and shoulders. Drainage ditches were cleaned and re-sloped, areas of deteriorated asphalt were removed and new asphalt material was installed. County roads that received a significant amount of maintenance included; County Roads 14 (Crooked Street), 39 (King Road), 52 (Jockey Street), 61 (Rowley Road), 76 (Lake Road), and 91 (Grooms Road).
- Repair of culvert # 366, County Road 45 over Glowegee Creek in the Town of Galway.
- Emergency repair of culvert # 389.80, County Road 7 (South Shore Road) over a tributary of the Sacandaga Reservoir in the Town of Edinburg.

EMERGENCY CULVERT REPAIR: COUNTY ROAD 7 OVER TRIB. OF SACANDAGA

- Repaired and cleaned out culverts on CR 16 (LIN 376), CR 19 (LIN 329.9), CR 36 (LIN 291), CR 45 (LIN 365), and CR 91 (LIN 214).
- Replaced over 275' of a 12" water main at the D.P.W. County Farm Complex.
- Installed a sidewalk at Saratoga County Clerk Complex overflow parking lot.

- Constructed a new 10' x 20' pump storage building for Emergency Services at the Fire Training Center.
- Constructed a 40'x 56' Pole Barn as a replacement for the demolished pole barn that was used by the animal shelter and the Buildings and Grounds Department.
- Repaired and replaced a 20' section of floor drains at the D.P.W. facility truck storage garage.
- The following county roads were cracksealed: Two (2) separate sections of 4 (North Shore Road), the Southerly most part of 10 (Mosher Road), the Northerly most section of 19 (North Creek and North Greenfield Road), all of 36 (Wilton-Greenfield Road), the Northerly most section of 52 (Jockey Street), Two sections of 45 (from Jockey Street to Armer Road and Paisley Road to Middleline Road), the Southeasterly section of 76 (Lake Road), and Two (2)short sections of 91 (Grooms Road) for a total of 32.58 miles.
- The entire 360-mile county highway system was restriped. Some town owned roads were also restriped on a "by-request" basis.
- Guiderail was upgraded repaired and installed at several locations within the county highway system.
- Twenty (20) culverts at various locations have been cleared of overgrown vegetation in preparation for 2010 inspections.
- Vegetation and trees were cleared along select areas within the county highway system. BATCHLERVILLE BRIDGE LANE REDUCTION
- The Batchellerville Bridge was reduced down to one-way alternating traffic with the installation of over 300 marker cones and two (2) portable traffic signals.

Adopt-A-Roadside:

• The Saratoga County Adopt-A-Roadside Program continues to play an important role in keeping our roads clean. In 2009, fifty-seven (57) community groups remain listed as active. Our inventory of adopted county highway is approximately eighty-one (81) miles. Our county D.P.W. provides orange garbage bags and safety vests to all participants. In addition, the county D.P.W. coordinates the pick-up, recycling, and disposal of all material collected in these

efforts throughout the year.

Recycling:

• Saratoga County Recycling is now completing its 21st year of operation. To date, over 188,000 tons of material has been successfully recycled since the program inception in 1988. Thousands of County residents participate either curbside, or by visiting a center on a weekly basis. Through November, our county has received \$361,360 dollars compared to \$808,967 in 2008. This represents a 55% decrease year-to-date, with December's revenue still to be

received. The recycling markets have made a slow comeback since the crash of November 2008. The revenue picture could have been much worse. Tonnage through November is at 5178 which represents a 6% decline from 2008. With economic instability still prevalent, all indications point to a very challenging year in 2010.

• The rehabilitation of the Saratoga Springs Recycling Center was completed by county personnel.

NEWLY REHABILITATED SARATOGA SPRINGS RECYCLING CENTER

Landfill/Solid Waste Division:

- In compliance with our N.Y.S.D.E.C. permit and the landfill "Interim Operational Plan", all maintenance functions have been performed.
- The county filed all documentation necessary for a landfill permit renewal early in 2008 and is awaiting a decision from N.Y.S.D.E.C. Our permit remains valid until such decision is rendered.
- All required annual and quarterly reports regarding this facility have been submitted to N.Y.S.D.E.C. Machinery:
- Continual maintenance of 230+ vehicles for D.P.W., Sheriff, Sewer and ten (10) other county departments. Continual maintenance is also provided on 130+ pieces of large construction equipment for D.P.W. activities. Special thanks is offered to the Public Works Department staff for completing the many tasks and to the Committee members and board for providing direction, support and the financial resources necessary to ensure that our county highway infrastructure and operations meet the needs of Saratoga County residents for the future. We look forward to another successful year in 2010.

WHEREAS, Local Law No. 1 of 1991, in Section 3 paragraph (c) defined "service supplier" as "...a telephone corporation which provides local exchange access service within a 911 service area", in accordance with the definition of that term in County Law §301(7) as provided in 1991; and

WHEREAS, in 2009, the New York State Legislature expanded the definition of "service supplier" in County Law Section 301(7), by adding "...or (ii) a provider of "voice over internet protocol service" or "VOIP service" that provides such service within a 911 service area," and adding a new paragraph (13) to Section 301 which reads as follows:

13. "Voice over internet protocol service" or "VOIP service" shall mean any service that (i) enables real-time, two-way voice communications; (ii) requires a broadband connection from the user's location; (iii) requires internet protocol compatible customer premises equipment (CPE); and (iv) permits users generally to receive calls that originate on the public switched telephone network and to terminate calls to the public switched telephone network, and

WHEREAS, our Public Safety Committee recommends the amendment of Local Law 1 of 1991 to provide for the inclusion of voice over internet protocol service in the definition of service suppliers; and

WHEREAS, this provision can only be included by Local Law; now, therefore, be it

RESOLVED, that a proposed Local Law, Identified as Introductory No. 2, Print No. 1 of 2009, entitled "A LOCAL LAW AMENDING LOCAL LAW 1 OF 1991 TO INCLUDE VOICE OVER INTERNET PROTOCOL SERVICES AMONG SERVICE SUPPLIERS", is hereby introduced before this Board of Supervisors; and be it further

WHEREAS, pursuant to County Law §266, the Commissioners of Saratoga County Sewer District No. 1 adopted a scale of charges for its 2010 services; and

WHEREAS, this scale was duly published in the official newspapers of the County and on the County of Saratoga's official website and was duly filed with our Clerk of the Board; and

WHEREAS, after due consideration, and upon the District's recommendation, this Board finds that it is in the public interest to adopt that scale of charges for collection, conveyance, treatment and disposal of sewage; now, therefore, be it

RESOLVED, that the following 2010 scale of charges for the Sewer District, be, and the same hereby is, confirmed, namely:

PROPOSED 2010 SCALE OF CHARGES FOR SARATOGA COUNTY SEWER DISTRICT NO. 1

SECTION 1 - SEWER CHARGES IMPOSED

Pursuant to County Law §266(1)(a), Saratoga County Sewer District No. 1 hereby imposes sewer charges for 2010 upon all premises and real property, within or without District boundaries, connected to, the District's sewer system.

SECTION 2 - ESTABLISHMENT AND CONFIRMATION OF SEWER CHARGES

Subject to confirmation by the County Board of Supervisors, this scale of charges may, from time to time, be amended by the District's Commission.

SECTION 3 - CRITERIA FOR ESTABLISHING SEWER USER CHARGES

The scale of sewer user charges shall use the following criteria:

- (a) A user is defined as any piece of land upon which a building or buildings stand and is connected to an interceptor, trunk or collector sewer served by the District.
- (b) The annual cost of debt service, administration, operation and maintenance for the District's treatment facilities will be generally allocated to all users.
- (c) The annual cost of debt service and operation and maintenance associated with the interceptor sewer, will be generally allocated to all users connected to and/or discharging into the system.
- (d)The annual cost of debt service and operation and maintenance associated with each major trunk sewer system will be generally allocated to all users connected to and/or discharging into the system.
- (e) A connection unit is defined as a single-family dwelling unit. Units include, but are not limited to, a single family house, each apartment unit (e.g. an apartment building with six apartments is six units), each half of a duplex, a cottage, a camp, a mobile home, and each unit of a condominium or townhouse. A "unit" as used for billing purposes will be 200 gallons per day of sewer discharge, or any portion thereof. No user will be rated at less than one unit. Users will be rated in terms of whole connection units. Each tenant with sanitary facilities within a commercial complex will be defined as an individual user.
- (f) For all users, including single-family dwelling units, equivalent connection units (e.c.u.) will be determined, based on the following schedule which accommodates peak demand and potential flow needs:

USER & COLLECTOR CHARGES:

Single parcel:

- A. Vacant no charge unless a lateral was requested and installed; if lateral is installed a collector fee shall be charged for each lateral.
- B. Occupied Residential
 - (1) Single Family Residence
 - a. 1 user, 1 collector as applicable.
 - (2) Multiple Family Residence Each separate dwelling unit in a two family, three family or multiple dwelling, which is not an apartment
 - a. 1 user per dwelling unit
 - b. 1 collector per dwelling unit as applicable
 - (3) Apartments
 - a. Each dwelling unit is assigned 1 user and 1 collector as applicable
 - b. Subsidized senior housing For complexes receiving Federal, State or municipal rent subsidies for dedicated senior housing, each 2 dwelling units will be assigned 1 user and 1 collector as applicable
 - c. Proof of entitlement to the designation as senior subsidized housing will need to be provided by the user and will be subject to approval of the Sewer Commission; confirmation of continuance of the subsidy will need to be provided to the Sewer District by September 1st of each year.
 - (4) Trailer Parks
 - a. 1 user for each trailer
 - C. Occupied Commercial
 - (1) 1 Collector for each user

For all commercial users: where actual sewer flow is measured, that flow (one year's record data) shall be used for determining an e.c.u. count with adjustments for discharge strength and content. The data is to provide cumulative and daily peak flow volumes; the methodology is subject to approval of the Executive Director.

Users generating higher annual sewer flows than above schedule, the following rate table applies:

For each additional 75,000 gallons or any part thereof, the number of connection units shall be increased by one.

- (g) When there is a substantial increase in sewer flows during the current year, the District may adjust the number of connection units charged and bill the user directly for that additional sum pursuant to Section 8.
- (h) Saratoga Spa State Park and Mount McGregor will be charged based on their 2009 measured waste expressed in E.C.U.'s discharged to District facilities.
- (i) Wastewater from wet processing and other operations is subject to the restrictions, prohibitions and surcharges outlined in the District's rules and regulations covering the discharge of sewage, industrial waste and other waste into the Saratoga County sewer system and all sewers tributary thereto.
- (j) A user discharging B.O.D. or T.S.S. to the District facilities exceeding the amount allowed in the District's rules and regulations will be charged \$700 per dry ton for that excess per conditions of their discharge permit.
- (k) All costs of the District's pretreatment and spill response program including, but not limited to, laboratory testing, labor, equipment, materials, consultants and subconsultants, contractors and subcontractors, and fines, shall be reimbursed by the individual or user.
- (l) Outside non-residential users will be charged two and one-half times the rate established for the trunk system servicing that user, residential housing will be one and one-half times that rate.
- (m) Collector sewer rates are generally based on the overall construction costs of the collector system together with debt service and operation and maintenance costs of the collector system.
- (n) Users of collection sewers turned over to the District will be charged for that portion of the District facilities utilized and at the same rate as the other users of the particular system.

SECTION 4 - SCALE OF CHARGES

The following is the 2010 scale of charges for the trunking and treatment of sewage.

SECTION 6 - PAYMENT OF SEWER USER CHARGES

All sewer charges, excepting those for Saratoga Springs, Saratoga Spa State Park and Mount McGregor shall be collected pursuant to Real Property Tax Law Article 11. The assessor of each municipality utilizing the town and county tax bills for the collection of taxes shall properly code the assessment roll as to the number of connection units for each particular property and for those properties utilizing the collector system. The assessor shall use the District's formula to determine the units for multiple dwellings and commercial users of the trunk and collector systems.

The City of Saratoga Springs, which includes the Geyser Crest, Geyser Road and a portion of the Saratoga Lake trunk sewer systems; as well as the Kirby Road, Loughberry Lake, Crescent Avenue and a portion of the Saratoga Lake collector systems shall each be considered as a single-bulk user and shall be so billed by the District. The city's collecting officer shall determine the appropriate method of assessing and collecting its sewer user charge. This single-bulk user charge may be passed on to city residents as a city sewer rent and enforced pursuant to General Municipal Law §452.

City payments shall be due quarterly by March 31, June 30, September 30 and December 31, 2010. A late payment charge of one percent (1%) per month shall be added for each month or portion thereof until paid.

The District shall bill Saratoga Spa State Park their 2010 user charges payable no later than May 1, 2010.

Mount McGregor shall be billed directly by the District and payment shall be on a quarterly basis.

Payments by single-bulk users shall be made to the County Treasurer who shall reject any untimely or insufficient payment. The postmark date of a payment shall be evidence of payment.

SECTION 7 - PENALTIES FOR LATE PAYMENTS

Sewer charges shall be subject to the same penalties and interest applicable to County taxes generally.

SECTION 8 - PAYMENT OF SEWER CHARGES NOT ON TOWN/COUNTY TAX ROLLS

The District shall bill directly those users of the collector sewer system and the trunk sewer system not appearing on the town and county tax rolls. Payments shall be made to the District and forwarded to the County Treasurer. Partial payments will not be accepted and will be returned.

The District shall also bill directly those users that have had an increase in connection units during the year.

The County Treasurer shall prepare and transmit to the Board of Supervisors, on or before December 1, a list of District residents or property owners within the District who are in arrears in the payment of such trunk or collector charges for a period of 30 days or more. The list shall contain a brief description of the properties for which the services were provided, the names of the persons or corporations liable to pay for same and the amount chargeable to each including penalties and interest computed to December 31.

The Board of Supervisors shall levy such sums against the properties liable and shall state the amount thereof in a separate column in the annual tax rolls of the various municipalities under the name of "county sewer charges". Such amounts, when collected by the several municipal collectors or receivers of taxes, shall be paid over to the County Treasurer. All of the provisions of the tax laws of the State of New York covering the enforcement and collection of unpaid taxes or assessments for special improvements not inconsistent herewith shall apply to the collection of such unpaid charges. Such amounts, when received by the County Treasurer, shall be credited to the County Sewer District fund for the District's exclusive use.

SECTION 9 - PROCEDURES

Resolution 174-77 shall govern the Commissioners' consideration, adoption and publication of this proposed scale of charges. After the Commissioners' actions, the Board of Supervisors shall act upon the published scale and any appeals there from as follows:

- (a) Confirmation thereof by a general resolution;
- (b) Amendment and confirmation by a general resolution; or
- (c) Recommitment to the District Commissioners for further study and consideration.
