Mr. Wickerham stated the auction is next Tuesday, and we may have several more tender offers before then.

Authorizing a \$4,250 correction to a tax bill in the Town of Halfmoon. (Carol Holley, Real Property Tax Director)

Mr. Wickerham said sewer units were added to the property in error.

ECONOMIC DEVELOPMENT

Amending the Zim Smith Trail Capital Fund to appropriate an additional \$1,686,589 in expenses and revenues. (Jason Kemper, Planning Director)

Mr. Wickerham said we accepted this money last year, and we are transferring it from the Operational account to the Capital account.

Authorizing the Chairman to enter into an amended agreement with Greenman Pederson, Inc. to authorize an additional \$150,000 in expenses for inspection services on the Zim Smith Trail. (Jason Kemper, Planning Director)

Mr. Wickerham said under the Stimulus rules, we are required to have a full-time engineer.
