## PUBLIC INPUT

Joel Reed, Executive Director for Saratoga Arts, said it has been a couple of years since they have spoken to the Board. He said among their many programs, they grant out funding they get from New York State and re-grant it to local artists, non profit groups, and art organizations across the County.

Adrianna Flax, Administrator for Saratoga Arts, stated they administer two grant programs. One is SPAF – Saratoga Program for Arts Funding that goes to non-profits, individual artists and municipalities sponsoring public arts programming. We also fund and re-grant arts and education grants for bringing teaching artists into the schools to work with the teachers, she said. She stated in 2010, they granted 16 project grants throughout Saratoga County communities, and that totaled over \$34,000. Also, nine arts and education grants in Saratoga County schools that totaled \$13,650. Since 1993, Saratoga Arts has re-granted \$500,000 in the arts, she said. Mr. Reed said they are a private, non-governmental non-profit organization. We raise money from the State, our mentors, and local businesses so we can present these programs to support the arts Countywide. We are a magnet for State funding, he said. We have 1,000 members and 100 volunteers and an active Board of Directors, and that is how we serve the entire County. He stated they have a new program beginning this year, Saratoga Arts will be the presenter/producer of First Night Saratoga that the YMCA ran for 14 years. That program attracts 8,000 to 10,000 visitors in Saratoga Springs for an evening of family-friendly alcohol free New Year's entertainment. We think that perfectly fits our mission, he added.

Molly Gagne, 22 Vichy Drive, Saratoga Springs, thanked the Board for the County project of rehabilitating the Geyser Road Bridge. What I have seen on this bridge and in the past few years is enough to give you chills down your spine, she said. She said she has seen an employee, probably of QuadGraphics or Ball, riding his bike at night on the bridge trying to get to work in the industrial park, and it's just not safe. She said she also has seen a mother trying to push a stroller down Geyser Road over the bridge to get to the park, and that is not safe. The first step in rehabbing the bridge, including pedestrian access to that bridge will make a world of difference for our neighborhood of about 5,000 people and to the whole community of Milton past us. She said they have a vision, and Matt Veitch and Joanne Yepsen have been helping them work on a trail for Geyser Road that will be a pedestrian/bicycle trail. This bridge rehab will be the first part of that trail, she said. The trail will eventually link folks to the park and to the Zim Smith Trail as the Green Infrastructure Plan calls for, she said. She said that Plan is so important to them, and she liked that the prayer today mentioned "thinking in a can do sort of way."

2009 Annual Report received from the Saratoga County Public Health Nursing Service.

## Received and filed.

Ms. Daly said the Economic Development Committee has finished the Message Map that it started in November of last year. We worked on it extensively with a draft proposed in February. We received comments on it, and we made some additions and deletions to it, and now it is ready to go. This is a tool for all Supervisors to use if you are looking for talking points about the County in a particular area, she said. This is all about our message and everything we do here, she stated. It is all about our quality of life and preserving that quality of life, she added. She requested everyone to take a copy of it with them before they leave.

Ms. Daly said the last Economic Development Committee meeting was held at TEC-SMART, and we enjoyed a tour of the building. The grand opening will be tomorrow that everyone is invited to. It was a pleasure to see that building before the grand opening, and she thanked Dr. Drew for everything he did over at Hudson Valley to arrange that tour for us. In light of everything we are doing regarding economic development, and in light of

the growth that is occurring in Saratoga County and the enjoyment we are experiencing as opposed to other places in this country and region, people support this County because of the people that are here, she said. The Economic Development Committee recognizes that in order to have quality of life, you have quality people, she said. We have come up with an idea and have entitled it Saratoga County Shares A Partnership With To Love A Child Delivering Educational Materials To Haiti. We have reached out with an organization called To Love A Child and have initiated an endeavor to which we would like to reach out to all school districts in Saratoga County to ask them that at the end of the school year when they have decided which curriculum materials they will not need for next year, to please hang on to those materials and package them in a box, label them with a grade and whether they are curriculum materials or classroom supplies, and we will partner with To Love A Child and transport these materials to the orphanage schools in Haiti which have been grossly devastated from the earthquake that has occurred there, she said. She mentioned 50% of the primary school-aged children are actually enrolled in school in Haiti, and right now, that number is much lower. She said they are working very hard to restore their schools. We can be the facilitator to collect these materials, and we will organize them to be shipped to Haiti. This is a perfect opportunity for us to be a facilitator for the taxpayers of Saratoga County to take some of the items they have already paid for and let them donate these materials as opposed to them being discarded, she stated. She said she has a flier on this project. Our County Attorney has drafted a template of a resolution that can be passed by each school's Board of Education supporting this initiative, she said. She stated she has a list of the school districts of the County. On behalf of the Economic Development Committee, we are reaching out to all of our colleagues asking them if they have the opportunity, to please call their school districts on this.

Ms. Daly said due to the increase in activity that we are experiencing in Saratoga County, she has been working with SEDC and we are partnering with the Center for Economic Growth on an initiative called Our Expanding Regional Semiconductor Cluster; Experiences from Dresden, Germany and Hillsboro, Oregon. We will participate with CEG in a program whereby they are bringing over Dr. Martin Gillo, who is a member of Parliament and a former Minister of Economic Affairs in Saxony, Germany as well as Mr. David Lawrence, principal of Lawrence Resources and former Deputy City Manager in Hillsboro. Both of these places underwent transformations from not having a Chip fab to having a Chip fab in their area. They will be spending four days in our region. Saratoga County is going to participate on Wednesday, May 12<sup>th</sup> with these individuals in roundtable discussions in the afternoon, tentatively scheduled from 1:00 to 3:30 p.m., to cover government, businesses and not-for-profits. There will be some sort of a reception we hope that evening at Saratoga National with these individuals, and on Thursday, May 13<sup>th</sup>, from 8:30 to 11:00 a.m., they will be available at the TEC-SMART auditorium at LFTC to give a presentation on everything we should know based on the listening they have done throughout the various counties. We welcome each and every Supervisor who is available, she said.

Ms. Daly stated the Economic Development Committee meeting for May has been changed from its usual time on the first Wednesday to Tuesday, May 4<sup>th</sup> at 3:30 p.m. at which time our meeting will be focused on tourism. We will have a presentation from Marcia White, of SPAC, Greg Dixon, of the Chamber, and our County Planner.

Mr. Sausville said he received a call yesterday morning from the Genesee County Economic Development Center. They are interested in coming to our County this Thursday and Friday to find out what our experiences have been in attracting GlobalFoundries to the Town of Malta. They are planning a panel discussion on Thursday evening with key leaders, and they asked me to bring together the Malta team of planners, assessors, comptroller, firemen, etc., on Friday to sit in a panel format to exchange ideas with them on some of the issues we have been facing. There will be a busload of about 40 people, he said. We will try to arrange a tour of GlobalFoundries on Friday morning, he stated.

Mr. Lawler thanked Mr. Sausville for his economic development effort in bringing these 40 visitors to our area. He announced the Water Authority meeting to be held on April 29<sup>th</sup> at 3:30 p.m. will be meeting here rather than at the Water Plant.

WHEREAS, the Governor and State Legislature must take steps this year to protect New York's valuable farmland and strengthen the future for farms across New York; now, therefore, be it

WHEREAS, the continued fiscal troubles of New York City Off-Track Betting (OTB) has caused it to default on \$15 million in fees owed to NYRA; and

WHEREAS, since VLTs are not operational, NYRA runs the risk of running out of operating revenue by the end of 2010, therefore putting the State's Horse Racing industry at risk; and

WHEREAS, Saratoga County recognizes the importance of Thoroughbred Racing to our economy, and commissioned a study in 2006 that found that the overall impact of racing in the immediate nine-county area is over \$200 million, and responsible for over 3,000 jobs, the loss of which would have a devastating effect on our regional economy; and

WHEREAS, locally the loss of Racing will mean the loss of millions of dollars in admissions taxes, OTB Surcharge fees, and sales tax receipts to Saratoga County; now, therefore, be it
