David Wickerham, County Administrator, reviewed the following Agenda items:

PUBLIC HEALTH

Authorizing the Chairman to enter into agreements with NYS Department of Health to accept \$34,890 in ARRA funding for the immunization program and amending the 2010 budget in relation thereto. (Janet Glenn, Public Health Nursing Director)

Amending the 2010 budget to increase appropriations and revenues by \$81,791 in Federal Aid for various activities related to emergency planning and public health preparedness. (Janet Glenn, Public Health Nursing Director)

Mr. Wickerham stated we accepted \$694,000, and this is the first appropriation.

BUILDINGS AND GROUNDS

Authorizing an easement on the Zim Smith Trail in the Town of Malta to NYSEG for the installation of an electric transformer to power a water connection for the Clifton Park Water Authority. (Jason Kemper, Planning Director)

Mr. Wickerham stated we need to grant an easement to NYSEG in order for them to put their pump down there.

ECONOMIC DEVELOPMENT

Amending Resolution 199 of 2009 to state that the landowner contribution, towards the purchase of development rights to the Purintondale Farm in Northumberland, be no less than \$33,504. (Jason Kemper, Planning Director)

Mr. Wickerham said after all of the new appraisals came in, this is the more appropriate number. We will still spend \$300,000 for the purchase of those rights, he said.

PUBLIC WORKS

Granting an easement to Luther Forest Technology Corporation across County Route 75 in the Town of Stillwater for electric company connections. (Joe Ritchey, Public Works Commissioner)

PUBLIC SAFETY

Authorizing the Chairman to accept a Crime Victims Board Grant in the District Attorney's Office in the amount of \$68,352. (Jim Murphy, District Attorney)

Mr. Wickerham stated this is slightly less than last year.

Authorizing the Chairman to accept a \$5,000 legislative grant from Senator McDonald for the District Attorney's Office and amending the 2010 budget. (Jim Murphy, District Attorney)

Mr. Wickerham said this will be used for various equipment for the automation of that department.

LAW AND FINANCE

Establishing standard workdays for Elected and Appointed County Officials. (Mark Rider, County Attorney) (Previously Tabled)

Mr. Wickerham stated this was tabled in January, but will be brought back on Tuesday and amended.

Appointing Andrew Davis as the Veterans Service Director for Saratoga County.

Mr. Wickerham stated Mr. Davis is from Saratoga Springs, and his appointment will be effective June 15th.

Vice-Chairman Wood introduced Andrew Davis to the Board. He comes to us with a great number of experiences and brings a lot of enthusiasm and energy, and we look forward to having him serve Saratoga County and all of our veterans, he said. Mr. Davis thanked the Board, and he said he looks forward to serving the County's veterans.

Chairman Peck said June in dairy month. Continue to buy ice cream and drink milk, he said.

Mr. Richardson said a little over three years ago, the Supervisors granted the City of Mechanicville \$100,000, and Senator Bruno matched that with \$100,000. He said that \$200,000 has now climbed to \$11,500,000 in grants. He thanked the Board for what they have done. Vice-Chairman Wood said good work and congratulations to Mechanicville.

PUBLIC INPUT

David Lockhart, of Corinth, NY and past Post Commander of the Horace D. Washburn American Legion Post 533, said he has put a letter out to all Supervisors in reference to the Saratoga County Veterans' Service Officer Position, and he read the contents of this letter:

It has come to the attention of this organization that the position of the Veterans' Service Officer for the Saratoga County Veterans' Service Agency has been vacated. It has also come to the attention of this organization that the position of the Saratoga County Veterans' Service Officer will not be filled.

In today's environment within the veterans' community, it would seem that there would be an effort to establish new positions for veterans' counselors rather than abolishing already established positions. Our County has prided itself in the support to the veteran community. It has been heard that our County does all it can do assist the veteran in obtaining all of the earned benefits earned while that veteran served on active duty.

Today, veterans are returning home from a war that leaves not only physical evidence that they participated in a war but evidence of a psychological condition that leaves the veteran and his family at a loss. It is the assistance of the Veterans' Service Agency of our county that has aided so many in obtaining the medical, psychological and monetary compensation and pension benefits for our veterans. The monies provided to the veteran and their family is federal money that means millions of dollars coming into our communities from the Veterans Administration. Without the aid and assistance of the Veterans' Service Agency Director and the Veterans' Service Officer, those benefits might be seriously jeopardized.

This organization, which was developed to provide the veteran with rehabilitation, stands amazed that to consider not filling the position of the Veterans' Service Officer of Saratoga County during a time when more veterans will be returning from their service, would be a disservice to the veteran and our community. This organization respectfully requests that the position of Saratoga County Veterans' Service Agency Service Officer be maintained.

Mr. Lockhart said he has since spoken with Bill Peck who said this Service Officer position is going to be filled. I work with a municipality and understand the wheels of Civil Service grinds slow, but I would like to see this position filled as soon as possible, he said.

Chairman Peck said the vacancy came open for the Veterans' Director's job, and we thought it would only be right to hire the Veterans' Director first to let him get his feet wet and get a feel for the office and then be in on the hiring for the no. 2 position. After today's vote for the new Veterans' Director, then the process can move forward, he said.

Jim Coyne, of Saratoga Springs, said he enlisted in the military in 1966 and served until 2002. He said he is a veteran of the Cold War, Vietnam, and War on Terrorism. He said he is the current Commander of the Italian American War Veterans in Saratoga Springs. He thanked the Board and said this body is the beacon

of light in darkness. He stated our priorities in Washington are screwed up, and in Albany, our government is dysfunctional. He said we, as veterans and the veterans' organization need a Service Officer. We have been working very hard to have a homeless shelter for ladies here in Ballston Spa, and the reason why is because this agency is close and can help us all, he said.

Chairman Peck said is it important for anyone who would like to speak to the entire Board of Supervisors to contact our Board Clerk, Barbara Plummer, to get on the agenda.

Mr. Thompson asked who said we were not going to fill this position. Chairman Peck said he believes word got out that we were slow in filling the position when Bob Mitchell was the Director and the no. 2 position became open, and there was some fear that we wouldn't be filling it fast enough. I don't think it was ever said directly that we were not going to fill it, he stated. Mrs. Johnson stated she talked to Jim Coyne about a week ago, and he brought these rumors to her attention. She told him the rumors were not true, and that we interviewed for the Director's position who would be looking at the no. 2 position. Chairman Peck said it is important you hire the head coach before you hire the assistant.

BE SMART, DON'T START POSTER CONTEST

Dick Rowland, Chairman of the Public Health Committee, said this school year, the Board of Supervisors, along with the Saratoga County Public Health Nursing Service, sponsored the "Be Smart, Don't Start" poster contest for 4th graders in Saratoga County schools. This poster contest is administered by the Alcohol and Substance Abuse Prevention Council. The theme for the poster contest is "Growing Up Smoke Free." Each student who participated in the contest is receiving a certificate from the Board of Supervisors, a gift certificate for a free ice cream cone, courtesy of Stewart's, and a special gift. The poster contest is designed to provide students with the facts and skills necessary to make life/health-affirming choices.

Mr. Rowland said the top three posters from each school were chosen and sent to the Board of Supervisors.
