Mr. Wickerham stated errors kept the owner from making payments in a timely fashion.

Mr. Wickerham stated previously, the pump had been fueled by diesel fuel.

PUBLIC WORKS

Accepting an 800 foot extension on County Road 46 in the Saratoga Springs Industrial Park. (Joe Ritchey, Public Works Commissioner)

Mr. Wickerham said the work will be provided by the Industrial Park and made to the specifications to the County.

Authorizing the Chairman to enter into E-Z Pass On-The-Go retail sales agreement with the New York State Thruway Authority to allow the sale of these passes at the Saratoga County DMV Offices. (Kathy Marchione, County Clerk)

Appointing John Adams as Director of the Saratoga County Probation Services effective August 18, 2010. (Jack Kalinkewicz, Personnel Director)

Mr. Wood introduced John Adams, who will be the head of the County Probation Department. He said a committee composed of Chairman Peck, Mr. Johnson, Ms. Wormuth, Mr. Wickerham, Mr. Kalinkewicz, and himself met on several occasions for a series of interviews, and John was selected as the outstanding candidate for the position. He currently is coming to us from Hamilton County where he has served as Probation Director since 2009, he said. Prior to that, for 10 years, he was a Probation Supervisor in Warren County, and a Probation Officer in Warren, Cortland and Tompkins Counties. He has served on numerous committees involving probation at the State level, and is very computer literate and knowledgeable of the software that is used for tracking and doing required paperwork for individuals on probation. For over 10 years, he was a member of the U.S. Army Reserve attaining the rank of Captain. He has a Batchelor's degree in sociology and criminology from SUNY Cortland. He lives in Glens Falls, is married with two children and is looking for property perhaps in the Town of Northumberland.

Mr. Adams said he looks forward to serving the people of Saratoga County and moving to Saratoga County. I want to bring the department on board with automation and make Saratoga County Probation the tip of the spear in our efforts, he said. He stated he looks forward to working with everyone.

Ms. Daly stated as soon as the Zim Smith Trail is completed, we will be having a ribbon cutting ceremony which you will all be invited to. We may put that on the schedule for the end of July, she said. She stated we will have a special event for that day, and she hopes to see everyone there. Mr. Veitch mentioned the Edie Road/Bullard Road trail opening will be on July 29th at 4:00 p.m. at the trailhead.

Discussion on Res. 140:

Mr. Lawler moved to table Res. 140. He said he appreciates the need for a central storage facility; however, he has some concerns about the prospect of a growing lease agreement that starts off at \$63,000 per year and increases after the first year. He stated the County has a facility at the landfill of \$140,000 s.f. which is more than adequate for the storage of these machines. He said he realizes that facility would take some retrofitting in order to meet the specifics of the R.F.P. for climate control. I would like to get some sense of what it would cost to retrofit that building so we could at least consider the possibility of doing that so we don't have a facility that has a growing expense for the taxpayers, he said. He said the facility at the landfill is, for the most part, unused

at this time, and I think it would be worth taking a look at what it would cost for the climate control and a security system instead of a three-year lease term of \$180,000. Once we have the one-time expense, we have the facility there, and if we ever do decide to use that facility in some way, we would have to undertake those expenses at any event. Mr. Thompson seconded, and the motion to table Res. 140 was approved by a unanimous vote.

Chairman Peck said he will refer this issue to the Buildings & Grounds Committee for their review.
