On a motion by Ms. Wormuth, seconded by Mr. Lucia, the minutes of the meeting of November 10, 2010 were approved unanimously.

David Wickerham, County Administrator, reviewed the following Agenda items:

Mr. Wickerham mentioned there may be another meeting of the Personnel and Law & Finance Committees next week.

EQUALIZATION AND ASSESSMENT

Accepting a \$2,361.73 tender offer in the Town of Ballston. (Sam Pitcheralle, County Treasurer)

Mr. Wickerham said we may get more tender offers between now and Tuesday.

Authorizing a correction to the 2009 tax roll for a parcel in the Town of Malta. (Carol Holley, Real Property Tax Director)

Mr. Wickerham said this was over assessed due to an assessor error. The Town has agreed with the correction.

PUBLIC HEALTH

Authorizing the Chairman to enter into an agreement with Harmony Healthcare International, Inc. to conduct Medicare audits and revenue analysis at an annual cost of \$36,400 effective January 1, 2011. (Diane Brown, Maplewood Manor Administrator)

Mr. Wickerham said this will allow us to bill for some additional funding. We expect a minimum of \$130,000 in additional revenue.

Authorizing the Chairman to enter into renewal agreement with Thomas Nicolla Consulting Services, PLLC at an hourly rate of \$46.48 for physical therapy services. (Diane Brown, Maplewood Manor Administrator)

Mr. Wickerham stated this has been the same rate for the past several years.

Authorizing the Chairman to accept \$78,164 in ARRA funding and amending the budget for expenses related to upgrading Early Intervention Program's client database system and authorizing an agreement with CMA Consulting Services to conduct system training at a cost not to exceed \$15,195. (Janet Glenn, Public Health Nursing Director)

BUILDINGS AND GROUNDS

Authorizing the Chairman to enter into a 5 year lease agreement with Frederick J. McNeary for property located at 431-433 Geyser Road, Town of Milton at a cost of \$2,750 a month for the first three years and \$3,000 a month for the last 2 years effective January 1, 2011. (Dale Angstadt, Mental Health Director)

Mr. Wickerham said this will now house the Friendship House, and there will be an annual savings of \$38,000 with this lease.

SOCIAL PROGRAMS

Authorizing the Chairman to enter into agreements with the NYS Office of Children and Family Services to accept \$109,888 in a Prevention Detention Grant. All funds will be passed through to the Probation Department. (Bob Christopher, Social Services Commissioner)

PUBLIC SAFETY

Authorizing the Chairman to enter into an agreement with NMS Labs for postmortem toxicology services in an amount not to exceed \$15,000 in the Saratoga County Coroner's Office. (Tom Salvadore, Coroner)

Mr. Wickerham said we will use that lab in addition to the Albany lab.

Authorizing the Chairman to accept a \$32,200 US Homeland Security Grant for an Explosive Detection Canine and amending the budget in relation thereto. (Sheriff James Bowen)

Authorizing the Chairman to accept a \$132,293 State Law Enforcement Terrorism Prevention Program Grant (SLETPP) for the purchase of an IROBOT for anti-terrorism activities and amending the budget in relation thereto. (Sheriff James Bowen)

Mr. Wickerham said the funds are coming from the Federal government, and there is no County match.

Authorizing the Chairman to enter into a three (3) year lease agreement with Lyme Timber for a land lease at Spruce Mountain for radio shelter and right of way at an annual cost of \$675. (Paul Lent, Emergency Services Director)

Mr. Wickerham said that is where we store the Sno Cat and materials we need to get up the mountain in the wintertime.

Report No. 17

2010 Racing Committee Year-End Report

There were several racing related issues facing Saratoga County from the beginning to the end of 2010. Many of the issues were a continuation from 2009, with the fate of Racing in NY State hanging in the balance. This committee worked hard to take a stand on those issues, for the greater good of the County and for our residents. This report will summarize a few of the highlights from 2010, and to pass along to future committees a few recommendations.

The committee first dealt with the issue of naming a VLT operator for Aqueduct Racetrack. Early in 2010, the State leaders announced that Aqueduct Entertainment Group would be chosen as the VLT operator for the track. As part of the NYRA franchise agreement, the State was to build a gaming facility at Aqueduct, to provide a stream of revenue for the State, and for NYRA. Estimates put the value of revenue from a gaming facility at \$1 million per day, and this is important to the County because having a fiscally sound NYRA helps to keep racing viable at Saratoga, and the impact of racing operations for our region is estimated at approximately \$250 million per year. We put forth a resolution urging the state to construct the VLT facility at Aqueduct as soon as possible, in order to continue Thoroughbred Racing operations in NYS. We thank the Board of Supervisors for unanimously supporting the resolution.

As the year progressed, the committee learned that Aqueduct Entertainment Group was not to be chosen by the State as the operator of the VLT gaming facility at Aqueduct, and the deal with the state became mired in corruption and scandal. In addition, NYC OTB was bankrupt, and owed NYRA approximately \$20 million that had not been paid over two years. This was unacceptable to our committee, as well as our citizens, many of who rely on the racing industry for their livelihood. We had the Concerned Citizens for Saratoga Racing, a group of business, civic and community leaders in Saratoga Springs make the case to the committee that the State was not holding up their end of the racing Franchise agreement from 2008. The agreement stipulated that if VLT operations were not completed by 2009 at Aqueduct, the State should begin negotiations with NYRA to make statutory payments in lieu of VLT operating revenues. This committee again put forth another resolution urging the State to resolve the VLT issues without delay, and to make its statutory payments to NYRA, as well as to continue the viability of NYC OTB, so that statutory payments in arrears to NYRA could be made. Again, the Board of Supervisors unanimously supported our resolution.

As 2010 continued on, NYRA indicated that they might be bankrupt before the Saratoga meet in July. The indicators were that there was not enough operating revenue to continue operations. The State floated a loan to NYRA of \$25 million, and the committee had NYRA President Charles Hayward give a briefing on the impact of this loan.

By the end of 2010, the State had awarded the VLT contracts to Genting NY, LLC, to run Aqueduct. Many of the issues we were facing at the beginning of 2010 were resolved by the State at the conclusion of the year.

Unfortunately, in December the State Senate failed to pass a bill that would financially support New York City OTB, and the betting parlors in New York City closed on December 8th. The full impact of this was not known as of the submission of this report, but the County stands to lose revenues of to \$600,000 in OTB surcharges in fees, without the NYCOTB operating. The County's Legislative & Research committee has passed a resolution urging the State to come up with a viable solution to the Horse Racing issues, so that revenues can continue to flow to NYRA, Horsemen, Breeders, Harness Tracks, and municipalities.

The Committee had several guests at our meetings to talk about the various aspects of Racing in Saratoga County. The Committee heard from Concerned Citizens for Saratoga Racing, NYRA President Charles Hayward, Ed Lewi Associates, and The Backstretch Employee Services Team. All these guests emphasized the importance of Racing to our Community, and we thank them for taking time out of their busy schedules to meet

with the Committee. We also held the second annual Saratoga County Day at the Races, where County residents received free admission to the Racetrack for the day, and we had a race named for the County this year.

Looking forward to 2011, this Committee recommends that the issues of VLT operations at Aqueduct continue to be monitored until construction of the facility is completed. In addition, this committee should be mindful of which capital improvements are made to the Saratoga Race Course, and to make sure the County has a voice in what is done, so that any changes are not detrimental to the Racing industry in Saratoga County. The Saratoga Day at the Races should be continued and expanded in future years. As Thoroughbred Racing as a sport declines in popularity nationally, we must continue to make sure the Saratoga racing meet keeps its prestige as one of the top racing meets in the world, and to ensure that the popularity of Saratoga continues for the foreseeable future. The County's economy depends on it.

Report No. 18 2010 BUILDINGS AND GROUNDS COMMITTEE

This has been a very productive year for the committee. The most notable accomplishment was the completion of the Animal Shelter at approximately \$300,000 under budget. Most recently new offices for Mental Health's Friendship House have been located and a lease negotiated at a savings to the County. We are progressing to move into these offices by the first of the year. Other notable projects and issues worked on are:

Airpor

Eminent Domain proceedings pertaining to Navigation Easements on a property necessary for tree removal were finalized.

The off-site air obstruction removal project was completed.

A NYSDOT Grant was accepted to perform an Airport Business Plan Study.

Construction of the new hangar completed.

Water line Easements

The committee approved easements for the hook-up to the Saratoga County Water Authority System at two (2) locations:

Clifton Park Water Authority will be hooking to the water main along the Zim Smith Trail and Magnolia Way.

Town of Ballston pumping station located along the Zim Smith Trail at the intersection with County Road 82 (Eastline Road).

Courthouse

The conceptual design for Interior Renovations of the Courthouse was completed. This encompassed the enclosure of the second floor lobby opening and better utilization of the first floor entrance.

Board of Elections

Warehouse was obtained for the housing of voting machines.

Capital Projects Completed

Emergency Generators were installed for Building #2, Building #3 and #4.

Public Works Personnel

Re-constructed and paved the visitors parking area and access road along Ballston Avenue at Maplewood Manor

Replaced sidewalks at Courthouse and rehabbed sidewalks around the Supervisors parking lot.

Built new concrete stairs leading from the Judges parking lot to the back entrance to the Courthouse.

Built new sidewalk connecting the Department of Motor vehicle parking lot with West High Street (N.Y.S. Route 67).

Demolished the old Animal Shelter and performed some road work in the area.

In addition to maintaining 650,000square feet of buildings with cleaning and ensuring an operating heating, ventilating and air condition systems the staff supports the operations of its employees. This year 2700 work requests were responded to. All of these items are part of our mission to provide a reasonably safe, comfortable work place for our employees and public that utilizes services that the County provides.

Report No. 19

Public Works Committee - 2010 End-of-Year Report

This report offers an overview of the accomplishments of this Committee and the Public Works Department over the past 12 months. The Public Works Committee and Department takes pride in the following projects that have been completed this year:

Highway Projects:

Reconstructed 12.65 miles of county-owned highways. Reconstruction work includes but is not limited to such tasks as reconstructing the drainage system, roadside ditches, road-base, asphalt pavement and resurfacing. Supplementary tasks include upgrading traffic signage and guiderail, as well as installing new shoulder fill and new roadway striping.

Completed the yellow flag repair of structure, Coons Crossing Road over the Anthony Kill in The Town of Halfmoon, B.I.N. #2202750, L.I.N. # 10.00. The undermined abutments were repaired and additional scour counter measures were installed.

Completed the yellow flag repair of structure, Bath Street over the Gordon Creek in The Village of Ballston Spa, B.I.N. #3304340, L.I.N. #119.40. The existing frozen bearings were replaced with new elastomeric bearings.

Completed the yellow flag repair of structure, Fenwick Street over the Gordon Creek in The Village of Ballston Spa, B.I.N. #3304610, L.I.N. #119.50. The existing precast voided slabs units were replaced.

Rehabilitation of structure, CR 32 (Wilton-Gansevoort Road) over the Snook Kill in the Town of Northumberland, L.I.N. # 249.20. The structure was relined and the inlets and outlet ends were improved and armored with erosion and scour protection measures.

Completed the rehabilitation of structure, CR 4 (North Shore Road) over Glass House Creek in The Town of Day, L.I.N. # 390.00. The bridge deck was replaced and the concrete abutments and wing walls were repaired.

Repair of structure, CR 68 (Stafford Bridge Road) over Sucker Brook in The Town of Saratoga, L.I.N. # 230.00. County highway personnel repaired one knee wall and footing at the base of the arch.

Repair of structure, CR 70 (Deans Corners Road) over a Tributary to Saratoga Lake in the Town of Stillwater, L.I.N. # 229.17. County highway personnel repaired the scoured footings on both sides of this structure.

Repair of structure, CR 67 (Quaker Springs Road) over a Tributary to Sucker Brook, in The Town of Saratoga, L.I.N. # 239.00. County highway personnel repaired extensive scouring at the base of the northwest wing wall as well as at both headwalls. (see photo below)

Repair of structure, CR 7 (South Shore Road) over a Tributary to the Sacandaga Lake in the Town of Edinburg, L.I.N. # 389.70. County highway personnel repaired scour on both sides of structure, added a new concrete floor with an attached sluiceway and repaired all four wing walls.

Repair of structure on CR 4 (North Shore Road) over Mink Brook in the Town of Hadley, L.I.N. # 346.10. County highway personnel reconstructed the inlet and stabilized embankments on both the inlet and outlet of structure. Crews also installed concrete scour counter measures for the entire length of both sides of the culvert. We oversaw partial replacement and repair of bridge over D&H Railroad on CR 43 (Geyser Road) BIN #33640200. This was a federally and state funded project.

Engineering Projects:

Our engineering staff continues to examine and study traffic issues as requested by towns or county residents. These requests may be as simple as the request for the installation of a sign or be as complex as the request for a traffic signal, or round about. Studies completed this year were primarily along the following county roads; CR 10 (West Mountain Road), CR56 (Hop City Road), CR 34 (Northern Pines Road) and on CR 24 (Palmer Ave). Our engineering staff continues to draft and design construction plans for various D.P.W. projects. Plans completed in 2010 include; Culvert # 249.20 on County Road 32 (Wilton-Gansevoort Road) in the Town of Northumberland as well as the rehabilitation of the Saratoga County Complex sidewalks, stairwells, stand-by generator project located at Building #4 and the reconstruction plan for the public parking lot at Maplewood Manor.

Comprehensive inspections of over thirty (30) county owned culverts were completed by our engineering staff. Our engineering staff also plays a key role in providing guidance and assistance to the maintenance and construction crews.

Maintenance Projects:

Our department continues to complete various maintenance projects as required along our entire highway system. Maintenance projects are typically scheduled and completed based upon priority and need.

Some of the projects are as follows;

In 2010, the majority of our maintenance projects included areas along the highway system that were experiencing deterioration of the asphalt and shoulders. Drainage ditches were cleaned and graded, areas of deteriorated asphalt were removed and new asphalt material was installed. County roads that received a significant amount of maintenance included; part of CR 10 (Corinth West Mountain Road), part of CR 7 (South Shore Road), part of CR13 (Fayville Road), part of CR32 (Wilton Gansevoort Road), part of CR39 (King Road), part of CR 98 (Batchellerville Road), and a portion of CR 339 (Lake Hill Road).

The reconstruction and repaying of approximately 35,000 square feet of the Maplewood Manor parking lot.

Nine (9) drop inlets were repaired on CR 59.

Installed a handicap access ramp along the sidewalk located on the south side of Maplewood Manor.

Replaced several large culvert cross pipes located along CR 63 in the Town of Malta.

Prepared the site for the new animal shelter, by removing: old foundations, buildings, trees, and waterlines. Along with rerouting the access road for the Milton Recycling Center, the removal of the old storage barn, and completing a replacement storage facility for the D.P.W., demolishing the old animal shelter were required for the timely completion of the new animal shelter.

Repaired one drop inlet located within one of the outside courtyard floors at the Saratoga County Jail. Repairs to Fraker Mountain Radio Tower, which included a new generator exhaust and access road repair.

Rebuilt the generator exhaust pipe at the Hadley Tower.

The following county roads were crack sealed: portions of CR 4 (North Shore Road), CR12 from Young Road to Lake Desolation (Lake Desolation Road), the Northerly section of CR13 (Barkersville-Fayville Road), CR16 (Barkersville Road), CR 21 (Middle Grove Road), CR 22 (Crescent Ave.), the westerly half of CR 43 (Geyser Road), the westerly 2/3 of CR 45 (West Galway and Ballston Galway Road), CR 51 (Charlton Road), CR 55 (Sweetman Road), CR 56 (Hop City Road and Scotch Bush Road), the northerly half of CR 64 (Nelson Ave), CR 66 (Dyer Switch Road) the Southerly three-quarters of CR 67 (Quaker Springs Road), CR 69 (Coveville Road) the easterly half of CR 71 (Cedar Bluff) the easterly half of CR 109 (Farm to Market Road), CR 104 (Murray Road) and CR 1345 (Pruyn Hill Road) for a total of 92.02 miles.

The entire 360-mile county highway system was restriped. Town owned roads were also restriped "as-requested".

Guiderail was upgraded repaired and installed at several locations within the county highway system.

Repaired, repaved and ditched approximately 1,300 feet of the access road for The Saratoga County Sewer Department Transfer Station located off of CR 63 in the Town of Malta.

Fifteen (15) culverts at various locations have been cleared of overgrown vegetation in preparation for 2011 inspections.

Vegetation and trees were cleared along select areas within the county highway system.

During the 2010 season 2,800 bags of trash were collected along the 360 mile highway system.

December 21, 2010

The Saratoga County Highway department performed various tasks along the access road leading to Emergency Services Radio Tower located on Spruce Mountain in the Town of Corinth. The road was graded as well as replaced drainage pipes as needed. Photo below shows some of the drain pipes that were replaced

Adopt-A-Roadside:

The Saratoga County Adopt-A-Roadside Program continues to play an important role in keeping our roads clean. In 2010, fifty eight (58) community groups remain listed as active. Our inventory of adopted county highway is approximately eighty two (82) miles. Our county D.P.W. provides orange garbage bags and safety vests to all participants. In addition, the county D.P.W. coordinates the pick-up, recycling, and disposal of all material collected in these efforts throughout the year.

Recycling:

Saratoga County Recycling is now completing its 23rd year of operation. Through December 9th 2010, over 193,000 tons of material has been successfully recycled since the program inception in 1988. Thousands of county residents participate either curbside or by visiting a center on a weekly basis. In 2010, a major change took place for many curbside customers of County Waste with the introduction of "Single Stream Recycling". While this has represented a 24% increase in material collected by waste haulers, our recycling centers are 18% behind last year's tonnage. Through November is at 4,262 tons of material has been collected by Saratoga County compared to 5,178 last November. This is an 18% drop in tonnage.

Due to a positive market condition for the duration of 2010, revenues are up 37%. The county has anticipated \$514,417 through 12/9/10. Last year at this time only \$376,421 was realized. This year's revenue will reimburse over 50% of our entire recycling budget expenditures. Recycling continues to be an important part of our community and our Department of Public Works continues to provide a valuable service to our Saratoga County residents.

Landfill/Solid Waste Division:

In compliance with our N.Y.S.D.E.C. permit and the landfill "Interim Operational Plan", all maintenance functions have been performed.

The county filed all documentation necessary for a landfill permit renewal early in 2008 and is awaiting a decision from N.Y.S.D.E.C. Our permit remains valid until such decision is rendered.

All required annual and quarterly reports regarding this facility have been submitted to N.Y.S.D.E.C.

Machinery:

Continual maintenance of 240+/- vehicles for D.P.W., Sheriff, Sewer and ten (10) other county departments. Continual maintenance is also provided on 130+/- pieces of large construction equipment for D.P.W. activities.

Special thanks is offered to the Public Works Department Staff for completing the many tasks and to the Committee members and board for providing direction, support and the financial resources necessary to ensure that our county highway infrastructure and operations meet the needs of Saratoga County residents for the future. We look forward to another successful year in 2011.

Report No. 20 2010 Trails Committee Year-End Report

The Trails Committee has been hard at work over the last two years. We have constructed three trails on County-owned forestry parcels, and are looking to continue this work for the foreseeable future. This report will be an overview of the origins of the Committee and the work through 2010, as well as descriptions of each parcel that has been developed. This report will also give some information on what the goals of this committee are for the future.

The Trails Committee was formed in 2009, and the first appointments to the committee were made by then Chairman Arthur Johnson of Wilton. This was the first committee formed to deal with the development of trails within the County, and it was decided upon that the committee would first deal with potential trails that could be constructed on County-owned land. The County owns several Reforested parcels dating back to the 1930's, and not much other than logging has occurred on the parcels since they were acquired by the County. It was an opportunity to open these parcels to passive recreation for the public.

In April of 2009, the Trails Committee decided that the first parcel to be developed would be in the town of Wilton, adjacent to the Wilton Mall on Louden Road. The County Planning department, along with the County Environmental Services department, and the County Department of Public Works, developed this trail. Trail routing, signage, and refurbishing the parking areas were all undertaken to get this trail to a useable standard. The Louden Trail is a 1.13 mile long trail on an 86 acre parcel, and there have been over 100 members of the general public who have signed the trail register since it officially opened in August of 2009. With access both from the Wilton Mall parking lots as well as Louden Road, this trail will be well used. The terrain is fairly hilly, with a few steeper hills on this trail. The path is very wide, and easy to hike.

For the early portion of 2010, the committee looked into developing a parcel in the town of Wilton off Edie Road, adjacent to the Wilton Wildlife Preserve and Park Trail. In fact, this County trail will be a link to trails within the Town's trail system. This trail was completely planned and constructed by residents of the Town of Wilton, and the County Department of Public Works personnel, with guidance from the County Planning Department. 2.3 miles of trails were built on this 189½ acre parcel. The Edie-Bullard Trail is a very easy hike, with minimal hills. There is a section of reforested Red Pine within the parcel, as well as some grassland vistas

that can be accessed by the County trail. There are three trail loops that can be walked depending on the ability of the hikers using the trail. Opened in July 2010, this trail has been moderately used.

The third trail planned by the Trails Committee has been the trail in the towns of Northumberland and Wilton. The parcel covers area within both towns. This parcel has been used for many decades by the BOCES forestry program, as a parcel for the education of students entering the Environmental Studies field. The trail was planned by the County's Planning Department, and wholly constructed by the Forestry students. Officially opened in November 2010, the Kalabus-Perry Trail covers 3.52 miles of trail on a 235\\[34\] acre parcel. This trail features many areas that have been logged, reforestation areas planted by the students, and also some very old stands of Oak trees within this parcel, The parcel has streams, vernal pools, and several small hills and terrain to be hiked. It is a very nice parcel for any non-motorized recreational activity.

The end of 2010 saw the committee focusing on the task of determining how trails will be maintained going forward. The County Department of Public Works is looking into how much labor it will take to maintain the trails. In addition, The Committee has undertaken and Adopt-A-Trail program, seeking volunteers who may be willing to maintain the County trails through agreement. The BOCES students have volunteered to take on parts of the Edie-Bullard Trail, and the Wilton Wildlife Preserve and Park has also looked into maintaining Edie-Bullard. Trail maintenance will remain a challenge for Saratoga County to make sure we are running this program in a cost-effective manner.

These three trails are just the beginning. In 2010, the Committee requested an inventory of all the County-Owned forestry parcels, in order to determine where we can expand our trail system in Saratoga County. This program has been an unqualified success, with the trails being well-used by the general public.

Looking forward to 2011, this Committee is continuing to look at the various parcels that can be developed. We have begun a partnership with the Saratoga Mountain Bike Association to construct a trail geared to Mountain Biking, as well as all other non-motorized uses. We will continue to monitor the maintenance needs of our trails, making sure we continue to be conscious of the costs. We will continue to expand our Adopt-A-Trail program. This committee is also starting to develop a document outlining legally permitted uses on Countyowned lands. Lastly, this committee would like to thank the Board of Supervisors, the County Department of Public Works, the County Planning Department, The County Environmental Services department, the former Supervisor of the town of Stillwater, Shawn Connelly, our two citizen committee members, Devin Dal Pos and Larry Gordon, the BOCES forestry program, Wilton Wildlife Preserve and Park, Wilton Mall, and the general public for using the trails and making this program a success. Attached to this report are the maps of the completed trails to date.

WHEREAS, this scale was duly published in the official newspapers of the County and on the County of Saratoga's official website and was duly filed with our Clerk of the Board; and

WHEREAS, after due consideration, and upon the District's recommendation, this Board finds that it is in the public interest to adopt that scale of charges for collection, conveyance, treatment and disposal of sewage; now, therefore, be it

RESOLVED, that the following 2011 scale of charges for the Sewer District, be, and the same hereby is, confirmed, namely:

PROPOSED 2011 SCALE OF CHARGES FOR SARATOGA COUNTY SEWER DISTRICT NO. 1

<u>SECTION 1 - SEWER CHARGES</u> IMPOSED

Pursuant to County Law §266(1)(a), Saratoga County Sewer District No. 1 hereby imposes sewer charges for 2011 upon all premises and real property, within or without District boundaries, connected to, the District's sewer system.

SECTION 2 - ESTABLISHMENT AND CONFIRMATION OF SEWER CHARGES

Subject to confirmation by the County Board of Supervisors, this scale of charges may, from time to time, be amended by the District's Commission.

SECTION 3 - CRITERIA FOR ESTABLISHING SEWER USER CHARGES

The scale of sewer user charges shall use the following criteria:

- (a) A user is defined as any piece of land upon which a building or buildings stand and is connected to an interceptor, trunk or collector sewer served by the District.
- (b) The annual cost of debt service, administration, operation and maintenance for the District's treatment facilities will be generally allocated to all users.
- (c) The annual cost of debt service and operation and maintenance associated with the interceptor sewer, will be generally allocated to all users connected to and/or discharging into the system.
- (d) The annual cost of debt service and operation and maintenance associated with each major trunk sewer system will be generally allocated to all users connected to and/or discharging into the system.
- (e) A connection unit is defined as a single-family dwelling unit. Units include, but are not limited to, a single family house, each apartment unit (e.g. an apartment building with six apartments is six units), each half of a duplex, a cottage, a camp, a mobile home, and each unit of a condominium or townhouse. A "unit" as used for billing purposes will be 200 gallons per day of sewer discharge, or any portion thereof. No user will be rated at less than one unit. Users will be rated in terms of whole connection units. Each tenant with sanitary facilities within a commercial complex will be defined as an individual user.
- (f) For all users, including single-family dwelling units, equivalent connection units (E.C.U.) will be determined based on the following schedule which accommodates peak demand and potential flow needs:

USER & COLLECTOR CHARGES:

Single parcel:

- A. Vacant no charge unless a lateral was requested and installed; if lateral is installed a collector fee shall be charged for each lateral.
- B. Occupied Residential
 - (1) Single Family Residence
 - a. 1 user, 1 collector as applicable.
- (2) Multiple Family Residence Each separate dwelling unit in a two family, three family or multiple dwelling, which is not an apartment
 - a. 1 user per dwelling unit
 - b. 1 collector per dwelling unit as applicable
 - (3) Apartments
 - a. Each dwelling unit is assigned 1 user and 1 collector as applicable
 - b. Subsidized senior housing For complexes receiving Federal, State or municipal rent subsidies for dedicated senior housing, each 2 dwelling units will be assigned 1 user and 1 collector as applicable
 - c. Proof of entitlement to the designation as senior subsidized housing will need to be provided by the user and will be subject to approval of the Sewer Commission; confirmation of continuance of the subsidy will need to be provided to the Sewer District by September 1st of each year.
 - (4) Trailer Parks
 - a. 1 user for each trailer
 - (5) Condominiums
 - a. Each unit is assigned 1 user and 1 collector as applicable
 - b. Charges will commence upon issuance of a Certificate of Occupancy by the local municipality for those units that the New York State Department of Law has authorized to be offered for sale. Common area facilities will be assessed to the owner of record as determined under provisions of Commercial Users.
- C. Occupied Commercial
 - (1) 1 Collector for each user

- A. Restroom is defined as 1 toilet, sink and/or urinal to be adjusted proportionately for additional facilities
- B. Commercial, non-food

User - 400 GPD/restroom, or

.1 GPD/sq. ft., whichever is greater

The data is to provide cumulative and daily peak flow volumes; the methodology is subject to approval of the Executive Director.

For each additional 75,000 gallons or any part thereof, the number of connection units shall be increased by one.

- (g) When there is a substantial increase in sewer flows during the current year, the District may adjust the number of connection units charged and bill the user directly for that additional sum pursuant to Section 8.
- (h) Saratoga Spa State Park and Mount McGregor will be charged based on their 2010 measured waste expressed in E.C.U.'s discharged to District facilities.
- (i) Wastewater from wet processing and other operations is subject to the restrictions, prohibitions and surcharges outlined in the District's rules and regulations covering the discharge of sewage, industrial waste and other waste into the Saratoga County sewer system and all sewers tributary thereto.
- (j) A user discharging B.O.D. or T.S.S. to the District facilities exceeding the amount allowed in the District's rules and regulations will be charged \$700 per dry ton for that excess per conditions of their discharge permit.

- (k) All costs of the District's pretreatment and spill response program including, but not limited to, laboratory testing, labor, equipment, materials, consultants and sub-consultants, contractors and subcontractors, and fines, shall be reimbursed by the individual or user.
- (l) Outside non-residential users will be charged two and one-half times the rate established for the trunk system servicing that user, residential housing will be one and one-half times that rate.
- (m) Collector sewer rates are generally based on the overall construction costs of the collector system together with debt service and operation and maintenance costs of the collector system.
- (n) Users of collection sewers turned over to the District will be charged for that portion of the District facilities utilized and at the same rate as the other users of the particular system.

SECTION 4 - SCALE OF CHARGES

The following is the 2011 scale of charges for the trunking and treatment of sewage.

SECTION 6 - PAYMENT OF SEWER USER CHARGES

All sewer charges, excepting those for Saratoga Springs, Saratoga Spa State Park, Mount McGregor, Town of Schaghticoke, Saratoga County Water Authority and GLOBALFOUNDRIES shall be collected pursuant to Real Property Tax Law Article 11. The assessor of each municipality utilizing the town and county tax bills for the collection of taxes shall properly code the assessment roll as to the number of connection units for each particular property and for those properties utilizing the collector system. The assessor shall use the District's formula to determine the units for multiple dwellings and commercial users of the trunk and collector systems.

The City of Saratoga Springs, which includes the Geyser Crest, Geyser Road and a portion of the Saratoga Lake trunk sewer systems; as well as the Kirby Road, Loughberry Lake, Crescent Avenue and a portion of the Saratoga Lake collector systems shall each be considered as a single-bulk user and shall be so billed by the District. The city's collecting officer shall determine the appropriate method of assessing and collecting its sewer user charge. This single-bulk user charge may be passed on to city residents as a city sewer rent and enforced pursuant to General Municipal Law §452.

City payments shall be due quarterly by March 31, June 30, September 30 and December 31, 2011. A late payment charge of one percent (1%) per month shall be added for each month or portion thereof until paid.

The District shall bill Saratoga Spa State Park their 2011 user charges payable no later than May 1, 2011.

Mount McGregor shall be billed directly by the District and payment shall be on a quarterly basis.

The Town of Schaghticoke shall be billed by the District for service to the Hemstreet Park area of the Town on a semi-annual basis in accordance with the terms of the District's Inter-municipal Agreement with the Town.

GLOBALFOUNDRIES and Saratoga County Water Authority will be billed on a monthly basis based on flows discharged the preceding month per terms of their Industrial Discharge Permits.

Payments by single-bulk users shall be made to the County Treasurer who shall reject any untimely or insufficient payment. The postmark date of a payment shall be evidence of payment.

SECTION 7 - PENALTIES FOR LATE PAYMENTS

Sewer charges shall be subject to the same penalties and interest applicable to County taxes generally.

SECTION 8 - PAYMENT OF SEWER CHARGES NOT ON TOWN/COUNTY TAX ROLLS

The District shall bill directly those users of the collector sewer system and the trunk sewer system not appearing on the town and county tax rolls. Payments shall be made to the District and forwarded to the County Treasurer. Partial payments will not be accepted and will be returned.

The District shall also bill directly those users that have had an increase in connection units during the year.

The County Treasurer shall prepare and transmit to the Board of Supervisors, on or before December 1, a list of District residents or property owners within the District who are in arrears in the payment of such trunk or collector charges for a period of 30 days or more. The list shall contain a brief description of the properties for which the services were provided, the names of the persons or corporations liable to pay for same and the amount chargeable to each including penalties and interest computed to December 31.

The Board of Supervisors shall levy such sums against the properties liable and shall state the amount thereof in a separate column in the annual tax rolls of the various municipalities under the name of "county sewer charges". Such amounts, when collected by the several municipal collectors or receivers of taxes, shall be paid over to the County Treasurer. All of the provisions of the tax laws of the State of New York covering the enforcement and collection of unpaid taxes or assessments for special improvements not inconsistent herewith shall apply to the collection of such unpaid charges. Such amounts, when received by the County Treasurer, shall be credited to the County Sewer District fund for the District's exclusive use.

SECTION 9 - PROCEDURES

Resolution 174-77, as amended by Resolution 174-09, shall govern the Commissioners' consideration, adoption and publication of this proposed scale of charges. After the Commissioners' actions, the Board of Supervisors shall act upon the published scale and any appeals therefrom as follows:

- (a) Confirmation thereof by a general resolution;
- (b) Amendment and confirmation by a general resolution; or
- (c) Recommitment to the District Commissioners for further study and consideration.
