Vice Chairman Grattidge called the meeting to order.

On a motion by Matt Veitch, seconded by John Collyer, the minutes of the December 9, 2011 meeting were approved.

Vice Chairman Grattidge acknowledged Mrs. Daly. Mrs. Daly updated the Supervisors on the Job Fair. She said there have been numerous calls and e-mails and thanked everyone for their help getting the word out and for help with the logistics. There was a sign up seat for Supervisors to see who would be available to be at the event.

Spencer Hellwig, County Administrator reviewed the following items:

"There will be one item under Economic Development to authorize the Chairman to enter into agreements with the State to accept a grant from the Office of Parks, Recreation and Historic Preservation.

Under Buildings, there will be four resolutions. The first item is a reappropriation of expenses and revenues related to various projects at the County Airport. The second item is authorization to enter into a lease agreement with Adirondack Soaring. The third item is authorization for the Chairman to enter into a five year lease with Roohan Realty for office space for Supreme Court Chambers and the final item under Buildings and Grounds will be authorization for the Chairman to enter into agreements necessary for the subdivision of a tax parcel in the Town of Corinth that currently houses the County's radio tower and the Spruce Mountain Fire Tower.

Under Public Health there will be two resolutions. One is going to be for a five year lease agreement with 6N Systems to provide clinical and financial software for Maplewood Manor. The second item is to accept an additional \$16,423 in State aid from the DOH.

Under Public Safety there are six items. The first item will be acceptance of a grant from the State to offset the cost of prosecuting Domestic Violence cases in the District Attorney's office. The next item is a reappropriation of expenses and revenues relative to the Supervision and Treatment Services for Juveniles Program. The third item is authorization to enter into an agreement with NYS Division of Criminal Justice Services to accept additional State aid for costs related to monitoring defendants with Ignition Interlock devices installed in their vehicles. The fourth item is a reappropriation of \$41,800 in expenses and revenues that was placed in last year's budget from the Animal Shelter Trust Fund. The fifth item is the reappropriation of a Companion Animal Grant balance that came under a Homeland Security Grant from the State. And the final item under Public Safety will be the reappropriation of Homeland Security money for the Emergency Services Department.

Under Public Works, there are three resolutions. The first one will be a reappropriation of \$3,317,280 in expenses and revenues for engineering and construction costs related to various road and bridge projects covered under the Capital Plan. The second item is authorization the Chairman to enter into a supplemental agreement to accept \$3,319,000 in funding for the construction and inspection services relative to the Stewarts Dam Bridge. And the final is for an authorization for a contract with Gerhardt, LLC to provide consulting services as well as to solicit proposals for public-private partnership for the Saratoga County Landfill.

Under E & A, we have three resolutions. The first one is three tender offers in the Towns of Clifton Park, Day and Edinburg. The second item is a housekeeping item to authorize the County Auditor to approve

tax corrections and refunds less than \$2,500. And the final item will be an authorization for a credit to a tax bill in the Town of Moreau.

Under Law & Finance, we have five resolutions. The first two are from the Sewer Commission. One is with Northern Engineering for a contract to conduct emissions monitoring from the incinerator stack at the main facility. The second one is an agreement with the Industrial Furnace Company of Rochester for the repair and improvements to the Sewer District's incinerator at a cost of \$3,077,200 which will also require a budget amendment. The third item will be to accept a Local Government Records Management Improvement Fund Grant in the County Clerk's office, authorize the part time positions to conduct that work and amend the budget in relation there to. The fourth item will be an authorization for the County Treasurer to make express payments to Blue Shield of Northeastern NY in advance of audit by the County Auditor and the Personnel Department contingent upon a pre-audit being done by Benetech, Inc. who is the County's benefit management consultant."

Vice Chairman Grattidge said there will be one more item for the Board Meeting and that will be to adopt Rule No. 15 as moved forward by Law and Finance.

Mr. Lawler asked about an escalation clause for the Glider Club Lease and said such clause should be included in the resolution. Mr. Hellwig said it would be included in the resolution. Mr. Rowland said an escalation clause based on the Consumer Index is included in the written lease agreement. Mr. Lawler asked about the area that is to be leased and if consideration was given to the length of the lease for this area and if there would be future use of it. Mr. Rowland said this is exactly same area and time span that the other glider club leases, FAA has been consulted and it has been determined that this is not land that would be developed.

On a motion by Mr. Lucia, seconded by Mr. Rowland the agenda was unanimously adopted as recited by the County Administrator.

On a motion by Mr. Jenkins, seconded by Ms. Raymond, the meeting adjourned.

Equalization and Assessment Committee 2011 Annual Report

The Equalization and Assessment Committee carried out its task of supervising assessment and tax collection policies with an objective of maintaining and promoting the equity of the tax collection and auction process for all county residents.

During this past year, the Committee oversaw the activities of two property auctions held on March 15th and September 20th. The auctions contained a total of 100 parcels, of which 20 were removed prior to the sale and 40 were removed by payment of taxes owed in the cumulative amount of \$298,069. A total of 40 parcels were presented for auction, with 25 of these actually being sold. According to the County Treasurer's Office, the sales resulted in a net profit of \$203,971. The County completed its foreclosure of 2009 delinquent taxes on December 2nd and took title to 91 parcels on December 5th. Those parcels not redeemed or pulled from the auction list will be offered for sale at auction in March 2012.

In the fall, the committee had a unique opportunity to work with the Planning Department and the Trails Committee to further develop the county trail system. Supervisor Art Johnson of Wilton requested that a parcel in his town be pulled from the September 20th auction due to the previous owner's willingness to pay delinquent taxes owed, plus penalties and interest, and grant the county a 15-foot wide trail easement along the northern and westerly boundaries of the parcel. The county owns a 190-acre parcel of reforested land adjacent to this property and maintains trails on that parcel that connect to a larger trail system maintained by the Town of Wilton and the Wilton Wildlife Preserve. The proposed trail easement would connect with these existing trails. Following review in September by the Trails Committee, this committee in November approved a resolution to accept a tender offer in the amount of \$14,937.24, subject to the reservation of the trail easement.

Saratoga County, together with Albany, Rensselaer, Warren and Washington Counties, continued legal action this year opposing the efforts of the Hudson River Black River Regulating District (HRBRRD) to bill the counties for its operating costs. The case is currently in appeal following an adverse ruling by the New York State Supreme Court on April 1st. If the counties lose this case, Saratoga County's share of the assessment would be approximately \$1.5 million per year, plus the unpaid assessments due since HRBRRD adopted its current apportionment methodology in 2010. In December, the Appellate Division denied a motion made by the NYS Attorney General to compel the counties to make a partial payment to HRBRRD in the amount of \$7,706,759 during the pendency of the appeal, given the District's dire financial circumstances. Saratoga County's share of that amount based on its 28.5% assessment would have been \$2,196,426. The Court also denied HRBRRD's motion to expedite the time for arguing and determining the appeal. In addition to this litigation, Saratoga County continues to work with our federal and state officials for a legislative solution.

In closing, I would like to thank my fellow supervisors on the Equalization and Assessment Committee for their support and insight over the past year. In addition, the committee would also like to recognize the contributions made by County Attorney Steve Dorsey, Real Property Director Joanne Bosley, County Treasurer Sam Pitcheralle, Deputy County Treasurer Cindy Baker and County Auditor Brian O'Conor.

REPORT NO. 2

Legislative and Research Committee 2011 Year-End Report

PROCEEDINGS OF THE BOARD OF SUPERVISORS - 5 - January 17, 2012

The 2011 Legislative and Research committee took on many tasks relating to New York State Legislative issues. As per our usual process, we developed a legislative agenda early in the year, and then met with our leaders in Albany to advocate for our County residents relating to those issues. As the year progressed, some larger issues emerged, which will have far-reaching effects on our County and its taxpayers, potentially for years to come. What follows is a summary of our activities by month:

February 2011

• The committee's first act of the year was outlining and discussing Saratoga County's 2011 Legislative Program, which consisted of the following ten items:

1. Urging Governor Cuomo and the NYS Legislature to authorize the reinstatement of VLT revenues for Saratoga Springs and Saratoga County.

2. Supporting the New York State Association of Counties "9 for 90" Anti-Mandate Campaign.

3. Supporting the New York State Association of Counties initiative to create a Sales Tax Joint Revenue Center.

4. Supporting an amendment to Civil Service Law 159-c to exclude employees who do not work year round or work seasonally, have the ability to take the time during the time in which they are not working during the rest of the year (shift workers) to take advantage of a paid leave of absence for up to 4 hours for breast or prostate cancer screening.

5. Supporting various health care reform initiatives including the permanent reinstatement of the Intergovernmental Transfer Program (IGT) and the restructuring of the funding mechanisms for mandated Medicaid services.

6. Urging Governor Cuomo and the members of the Medicaid Redesign Team (MRT) to consult with Counties regarding the State takeover of local Medicaid administrative responsibilities.

7. Opposing any effort by the Hudson River-Black River Regulating District (HRBRRD) to assess fees or charges against Saratoga County or other governments to cover the revenue shortfall in their operating budget caused by the federal court ruling.

8. Opposing any New York State imposed Property Tax Cap without providing an equal or greater amount of mandate relief to offset the lost revenues.

9. Opposing the creation of any new Indian Casino Gambling in New York State.

10. Requesting a more equitable share of the New York State Public Safety Surcharge to support statewide interoperable public safety communications.

• In light of past cuts in state funding for farmland protection – and in recognition of the importance of agriculture to Saratoga County's economy - the committee also approved a resolution urging the governor and state legislature to support New York State farmers, the state's agricultural economy and the protection of valuable farmland by supporting \$22 million in funding for the Farmland Protection Program and \$222 million for the Environmental Protection Fund for the purpose of conservation efforts.

March 2011

 John Penzer and Peter Whitten of Shelters of Saratoga visited the committee in March to discuss the organization's programs and provide an update on its ongoing efforts to obtain state and federal funding. In recognition of the organization's valuable and much needed services to individuals in Saratoga County who are homeless or at risk of becoming homeless, the committee approved a resolution expressing its strong support for Shelters of Saratoga's efforts to retain state and federal funding for its Rural Preservation Program and Homeless Prevention and Rapid Re-Housing Program.

• On March 25th a number of supervisors, joined by Chairman Wood and members of the county administration, traveled to the State Capitol to discuss our 2011 Legislative Program with Senators Hugh Farley and Roy McDonald and Assemblymen Jim Tedisco and Bob Reilly. Our state representatives discussed the partial restoration of VLT revenues, which they negotiated into the 2011-12 State Budget and said they hope to continue into next year.

<u>April 20</u>11

• At its April meeting, the committee considered an invitation to join the Adirondack Partnership, a coalition of local governments, non-profit organizations and other institutions that share a common goal of enhancing the communities, the economic development and the environment of the Adirondack Park. The impetus for the group grew out of an in-depth demographic report on the condition of the Adirondacks that spelled out the region's serious economic needs. The Towns of Day, Edinburg and Hadley had already joined and in recognition of Saratoga County's support of its goals, the committee approved a resolution to join the Adirondack Partnership. The committee further expressed its strong support for the Partnership's \$190,000 Smart Growth application for state grant assistance and authorized a letter of support to be sent to the Department of Environmental Conservation.

• The second issue addressed in April was the Mohawk Valley Heritage Corridor Commission (MVHCC), which was created in 1995 by the state legislature to promote historical tourism along the Mohawk River Valley but which had since suffered due to a lack of financial support from the state, incurring monetary liabilities without any ongoing revenue capabilities. Due to the perceived financial risk in remaining involved with the Commission, Fulton County had previously withdrawn its membership. The committee approved a resolution to withdraw Saratoga County's membership and urged the governor and state legislature to decommission the organization due to its inability to fulfill its mission.

October 2011

In October, the committee passed a resolution supporting important state legislation co-sponsored by Senator Roy McDonald designed to provide mandate relief for counties in the form of an eight-year state takeover of county Medicaid costs. The bill (S.5889-B/A.8644) would freeze at 2011 levels the counties' Medicaid contributions beginning January 1, 2012, and gradually decrease those contributions to zero over a period of eight years. The bill proposes to finance the state takeover through cost-saving reforms instituted by the Governor's Medicaid Redesign Team (MRT) and opportunities created by the federal Patient Protection and Affordable Care Act. Saratoga County's Medicaid costs typically exceed 47% of its property tax levy.

The committee's final official act of 2011 was the establishment of a subcommittee to study the possibility of introducing a local law to combat the introduction of aquatic invasive species into Saratoga County's waterways. Warren County passed a local law this year in the aftermath of an Asian clam infestation in Lake George, which damaged the lake's natural ecosystem. The subcommittee will continue its investigation moving forward into 2012.

In conclusion, the issues of lessening State funding, as well as continued unfunded mandates, should be a high priority for our County going forward. State Medicaid reform must be a major part of future legislative agendas. In addition, the Legislative & Research Committee, as described in our rules, has the duty to look at our own County operations and focus on how we can function more efficiently. Looking at our departments, and how departments relate to each other, is something that should have renewed focus. With our yearly budget issues, focusing on these tasks will be beneficial to the County government operations for the future.

REPORT NO. 3

Public Health Committee 2011 Annual Report

As in prior years, the greatest challenge this year for the Public Health Committee was the deteriorating financial position of Maplewood Manor. While we remain proud of the facility's workforce, its administration and its reputation for excellent care, inadequate Medicaid reimbursements from the state have driven the projected General Fund subsidy needed to balance Maplewood's operating budget to nearly \$10 million per year. In addition to corrective actions taken this year by this committee to improve the facility's financial position, including increasing the private pay rate in November from \$260 to \$307 (plus the 7.2% cash assessment), the Public Health Committee is committed in 2012 to examining all available alternative funding options that will both protect Maplewood's residents and provide financial relief to county taxpayers who have been underwriting the facility's recurring losses. Since 2004, the General Fund subsidy has ranged from \$3 million to \$6.5 million, excluding years in which the nursing home received an intergovernmental transfer (IGT) payment.

In March, this Committee approved a resolution to move \$5.2 million out of the County's fund balance to address an unanticipated shortfall at the nursing home during the 2010 budget year. This shortfall was the result of a number of factors including: a beginning fund balance that was \$1.3 million less than anticipated; lower than budgeted reimbursement from Medicare and Medicaid, partially due to the state's failure to implement rebasing as enacted in the 2009-10 State Budget; a \$577,000 recoupment of departmental income by the state Office of the Medicaid Inspector General due to a dispute with the state regarding reimbursement for Maplewood's co-gen plant; and higher than anticipated contractual expenses, salaries and fringe benefits, including more than \$583,000 in required payments to the state pension fund.

In April, Maplewood Administrator Diane Brown reported the impact of the adopted 2011-12 State Budget, which after years of false starts finally implemented rebasing at 2002 levels beginning July 1st. At the same time, however, the state increased the cash assessment on nursing homes by 1.1% beginning April 1st (bringing Maplewood's cash assessment to 7.2%) and announced that a new regional rebasing methodology would be implemented by 2012, the impact of which remains to be seen. The state also announced that it would eliminate hospital bed hold privileges effective January 1, 2012 unless nursing homes enroll 50% or more of their eligible residents in Medicaid managed care plans.

From May through September, the committee revamped Maplewood Manor's Collection Policies and Procedures in an effort to both limit the occurrence of and improve the county's ability to collect bad debts. The policy had last been revised in 2002. The committee approved a resolution in September implementing the following changes:

- Potential residents must have in place prior to admission a Power of Attorney who resides in New York State;
- The Maplewood Manor application was revised to require more detailed financial information;
- A Medicaid application with required financial documentation must be assembled and submitted to Medicaid prior to admission;
- Residents' income must be directed to Maplewood prior to admission, with the County Treasurer charged with making any refunds to which a spouse living outside Maplewood might be entitled;
- Maplewood will begin collecting late fees on delinquent payments owed by residents who are classified as private pay; and
- The procedures in place for beginning legal action to collect delinquent payments, in consultation with the County Attorney, County Administrator and Chair of the Public Health Committee, were expedited.

September also brought some good news for Maplewood Manor, with confirmation from the state that the facility would once again be eligible to receive additional funding under the Federal Medicaid Assistance Program (FMAP). The Board of Supervisors appropriated \$4.8 million from fund balance into the Department of Social Services budget. That sum was then paid out to the state, generating a \$9.6 million

IGT payment back to Maplewood Manor, thereby eliminating the need for any additional 2011 General Fund subsidy beyond the \$4.8 million incurred during this transaction.

Elsewhere, our Public Health Nursing Service (PHNS) continued to deliver a multitude of services to thousands of adults and children residing in Saratoga County. The department provided or contracted for clinical services, lead screening, treatment for rabies, immunizations for communicable diseases, tuberculosis treatment, nutrition training programs, occupational therapy, speech therapy and physical therapy while maintaining the medical portion of the county's Physically Handicapped Children's program and coordinating services under the Early Intervention Program, which treats eligible infants and toddlers who are developmentally delayed or disabled.

In May, the committee was pleased to welcome Karen Levison as the new Director of Public Health. Karen had previously served in a similar capacity with Essex and Hamilton Counties. In addition to managing the department's day-to-day operations, Karen is charged with guiding its transition to a full service health department that will handle restaurant inspections and environmental health. This transition is triggered by the county's population growth and mandated under state law.

As in other years, the committee approved resolutions accepting a number of grants that will be used to further the mission of PHNS, including an Early Intervention ARRA Grant (\$23,019), a Medical Reserve Corp. Capacity Building Award (\$5,000), Emergency Preparedness Grants (\$234,684 and \$191,010) and a NYSDOH Lead Grant (\$33,225). In August, Public Health updated its Policies and Procedures with respect to high risk medications policy, patient specific parameters, risk for developing pressure ulcers, depression screening, multi-factor fault risk assessment, standardized maternal health visit, human exposure to potentially rabid animals and Accutrend Plus testing. In December, the committee approved a resolution updating Public Health's agency fees for the first time since 2008. By adopting these increased rates, PHNS will be better able to meet the increased costs of providing its services and establish charges high enough to maximize federal and Medicaid funding.

In Mental Health, Director Hans Lehr presented the Mental Health Department's annual report in May, which reflected among other things the closure of the Clifton Park satellite office, relocation of Friendship House to Gevser Crest, clinic restructuring and a new five-year professional lease agreement with Saratoga Hospital, which has provided psychiatric coverage while allowing the department to eliminate costly full-time positions from its budget.

In June, following the recommendations of the Technology Committee, this committee approved a resolution to contract with Netsmart to provide a hosted platform for the department's billing, bringing that system into compliance with federal HIPAA standards. Maplewood Manor uses a similar hosted platform for its billing. In August, again in consultation with the Technology Committee, this committee approved a third such hosted platform for Public Health's billing system with Procura. These three hosted platforms will better allow our departments to keep up with federal and state regulatory changes without having to purchase, maintain and update costly in-house equipment. These arrangements will also save on staff time otherwise spent maintaining old servers and allow the county to house important medical data on safe, secure servers located off-site.

Additional items for the Mental Health Department included the acceptance in August of additional State Aid for programs administered on the County's behalf by Saratoga Bridges, Community Work and Independence Inc., the Franklin Community Center and Transitional Services Association Inc. In November, Director Hans Lehr announced that Saratoga County is one of thirteen counties chosen by the NYS Department of Health to participate in phase one of a pilot program to establish Health Homes, a network of organizations providing care to the Medicaid population. The program will begin in January 2012 and its goal is to increase the federal government's share of Medicaid costs in New York State.

In closing, I would like to thank my fellow supervisors on the Public Health Committee and the staff who maintained quality health care services over the past year. I especially thank Maplewood Manor Administrator Diane Brown and Accountant Sandy Fisher, Director of Mental Health Hans Lehr, Director of Public Health Karen Levison and Director of Patient Services Lori Stiles, who stepped up earlier this year by serving as Acting Director of Public Health/Patient Services through May. For their assistance

REPORT NO. 4

Veterans Committee 2011 Year Report

2011 WAS A VERY EXCITING AND PRODUCTIVE FOR THE VETERANS COMMITTEE. We had several "firsts" for Saratoga County, new programs and updated programs that provided our veterans with many new and updated benefits.

Our year started out with County Clerk Kathy Marchione presenting a new initiative called the "Return the Favor" program. The intent of the program is to offer discounts to veterans and their families from the many different businesses that signed up to participate in the program. The program has been, and continues to be, a great success with our veterans. Over 2,000 ID cards have been issued and more than 230 businesses have signed on to participate. Veterans Director Andy Davis has handled over 1873 veterans requests for obtaining a copy of their DD214 record which is required to obtain an ID card to participate in the program. Many compliments have been received from veterans on the benefit of this program to them.

One of the "firsts" for Saratoga County veterans and the County was the recognition and the honoring of our "first" living veteran, the "first" African-American veteran, Tuskagee Airman Clarence Dart at the Wesley Nursing home. Several of our political representatives presented special commendations to Mr. Dart while the standing-room only crowd applauded and praised him for his outstanding service to his country. WWII residents of Wesley were also there to show their support for him.

Our veterans' concert was held at SPAC on 9/7 with a good crowd in attendance to enjoy the presentation by the U.S. Coast Guard band. Due to budget cut-backs in 2012, the concert will not be held in 2012.

We spent several months involved in the discussion and development of a Local Law that would limit the times and distances that protestors would be allowed to congregate with the intent to disrupt military funerals. The passage of this Local Law is a big win for the families and friends of veterans whose loved ones lost their lives in the defense of their country. The dignity and the respect that they so deserve will now prevail.

Chairman Johnson served as the Master of Ceremonies at the annual Yellow Ribbon Day ceremony on 4/9 at the Wilton Elks Club.

Veterans Assistance Night was held in October at the City Center in Saratoga Springs. Director Andy Davis made changes to the event this year by having 2 events in one night. There was a 2-hour benefit and job fair with an on-site benefits briefing, health care enrollment and e-benefits and e-enrollment by the VA personnel. Classes were separated into age-groups – less than 55 years old and more than 55 years old so that they got the information most applicable to them. The 2^{nd} . Event was a recognition ceremony honoring the Korean War veterans. Approximately 45 veterans were scheduled to receive their commendations from state leaders and the Korean War Service medal from Chairman Wood. An unexpected presentation of the evening was the "first" key to Saratoga County presented by Chairman Wood to a most deserving Korean War veteran, Gene Corsale.

PROCEEDINGS OF THE BOARD OF SUPERVISORS - 10 - January 17, 2012

Throughout the year, Director Andy Davis made several presentations to the veterans committee for their awareness and/or approval on changes and additions to his office to improve benefits for veterans but at the same time decreasing costs to the County. Some of these were:

- 1. The Van Service that the County provides to ambulatory veterans to Albany Veterans Medical Center in Albany will no longer be making pick-ups at personal residences but they will be picked up at the established pick-up points throughout the County. This will save on fuel costs, time and allow him to expand on the benefits that can be made available.
- 2. Saratoga County piggy-backed with Schoharie County on the Honor Flight to Washington, D.C. this year. We were able to send 6 WWII veterans to Washington where they visited the WWII Memorial, the White House, the changing of the Guard at Arlington National Cemetery and the Iwo Jima memorial. Their responses to this visit were "over-whelming", "appreciative", "very emotional" and everyone was happy to have had the chance to go. Director Davis has made arrangements whereby Saratoga County will now start its own chapter to piggyback on the NYS Honor Flight organization and more Saratoga County veterans will have the opportunity to take part in this program including the Korean War and Viet Nam veterans.
- 3. Dir. Davis has started a group called the Saratoga Veterans Resource Initiative consisting of himself, NYS Division of Veterans Affairs, Office of the Aging, Probation Department and anyone who is interested in assisting in the welfare of our veterans.
- 4. Dir. Davis has already obtained a vendor to sponsor a 5K race in 2012 with all proceeds going to build up the established Saratoga County Veterans Trust & Agency Fund.

We closed out our year with the establishment of the Saratoga County Veterans Trust Fund. We feel this is one of the best things that could be done to assist our veterans especially at this time when so many are returning home from duty in Iraq and Afghanistan. Supervisor Daly of Clifton Park made a request to the committee that a fund be established whereby anyone could make a donation to be used in assisting veterans or their families. After much thought and working with Dir. Davis and Attorney Steve Dorsey, we finalized the document and its necessary attachments in time to have it presented to the full Board where it was passed in December 2011. A Saratoga veteran or a Saratoga Veterans organization requesting funds must first make out an application, submit it to the Director Of Veterans where it is then reviewed for completeness. Completed applications are then sent on to the Veterans committee for their action. To make this program successful, donations must be received so information about the fund has been distributed to funeral homes, legal firms, Veterans organizations and County and Town websites. We appreciate any help that our Board of Supervisors, our employees, the media and the public can give this program by spreading the word to the many people you come in contact with in your daily lives. We thank Supervisor Daly, Director Davis, Attorney Dorsey and all others that helped us make this a successful addition to the many benefit programs that we offer our veterans. Further information on the program can be obtained from Dir. Andy Davis' office,

In closing, we have many people to thank for assisting us in the completion of the many beneficial accomplishments we were able to complete this year. First I would like to thank the dedicated committee members that I had to work with, Vice-Chairman Mo Wright, Attorney Steve Dorsey, the Administrative staff of Ryan Moore and Spencer Hellwig, County Clerk Kathy Marchione and her FAVOR program staff, Board Clerk Pam Hargrave and Chris Sansom, the Board of Supervisors and most certainly Director Andy Davis and his staff. We thank our Veterans who have defended our country to protect us so that we do not have to do that ourselves.

2011 Personnel Committee Annual Report

The Personnel Committee had a successful year in 2011. All members of the committee worked diligently to adapt to changes to the County's Health Insurance plans and Self Insurance plans. The committee members are sincerely thanked for the service to the committee and to the County. Highlights of the monthly meetings included:

- Held Public Hearing on Reorganizations that will add to the county's successful operation and efficiency. Three Department Heads were appointed and saved the County funding due to retirements and changes to compensation.
 - --Katherine Shrome, Director of Purchasing (savings: \$47,000)
 - --Hans Lehr, Director of Community Mental Health Services (savings: \$30,000)
 - --Lisa Scaccia, Training and Employment Director (savings: \$26,000)
- Committee approved Compensation plan changes resulting in a total savings of \$8776. Departments that were effected: Purchasing, Treasurer's Office, Mental Health and the Sewer District.
- Approved contract with Sedgwick Claims Management Services, Inc. to act as the County's third party administrator for the Saratoga County Self Insurance program. The Personnel department eliminated a Specialist and an Account Clerk representing a savings of approximately \$172,000.
- Approved and supported the Saratoga County Wellness committee on the Step Up to the Challenge. There were 110 employees who participated, 55 groups. The winner took approximately 2 million steps.
- Renewed Cool Insurance contract although rise to premium. Rise to premium was based on two major claims, one at the sewer plant and another over a collapse of a storage facility. The County renewed Insurance Policy for the period of 5/08/2011 and 5/08/2012 at a cost of \$626,000 to approve a fourth part time van driver for the Veteran's Agency and to amend the compensation plan. Only three positions may be filled at any given time.
- Approved a resolution to hire consultants Marshall & Sterling at a cost not to exceed \$22,500. The consultant will be responsible for reviewing existing policies that the County currently has in place and conduct an evaluation of the agents and brokers to then make a determination of who to assign the insurance market to.
- Approval of the Employee Identification program and process to administrator identification badges to all County employees
- Created temporary positions for the Department of Social Services in the food stamp department due to volume increase. Positions were created temporarily through December 31, 2011.
- Discussions took place for renewing BlueShield contract but having an alternate funding arrangement. The committee discussed going to an Administrative Service Only model, where the County engages Benetech to handle the administrative tasks (e.g. billing, claims handling, claims payment, qualification, etc.) for the County. Discussions were held on the County's self-insured role which means that they are financially responsible for any claim payments to their employees.
- Discussions took place in regards to the current policy on evaluations for management staff. The discussion is ongoing.

RESOLUTION 38 - 12

URGING THE U.S. DEPARTMENT OF AGRICULTURE NOT TO CLOSE THE SARATOGA COUNTY OFFICE OF THE FARM SERVICE AGENCY

WHEREAS, the Farm Service Agency (FSA) is an agency of the United States Department of Agriculture (USDA) that administer direct payment, disaster payment, conservation payment, emergency program and farm loan programs directly to farmers at the county level throughout the United States; and

WHEREAS, the FSA maintains a local office in Saratoga County's Office Building #5 at 50 West High Street, Ballston Spa, New York; and

WHEREAS, in addition to administering various natural disaster, conservation, facility loan and core price support programs, the Saratoga County FSA serves as local coordinator for agricultural producers for natural disaster emergency reporting and assessment; and

WHEREAS, the Saratoga County office of the FSA has disbursed funds into the local agricultural community in the amounts of \$712,345 in 2011 and \$824,200 in 2010; and

WHEREAS, the Saratoga County FSA also oversees the making and repayment of annual commodity loans in the approximate sum of \$325,000 each year; and

WHEREAS, the Saratoga County FSA, the Cornell Cooperative Extension Service, the Saratoga County Soil and Water Conservation District, and Natural Resource Conservation Service Office are all located in Saratoga County's Office Building #5, thereby providing a convenient one-stop service location for 645 local farmers, producers and agricultural landowners; and

WHEREAS, the USDA has proposed closing and consolidating 131 county FSA offices in 32 states in the interests of streamlining operations, promoting efficiencies, and reducing expenses; and

WHEREAS, in New York State, the USDA has proposed closing county FSA offices in Saratoga, Albany, Sullivan and Yates counties; and

WHEREAS, in the case of Saratoga County's FSA office, the USDA has proposed closing the office and consolidating it with the Washington-Warren County FSA office in Greenwich, New York; and

WHEREAS, the USDA has scheduled a public meeting for Tuesday, February 7, 2012 at 1:30 pm. in the Auditorium Room of Building #5, 50 West High Street, Ballston Spa, to receive public comment on its proposed plan to close and consolidate the Saratoga County FSA Office; and

WHEREAS, this Board believes that the proposed closure and consolidation of the Saratoga County FSA office would result in both an inconvenience and a reduction in service to Saratoga County agricultural producers by requiring trips to two office locations to receive USDA services; and

WHEREAS, it is appropriate that this Board advise the USDA of its strong opposition to the USDA's proposed closure of the FSA's Saratoga County Office; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby strongly opposes the USDA's proposed closure and consolidation of the Saratoga County Office of the Farm Services Agency, and urges the USDA allow the Saratoga County FSA office to remain on-site with the Saratoga County Cornell Cooperative Extension, the Saratoga County Soil and Water Conservation District, the National Resource Conservation Service Office and the Saratoga County Planning Department as a convenient one stop location for agricultural producers seeking federal, state and county agricultural services; and be it further

RESOLVED, that the Clerk of the Saratoga County Board of Supervisors forward a copy of this Resolution to the United States Department of Agriculture, Senator Charles Schumer, Senator Kirsten Gillibrand, Congressman Chris Gibson and FSA Syracuse.

PROCEEDINGS OF THE BOARD OF SUPERVISORS - 27 - January 17, 2012

Ms. Yepsen said that the Governor had put out his proposed budget and pointed out that this included a three year phase out of Medicaid as well as pension reforms. She said there is no change in the VLT funding distribution which is a positive impact on Saratoga Springs as well as the County.

Mr. Lawler said he gives accolades to the Governor for the VLT funds but did not see any mention of a three year phase out of Medicaid. He said he is deeply disappointed by the budget as there is not the promised mandate relief so desperately needed in the County's in New York State. He said he does not see any improvement in the State's treatment of the County's over the next several years. He pointed out that there is nothing in the Governor's budget that doesn't change the fact that 120%, which is every tax dollar the County collects plus 20% will once again go the State for Unfunded Mandates. Mr. Lawler pointed out the County can't afford to keep paying the State's expenses. He said there was a cap put on the County as to how much revenue can be collected and he wishes the State would put a cap on how much the State could take away from the Counties. He said the people of the State of New York have been failed by their State Government.
