Vice Chairman Wright called the meeting to order and welcomed everyone to the meeting.

On a motion by Mr. Jenkins, seconded by Mr. Veitch the minutes of the March 11, 2015 meeting were unanimously approved.

Mr. Hellwig presented the following:

EQUALIZATION & ASSESSMENT

Accepting a tender offer on a parcel in the Town of Wilton which covers 2012, 2013 & 2014 delinquent taxes including all penalties and interest.

Acceptance of the successful bids from the March tax foreclosure auction. From the 41 parcels listed at the auction, 28 were sold. Total revenue was over \$400,000 which represents a profit of \$300,000 over the foreclosed delinquent taxes.

PERSONNEL & INSURANCE

Authorizing the County's insurance coverages through May 8, 2016 at a cost of \$828,495.68 with an allowance for additional premium expenses not to exceed \$5,000. The same coverage that is currently in place will be extended and are looking at a 1.9% premium increase from the expiring policies.

Authorizing the Chairman to enter into an agreement with Capital Indemnity Corporation for third party employer liability coverage for workers compensation under the Saratoga County Self-Insurance Plan at a cost not to exceed \$22,235. This coverage will protect the County from incurring any excessive expenses in defending of claims.

Authorizing the Chairman to enter into a renewal agreement with Girvin and Ferlazzo, P.C. for comprehensive labor relation services for a one year period through the end of this year. Costs are identical to last year's agreement.

SOCIAL PROGRAMS

Proclaiming May 2015 as "Older Americans Month" in the County of Saratoga.

Authorize the acceptance of a Balancing Incentive Program (BIP) Caregiver Support Program Grant which is a Federal initiative authorizing grant to increase non-institutional community based long term services by providing funding for senior caregivers.

PUBLIC HEALTH

Authorizing the execution of an intermunicipal agreement with Rensselaer, Warren, Washington and Schenectady Counties detailing the operation of a Mobile Mental Health Crisis Team for Adults.

Authorizing the execution of an intermunicipal agreement with Warren and Washington Counties detailing the operation of a Mobile Mental Health Crisis Team for children.

Mr. Hellwig said the above two agreements will allow the County to participate in regional mobile mental health crisis teams to assist individuals who are experiencing or may be at risk of experiencing psychological crisis.

PUBLIC SAFETY

Authorizing the Chairman to accept a \$35,600 Domestic Violence Prosecution Grant from the New York State Division of Criminal Justice Services. This is a slight decrease from last year.

Approving the County's Alternatives to Incarceration Performance Based Services Plan and authorizing acceptance of state grants in the amounts of \$10,128 for the Community Work Order Program and \$16,827 for the Pre-Trial Services Program for the period beginning July 1, 2015 and ending June 30, 2016.

PUBLIC WORKS

Rescinding Resolution 40 of 2015, authorizing the implementation and funding in the first instance of 100% of the federal aid and state "Marchiselli" program aid-eligible costs of a transportation federal aid project for the CR 45 (Northline Road) Bridge over the Kayaderosseras Creek in the Town of Malta, and amending the budget in relation thereto.

LAW & FINANCE

Authorizing an amendment in the amount of \$252,299.81 to the construction agreement with Insituform Technologies, Inc. for Phase V of the Saratoga County Sewer District's Interceptor Relining project to cover costs related to the relining of additional pipe sections.

Authorizing the Chairman to enter into an agreement with GHD Consulting Services, Inc. for engineering services related to the replacement of Bar Screens No. 1 and 2 at the sewage treatment plant in an amount not to exceed \$89,000.

Requesting the enactment of S.4547/A.6909 to amend Tax Law § 1202-g to revise the manner in which the Board of Supervisors allocates room occupancy tax revenues and to revise the membership composition of the committee appointed by the Board of Supervisors on room occupancy tax matters.

On a motion by Mr. Richardson, seconded by Mr. Peck the agenda was unanimously set for the April 21, 2015 Board Meeting.

Mr. Wright said the County Administrator has put together a quarterly report that everyone will be receiving a copy of. If you have any question, you can give Mr. Hellwig a call.

Mr. Lawler said earlier this year the Saratoga County Prosperity Partnership undertook what proved to be a difficult but very rewarding task in recruiting the first President/Executive Director of the Saratoga County Prosperity Partnership. He extended his sincere appreciation to all of his colleagues on the Board who have been so supportive of this effort as we moved to get it to this point. He truly appreciated your patience and support and continued expression of support in funding this program. After an exhaustive, nationwide search which included candidates from as far away as California and Texas truly every part of the Country responded to an opportunity to lead Saratoga County's economic opportunity efforts going forward. Top flight applicants applied for this position and were very impressed with the quality of applicants and the quality of the interviews. He said Saratoga County is well known and highly regarded as an economic engine in the Northeast United States. Saratoga County has made its mark. He is pleased to introduce to his colleagues on the Board and the residents of Saratoga County and beyond, Martin K. Vanags. Mr. Vanags joins us as the previous Vice President of Regional Economic Development and the Executive Director of the Indiana Chamber and the Indianapolis Partnership for Economic Development. He comes to us with a lifetime of experience. Previous to this he was the Economic Development Chief Executive Officer for Bloomington-Normal Economic Development Council in Bloomington, IL. Mr. Lawler welcomed Mr. Vanags who has spent the last couple of days here working toward hitting the ground running. Mr. Vanags thanked Mr. Lawler for the kind words. He is very excited for this opportunity here in Saratoga County. He has spent a long time in economic

development, private management, city development and public administration. He looks forward to moving here and is excited about it and looks forward to bringing prosperity to the County.

Mr. Richardson said the City of Mechanicville received a grant last month in the amount of \$1,877,000 to refurbish one more bridge in Mechanicville which brings the grant total received over the last 8 years to over \$15M. He thanked his colleagues past and present to get the revitalization efforts started in the City of Mechanicville.

WHEREAS, our Office for the Aging proposes to utilize said BIP grant funding to retain the services of HHDL, Inc. d/b/a Home Helpers & Direct Link to provide caregiver support services in the form of respite care/companionship services at a cost of \$18.00 per hour and personal care services at a cost of \$22.00 per hour; and

WHEREAS, the acceptance of this grant requires our approval and an amendment to the 2015 Saratoga County Budget; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute any and all applications, agreements and other documents necessary to accept a \$37,267 Balancing Incentive Program grant from the New York State Office for the Aging; and, be it further

WHEREAS, the Program seeks to provide appropriate community-based mental health intervention services thereby reducing avoidable emergency room and in-patient psychiatric hospitalizations; and

WHEREAS, the Rensselaer County Department of Mental Health has agreed to accept the OMH grant monies and oversee the administration of the Program on behalf of the five counties; and

WHEREAS, Rensselaer County will be retaining the services of the Parsons Child & Family Center to staff the Mobile Mental Health Crisis Team; and

WHEREAS, our Public Health Committee and the Director of the Saratoga County Mental Health Center have recommended that the County, acting on behalf of the Saratoga County Community Services Board, enter into an intermunicipal agreement with the Counties of Rensselaer, Schenectady, Warren and Washington for the development and operation of the Program, and its administration by Rensselaer County; now, therefore, be it

RESOLVED, that the Chair of the Board and the Saratoga County Community Services Board are hereby authorized to enter into an intermunicipal agreement with the Counties of Rensselaer, Schenectady, Warren and Washington for the development and operation of a Mobile Mental Health Crisis Team to provide community-based mental health intervention services for adults within the five counties, with the form and content of such agreement to be subject to the approval of the Saratoga County Attorney; and, be it further

RESOLVED, that the Rensselaer County Department of Health is hereby authorized to act on behalf of the County of Saratoga for the limited purpose of accepting and administering the OMH grant funds for this Program, and overseeing the administration of the Program.

BUDGET IMPACT STATEMENT: None. This agreement has no financial impact on the County.

WHEREAS, Warren County will be retaining the services of the Parsons Child & Family Center to staff the Mobile Mental Health Crisis Team; and

WHEREAS, our Public Health Committee and the Director of the Saratoga County Mental Health Center have recommended that the County, acting on behalf of the Saratoga County Community Services Board, enter into an intermunicipal agreement with the Counties of Warren and Washington for the development and operation of the Program, and its administration by Warren County; now, therefore, be it

RESOLVED, that the Chair of the Board and the Saratoga County Community Services Board are hereby authorized to enter into an intermunicipal agreement with the Counties of Warren and Washington for the development and operation of a Tri-County Mobile Mental Health Crisis Team to provide community-based mental health intervention services for children and youth within the three counties, with the form and content of such agreement to be subject to the approval of the Saratoga County Attorney; and, be it further

RESOLVED, that the Warren County Office of Community Services is hereby authorized to act on behalf of the County of Saratoga for the limited purpose of accepting and administering the OMH grant funds for this Program, and overseeing the administration of the Program.

BUDGET IMPACT STATEMENT: None. This agreement has no financial impact on the County.

RESOLUTION 77 - 2015

WHEREAS, the County of Saratoga desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of Design, ROW and Construction; and

WHEREAS, pursuant to Resolution 40-2015, this Board authorized the additional appropriation in the sum of \$1,034,269 from the County's Highway Fund to cover the cost of Design, ROW and construction work for the Project; and

RESOLVED, that in the event the full federal and non-federal share costs of the Project exceeds the amount appropriated above, the Saratoga County Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York state Department of Transportation thereof; and it is further

RESOLVED, that the Chairman of the Saratoga County Board of Supervisors be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the County of Saratoga with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding or project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project; and it is further

AUTHORIZING AN AMENDED AGREEMENT WITH INSITUFORM TECHNOLOGIES, INC. FOR AN EXTENSION OF PHASE V OF SARATOGA COUNTY SEWER DISTRICT NO. 1'S INTERCEPTOR RELINING CAPITAL PROJECT

WHEREAS, pursuant to Resolution 196-2014, this Board authorized an agreement with Insituform Technologies, Inc. for the relining of approximately 3,000 feet of interceptor sewer in the Town of Ballston at a cost not to exceed \$876,410.50; and

WHEREAS, in the course of completing Phase V of Saratoga County Sewer District No. 1's interceptor relining project, Insituform Technologies, Inc. conducted a televised inspection of the interceptor pipe adjoining the last relined section of pipe; and

WHEREAS, the televised inspection of the adjoining section of interceptor pipe revealed that sections of the pipe had dissolved due to hydrogen sulfide corrosion, thereby exposing a layer of reinforcing steel; and

WHEREAS, the Saratoga County Sewer District Commission and the Sewer District's Executive Director have recommended that the County's contract with Insituform Technologies, Inc. be amended to authorize the relining of an additional 1,000 ft. section of adjoining interceptor pipe at a cost not to exceed \$252,299.81; and

WHEREAS, the Sewer District has funds available in its 2015 Budget to cover the costs associated with the proposed 1,000 ft. extension of Phase V of the interceptor relining project; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an amendment to the agreement with Insituform Technologies, Inc. of Mount Vernon, New York, for the relining of an additional 1,000 ft. section of interceptor sewer line in the Town of Ballston, at an additional cost not to exceed \$252,299.81 bringing the total cost of the Phase V interceptor relining project to \$1,128,710.31; and, be it further

RESOLVED, that the form and content of such contract amendment shall be subject to the approval of the County Attorney.

BUDGET IMPACT STATEMENT: None. Funding is available in the Sewer District's budget.

WHEREAS, the Sewer District solicited and received proposals for engineering services for the replacement of Bar Screens No. 1 and No. 2; and

WHEREAS, the Saratoga County Sewer District Commission and the Executive Director of the Sewer District have recommended that a contract for engineering services for the replacement of Bar Screens No. 1 and No. 2 be awarded to GHD Consulting Services, Inc., the most compliant and cost-effective proposal received; now, therefore, be it

RESOLVED, that the Chair of the Board of Supervisors is authorized to execute an agreement with GHD Consulting Services, Inc. of Cazenovia, New York, for engineering services related to the replacement of Bar Screens No. 1 and No. 2 at the Saratoga County Sewer District No. 1 Wastewater Treatment Plant at a cost of \$89,000, with the form and content of such agreement being subject to the approval of the County Attorney.

BUDGET IMPACT STATEMENT: No budget impact.

REQUESTING HOME RULE LEGISLATION TO AMEND TAX LAW §1202-g TO REVISE THE MANNER IN WHICH THE BOARD OF SUPERVISORS ALLOCATES ROOM OCCUPANCY TAX REVENUES AND TO REVISE THE MEMBERSHIP COMPOSITION OF THE COMMITTEE APPOINTED BY THE BOARD OF SUPERVISORS ON ROOM OCCUPANCY TAX MATTERS

WHEREAS, pursuant to Resolution No. 55 of 1977 the Saratoga County Board of Supervisors requested that the New York State Legislature enact state legislation authorizing the Board to enact a Room Occupancy Tax for use in the advancement and promotion of tourism within Saratoga County; and

WHEREAS, pursuant to the Board's home rule request the State Legislature passed and the Governor signed into law Chapter 501 of the Laws of 1977 enacting Tax Law §1202-g authorizing the County of Saratoga to adopt and amend local laws imposing a Room Occupancy Tax on tourist home, hotel and motel rooms in the County; and

WHEREAS, pursuant to the authority granted it by Tax Law §1202-g, the Saratoga County Board of Supervisors enacted Local Law No. 7 of 1977 imposing a tax upon certain rentals of tourist home, hotel and motel rooms in Saratoga County; and

WHEREAS, subdivision nine of Tax Law §1202-g currently provides that revenues resulting from the imposition of the room occupancy tax shall be credited to and deposited to the general fund of the County, with the net collections therefrom to be allocated by the Saratoga County Board of Supervisors only for the promotion of tourism and conventions, with the exception of net collections designated by Tax Law §1202-g to be paid to the City of Saratoga Springs general fund, the City of Saratoga Springs convention and tourism bureau, and the Saratoga Springs City Center; and

WHEREAS, in accordance with subdivision nine of Tax Law §1202-g, Section 12 of Local Law No. 7 of 1977 provides that the net collections derived from the room occupancy tax, after payment to the County for administration and collection costs, shall be allocated by the Board of Supervisors only for the promotion of tourism and conventions, such as the Saratoga Convention and Tourism Bureau and the Saratoga County Chamber of Commerce; and

WHEREAS, subdivision nine of Tax Law §1202-g and Section 12 of Local Law No. 7 of 1977 further require that the Saratoga County Board of Supervisors appoint a committee of nine persons, four of whom shall be members of the Board of Supervisors and five of whom shall be owners, managers or, if such facility be owned by a corporation or partnership, partners or officers, of facilities paying such tax, to advise and recommend expenditures made by the County for the promotion of tourism and conventions in Saratoga County; and

WHEREAS, pursuant to Resolution 65-2014, this Board of Supervisors adopted the Saratoga County Economic Development Strategic Plan; and

WHEREAS, the Saratoga County Economic Development Strategic Plan identifies Saratoga County's economy as being built on three pillars: tourism, agriculture, and business and industry; and

WHEREAS, the first goal of the Saratoga County Economic Development Strategic Plan is to identify and support strategic investment in high-impact projects categorized as "Catalyst Projects"; and

WHEREAS, one such Catalyst Project identified in the Strategic Plan is an initiative to build a more connected sports and recreation cluster, utilizing and building upon such existing assets as historic spas, rowing regattas, horse riding, cycling, snowmobiling, whitewater paddling and trails; and

WHEREAS, in accordance with a recommendation made in the Saratoga County Economic Development Strategic Plan, this Board of Supervisors authorized and directed pursuant to Resolution 106-2014

the formation of the Saratoga County Prosperity Partnership, Inc., a local development corporation organized pursuant to Not-For-Profit Corporation Law §1411, to undertake certain projects and initiatives for the economic benefit of Saratoga County; and

WHEREAS, one of the projects the Saratoga County Prosperity Partnership, Inc. will be reviewing in 2015 is a funding request by a prominent local sports club to provide financial assistance in the construction of a sports facility that will assist in the hosting of larger competitions that will greatly impact tourism in the County by bringing competing teams and their families to the County where they will stay at local hotels and patronize local businesses; and

WHEREAS, since the enactment of Tax Law §1202-g and Local Law No. 7 of 1977, prominent tourism promotion entities have been formed in Saratoga County such as the Saratoga Springs City Center Authority in 1982 and the Saratoga Convention and Tourism Bureau in 1985, which entities have played a critical role in the local economy by promoting and marketing Saratoga County and the City of Saratoga Springs as a world-class destination for meetings, conventions, and groups; and

WHEREAS, it is appropriate that such key tourism promotion organizations such as the Saratoga County Tourism and Convention Bureau, the Saratoga Springs City Center Authority, and the Saratoga County Chamber of Commerce have a voice in advising this Board of Supervisors as to how room occupancy tax revenues should be expended in the promotion of tourism and conventions in Saratoga County; and

WHEREAS, pursuant to Resolution 37-2015, this Board of Supervisors requested home rule legislation amending subdivision nine of Tax Law §1202-g, to: 1) authorize the Saratoga County Board of Supervisors to allocate the net collections received from the County's Room Occupancy Tax (excluding those amounts designated by Tax Law §1202-g to be paid to the City of Saratoga Springs general fund, the City of Saratoga Springs convention and tourism bureau, and the Saratoga Springs City Center) fifty percent (50%) for the promotion of tourism and conventions and fifty percent (50%) to the Saratoga County Prosperity Partnership, Inc. for the promotion of tourism and other economic development-related purposes; and 2) to revise the membership composition of the nine member committee appointed by the Board of Supervisors to advise the Board on expenditures made by the County for the promotion of tourism and conventions to consist of four members of the Board of Supervisors who shall include the Chair of the Board of Supervisors, the Chair of the Board's Economic Development Committee, the Chair of the Board's Law and Finance Committee, and one member of the Board of Supervisors who also serves as a Director of the Saratoga County Prosperity Partnership, Inc.; one representative from Saratoga County Chamber of Commerce, one representative from the Chamber of Southern Saratoga County, one representative from the Saratoga Convention and Tourism Bureau, one representative from the Saratoga Springs City Center Authority and the Saratoga County Treasurer; and

WHEREAS, Senate Bill No. S4547 and Assembly Bill No. A6909 have been introduced in the State Legislature and would amend Tax Law §1202-g, subdivision nine, as requested by Resolution 37-2015; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors requests the enactment by the New York State Legislature of Senate Bill No. S4547 and Assembly Bill No. A6909 entitled "An act to amend the tax law, in relation to the tourist home, inn, hotel or motel tax in Saratoga County and the City of Saratoga Springs"; and, be it further

RESOLVED, that a necessity exists for the enactment of such legislation due to the fact that the Saratoga County Board of Supervisors does not have the power to enact such legislation solely by local law; and, be it further

RESOLVED, that the Clerk of the Board forward certified copies of this Resolution to our local State legislators.

BUDGET IMPACT STATEMENT: No budget impact.
