The invocation was given by Thomas N. Wood, III, Chaplain.

PUBLIC INPUT:

Peggy Lounsbury, Chair of the Saratoga County Citizens Committee for Mental Health regarding the Concerns related to Saratoga County Mental Health. Ms. Lounsbury told about the Citizens Committee, why they were formed and what they do. She said recently psychiatrists have left the Mental Health Clinic and is concerned about access to these services by clients. She encouraged the Board to develop an interim plan and to understand why staff is leaving. Ms. Lounsbury said there is unrest in the clinic and would like the Board to get to the root cause so there is no adverse effect on the clients. She spoke of her concern for the lack of an automated external defibrillator and lack of safety drills. Ms. Lounsbury encouraged the Board to address the safety concerns as soon as possible.

Susan Abbott, Principle Account Clerk at Saratoga County Mental Health. Mrs. Abbott said she has been a county employee for 27 years, 8 of which have been in the Mental Health Department. She said she has always strived to be professional and has taken great pride in her work. She said it has been her experience that it is the staff that is causing a hostile work environment, not the Director. Some staff do not follow the rules and try to navigate outside the box. Ms. Abbott said it would set a bad precedent to remove the Director. She said she could not speak to what had happened in the past but assured the Board Director Prezioso has always treated her with courtesy and respect. She said she is not being groomed for anything as she is blamed by some staff she is simply doing her job.

Carol Lyte, Administrative Officer at Saratoga County Mental Health. Ms. Lyte stated she has been a county employee in Mental Health for 19 years. She stated that when Dr. Prezioso started at the Clinic, staff were pleased with his management style. The distrust started in January when at the directive of County Personnel Dr. Prezioso eliminated the four day work week. After an article appeared in the Times Union in April, Dr. Prezioso was blamed for a doctor shortage. Saratoga County Mental Health has an ongoing contract with Saratoga Hospital to provide center psychiatrists who are hospital employees and are recruited through the hospital's HR departmental procedures. Ms. Lyte said she has never witnessed any disrespectful or unprofessional behavior by Dr. Prezioso to staff. The toxic environment is caused by staff circulating a document that contains erroneous information.

Cari Abatemarco, Principle Typist at Saratoga County Mental Health. She said that many have heard of a toxic environmental in Mental Health and was there to give her view from where she stands. She will not deny there is a toxic environment however Dr. Prezioso is not the cause of it. She has never seen Dr. Prezioso be anything but professional. Ms. Abatemarco said Dr. Prezioso was vilified when he brought the work week to 7 hours a day, 5 days a week as was agreed upon by the Union. Staff was eventually able to keep their flex work week but Dr. Prezioso remained a target. When an article was published, staff quickly became the judge and jury without knowing any of the background and found him guilty. Ms. Abatemarco said there are many employees who come to work to do their job but get bullied and she wants to be their voice to have this stopped.

Patricia Huber, Clinical Social Worker at Saratoga County Mental Health. Ms. Huber said she wanted to comment on something Ms. Lounsberry said when she said there is something very wrong at the Mental Health Center. Ms. Huber agrees, 100%. She said she worked in the Friendship house which was distant from the center. When the Department moved to South Broadway and was all under one roof the dysfunction was clear.

When Dr. Prezioso started at the center the first task he assigned was to come up with a mission, vision and values of the center. With 50 different employees there were many opinions and difficult to come up with a compromise. This climate is not new and has been part of the center a long time.

Lori Snyder, Senior Typist at Saratoga County Mental Health. Ms. Snyder said she has been with the department 1 year and all of her interactions with Michael Prezioso have been professional and courteous. She believes the hostile work environment is not coming from the Director's Office but from a few disgruntled staff members which started just after the first article appeared in the newspaper. The office is divided into camps with the support staff caught in the middle. The client's privacy has been compromised because of the press this has gotten. When the move took place it was decided not to label the building to maintain this confidentiality. She said now there are news cameras filming the building. She said what's most important is for the staff to go to work and give the clients the best possible care they can give.

WHEREAS, the Workforce Development Board (WDB) will need to obtain administrative services to assist in coordinating activities of the WDB for the Workforce Development Area commencing on or about July 1, 2015; and

WHEREAS, Saratoga County is the Grant Recipient for WDB funding, and WDB expenditures are paid through County employment and training funds, with adjustments made in the allocation of WDB funding among Saratoga, Warren and Washington Counties; and

WHEREAS, additional revenue to fund this contract is received from system partners that may include the NYS Department of Labor, ACCES-VR, Adirondack Community College, and WSWHE BOCES pending further guidance from the New York State Department of Labor regarding the administration of WIOA legislation; and

WHEREAS, quotes were obtained for the provision of these necessary administrative services, and our Economic Development Committee has recommended that a contract be awarded to J.J. Young, LLC, the lowest quote received for said services, for a term of one year; now, therefore, be it

AUTHORIZING AN INTERMUNICIPAL AGREEMENT WITH THE COUNTY OF SCHENECTADY FOR THE PRINTING OF ELECTION BALLOTS

WHEREAS, the County of Schenectady, acting through its County Board of Elections, purchased printing hardware using federal grant money that allows Schenectady County to print election ballots for Schenectady County and provide that service to other counties at cost; and

WHEREAS, pursuant to the terms of its grant, if Schenectady County were to earn a profit on its printing of election ballots, the profit must be paid to the Federal Election Commission; and

WHEREAS, our Saratoga County Commissioners of Election have recommended that Saratoga County enter into an intermunicipal agreement with the County of Schenectady, acting by and through the Schenectady County Board of Elections, for the printing of election ballots in Saratoga County at a cost not to exceed \$0.26 per ballot, for a term of one year subject to annual renewal; and

WHEREAS, at a cost of \$0.26 per ballot, the County would experience cost savings of approximately 55% per ballot over the cost of commercial printers; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute an intermunicipal agreement with the County of Schenectady, acting by and through its Schenectady County Board of Elections, providing for the printing of election ballots for the Saratoga County Board of Elections at a cost not to exceed \$0.26 per ballot, for the term from July 1, 2015 through June 30, 2016, subject to renewal for additional terms of one year; and, be it further

RESOLVED, that the form and content of such intermunicipal agreement shall be subject to the approval of the County Attorney.

<u>BUDGET IMPACT STATEMENT</u>: The savings associated with this agreement will reduce the annual cost of ballot printing by 55%.

WHEREAS, the Lakes to Locks Passage, "The Great Northeast Journey All-American Road", is a scenic byway that links the towns, villages, hamlets and cities along the interconnected waterway of Lake Champlain, Lake George, the Champlain Canal and the Hudson River; and

WHEREAS, the waters of Lake Champlain, Lake George, the Champlain Canal and the Hudson River provide a beautiful backdrop to the scenic, recreational and natural resources along the corridor; and

WHEREAS, the cultural and economic history of the Town of Saratoga and City of Saratoga Springs should be showcased to travelers along the Lakes to Locks Passage in Saratoga County; and

WHEREAS, the County of Saratoga recognizes that tourism is an important industry to the County and believes that the designated route for Lakes to Locks Passage should direct travelers through the Town of Saratoga and the City of Saratoga Springs to increase visitors' desire to stop and visit; and

WHEREAS, the overall economies of the communities along the Lakes to Locks Passage would benefit from a boost in tourism that will result from the inclusion a "Saratoga Spur;" travel route within the Lakes to Locks Passage; now, therefore, be it

RESOLVED, that the County of Saratoga urges the New York State Department of Transportation to modify the designation of the Lakes to Locks Passage State Scenic Byway to add a "Saratoga Spur", which "Spur" will extend from the Byway's intersection of US Route 4 and NYS Route 29 in the Village of Schuylerville, west along NYS Route 29 to the intersection with US Route 9 in downtown Saratoga Springs; and, be it further

RESOLVED, that the Clerk of the Board shall distribute copies of this Resolution to our local representatives in Congress, the New York State Senate, and the New York State Assembly, and to Mark Woods of the NYS Department of Transportation and Janet Kennedy, Executive Director of Lakes to Locks, Inc.

BUDGET IMPACT STATEMENT: No budget impact.

On a motion by Mr. Peck, seconded by Mr. Collyer the Rules of the Board were amended for the purpose of making the public input portion of the Board Meeting three (3) minutes to be consistent with the Public Hearing by a unanimous vote. Mr. Martin asked that speakers be advised they would be able to submit written comments. Mr. Veitch said that the website would be changed to reflect the new 3 minute rule.

Mr. Kinowski spoke about the Dix Bridge Trail Head that goes over the Hudson. He said he had the pleasure of attending a luncheon on the Dix Bridge. The Champlain Canal working group did an outstanding job in their efforts to bring a trail system, tourism into Saratoga and surrounding counties. A major bike tour group from North Carolina has been invited to the park and to go through the trail systems. He said this is only one item that has come up from outside sourcing coming into Saratoga County to enjoy our trail system. The value is tremendous and it does bring economic development to our area.

Mr. Grattidge reminded everyone that Sundae on the Farm is Father's Day, June 21st at Smith Brothers Farm on Jockey Street in the Town of Charlton from Noon until 4pm. He hopes everyone will be able to stop by to visit this diverse farm.
