Mr. Hellwig presented the following:

PUBLIC HEALTH

Authorizing a renewal of various service provider contracts in the Mental Health Department for a period of one year. The rates will be unchanged from the expiring contracts.

Support for increased organ donations. Chairman Veitch, Supervisor Tollisen as well as County Clerk Hayner have been working to improve and promote this initiative to bring attention to the benefits of organ donation.

PERSONNEL & INSURANCE

Authorize an agreement with Health efx to provide software monitoring of employee benefits which the County is now required to report in an automated fashion to IRS under the Affordable Care Act.

An amendment to the Saratoga County Policies and Procedures manual to provide for the revision of the Terminations Policy now titled Resignation/Retirement Process and Procedures. This will provide additional details and procedures to follow by the Departments in terms of forms and check lists and other various improvements.

An amendment to the Saratoga County Policies and Procedures Manual to provide for the revision of the Sexual Harassment Policy now titled as Unlawful Work Place Harassment. One of the changes will be to identify the Personnel Director as the party responsible for investigating any claims.

Approving a revised standard workday reporting resolution for elected and appointed county officials for retirement purposes.

EQUALIZATION & ASSESSMENT

Authorizing a refund of a property auction bid deposit for a property in the Town of Ballston. The property owner did work out an arrangement with the original buyer at the auction at this time needs to complete the transaction with the County by the end of December to pay any back taxes penalties and interest.

PUBLIC SAFETY

Authorizing an agreement with Monroe County for provision of a secure detention facility for inmates in need of patient psychiatric services that can't be incarcerated at the County Jail.

Authorizing acceptance of a New York State grant for the Probation Department to use to offset some of the costs associated with Alternatives to Secure Detention which includes a contract a contract with Berkshire Farms as well as a monitoring company that will provide electronic surveillance of the juveniles there.

Authorizing the Chair to enter into an agreement with the New York State Division of Criminal Justice Services to accept state aid for reimbursement of expenses related to the Ignition Interlock Device Monitoring Program.

Authorizing an intermunicipal agreement with Albany County on the shared interoperable 9-1-1 telephone system, computer aided dispatch system and a record management system.

Authorizing an amendment to the contract with Tecta America in the amount of \$4,978.81 associated with additional construction services as part of the Spruce Mountain 9-1-1 shelter roof replacement project.

LAW & FINANCE

Home Rule Request to designate the Route 9P Overpass at I87 Exit 14 in honor of Robert D'Andrea.

Establishment of the County Trails Development Reserve Fund to reserve funds for projects that exceed over one budget year.

Confirming the 2016 scale of charges for the Saratoga County Sewer District. Those charges were approved by the Sewer Commissioner and also presented at a Public Hearing in November.

Levying amounts payable to County Treasurer and Town Supervisors which is necessary in order for tax bills to be issued.

Establishing January 4, 2016 at 3:00 pm as the date, time and place of the 2016 Organizational Meeting of the Board of Supervisors.

On a motion by Mr. Collyer, seconded by Mr. Martin the agenda was set for the December 15, 2015 Board meeting.

On a motion by Mr. Veitch, seconded by Mr. Peck the minutes of the November 12, 2015 meeting were unanimously approved.

Mr. Sausville introduced Supervisor-elect Vincent DeLucia of the Town of Malta.

Public Input:

Ed Ehrlich – Clifton Park re: Kinns Road Park. Mr. Ehrlich said he has heard that healthy trees are going to be logged on the Kinns Road Park parcel to make money for the County. This is a very busy park and it doesn't sound right that the County is making money on healthy trees. He said he feels totally safe there. Trees can be dangerous as they do fall on houses, cars and on roads; but the truth is that a tree falling on a walker or hiker is rare. Mr. Ehrlich said that the public should be more involved in the decision.

Judy Karmiohl Ehrlich – Clifton Park re: Kinns Road Park. Mrs. Ehrlich asked the Board members to put on the agenda for next week's meeting a discussion on Kinns Road Park. She suggested that the Board may not be obligated to do this but rather the right thing to do. She went over the many questions she has regarding the logging of the park and the misconceptions she has heard.

The invocation was given by Thomas N. Wood, III, Chaplain.

Mr. Veitch asked for a moment of silence for the passing of Thomas Clements who was Supervisor from the City of Saratoga Springs from 1968-1978 and chaired the Board in 1975.

PUBLIC INPUT:

Charles Huff, Dutchess Path, Clifton Park Re: Kinns Road Park. Mr. Huff said he resides in the Town of Halfmoon. He said he uses the park about 3 times a week for the past 10 years. He said this park is a treasure with a good balance of trails and is used for multiple activities. He said he supports the removal of dead trees as well as selective harvesting for a better forest. Every effort should be made to hire a qualified timber expert and to minimize the amount of time it takes to perform he harvesting.

Alan Smith, Wheeler Road, Clifton Park Re: Kinns Road Park. Mr. Smith said he has lived in Clifton Park since 1994. He spoke of the safety of the trees in the park. He doesn't think the public has enough information about the plan. He said the park will be a mess after logging. He believes logging should be prohibited in the park.

David Kalish, Dater Farm Way, Clifton Park Re: Kinns Roard Park. Mr. Kalish said he is a resident of Clifton Park and has walked his dogs in the park for 10 years. He is concerned about the timber operation that was announced without public input. He said Supervisor Barrett has proposed an alternative plan. Mr. Kalish said he was happy to hear the County as postponed the logging of the park as it considers the Town's plan.

Peter Gronczlik, Baltusol Drive, Clifton Park Re: Kinns Road Park. Mr. Gronczlik thanked the Board for the opportunity to speak. He said he has used the park for over 10 years. He spoke of a citizen's group that was started to work with the Town to create a permit system for dog walkers so they could allow their dogs in the park without a leash. He said the agreement for the Town to take down the dead and hazardous trees in exchange for the County not logging live trees in Kinns Road Park, is an attractive alternative.

Mr. Veitch said the County and the Town are certainly working together to come up with an agreement. There is no final agreement at this time. Once an agreement has been worked out, it will be announced.

Mr. Barrett thanked Mr. Veitch and everyone involved for keeping an open mind as this process is gone through. He said he looks forward to the continued dialogue.

Mr. Vanags reported to the Board the activities of the Prosperity Partnership. He thanked the Board for the opportunity to speak today. He then thanked Supervisors Lawler, Kinowski, Daly, Johnson, and Veitch who are on the Board of the Prosperity Partnership. In March of 2014 the SCPP was formed. He was honored to be chosen as the President. Mr. Vanags spoke about the Strategic Plan that was put together and the initiatives included in that plan. He handed out the 4 point strategy and went over each of them. Mr. Vanags said one of the most important initiatives is the 4th one named which are the relationships with every level of government. He the 1st is attraction, attracting new businesses to Saratoga County. The 2nd is business retention and expansion. And the 3rd is leveraging the investment GlobalFoundries has made to Saratoga County.

Mr. Lawler said the Strategic Plan is available on the SCPP's website. He recognized Mr. Vanags' efforts in the 7 months he has been here. He has built the organization around him right down to the cleaning, office set up, hire staff, etc. Mr. Lawler thanked him for hitting the ground running from the moment he has gotten here.

Mr. Veitch asked Mrs. Roberts to join him at the podium. He said "this year we were able to conserve an important map in the collection of the Saratoga County Historian. Entitled "A Map of a number of building lots lying near the Congress Spring in the Town of Saratoga Springs and County of Saratoga being the property of the heirs of Gideon Putnam, deceased, as the same was surveyed in April 1810 by James Scott, surveyor" this manuscript was drawn in 1825 by G.G. Scott and was probably filed in the Saratoga County Clerk's Office at that time. This map, commonly referred to as "the

Putnam map" is believed to be the earliest map showing the configuration of what would become the village of Saratoga Springs and was used as the base from which other maps of the Village, and eventually the City of Saratoga Springs, were drawn.

Gideon Putnam was a true visionary and was the first to believe that Saratoga Springs would become a popular resort community, attracting people from all over the country with their unique mineral springs. Putnam laid out the main streets in the village (making Broad Street wide enough to turn his lumber wagons around), donated the first burying ground, schoolhouse lot and meeting house, and erected the first three-story hotel (which others referred to as Putnam's folly). He also tubed four mineral springs and made it a point to locate them in places that were accessible to the public so that everyone could benefit from them.

Putnam died prematurely at the age of 49 after falling from scaffolding while overseeing the building of his new hotel, Congress Hall. The map we have preserved shows the land that passed to his heirs after his death and is recognized as the basis of what we know today as the City of Saratoga Springs. This year, 2015, is the Centennial Anniversary of the creation of the city, and is an appropriate time to recognize the importance of this map and ensure its stability for future generations. Local paper conservator Donia Conn was able to remove several backings that were adhered to the map over the years, clean it and stabilize the paper. The map has been mounted and framed and will be on display in the Board of Supervisors Conference room where it is accessible to the public."

Mr. Veitch unveiled a new photo for the Board Rooms. The photo is actually a collage of the Board of Supervisors from 2000 through 2010.

Mr. Veitch spoke of a brochure he asked Fire Coordinator Ed Tremblay put together titled "Fireworks Safety: It's Up to You". Each Supervisor was given a packet to take back to their Town Halls.

ENCOURAGING SARATOGA COUNTY AND NEW YORK STATE RESIDENTS TO REGISTER AS ORGAN AND TISSUE DONORS

WHEREAS, New York State has the second lowest donor registry enrollment share in the country, with just 24% (approximately 3.8 million) of all residents age 18 and older registered to become organ and tissue donors, compared to the national average of over 50%; and

WHEREAS, in New York State there are more than 10,000 people waiting for an organ transplant which represents the third highest need in the nation; and

WHEREAS, an estimated 600 New Yorkers die every year while waiting for an organ transplant that did not arrive in time; and

WHEREAS, one organ donor can save up to 8 lives, and one tissue donor can improve the lives of more than 50 people; and

WHEREAS, counties play a direct role in saving lives through organ and tissue donation through their DMV offices and Boards of Elections where people can register to be organ and tissue donors; and

WHEREAS, county leaders statewide can play an important role in increasing organ and tissue donation by passing resolutions and promoting organ and tissue donation on their website and through county departments that interact with the public; and

WHEREAS, under the direction of NYSAC Past President Hon. Edward Diana, a strong supporter of organ and tissue donation who himself had the personal experience of being placed on the transplant waiting list, counties are encouraging residents to register as organ and tissue donors; and

WHEREAS, becoming a registered organ and tissue donor in New York State is easy and can be done in many ways, such as, the New York Alliance for Donation website, the MyDMV website, and DMV office, New York State Department of Health Website, New York State voter registration forms or by completing paper enrollment forms; and

WHEREAS, our Public Health Committee, the Chair of this Board of Supervisors, and our County Clerk wish to encourage and urge Saratoga County residents, as well as all New York State residents, to register as organ and tissue donors using any of the aforementioned options; now, therefore, be it

RESOLVED, that this Board of Supervisors hereby encourages and urges residents of Saratoga County and the State of New York to register as organ and tissue donors, and give the gift of life to those New Yorkers desperately awaiting organ transplants; and, be it further

RESOLVED, the Executive Deputy Commissioner of the New York State Department of Motor Vehicles is hereby urged to increase efforts by the State Department of Motor Vehicles to promote the registration of organ and tissue donors through the numerous resources available to the Department; and, be it further

RESOLVED, that the Clerk of the Board shall forward copies of this resolution to Governor Andrew M. Cuomo, State DMV Executive Deputy Commissioner Theresa Egan, our local State legislators and the New York State Association of Counties.

RESOLUTION 237 - 2015

AUTHORIZING AN AGREEMENT WITH HEALTH efx TO PROVIDE EMPLOYEE TRACKING AND MANAGEMENT SOFTWARE COMPLIANT WITH THE AFFORDABLE CARE ACT, AND AMENDING THE 2016 ADOPTED BUDGET IN RELATION THERETO

WHEREAS, the federal Affordable Care Act ("ACA") imposes numerous requirements on the County as an employer, including the monitoring of employee eligibility for medical benefits coverage; and

WHEREAS, the County's insurance consultant, Marshall & Sterling, Inc., recommended that the County install appropriate software that will allow the County to comply with the mandates of the ACA; and

WHEREAS, proposals were solicited for the desired ACA-compliant software; and

WHEREAS, Health efx submitted a proposal to provide employee tracking and management software compliant with ACA mandates for a term of two years at a cost of \$23,700 the first year, inclusive of a one-time implementation fee of \$9,200, and at a cost of \$14,500 the second year; and

WHEREAS, our Personnel and Insurance Committee, Marshall & Sterling, Inc. and the Director of Personnel have recommended that the proposal of Health efx be accepted; and

WHEREAS, an amendment to the 2016 Adopted County Budget is needed to appropriate the necessary funds from fund balance for this contract; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized and directed to execute an agreement with Health efx of Minnesota, for the provision of employee tracking and management software compliant with the mandates of the federal Affordable Care Act, for the term January 1, 2016 through December 31, 2017, at a cost not to exceed \$14,500 per year plus a one-time implementation fee of \$9,200 payable in the first year, with the form and content of such agreement to be subject to the approval of the County Attorney; and, be it further

AMENDING THE POLICIES AND PROCEDURES MANUAL TO REVISE AND RETITLE THE TERMINATIONS POLICY FOR EMPLOYEES

WHEREAS, Resolution 330-82 adopted a manual of Policies and Procedures for the conduct of Saratoga County government; and

WHEREAS, since its adoption, the Board of Supervisors has enacted numerous amendments to the Manual; and WHEREAS, the annual review of the Manual mandated by General Municipal Law §104-b has disclosed the appropriateness of revisions to update the County's

Terminations Policy to provide greater guidance to employees seeking to resign or retire from County employment by setting forth detailed procedures outlining the proper process the County and its employee should follow to effect an employee's resignation or retirement; and accordingly retitling the policy as "Resignation/Retirement Process and Procedures"; and

WHEREAS, the former owner of Tax Parcel #249-3-49, Kevin Mrozek, and Anthony Vaccarelli have been engaged in negotiations intended to result in the refund of Mr. Vaccarelli's bid deposit in the amount of \$13,750, the payment of all delinquent taxes, penalties and interest owed on the parcel, and the reconveyance of the parcel back to Mr. Mrozek; and

WHEREAS, Kevin Mrozek has personally refunded to Anthony Vaccarelli his bid deposit of \$13,750, plus an additional \$500; and

WHEREAS, Anthony Vaccarelli has provided the County with his duly executed release releasing all rights he has as the successful bidder to Tax Parcel #249.-3-49 and releasing all claims he may have against the County resulting from the auction sale of the parcel to him; and

WHEREAS, the underbidder on Tax Parcel #249.-3-49, Starr Mowery, has provided the County with her duly executed release releasing all rights she had as the underbidder to the purchase of the parcel; and

WHEREAS, Kevin Mrozek is prepared to submit a Repurchase Offer to the County for Tax Parcel #249.-3-49, but needs to recover the \$13,750 he paid Anthony Vaccarelli in order to have sufficient funds to pay the delinquent taxes, penalties and interest owed in full; and

WHEREAS, Anthony Vaccarelli has provided the County with his written consent authorizing the County to credit his bid deposit in the amount of \$13,750, which amount he had already been refunded by Kevin Mrozek, towards the delinquent taxes, penalties and interest owed by Mr. Mrozek on Tax Parcel #249.-3-49; and

WHEREAS, our Equalization and Assessment Committee and the County Attorney have recommended that this Board's approval of the auction sale of Tax Parcel #249.-3-49 to Anthony Vaccarelli be rescinded, and that Anthony Vaccarelli's bid deposit be refunded, and, in accordance with the written request of Mr. Vaccarelli, credited towards the delinquent taxes, penalties and interest owed by Kevin Mrozek on Tax Parcel #249.-3-49; now, therefore, be it

RESOLVED, that this Board's approval of the auction sale of Tax Parcel #249.-3-49 in the Town of Ballston to Anthony Vaccarelli set forth in Resolution 187-2015 is hereby rescinded; and, be it further

RESOLVED, that Kevin Mrozek shall have until December 31, 2015 to submit a written Repurchase Offer to the Saratoga County Treasurer for Tax Parcel #249.-3-49, together with payment in full of the balance of the delinquent taxes, penalties and interest owed on the parcel after application of the aforesaid credit in the amount of \$13,750; and, be it further

RESOLVED, that in the event Kevin Mrozek should fail to submit to the Saratoga County Treasurer a Repurchase Offer accompanied by payment of the balance of the delinquent taxes, penalties and interest owed for Tax Parcel #249.-3-49 by December 31, 2015, Anthony Vaccarelli shall have the right to seek the completion of his purchase at auction of Tax Parcel #249.-3-49 within a timeframe to be established by this Board.

WHEREAS, Resolution 176 of 2010 most recently authorized an agreement with Monroe County for their provision of in-patient psychiatric services and a secure detention facility for Saratoga County inmates at their local forensic unit; and

WHEREAS, Correction Law Article 20 authorizes both the provision of appropriate medical care or treatment at a location other than the local County jail and the designation of a substitute jail; and

WHEREAS, previous agreements with Monroe County for these services have been satisfactory and their continuation is desirable; now, therefore, be it

RESOLVED, that the Chairman of the Board of Supervisors is hereby authorized to execute an agreement with Monroe County for its provision of inpatient psychiatric services for mentally ill Saratoga County inmates in a secure detention facility setting at the Rochester Psychiatric Center, at a daily cost of \$140 for each inmate, for a term of five years effective from January 1, 2016 through December 31, 2020, with the form and content thereof being subject to the approval of the Saratoga County Sheriff and the County Attorney.

BUDGET IMPACT STATEMENT: No budget impact.

AUTHORIZING ACCEPTANCE OF A NEW YORK STATE SUPERVISION AND TREATMENT SERVICES FOR JUVENILES PROGRAM (STSJP) GRANT, AND AUTHORIZING PROVIDER CONTRACTS THROUGH DECEMBER 31, 2016

WHEREAS, the County's Department of Social Services and Probation Department are eligible for a grant from the New York State Office of Children and Family Services directed to reduce juvenile detention usage and encourage alternatives to detention and placement, known as the Supervision and Treatment Services for Juveniles Program (STSJP) grant; and

WHEREAS, the County has made application for an STSJP grant in an amount up to \$66,294 to cover the State's 62% share of the costs associated with clients who are not fully reimbursed under the Flexible Fund for Family Services (FFFS) program, with the remaining 38% of those costs to be funded by the County; and

WHEREAS, said grant funds, if received, would be accepted by the Department of Social Services and passed through to the Probation Department along with the County's matching funds; and

WHEREAS, the Probation Department proposes to utilize said STSJP grant and matching funds to: 1) contract with Berkshire Farms Center and Services for Youth, Inc. to provide intensive family-based programming to reduce and prevent juvenile detention through Berkshire Farms' Stepping Stones Program at a cost not to exceed \$163,212; 2) enter into a minor contract with KMG Monitoring Service to provide electronic monitoring of youth diverted from detention at an annual cost not to exceed \$10,000; and 3) enter into a minor contract with CAPTAIN Youth and Family Services to provide residential respite services for eligible youth to prevent detention at an annual cost not to exceed \$988; and

WHEREAS, the contract period for the foregoing contracts shall run from January 1, 2016 through December 31, 2016; now, therefore, be it

RESOLVED, that the Chair of the Board and/or the County Commissioner of Social Services execute any and all documents necessary to apply for and accept a Supervision and Treatment Services for Juvenile Program (STSJP) grant in an amount up to \$66,294 to reduce juvenile detention usage and encourage alternatives to detention and placement; and, be it further

RESOLVED, that the Chair of the Board is further authorized to execute a contract with Berkshire Farms Center and Services for Youth, Inc. of Canaan, New York, for the provision of intensive family-based programming to reduce and prevent juvenile detention for the term January 1, 2016 through December 31, 2016, at a sum not to exceed \$163,212, with the form and content of said contract being subject to the approval of the County Attorney; and, be it further

RESOLVED, that the County Administrator is hereby authorized to execute a minor contract with KMG Monitoring Services to provide electronic monitoring services of youth diverted from detention for the term January 1, 2016 through December 31, 2016, at an annual cost not to exceed \$10,000, with the form and content of such minor contract being subject to the approval of the County Attorney; and, be it further

RESOLVED, that the County Administrator is further authorized to execute a minor contract with CAPTAIN Youth and Family Services for the provision of residential respite services for eligible youth to prevent detention for the term January 1, 2016 through December 31, 2016, at an annual cost not to exceed \$988, with the form and content of such minor contract being subject to the approval of the County Attorney.

<u>BUDGET IMPACT STATEMENT</u>: None. The funding to administer these contracts is budgeted in the DSS budget and will be passed through from DSS to Probation.

WHEREAS, pursuant to Resolution 216-2015, this Board accepted a Round 4 Statewide Interoperable Communications Grant from the New York State Division of Homeland Security in the amount of \$2,961,221 to update the County's Computer Aided Dispatch (CAD)/Mobile 9-1-1 System and improve interoperability communications with other counties; and

WHEREAS, the Albany County Sheriff's Office, the Saratoga County Sheriff's Office and the Saratoga County Office of Emergency Services wish to construct a shared interoperable 9-1-1 Telephone, Computer Aid Dispatch and Records Management Network to serve Albany and Saratoga Counties, using existing infrastructure in both Counties, and

replacing, upgrading, and purchasing new infrastructure through a combination of grant funds and E911 surcharge funds; and

WHEREAS, the shared interoperable 9-1-1 telephone, CAD, and records management network will serve all first responders in Albany and Saratoga Counties, as well as being capable of interfacing with other public service agencies and surrounding counties; and

WHEREAS, current plans call for Albany and Saratoga Counties to solicit the participation of other surrounding counties and municipalities to form a larger shared network by expanding the system and distributing the costs with other participating members; and

WHEREAS, Albany and Saratoga County recognize the need to form a regulatory Board of Directors for purposes of implementing, managing and creating policy to govern the interoperable communications system; and

WHEREAS, the Albany County Sheriff's Department, Saratoga County Sheriff's Department and Saratoga County Office of Emergency Services have proposed that Albany County and Saratoga County enter into an intermunicipal agreement setting forth the financial, operational, and maintenance responsibilities of the two counties in the establishment of the shared interoperable 9-1-1 telephone, CAD and records management network, and establishing a regulatory Board of Directors to govern the interoperable communications system; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an intermunicipal agreement with the County of Albany establishing a shared interoperable 9-1-1 Telephone, Computer Aided Dispatch, and Records Management Network to serve Albany and Saratoga Counties, as well as any other surrounding counties and municipalities wishing to join the interoperable communications network, and establishing a regulatory Board of Directors to govern the network, with said intermunicipal agreement to be for a term of ten (10) years commencing January 1, 2016 and terminating on December 31, 2025; and, be it further

RESOLVED, that the form and content of such intermunicipal agreement shall be subject to the approval of the County Attorney.

RESOLUTION 249 - 2015

Introduced by Supervisors Wright, Collyer, Daly, Kinowski, Lewza, Sausville and Tollisen

ESTABLISHING A CAPITAL RESERVE FUND FOR THE CONSTRUCTION OF TRAILS IN SARATOGA COUNTY

WHEREAS, the 2015 Saratoga County Budget included a Trails Grant Program to give matching grants to local municipalities to fund trail development and construction projects; and

WHEREAS, trail development projects are often complex, and can take several years to complete; and

WHEREAS, the inability to complete such projects within the fiscal year for which the project funding is budgeted results in the unspent budgeted funds being allocated to County's fund balance at year's end; and

WHEREAS, the County's outside auditors, Toski & Co., and the County Treasurer have recommended that the County establish a Capital Reserve Fund-Type pursuant to General Municipal Law §6-c for the purpose of accumulating moneys to finance the costs of the County's trail development projects over a period in excess of a single fiscal year; now, therefore, be it

RESOLVED, that pursuant to Section 6-c of the General Municipal Law, the Saratoga County Board of Supervisors hereby establishes a capital reserve fund to be known as the "County Trails Development Reserve" (hereinafter "Reserve Fund") for the purpose of accumulating moneys to finance the costs of a type of capital projects consisting of the financing of the acquisition of land or interests in land within Saratoga County to be used for, and the construction thereon, of public recreational and multi-use trails subject to the approval of each such trail development project by our Trails Committee and this Board of Supervisors; and, be it further

RESOLVED, that the Board of Supervisors may, from time to time, authorize the appropriation of moneys to this Reserve Fund either from annual tax levies through the approval of its operating budget, or from specific allocations of general fund balance through approval of motions so made; and, be it further

RESOLVED, that the Saratoga County Treasurer is hereby directed to deposit and secure the moneys of this Reserve Fund in the manner provided by Section 10 of the General Municipal Law. The Treasurer may invest the moneys in the Reserve Fund in the manner provided by Section 11 of the General Municipal Law, and consistent with the Investment Policy of Saratoga

County. Any interest earned or capital gains realized on the moneys so deposited or invested shall accrue to and become part of the Reserve Fund. The Treasurer shall account for the Reserve Fund in a manner which maintains the separate identity of the Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investment of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investment, and shall, at the end of each fiscal year, render to the Board of Supervisors a detailed report of the operation and condition of the Reserve Fund.; and, be it further

RESOLVED, that except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of the Board of Supervisors and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law, including a permissive referendum if required by subdivision 4 of Section 6-c.

ESTABLISHING 2016 SCALE OF CHARGES FOR SARATOGA COUNTY SEWER DISTRICT NO. 1

WHEREAS, pursuant to County Law §266, the Commissioners of Saratoga County Sewer District No. 1 adopted a scale of charges for the Sewer District's 2015 services; and

WHEREAS, this scale was duly published in the official newspapers of the County and on the County of Saratoga's official website and was duly filed with our Clerk of the Board; and

WHEREAS, after due consideration, and upon the District's recommendation, this Board finds that it is in the public interest to adopt that scale of charges for collection, conveyance, treatment and disposal of sewage; now, therefore, be it

RESOLVED, that the following 2016 scale of charges for the Sewer District, be, and the same hereby is, confirmed and established:

PROPOSED 2016 SCALE OF CHARGES FOR SARATOGA COUNTY SEWER DISTRICT NO. 1

SECTION 1 - SEWER CHARGES IMPOSED

Pursuant to County Law §266(1)(a), Saratoga County Sewer District No. 1 hereby imposes sewer charges for 2016 upon all premises and real property, within or without District boundaries, connected to, the District's sewer system.

SECTION 2 - ESTABLISHMENT AND CONFIRMATION OF SEWER CHARGES

Subject to confirmation by the County Board of Supervisors, this scale of charges may, from time to time, be amended by the District's Commission.

SECTION 3 - CRITERIA FOR ESTABLISHING SEWER USER CHARGES

The scale of sewer user charges shall use the following criteria:

- (a) A user is defined as any piece of land upon which a building or buildings stand and is connected to an interceptor, trunk or collector sewer served by the District.
- (b) The annual cost of debt service, administration, operation and maintenance for the District's treatment facilities will be generally allocated to all users.
- (c) The annual cost of debt service and operation and maintenance associated with the interceptor sewer, will be generally allocated to all users connected to and/or discharging into the system.
- (d) The annual cost of debt service and operation and maintenance associated with each major trunk sewer system will be generally allocated to all users connected to and/or discharging into the system.

- (e) A connection unit is defined as a single-family dwelling unit. Units include, but are not limited to, a single family house, each apartment unit (e.g. an apartment building with six apartments is six units), each half of a duplex, a cottage, a camp, a mobile home, and each unit of a condominium or townhouse. A "unit" as used for billing purposes will be 200 gallons per day of sewer discharge, or any portion thereof. No user will be rated at less than one unit. Users will be rated in terms of whole connection units. Each tenant with sanitary facilities within a commercial complex will be defined as an individual user.
- (f) For all users, including single-family dwelling units, equivalent connection units (E.C.U.) will be determined based on the following schedule which accommodates peak demand and potential flow needs:

USER & COLLECTOR CHARGES:

Single parcel:

- A. Vacant no charge unless a lateral was requested and installed. If lateral is installed, a collector fee shall be charged for each lateral.
- B. Occupied Residential
 - (1) Single Family Residence
 - a. 1 user, 1 collector as applicable.
 - (2) Multiple Family Residence Each separate dwelling unit in a two family, three family or multiple dwelling, which is not an apartment
 - a. 1 user per dwelling unit
 - b. 1 collector per dwelling unit as applicable
 - (3) Apartments
 - a. Each dwelling unit is assigned 1 user and 1 collector as applicable
 - b. Subsidized senior housing For complexes receiving Federal, State or municipal rent subsidies for dedicated senior housing, each 2 dwelling units will be assigned 1 user and 1 collector as applicable
 - c. Proof of entitlement to the designation as senior subsidized housing will need to be provided by the user and will be subject to approval of the Sewer Commission; confirmation of continuance of the subsidy will need to be provided to the Sewer District by September 1st of each year.
 - (4) Trailer Parks
 - a. 1 user for each approved trailer site
 - (5) Condominiums
 - a. Each unit is assigned 1 user and 1 collector as applicable
 - b. Charges will commence upon issuance of a Certificate of Occupancy by the local municipality for those units that the New York State Department of Law has authorized to be offered for sale. Common area facilities will be assessed to the owner of record as determined under provisions of Commercial Users.
 - C. Occupied Commercial
 - (1) 1 Collector for each user

- A. Restroom is defined as 1 toilet, sink and/or urinal to be adjusted proportionately for additional facilities

(g) When there is a substantial increase in sewer flows during the current year, the District may adjust the number of connection units charged and bill the user directly for that additional sum pursuant to Section 8.

- (h) Saratoga Spa State Park will be charged based on their 2015 measured waste expressed in E.C.U.'s discharged to District facilities.
- (i) Wastewater from wet processing and other operations is subject to the restrictions, prohibitions and surcharges outlined in the District's rules and regulations covering the discharge of sewage, industrial waste and other waste into the Saratoga County sewer system and all sewers tributary thereto.
- (j) A user discharging B.O.D. or T.S.S. to the District facilities exceeding the amount allowed in the District's rules and regulations will be charged \$700 per dry ton for that excess per conditions of their discharge permit.
- (k) All costs of the District's pretreatment and spill response program including, but not limited to, laboratory testing, labor, equipment, materials, consultants and sub-consultants, contractors and subcontractors, and fines, shall be reimbursed by the individual or user.
- (l) Outside non-residential users will be charged two and one-half times the rate established for the trunk system servicing that user, residential housing will be one and one-half times that rate.
- (m) Collector sewer rates are generally based on the overall construction costs of the collector system together with debt service and operation and maintenance costs of the collector system.
- (n) Users of collection sewers turned over to the District will be charged for that portion of the District facilities utilized and at the same rate as the other users of the particular system.

SECTION 4 - SCALE OF CHARGES

The following is the 2016 scale of charges for the trunking and treatment of sewage.

(a) The cost of the treatment facilities and interceptor sewer lines is allocated among the 23 trunk systems. The units for those trunks and the portion of the 2016 user charges based on those units are as follows:

SECTION 6 - PAYMENT OF SEWER USER CHARGES

All sewer charges, excepting those for Saratoga Springs, Saratoga Spa State Park, Town of Schaghticoke, Saratoga County Water Authority, NYSERDA and GLOBALFOUNDRIES shall be collected pursuant to Real Property Tax Law Article 11. The assessor of each municipality utilizing the town and county tax bills for the collection of taxes shall properly code the assessment roll as to the number of connection units for each particular property and for those properties utilizing the collector system. The assessor shall use the District's formula to determine the units for multiple dwellings and commercial users of the trunk and collector systems.

The City of Saratoga Springs, which includes the Geyser Crest, Geyser Road and a portion of the Saratoga Lake trunk sewer systems; as well as the Kirby Road, Loughberry Lake, Crescent Avenue and a portion of the Saratoga Lake collector systems shall each be considered as a single-bulk user and shall be so billed by the District. The city's collecting officer shall determine the appropriate method of assessing and collecting its sewer user charge. This single-bulk user charge may be passed on to city residents as a city sewer rent and enforced pursuant to General Municipal Law §452.

City payments shall be due quarterly by March 31, June 30, September 30 and December 31, 2016. A late payment charge of one percent (1%) per month shall be added for each month or portion thereof until paid.

The District shall bill Saratoga Spa State Park their 2016 user charges payable no later than May 1, 2016.

The Town of Schaghticoke shall be billed by the District for service to the Hemstreet Park area of the Town on a semi-annual basis in accordance with the terms of the District's Inter-municipal Agreement with the Town.

GLOBALFOUNDRIES and Saratoga County Water Authority will be billed on a monthly basis based on flows discharged the preceding month per terms of their Industrial Discharge Permits.

Payments by single-bulk users shall be made to the County Treasurer who shall reject any untimely or insufficient payment. The postmark date of a payment shall be evidence of payment.

SECTION 7 - PENALTIES FOR LATE PAYMENTS

Sewer charges shall be subject to the same penalties and interest applicable to County taxes generally.

SECTION 8 - PAYMENT OF SEWER CHARGES NOT ON TOWN/COUNTY TAX ROLLS

The District shall bill directly those users of the collector sewer system and the trunk sewer system not appearing on the town and county tax rolls. Payments shall be made to the District and forwarded to the County Treasurer. Partial payments will not be accepted and will be returned.

The District shall also bill directly those users that have had an increase in connection units during the year.

The County Treasurer shall prepare and transmit to the Board of Supervisors, on or before December 1, a list of District residents or property owners within the District who are in arrears in the payment of such trunk or collector charges for a period of 30 days or more. The list shall contain a brief description of the properties for which the services were provided, the names of the persons or corporations liable to pay for same and the amount chargeable to each including penalties and interest computed to December 31.

The Board of Supervisors shall levy such sums against the properties liable and shall state the amount thereof in a separate column in the annual tax rolls of the various municipalities under the name of "county sewer charges". Such amounts, when collected by the several municipal collectors or receivers of taxes, shall be paid over to the County Treasurer. All of the provisions of the tax laws of the State of New York covering the enforcement and collection of unpaid taxes or assessments for special improvements not inconsistent herewith shall apply to the collection of such unpaid charges. Such amounts, when received by the County Treasurer, shall be credited to the County Sewer District fund for the District's exclusive use.

SECTION 9 - PROCEDURES

Resolution 174-77, as amended by Resolution 174-09, shall govern the Commissioners' consideration, adoption and publication of this proposed scale of charges. After the Commissioners' actions, the Board of Supervisors shall act upon the published scale and any appeals therefrom as follows:

- (a) Confirmation thereof by a general resolution;
- (b) Amendment and confirmation by a general resolution; or
- (c) Recommitment to the District Commissioners for further study and consideration.

REQUESTING HOME RULE LEGISLATION TO DESIGNATE THE NEW YORK STATE ROUTE 9P BRIDGE OVER INTERSTATE 87 AT EXIT 14 AS THE "ASSEMBLYMAN BOBBY D'ANDREA BRIDGE"

WHEREAS, Bobby D'Andrea served on the Saratoga County Board of Supervisors as Supervisor for the City of Saratoga Springs for seven years from 1968 to 1974; and

WHEREAS, in November 1974, Bobby D'Andrea was elected to the New York State Assembly, where he served as the Assemblyman representing the City of Saratoga Springs and surrounding municipalities in Saratoga County and Washington County over a period of twenty-seven years until his retirement in 2002; and

WHEREAS, during his tenure with the Assembly, Bobby served on many committees, including the Aging Committee, upon which he was the ranking member, the Racing and Wagering Committee, and the Environmental Conservation Committee; and

WHEREAS, through his hard work, diligence and skill, Bobby rose to the position of Minority Whip in the Assembly, and later achieved the status of Assistant Minority Leader Pro Tem in 1999; and

WHEREAS, during his time in the Assembly, Bobby treated his part-time position as an Assemblyman as a full-time job, enjoyed a near perfect attendance record in the Assembly, and earned a well-deserved reputation as an Assemblyman devoted to serving the needs of his constituents; and

WHEREAS, Bobby D'Andrea was admired by his constituents for his frequent appearances at dedications, fundraisers, rallies, celebrations and other similar events, where he greeted everyone in attendance with his warm smile and open accessibility; and

WHEREAS, Bobby's dedication to the people he represented and his non-partisan approach to doing business with his fellow legislators made him a model Supervisor and Assemblyman; and

WHEREAS, Bobby has resided in the City of Saratoga Springs east of Interstate 87 at Exit 14 for decades; and

WHEREAS, this Board of Supervisors deems it fitting that the New York State Route 9P bridge over Interstate 87 at Exit 14 be named in honor of Bobby D'Andrea for his years of devoted service to his constituents in the City of Saratoga Springs and surrounding communities; and

WHEREAS, to officially dedicate a New York State bridge or highway in honor of a person or group requires home rule legislation amending the Highway Law of the State of New York; now, therefore, be it

RESOLVED, that the Board of Supervisors of the County of Saratoga requests the enactment of State legislation designating the New York State Route 9P bridge over Interstate 87 at Exit 14 as the "Assemblyman Bobby D'Andrea Bridge"; and, be it further

RESOLVED, that a necessity exists for the enactment of such legislation as it is in the sole discretion of the Legislature to officially designate the names of State bridges; and, be it further

RESOLVED, that the Clerk of the Board forward certified copies of this Resolution to our local State legislators.

BUDGET IMPACT STATEMENT: No budget impact.
