The board did introduce Home Rule and sent it down to Albany. The Legislature has now assigned bill numbers to that legislation so the Board's approval needs to be updated to reflect those numbers.

Mr. Grattidge said there wasn't a Public Health Committee meeting this month so he wanted to report that the County will be purchasing mosquito dunks to be made available to the towns. Mr. Kinowski said his town has a supply and will check to

see if they are usable. Mr. Johnson said the Town of Wilton still uses them and will provide the vendor the Town uses.

My experiences both professional and personal are varied – times change and we find ourselves in an eclectic environment with tremendous opportunities.

Over the course of time together performing the work of the people we have shared moments of accomplishments and dreams of what could be – together as a team we do the job right and have been rewarded with re-election of office to continue to serve the people who benefit from our accomplishments.

My time has come to set a new course, to meet new challenges and hopefully be rewarded again.....this time on a different stage with a different audience.

Saratoga County is obviously a big part of my life. I am lucky because I can submit this resignation with a sense of fulfillment with respect to the County's past and a sense of optimism about the County's future. And using the words fulfillment and optimism, in the same sentence when it comes to government service, is a rarity.

But Saratoga County is a rarity and I am honored to have had a role in its direction.

To all my friendships I leave here with many memories and I will continue to applaud your efforts.

I thank you, my colleagues, for your unwavering support and my family for always being by my side.

WHEREAS, pursuant to Environmental Conservation Law ("ECL") §42-0103, the Historic Hudson-Hoosic Rivers Partnership (the "Partnership") was established to preserve, enhance and develop the historic, agricultural, scenic, natural and recreational resources and the significant waterways of the communities surrounding the Hudson and Hoosic Rivers in Saratoga, Rensselaer and Washington Counties; and

WHEREAS, pursuant to ECL §42-0105, the area encompassed within the municipal boundaries in the towns of Saratoga, Stillwater, Northumberland, Easton, Fort Edward, Waterford, Halfmoon, Moreau, Schaghticoke, Cambridge, White Creek, Pittstown, Hoosick, Kingsbury, Corinth and Greenwich; the villages of South Glens Falls, Cambridge, Hudson Falls, Valley Falls, Schaghticoke, Corinth and Hudson Falls; and the City of Mechanicville are designated as the Historic Hudson-Hoosic Rivers Partnership Reserve (the "Reserve"); and

WHEREAS, the Partnership is pursuing plans to construct a visitor center on a two acre parcel of land owned by the Town of Saratoga in Fort Hardy Park in the Village of Schuylerville; and

WHEREAS, the visitor center will be known as the Gateway Visitor Center, and will be a multi-story building with exhibits showcasing the natural, cultural, and historic attractions in the area, and space for group meetings and educational demonstrations; and

WHEREAS, pursuant to ECL §42-0103, every state agency and public corporation having jurisdiction of land within municipalities located within the Reserve shall, to the fullest extent practicable, cooperate and assist the Partnership in carrying out the provision of ECL Article 42; and

WHEREAS, the County owns and maintains various parcels of reforested lands throughout Saratoga County pursuant to County Law §219; and

WHEREAS, the Partnership has requested a donation of timber from the County to be utilized in the timber frame construction of the Gateway Visitor Center; and

WHEREAS, County Law §219 provides that the trees, timber and other forest products on county reforested lands may be sold or otherwise disposed of in such manner as a county's board of supervisors may direct; and

WHEREAS, this Board of Supervisors is agreeable to donating to the Partnership the timber needed to construct the Gateway Visitor Center from the County's reforested lands in the Towns of Northumberland and Wilton, upon the condition that the Partnership shall reimburse the County for all costs associated with marking, cutting, loading and transporting the timber to the mill; and

WHEREAS, pursuant to Resolution 102-06, this Board authorized a contract with Saratoga Land Management Corp. for the provision of forestry management services for County-owned forest lands, which services include the identification and marking of trees for harvesting; and

WHEREAS, the services provided by Saratoga Land Management Corp. have been very satisfactory, and our County Director of Planning has recommended that the County retain the services of Saratoga Land Management Corp. to mark, cut, load and transport to mill that timber needed for the County's donation of timber for the construction of the Gateway Visitor Center; and

WHEREAS, Saratoga Land Management Corp. has submitted a proposal: to mark the needed timber at a fee of \$50.00/hr.; to cut hardwood timber at a fee of \$200/MBF; to cut softwood timber at a fee of \$150/MBF; to load the timber at a fee of \$150/MBF, and to transport the timber to mill at a fee of \$455/load; and

WHEREAS, the County's Director of Planning has estimated the total costs for marking, cutting, loading and transporting the timber at the foregoing rates quoted by Saratoga Land Management Corp. to be \$26,000; and

WHEREAS, our Economic Development Committee has recommended that a contract for the marking, cutting, loading and transporting of the donated timber from the County's reforested lands in the Towns of Northumberland and Wilton be awarded to Saratoga Land Management Corp. at the foregoing quoted rates; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute a cooperative agreement and any necessary related documents with the Historic Hudson-Hoosic Rivers Partnership providing for the County's donation of timber, in a species and quantity to be determined by the Timber Frame Guild, to the Partnership for the construction of the Gateway Visitor Center in the Village of Schuylerville, subject to the Partnership reimbursing the County for all costs incurred in marking, cutting, loading and transporting the timber to mill; and, be it further

WHEREAS, the three parcels, Tax Parcels #129.-1-60, #129.-1-47 and #129.-1-48, encompass approximately 126 acres of forestland; and

WHEREAS, bids were solicited for the harvesting of the timber, and bidders were given an option to submit a lump sum timber harvest bid that would allow the potential bidders to market the timber for the highest price, and, in turn, hopefully increase the bid amounts received; and

WHEREAS, the highest bid received was the lump sum timber harvest bid submitted by Daniel Galusha d/b/a G&T Enterprises in the amount of \$126,774.75; and

WHEREAS, our Economic Development Committee, the County's Director of Planning and the County Forester recommend that the bid of G&T Enterprises be accepted; and

WHEREAS, the lump sum bid process will allow G&T Enterprises to market the timber for the highest value, resulting in the County receiving revenue that is approximately 20% higher than originally projected,

WHEREAS, the proposed timber harvest will cover two years of budgeted timber harvest revenue for the Planning Department, and, as a result thereof, the Director of Planning is proposing that no timber harvest revenue be budgeted in the Planning Department's budget for the 2017 fiscal year; and

WHEREAS, due to the increased timber harvest revenue for 2016, and amendment is needed to the 2016 County Budget to authorize the payment of a higher than budgeted commission to the County Forester; now, therefore, be it

RESOLVED, that the Chair of the Board execute an agreement with Daniel Galusha, d/b/a G&T Enterprises, of Johnsburg, New York, for the selective harvesting of timber on approximately 126 acres of County forest land in the Town of Northumberland, identified herein as Tax Parcels #129.-1-60, #129.-1-47 and #129.-1-48, for which G&T Enterprises will pay the County the sum of \$126,774.75 for the harvested timber; and, be it further

RESOLVED, that said agreement shall provide that in the event Daniel Galusha, d/b/a G&T Enterprises, should fail to submit the required deposits of \$5,000 at contract signing, and of \$55,000 by the earlier of the commencement of harvesting or December 1, 2016, the County shall have the right to immediately terminate this agreement, and the County shall be authorized to enter into a contract for the harvesting of the site with the underbidder, Wadsworth Logging, at the rate quoted in the underbidder's bid; and, be it further

WHEREAS, federal regulations require a mutually-approved arrangement for a government radio station to allow a non-government user to use any radio frequency authorized solely to a government radio network; and

WHEREAS, our Public Safety Committee and the County's Director of Emergency Services recommend that the Chair of the Board be authorized to execute a Memorandum of Understanding with any public safety agency wishing to access and use the Saratoga County Public Safety Radio Network; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute a Memorandum of Understanding with any public safety agency requesting authorization to access and use the Saratoga County Public Safety Radio Network for the purpose of public safety and mutual aid intercommunications with the County and other authorized public safety agencies; and, be it further

RESOLVED, each authorized user will be responsible for purchasing its own Motorola approved radio equipment, and any equipment necessary for the user to operate on the system, and shall pay all expenses associated with the operation of said equipment on the system; and, be it further

RESOLVED, that the Saratoga County Office of Emergency Services may temporarily loan to an authorized user, at no charge, the necessary equipment to operate on the SCPSRN, provided the Office of Emergency Services has such equipment available and the authorized user is diligently pursuing the purchase of such equipment; and, be it further

RESOLVED, that the form and content of the standard Memorandum of Understanding to be executed by the Chair of the Board and each authorized user shall be subject to the approval of the County Attorney and the Director of the Office of Emergency Services.

WHEREAS, the Research Foundation for the State University of New York is the recipient of a New York State Division of Homeland Security and Emergency Services grant to support the development of the New York State Early Warning Weather Detection System, also known as the New York State Mesonet; and

WHEREAS, the NYS Mesonet will be an advanced, statewide weather network consisting of up to 125 state-of-the art surface weather stations, with every county hosting one or more stations, and will serve as the foundation of an Early Warning Severe Weather Detection network for the entire State of New York; and

WHEREAS, the Research Foundation proposes to locate, construct and operate at its own expense, a Mesonet Weather Station on a 33 ft. by 33 ft. plot of County-owned land east of the County's Department of Public Works facility off of Galway Road; and

WHEREAS, if approved and constructed, the Mesonet station will measure temperature, relative humidity, wind speed, wind direction, precipitation, solar radiation, atmospheric pressure, and soil moisture and temperature at these depths, and will provide federal, state and local government officials with access to real-time data and improved predictive models, enabling emergency management decision-makers to better plan for and mitigate extreme and devastating weather events; and

WHEREAS, in addition, the Mesonet network will support more accurate and precise decision-making in agriculture, energy, ground transportation and aviation; and

WHEREAS, our Buildings and Grounds Committee, Commissioner of Public Works and Director of Emergency Services have recommended that the Research Foundation of the State University of New York be granted a land use permit for a term of ten (10) years, subject to renewal, for the construction of a Mesonet

weather station on County owned land at the County Farm Road complex, with the exact location and construction details of the weather station to be subject to the approval of the County's Commissioner of Public Works; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute and issue a Land Use Permit to the Research Foundation of the State of New York for a term of ten years, subject to renewal for additional terms of ten (10) years, for the construction and operation of a Mesonet weather station on County-owned land at the County Farm Road complex, with the exact location and construction details of the weather station to be subject to the approval of the Saratoga County Commissioner of Public Works; and, be it further

RESOLVED, that the form and content of such Land Use Permit shall be subject to the approval of the County Attorney.

<u>BUDGET IMPACT STATEMENT</u>: None. The Research Foundation will pay for all costs associated with installation and maintenance of the weather station.

REQUESTING HOME RULE LEGISLATION TO DESIGNATE THE NEW YORK STATE ROUTE 9P BRIDGE OVER INTERSTATE 87 AT EXIT 14 AS THE "ASSEMBLYMAN ROBERT D'ANDREA BRIDGE"

WHEREAS, Robert "Bobby" D'Andrea served on the Saratoga County Board of Supervisors as Supervisor for the City of Saratoga Springs for seven years from 1968 to 1974; and

WHEREAS, in November 1974, Bobby D'Andrea was elected to the New York State Assembly, where he served as the Assemblyman representing the City of Saratoga Springs and surrounding municipalities in Saratoga County and Washington County over a period of twenty-seven years until his retirement in 2002; and

WHEREAS, during his tenure with the Assembly, Bobby served on many committees, including the Aging Committee, upon which he was the ranking member, the Racing and Wagering Committee, and the Environmental Conservation Committee; and

WHEREAS, through his hard work, diligence and skill, Bobby rose to the position of Minority Whip in the Assembly, and later achieved the status of Assistant Minority Leader Pro Tem in 1999; and

WHEREAS, during his time in the Assembly, Bobby treated his part-time position as an Assemblyman as a full-time job, enjoyed a near perfect attendance record in the Assembly, and earned a well-deserved reputation as an Assemblyman devoted to serving the needs of his constituents; and

WHEREAS, Bobby D'Andrea was admired by his constituents for his frequent appearances at dedications, fundraisers, rallies, celebrations and other similar events, where he greeted everyone in attendance with his warm smile and open accessibility; and

WHEREAS, Bobby's dedication to the people he represented and his non-partisan approach to doing business with his fellow legislators made him a model Supervisor and Assemblyman; and

WHEREAS, Bobby has resided in the City of Saratoga Springs east of Interstate 87 at Exit 14 for decades; and

WHEREAS, pursuant to Resolution 251-2015, this Board of Supervisors requested home rule legislation designating the New York State Route 9P bridge over Interstate 87 at Exit 14 as the "Assemblyman Bobby D'Andrea Bridge"; and

WHEREAS, Assembly Bill No. A9779 and Senate Bill No. S6482 have been introduced in the New York State Legislature, and if enacted into law would add a new section 342-vvv to the Highway Law of the State of New York which would designate the New York State Route 9P bridge over Interstate 87 at Exit 14 as the "Assemblyman Robert D'Andrea Bridge"; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors requests the enactment by the New York State Legislature of Assembly Bill No. A9779 and Senate Bill No. S6482 entitled "An Act to amend the highway law, in relation to designating a portion of the state highway system in the City of Saratoga Springs, County of Saratoga, as the 'Assemblyman Robert D'Andrea Bridge' "; and, be it further

RESOLVED, that a necessity exists for the enactment of such legislation due to the fact that the Saratoga County Board of Supervisors does not have the power to enact such legislation solely by local law; and, be it further

RESOLVED, that the Clerk of the Board forward certified copies of this Resolution to our local State legislators.

BUDGET IMPACT STATEMENT: No budget impact.

Mr. Kinowski said we heard at the beginning of the meeting what a partnership is capable of doing. The visitor's center is slated to help bring tourism to our County. In light of the Economic Development Week we've all just heard and voted on, the Prosperity Partnership that we created is moving the County forward. He brought forward the proposed resolution which will bring together all agencies within the County and offer strong support for the Prosperity Partnership to move forward.

Mr. Johnson seconded the motion. The Prosperity Partnership and the IDA are both entities created by Saratoga County Government. Both with economic development missions and both Boards are appointed by the Board of Supervisors. It's important for these two organizations partner, work together and promote each other. The agreement will go a long way in accomplishing that and is consistent with the Strategic Plan.

Mr. Kinowski clarified the agreement is a wide open agreement and does not prohibit any other development agency of any kind to do business with the IDA. It just offers the Board's strong support to the IDA and the Partnership to work in harmony together moving forward.

Mr. Congdon said part of this resolution refers to an agreement which he did not get a copy of. He understands it gives the exclusive right to the Partnership and in his town they already have an agreement with SEDC on their Industrial Park. He asked how this will affect that agreement.

Mr. Kinowski said it does not have exclusivity in the contract. There was an original version submitted to the IDA and that has since been changed. Mr. Kinowski gave Mr. Congdon a copy of the agreement which does not have exclusive language contained in it. He said the SEDC and others can work with the IDA.

Mr. Barrett said he does not have a problem with the Partnership and the County is spending a fair amount of money on this initiative he wants it to be successful and worth the money. He said he didn't get the agreement until today and appreciated Mr. Kinowski speaking with him before the Board Meeting. He asked how the agreement will mesh with the proposal that the Partnership has presented to the IDA recently regarding how the two will work together.

Mr. Kinowski said we can't dictate to the IDA how they choose to enter into agreements with economic development engines. It's up to them to look at the Partnership's contract, look at any other economic development engines' contracts and pursue an agreement with each or with all. Mr. Barrett said at the IDA meeting a pitch was made by the Partnership and asked if this is what was pitched or is it something different.

Mr. Lawler said it's a little of both. The Partnership did attend an IDA meeting to discuss a proposal. Several members of the IDA expressed concerns about that proposal. There were two issues discussed and one was the exclusivity that the Partnership was looking for. It made sense to the Partnership to withdraw that. It makes sense that if another IDA, Chamber or economic development agency submits a proposal, we want the IDA to have the flexibility to work with them. The Partnership wants to make economic development in Saratoga County as cost effective and user friendly as possible. He explained the fees, how they are collected and disbursed. The Partnership proposed to the IDA to reduce their fee and not pay the Partnership anything. Some

members of the IDA expressed concerns. The agreement before you today is that the Partnership will refund the fee to the business. It makes sense that the IDA and the Partnership to work together. The agreement will be presented to the IDA at their May 20^{th} meeting.

Mr. Barrett cited a section of the agreement that says if a business goes directly to the IDA, the IDA will refer the business to the Partnership. He asked if he was interpreting that portion of the agreement correctly.

Mr. Johnson said that was correct. He said it is a rarity that a business goes right to the IDA but if it does the agreement is asking the IDA to refer that business to the Partnership. Mr. Barrett said hypothetically if there was another economic development agency in the County that happened to submit an application to the IDA than they would be able to follow that application through the process. Mr. Lawler said that was correct.

Mrs. Daly underscored the importance of the resolution presented. This strengthens the opportunities that the IDA has in working directly with the Partnership. She said it's important that we are all on the same path moving forward and have a unified effort to achieve the County's economic development goals. She reminded the Board they created the Capital Resource Corporation which in essence is the sister association of the IDA which has been lock in step with the Partnership.

Mr. Grattidge said after attending the Economic Development meeting last week at the Partnership's Offices and attending the Partnership's Board Meeting, he strongly supports this resolution and said it makes the most sense for the organizations going forward.

Mr. Congdon asked if this will put SEDC out of business. Mr. Wright said absolutely not. Mr. Congdon asked what they could do. Mr. Wright said they could bring any application they would like to the IDA. Mr. Congdon said he read a line in the agreement that still contained the word "exclusive". Mr. Peck explained to Mr. Congdon that the agreement states that if a business goes directly to the IDA, the IDA would then refer the business to the Partnership. He said if the SEDC goes to the IDA with a company, the SEDC will follow the application through the process. This is only if the company goes directly to the IDA. Mr. Collyer suggested a sentence could have been worded a bit differently which may have alleviated some confusion. He does support the Partnership. Mr. Wright said keep in mind this does not happen very often. The IDA is an organization that was developed by this Board of Supervisors. The Partnership was developed by this Board of Supervisors and we fully expect every Board to work together and support each other. He said this does not exclude any one from bringing an application to the IDA.

EXPRESSING STRONG SUPPORT FOR THE SARATOGA COUNTY INDUSTRIAL DEVELOPMENT AGENCY AND THE SARATOGA COUNTY PROSPERITY PARTNERSHIP, INC. ENTERING INTO AN ECONOMIC DEVELOPMENT SERVICES AGREEMENT

WHEREAS, pursuant to Resolution 65-2014, this Board adopted the Saratoga County Economic Development Strategic Plan ("Strategic Plan") to guide economic development efforts throughout Saratoga County over a ten year period; and

WHEREAS, in accordance with the recommendations made in the Strategic Plan, this Board determined pursuant to Resolution 86-2014 to form a local development corporation under which economic development entities in Saratoga County would be united in a true economic development partnership; and

WHEREAS, pursuant to Resolution 106-2014, this Board authorized the formation of the Saratoga County Prosperity Partnership, Inc. ("SCPPI") pursuant to Not-For-Profit Corporation Law §1411 (the "LDC Act") and a Certificate of Incorporation establishing the SCPPI was filed with the New York Secretary of State on May 29, 2014, pursuant to which the SCPPI has been organized for purposes of developing and promoting industry and economic development in the Saratoga County region, including: marketing the County to prospective new businesses; providing a support system of economic development resources to businesses in the County; assisting new and existing firms with access to economic development financing programs; serving as the economic development arm for the County; and promoting, providing and overseeing all economic development activities identified in the Strategic Plan; and

WHEREAS, in furtherance of the Strategic Plan, the County engages and compensates SCPPI for economic development, promotional and marketing services pursuant to an annual Services Agreement; and

WHEREAS, the Saratoga County Industrial Development Agency ("IDA") was established as a public benefit corporation pursuant to by Title 1 of Article 18-A of the General Municipal Law of the State of New York, as amended, and Chapter 855 of the Laws of 1971 of the State of New York, (hereinafter collectively called the "IDA Act") with the authority and power to promote, develop, encourage and assist in acquiring, constructing, reconstructing, improving, maintaining, equipping and furnishing industrial, manufacturing, warehousing, commercial, research, and recreational facilities as authorized by the Act, and in connection therewith to issue its revenue bonds, enter into straight lease transactions and provide other forms of financial assistance; and

WHEREAS, in furtherance of the Strategic Plan, the LDC Act and the IDA Act, SCPPI and the IDA desire to enter into an agreement pursuant to which SCPPI will perform certain economic development services for the benefit of the IDA in connection with projects and applications for financial assistance brought before the IDA from time to time; and

WHEREAS, this Board wishes to express its strong support for the SCPPI and the IDA entering into an economic development services agreement that will further the goals and objectives of the County's Economic Development Strategic Plan; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby expresses its strong support for the Saratoga County Prosperity Partnership, Inc. and the Saratoga County Industrial Development Agency entering into an economic development services agreement, and urges the parties to complete their negotiations and approve such agreement as soon as possible; and, be it further

RESOLVED, that the Clerk of this Board forward copies of this resolution to Martin Vanags, President of the Saratoga County Prosperity Partnership, Inc., John Lawler, Chairman of the Board of Directors of the Saratoga County Prosperity Partnership, Inc., Richard Ferguson, CEO of the Saratoga County Industrial Development Agency, and Rodney J. Sutton, Chairman of the Saratoga County Industrial Development Agency.

BUDGET IMPACT STATEMENT: No budget impact.

No one is better at planning a party or event than Anita. She has always brought new ideas, gimmicks, and prizes to any event or party. We will miss that. Good luck Anita.

Mr. Lucia said he can't do more than echo what has already been said. He wished her well and said he has been neatly tucked into a cocoon for a long time between Jean, Mary Ann and Anita. He wished her well and it's been a pleasure working with her.

Mr. Peck commends Anita for her public service. He believes in giving back to your community and Anita has done an outstanding job. As he looks around the room, there aren't many that have been here longer than he has. Anita is one, Jean yes; anyways, Anita has been a great leader and teacher/mentor for all of us. Congratulations on a great career in public service.

Mrs. Daly she is going on to a good place. Supervisor Wood said earlier change keeps you young and she will remember those words. She has made great friendships and memories. She has tried to serve well with dignity, respect and responsibility. She has not done this by herself. It has been a team effort. Anyone who sits at any one of these seats knows you cannot do what you need to do here unless you have the support, respect and rapport with the people that you work with. She thanked everyone for working with her, including the staff. She thanked Spencer, Marcy and Steve. The County has great, great staff. She knows that the supervisors are not always easy to work for and again thanked the staff. Thank you, Pam for holding it together and keeping us on a level and make us all conform at the standard to make all of the people of Saratoga County proud. Thank you for all of that. Thank you to all of you, my colleagues. It was you and not just me. Change is hard but it's good and will keep me young. She will continue to see you all. She thanked her husband, Bob for all of his support.
