WHEREAS, the approved trail mileage includes a new trail designated as Trail A traversing the Towns of Edinburg, Greenfield and Providence, a reroute of Trail S83 in the town of Edinburg, and a reroute of Trail S83B in the Town of Galway; and

WHEREAS, the proposed modifications to the snowmobile trail system in the County (the "Project") are a Type II Action subject to the requirements of the State Environmental Quality Review Act ("SEQRA") pursuant to 6 NYCRR Part 617; now, therefore, be it

RESOLVED, that the Chair of the Board execute all appropriate documents for application for, acceptance and receipt of a 2017/2018 State Snowmobile Grant-In-Aid Program Grant not to exceed \$89,000 and for its administration by the Saratoga County Association of Snowmobile Clubs; and it is further

AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH ADIRONDACK ENVIRONMENTAL SERVICES, INC. TO INCREASE THE CONTRACT AMOUNT FOR WASTEWATER ANALYSIS SERVICES AND AMEND THE RATES CHARGED FOR SERVICES

WHEREAS, pursuant to Resolution 136-2016, this Board authorized a renewal agreement with Adirondack Environmental Services, Inc. to provide lab testing and wastewater analysis services to ensure Saratoga County Sewer District No. 1's compliance with its State Pollution Discharge Elimination System (SPDES) Permit for the term of June 1, 2016 through December 31, 2017, at a cost not to exceed \$35,000; and

WHEREAS, the Sewer District needs Adirondack Environmental Services, Inc. to conduct additional lab testing and wastewater analysis this year to ensure compliance with the Sewer District's NYSDEC SPDES Permit, the cost of which services will exceed the current contract amount of \$35,000; and

WHEREAS, the cost of these additional testing services when performed by Adirondack Environmental Services, Inc. will exceed the current contract amount by \$20,000; and

WHEREAS, the list of chemicals that the Sewer District must test for is always changing as new chemicals are discharged to the District's treatment plant; and

WHEREAS, it is appropriate that the County's contract with Adirondack Environmental Services, Inc. ("Adirondack") be amended to include a provision that Adirondack shall bill the Sewer District for lab testing and wastewater analysis services at the rates charged by Adirondack at the time Adirondack renders its services to the Sewer District, provided Adirondack attaches its rate sheet in effect at the time the services were rendered to any vouchers submitted to the Sewer District for payment; and

WHEREAS, the Saratoga County Sewer District Commission and the Sewer District's Executive Director have recommended that the contract for testing and wastewater analysis services with Adirondack Environmental Services, Inc. be amended to: 1) increase the contract's amount by \$20,000 to \$55,000; and 2) include a provision that future services are to be invoiced according to the rate schedule in effect at the time services were rendered; now, therefore be it

RESOLVED, that the Chair of the Board is authorized to execute an amendment to the agreement with Adirondack Environmental Services, Inc. of Albany, New York, providing for: 1) an increase in the contract's amount by \$20,000 to \$55,000; and 2) Adirondack Environmental Services, Inc. to charge for its lab testing and wastewater analysis services at its rates in effect at the time the services were rendered to Saratoga County Sewer District No. 1, provided that Adirondack Environmental Services, Inc. shall attach to any voucher submitted to the Sewer District for payment a rate sheet confirming the rates it was charging at the time the services being billed for were rendered; and be it further

RESOLVED, that the form and content of such amendment shall be subject to the approval of the County Attorney.

AUTHORIZING THE COMMENCEMENT OF LITIGATION AGAINST TOWN AND COUNTRY CONSTRUCTION CO. OF SCHAGHTICOKE, INC. D/B/A DRAIN CARE FOR THE RECOVERY OF UNPAID FEES FOR SERVICES RENDERED BY SARATOGA COUNTY SEWER DISTRICT NO. 1

WHEREAS, the Saratoga County Sewer District No. 1 ("SCSD1") accepted and treated septage discharge from Town and Country Construction Co. of Schaghticoke, Inc. d/b/a Drain Care up until August 8, 2016; and

WHEREAS, Town and Country Construction Co. of Schaghticoke, Inc. d/b/a Drain Care has accrued an unpaid balance owed to SCSD1 totaling \$7,046.46 through May 5, 2017, which amount includes interest and late payment penalty charges at the rate of 5% per month; and

WHEREAS, the Saratoga County Sewer District Commission and SCSD1's Executive Director have recommended that the County commence litigation against Town and Country Construction Co. of Schaghticoke d/b/a Drain Care in an attempt to recover the unpaid balance of \$7,046.46 plus interest and penalties accruing thereon; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby authorizes the County Attorney to commence legal action, and take any and all lawful action necessary, against Town and Country Construction Co. of Schaghticoke, Inc. d/b/a Drain Care to collect unpaid septage fees, penalties and interest in the amount of \$7,046.46 owed through May 5, 2017 to Saratoga County Sewer District No. 1 for the acceptance and treatment of septage discharge, together with any lawful interest and penalties accruing thereon.
