Board called to order by the Clerk.

The invocation was given by Thomas N. Wood, III, Chaplain.

On a motion by Mr. Wood, seconded by Mr. Lucia, Arthur Wright was named Temporary Chairman by a unanimous vote.

Mr. Tollisen said "I would like to nominate Supervisor Edward D. Kinowski from the Town of Stillwater as Chairman of the Saratoga County Board of Supervisors for another year in 2018.

To give a brief history, Supervisor Kinowski's parents, Edward and Agnes Kinowski raised six children Ed's father established and operated the Kinowski Insurance Agency for many years.

Ed is a retired Vice Commander of the 109th Airlift Wing, based in Glenville. He is also a Brigadier General in the Reserves.

During Ed's eight years on the County Board of Supervisors, he has been a leader, and one who has been instrumental in the establishment of the Saratoga County Prosperity Partnership, the sale of Maplewood Manor and the Northumberland landfill, and in pursuing the design and construction of the new Public Safety Building.

In his hometown, he worked with his fellow town board members and members of the community together to purchase, restore and revitalize Brown's Beach: know known as the Stillwater Town Park which brings thousands of visitors to the County.

It is my distinct honor and pleasure to nominate Edward D. Kinowski as Chairman of the Saratoga County Board of Supervisors for the year 2018. Thank you."

Mr. Lent seconded the motion. By a unanimous vote, Edward D. Kinowski was appointed Chairman of the Board for 2018.

Mr. Lawler and Mr. Peck escorted Mr. Kinowski to the podium where he was administered the oath of office, along with his wife Kathy by the Honorable Edward Richardson.

"Good Afternoon, Happy New Year to all and thank you for joining us today as we begin, what I am sure, will be another challenging and rewarding year for Saratoga County. The start of a new year is always an exciting time and this year is no different. I am looking forward to the numerous opportunities that lie ahead, and with your support, am confident we'll be able to achieve our goals. To my fellow supervisors, thank you for the opportunity to serve as your Chair for a second year. It is a great joy and high honor to stand before you today. I proudly accept the nomination as Chairman of the Board. I continue to be humbled and enthusiastically ready to lead the board as we move forward together in 2018. I am energized by your support and trust, and assure you of my pledge to honor this trusted position with the integrity it deserves and through service before self. I will work hard, and as a team, help us to succeed in our efforts to serve all the residents of Saratoga County. Before I describe several of the important things we have planned for 2018, I would like to introduce and thank some of the people that are here today. I would like to begin by thanking the Honorable Edward W. Richardson for administering my oath of office. Judge Richardson has supported the Town of Stillwater and Saratoga County for a number of years; and, with his help, will be administering the Oaths for our Town elected officials on Thursday – Many thanks Ed!

Family and friends are an integral part of our lives. They support us, make fun of us, but most importantly Love us for who we are! That said, I would like to introduce my wife, friends, and Stillwater family. To my wife Kathy—I guarantee, just this one more year.... To my friends – thanks for listening, and please, don't repeat.... To my Stillwater Family -- I am here for you and we will work as a team to enhance our future.

I am surrounded in this room by wonderful colleagues on the Board of Supervisors. You are each highly skilled, hardworking, and dedicated individuals and together as a team are unstoppable. You set the bar for professionalism and are a true pleasure to work with. In addition to my fellow supervisors, I am surrounded by a team of county department heads, who know their jobs well and perform them with excellence. Working together our elected officials and public servants will continue to effectively and efficiently provide quality services to our residents. I have thought for a considerable time about the terms and words that I would use to characterize the upcoming year. I am optimistic but also realistic. We will have to be steady and deliberate in our actions. We started a number of initiatives in 2017 with significant importance placed on Planning and designing a new combined Public Safety Facility and coordinating efforts to combat a most hideous Opioid crisis. These initiatives and many other will require a stern focus on maintaining best use of our resources and yet modernizing to meet current and future demands.

Historically, this Board has always taken a very judicious approach towards investing County resources in the services we provide. It is a well-known fact that all of the property tax paid by our residents is used solely to pay for State mandated programs like Medicaid, state retirement system, and Community College tuition. Unfortunately, NYS is still one of only a handful of states that forces County government to pay a portion of these costs. In 2018, that portion will be \$94 million and with a net cost of \$60.7 million after subtracting the state aid we're forced to spend all of our property tax collections plus \$2 million in fund balance to pay for their programs. Getting back to my comments regarding our discretionary spending, this year I am very happy to report, we will be able to not only enhance our core services, but make ongoing improvements to our countywide infrastructure. A new Virtual Reality Stadium, High Speed Rail and Facility Heliports.......Well, maybe one day? But, for now, we'll stick to roads, bridges, and our water & sanitary sewer systems.

In addition, we are moving methodically closer to breaking ground this Spring on our new Public Safety Building. This facility brings Public Safety in Saratoga County into the 21st Century and appropriate departments under one roof to increase effectiveness of services to residents.

This new building will provide space for five departments, which are currently housed in overcrowded, outdated, and inadequate spaces.

- Sheriff, Public Health, Emergency Services, Probation, and 9-1-1 Services
- There will be space for inter-departmental training
- Built for growth allowing the departments to grow in pace with population to best serve the residents
- Will also provide for necessary upgrades to our 9-1-1 radio system

In 2010, the U.S. census reported Saratoga County's population growth at 9.6%; the fastest in the entire state. We are on track to experience similar growth in 2020. So, it only makes sense to plan for that eventuality in everything we do. We must think – Modernize, Streamline and revolutionize – to retain our superior fiscal strength and quality of service.

I have proposed several new initiatives for 2018 and most of these will be described under committee assignments. However, I think one of the most critical ones, which we can all agree on, is doing our part to reverse the addictive and destructive trend of Opioid abuse. It has taken a heavy toll on individuals and families across our great nation and our County is not immune from its impact.

It was reported by federal officials this past December that life expectancy in the U.S. fell for the second year in a row in 2016, nudged down again by a surge in fatal opioid overdoses. The last time the U.S. life expectancy

dropped was in 1993 because of the AIDS epidemic. Life expectancy hasn't fallen two years in a row in the U.S. since the early 1960s.

We all recognize that the drug overdose problem is a public health problem, and it needs to be addressed on a level beyond what we are currently able to provide through our law enforcement, mental health, and public health departments.

This Board has authorized litigation against the manufacturers and distributors of opioids, which we have all seen drive unprecedented levels of addiction and death. In 2018, we will be doing everything within our power to hold the drug manufacturers and distributors that have recklessly engaged in behaviors that have caused this epidemic, accountable for their actions.

To deal with some of the ongoing challenges facing us in 2018 it will be desirable to reappoint some of our 2017 Committee chairs for another year. The knowledge these supervisors have and the stability they can provide to their respective committees will be invaluable. In addition, experienced supervisors are strategically assigned to provide needed background and input. I sincerely tried to put as many supervisors on the committees they requested.

Most of you will be on the committee that was your first choice and with the consolidation of the Public Health and Social Programs committees into a new Health & Human Services Committee about half of you will serve on 3 committees and the other half will serve on 4 committees.

I value each and every supervisor. I did my best to place you in positions where we can maximize your skills and knowledge; and be of greatest service to the county.

--Our new Chair of the Law and Finance Committee will be Kevin Tollisen. Kevin is an extremely hard worker and brings to the position a broad legal background and has an extensive knowledge of county government. I will rely heavily upon him for his support of our 2018 goals. The stated purpose of the Law and Finance Committee is to have general supervision over all matters where County funds, rules of the board or laws are concerned, and review the Annual Budget for consideration by the Board.

--I am asking Supervisor Lent to continue as our Chair of the Public Safety Committee. His insight and experience, in the public safety and communications realm, will be essential as we undertake an assortment of law enforcement and public safety initiatives; and particularly programs to address the Opioid epidemic. We must be vigilant to maintain our status as one of the safest place to live and work in the region and in the country. I am also expecting Paul and this committee to maintain a presence in the Public Safety building project to ensure that all of the departmental needs are prioritized as the process moves forward.

--During the last year our Human Resources & Insurance committee and HR Department worked aggressively to find and take advantage of opportunities that translated into hundreds of thousands of dollars in labor and benefit costs. In addition, one of the less glamorous initiatives was succession planning for all of the County Departments. The Committee approved various ways to incorporate strategies for recruitment, retention, and training and development to ensure the most efficient and effective means of County operations. I could go on and on because this committee was very busy; but, I'll stop here to let all of you know I have re-appointed Supervisor Wood. He has shown a real aptitude for this work and seems to enjoy spending the countless hours required to prepare for the monthly meetings to oversee our labor and insurance needs.

--In the area of economic development, growth opportunities are availing themselves through the hard work of our Prosperity Partnership the official economic development agency representing Saratoga County. Together, with local Industrial Development agencies, area Chambers of Commerce, and other economic engines our county will provide the resources that will allow our existing businesses to prosper, while giving new companies a reason to become a part of the Saratoga County business community. In the end we want to minimize the risks for our business owners and in return grow the jobs, commodities, and the variety of services they'll be able to provide. I am appointing Matt Veitch to Chair the Economic Development Committee. Matt is a former Board Chair, and has served on all of our standing committees. In addition, he has also been on numerous regulatory, special, and ad hoc board's that make him more than capable of helping Saratoga County continue to grow and prosper in local, regional, and global economies.

--In the area of Building and Grounds I am reappointing Supervisor Bill Peck to continue as our Chair of this Committee to make sure we stay on track with the approval process for construction of the Public Safety building this year. This facility brings the building infrastructure in Saratoga County into the 21st Century by locating the Sheriff, Public Health, Emergency Services, Probation, 9-1-1 Services under one roof to increase effectiveness of these essential services to our residents.

This is a partial list of the standing committee chairs: the full list of all the assignments will be distributed shortly. Although I haven't mentioned each and every committee, they are all equally important and the chair and members equally competent. In order to develop and execute the various initiatives for the common good of the people of Saratoga County, I will rely on these committees and their Chairs.

So fellow supervisors, that's a brief outline of plans for next year. I am sure issues will develop that we haven't yet contemplated. The key to our success will be to remain true to our basic values and continue on a steady, well planned, path to prosperity.

Again, I thank each of you for your support and look forward to a very productive 2018. Thank you and God Bless.

Chairman Kinowski asked the County Attorney to present the Rules of the Board. Mr. Dorsey presented the rules and spoke of the changes made for 2018. On a motion by Mr. Johnson, seconded by Ms. Raymond the Rules of the Board and Standing Committee Duties were adopted by a unanimous vote.

RULES OF THE BOARD

1. The Board shall convene for its regular and Agenda meetings in its room at Ballston Spa, New York, as follows:

(a) The Board shall convene for its regular meeting at 4:00 o'clock in the afternoon of the third Tuesday of every month, unless a different time shall have been determined at a previous meeting. The Board's regular meeting for February shall convene at 4:00 o'clock in the afternoon of the fourth Tuesday.

(b) The Board shall convene at 4:30 o'clock in the afternoon of the Wednesday preceding the Board's regular meeting for the purpose of setting the agenda for its regular monthly meeting. The Board's Agenda meeting for February shall convene at 4:30 p.m. in the afternoon of the third Wednesday of the month.

- (c) Meetings shall be called to order as soon thereafter as a quorum is present.
- 2. The order of business at Regular and Agenda meetings shall be as follows:
 - a. <u>Regular Meetings</u>:
 - 1. Calling of the roll of members
 - 2. Approval of minutes of prior meetings
 - 3. Presentation of public comment, petitions and communications
 - 4. Reports of committees
 - 5. Motions, resolutions and notices
 - 6. Miscellaneous and unfinished business
 - b. <u>Agenda Meetings</u>:
 - 1. Calling the roll of members
 - 2. Approval of minutes of prior meetings
 - 3. Adoption of proposed Agenda approved by Law and Finance Committee
 - 4. Motions and notices
 - 5. Any other business

3. The Board shall be called to order by the Chair at Regular meetings and by the Vice-Chair at Agenda meetings, and the roll called. A quorum being present, the minutes of previous meetings, when available, shall be approved and any errors therein shall be corrected. A quorum shall be defined as being at least 12 members present representing over one-half of the Board's total weighted vote.

4. Any member who enters the room after the roll call shall be entitled to take a seat after being recognized by the Chair, and the Clerk shall note the member's presence in the minutes.

5. No member shall withdraw from the session without leave being granted by the Chair.

6. The following rules shall govern the appearance of persons who desire to address the Board of Supervisors or any of its Committees:

(a) Any person may address any Committee meeting with twenty-four (24) hours' prior notice to the Chair of such Committee. The Chair may waive the prior notice requirement.

(b) No person shall be permitted to address a regular, Agenda or special meeting of the Board of Supervisors unless twenty-four (24) hours' prior notice is given to the Clerk of the Board setting forth the identity of such person or organization and the nature of the subject matter to be presented to the Board. Regardless of the provisions set forth herein relating to twenty-four (24) hours' prior notice, any person shall be permitted to address a meeting of the Board with the approval of a majority of the total weighted votes of the Board. Speakers will be limited to three (3) minutes, unless their time is extended by the Chairman. Speaking time may not be transferred from one speaker to another. Commercial solicitations to the Board shall be prohibited. All written comments will be accepted and filed with the meeting minutes.

(c) Any person wishing to speak at a public hearing held by the Board must sign their name and address on a sign-up sheet for speakers on the date and at the time of the scheduled public hearing. Oral comments will be limited to three (3) minutes. Speakers will be called in the order in which they sign up. Speaking time may not be transferred from one speaker to another. All written comments will be accepted and included in the minutes of the hearing.

(d) The Chair of the Board and of each Committee shall have the right to establish other rules and reasonable time limits governing the appearance of persons before the Board and/or respective Committees.

7. All resolutions presented to the Board shall be in writing with the name of the member(s) presenting such appearing thereon, and the Clerk shall enter the names of the moving members in the minutes.

8. Final action shall not be taken on the annual budget until at least ten (10) days shall have elapsed after a printed or typewritten copy thereof shall have been placed on the desk of each Supervisor.

9. No member shall be allowed to debate upon any report, resolution or notice, or amendment or subsidiary motions thereto, or otherwise hold the floor at a Board meeting, for a longer period than five (5) minutes without the consent of the majority of the members present.

10. All resolutions and reports of Committees shall be numbered consecutively by the Clerk as presented. With respect to each resolution, the Clerk shall read the name of the Committee introducing the resolution, the title of the resolution, all Resolved paragraphs, and the budget impact statement. The reading by the Clerk of the Resolved paragraphs of a resolution or resolutions may be waived on motion of any member, duly seconded, and approved by voice vote of a majority of the members present.

11. The ayes and noes shall be recorded on all resolutions and reports of committees, and on any question, the ayes and noes shall be recorded if requested by any member. Such votes shall be recorded in accordance with Local Law 2-68, as amended, which establishes the weighted vote of each member. Any member may request a separate vote on any resolution. A request for a separate vote shall not require a second.

12. The following standing Committees shall be appointed by the Chair:

13. The Chair of the Board shall be a member ex-officio of all Committees, and the Clerk of the Board shall be directly responsible to the Chair. With respect to all standing Committees, a quorum shall consist of a simple majority of its members. Whenever a quorum of a standing Committee is at a meeting properly called or provided for, a majority vote of the members present shall be sufficient to make the act the act of the Committee.

14. When any standing Committee is acting on matters affecting only a single Town or City, or is engaged in obtaining rights of way, the Supervisor or Supervisors of the Town or City affected shall be a member of said Committee.

15. All resolutions to be presented for consideration of the Board shall, so far as possible and practicable, be delivered to the Clerk by 12:00 o'clock Noon on the Monday preceding the Board meeting. The Clerk will prepare an agenda of resolutions and place a copy on the desk of each Supervisor prior to the opening of the meeting. Any resolution not so presented may be considered by the Board during the "Miscellaneous and unfinished business" portion of the Board's meeting agenda upon the motion of any Supervisor, which is duly seconded, and approved for addition to the agenda by a majority of the weighted vote of the Board.

16. At the Organization meeting of the Board, held in accordance with the provisions of §151 of the County Law, the Board shall select a Chair and a Vice-Chair. In the absence of the Chair, the Vice-Chair shall assume the duties of the Chair. The duties to be performed by the Vice-Chair shall be as follows:

- (a) preside over each duly constituted meeting of the Board
- (b) have and exercise all the powers and duties of the Chair at any meeting over which the Vice-Chair is called to preside;
- (c) execute as Acting Chair any and all documents and agreements authorized to be executed by the Chair of the Board of Supervisors
- (d) have and exercise those additional powers and duties authorized by Resolution of the Board, provided such Resolution shall specify:
 - (i) the dates during which such Vice-Chair may exercise those powers and duties; and
 - (ii) that the powers and duties authorized to such Vice-Chair shall not be exercised by the Chair during that designated time period.
- 17. The duties and functions of the standing Committees of the Board shall be as follows:

1. <u>BUILDINGS AND GROUNDS COMMITTEE:</u> To have charge of all County property, its use, maintenance, renovation, space allocation, repairs and replacement, including maintenance operation or development of the Saratoga County Airport; to oversee and approve all lease agreements involving the County of Saratoga; to oversee parking regulations and facilities; and supervise the provision of construction, technical, engineering and legal services necessary or appropriate for construction of County facilities.

ECONOMIC DEVELOPMENT COMMITTEE: To have supervision over County planning 2. matters and activities as provided under §220 of the County Law and Article 12(b) of the General Municipal Law; to meet periodically with the County Planning Board for the purpose of correlating its activities and objectives; to have general cognizance of all matters relating to the preservation and improvement of the environment; to maintain liaison with the Environmental Management Council; generally managing and dealing with all matters of transportation, excluding those assigned to the Public Works Committee; to act as liaison with the Capital District Transportation Authority; to handle matters under the Mass Transportation Act; to develop, as the need arises, long range plans affecting any forms of transportation within the County; to work in conjunction with various County publicity and promotion committees in fostering continuous publicity for the County and to formulate a County promotion program; to consult with industrial and business firms regarding matters of mutual interest and concern; to assist local efforts to attract new business and industry to the County in a continuous effort to improve the commercial and industrial climate of the area; to foster the creation and oversee the implementation of a Saratoga County Economic Development Strategic Plan; to have general supervision over the operations of the County's Office of Employment and Training; to meet periodically with and to maintain liaison with appropriate economic development organizations and to make such recommendations to the Board of Supervisors as it deems in the best interests of the County; to have general cognizance of all matters relating to preservation and improvement of agriculture and husbandry, propagation of fish and game birds, reforestation projects and care of trees, forest fires, bounties, soil conservation, extension service, and to meet periodically and maintain liaison with Boards of Directors of County Extension Association, Soil Conservation District and County Fair.

3. <u>LAW AND FINANCE COMMITTEE:</u> To have general supervision over all matters where County funds, Rules of the Board or laws are concerned; to review the tentative Annual Budget for the consideration of the Board; to have general supervision over matters pertaining to the offices of County Auditor, Budget Officer, County Treasurer, County Clerk and County Attorney; to have general oversight over matters related to the operation of Saratoga County Sewer District No. 1 and matters referred to the Board of Supervisors by the Saratoga County Sewer District Commission; to supervise negotiations with employees organizations; to coordinate Committee programs and to make recommendations relative to office management, equipment and personnel; to have jurisdiction over all referred matters from any ad hoc or special Committee created by either the Chairman or the Board; to have initial jurisdiction over all referred matters not specifically within the jurisdiction of another Committee, and to confer with the Chair and members of a Committee when a matter overlaps or infringes on the functions of such Committee.

4. <u>LEGISLATIVE AND RESEARCH COMMITTEE</u>: To confer with members of other legislative bodies; to urge such bodies to approve or disapprove legislation affecting the County of Saratoga; to attend sessions of other legislative bodies, particularly the State Legislature; to examine all proposed legislation affecting the County or any of its subdivisions; to report to the Board for its approval or disapproval of such legislation; to maintain liaison with Boards of Supervisors of other counties; to promote, chart and improve the scope, efficiency, effectiveness and economy of County government and to recommend means of improving the coordination of the entire County operation and of its various departments with each other.

5. <u>HEALTH AND SOCIAL SERVICES</u>: To oversee generally all County health programs, including the Physically Handicapped Children's program; to consult with the County Community Services Board; and to have general supervision over the operations and programs of Saratoga County Public Health Services and Saratoga County Mental Health and Addiction Services. To have general supervision over the operations of all agencies and departments now or hereafter involved with social programs, including the Social Services department, Office for the Aging and Youth Bureau; to maintain liaison with federal and state agencies in connection with such programs; to recommend any changes in personnel or appropriations required for the efficient operation of the said County departments; to hear any member's recommendations to the Board of Supervisors in connection therewith; to explore all federal and/or state social programs applicable to the County,

its departments or municipalities; to make recommendations to the Board of Supervisors as to the advisability of County participation and to forward pertinent data thereon to other interested County municipalities.

6. <u>HUMAN RESOURCES & INSURANCE COMMITTEE</u>: To have general supervision over all county personnel matters; to have charge of safety concerns regarding county personnel and property; to have charge of a County Risk Management Program; to have jurisdiction over all county liability insurance; to supervise county compliance with the Occupational Safety and Health Act; to have jurisdiction over the Saratoga County Workers' Compensation Plan and to advise and assist the Workers' Compensation Administrator in the management of the Workers' Compensation Plan; to oversee and make recommendations regarding the creation, abolishment and reclassification of job descriptions and regarding the functions, staffing and salaries for county departments; and to review and evaluate compensation and performance of county employees who are not members of collective bargaining units, including county officials and department heads.

7. <u>PUBLIC SAFETY COMMITTEE:</u> To have supervision over County matters pertaining to the Courts, law enforcement and emergency services agencies, including the Sheriff's department, District Attorney, Supreme, County, Surrogate and Family Courts, Public Defender, Probation Department, Supreme Court Library, Commissioner of Jurors, Civil Defense, Office of Emergency Services, the County's emergency radio communications system, and the operation of the County Animal Shelter.

8. <u>PUBLIC WORKS COMMITTEE:</u> To consider all requests and recommendations made by the County Commissioner of Public Works as to order and type of roads to be constructed, programs and projects for road construction, reconstruction or maintenance; snow and ice control; purchase of machinery; acquisition of rights of way for State and County highways; to confer with State officials with reference to location of proposed State highways within the County; to provide requested engineering services to other County departments; and to supervise the privatization of the County's recycling program.

9. <u>RACING AND GAMING COMMITTEE</u>: To consider matters related to the horse racing and electronic gaming industries in Saratoga County and to oversee and develop County policies and activities in support of the racing and electronic gaming industries in Saratoga County; and to make such recommendations to the Board of Supervisors as it deems in the best interests of the County.

10. <u>REAL PROPERTY TAX COMMITTEE</u>: To have general oversight of the County's real property tax enforcement proceedings, including setting the dates of the County's real property auctions, reviewing tax delinquent parcels that may be acquired through the tax foreclosure process, approving requested second pulls of parcels from the County's real property auction, approving repurchase offers for tax acquired properties, approving the results of the County's real property auction, approving the pre-auction conveyance of a tax acquired parcel to an authorized municipal or public entity which is not the former owner of such parcel, and, when appropriate, recommending to the Board alternatives to the disposition of tax acquired parcels for municipal purposes; review the reports of the County Auditor as to all tax refunds paid by the County Auditor in amounts up to \$2,500; recommending to the Board the approval of any requested tax bill corrections, tax refunds, or tax credits over the amount of \$2,500; recommending to the Board the appropriate action to be taken relative to any new tax exemptions or changes in current tax exemptions; and maintaining a Manual of Policies and Procedures of the County.

11. <u>VETERANS AFFAIRS COMMITTEE</u>: To oversee all programs for military veterans throughout the County; to confer with members of other legislative bodies on appropriate benefits for military veterans; to conduct suitable events to honor and memorialize veterans.

On a motion by Mr. Szczepaniak, seconded by Mr. DeLucia, Kevin Tollisen was unanimously elected Vice Chairman of the Board of Supervisors for 2018.
