PUBLIC INPUT: Chairman Kinowski called the speakers.

Darlene McGraw – Saratoga Springs: Ms. McGraw thanked Saratoga County, particularly the Department of Social Services for putting ribbons out this month in honor of Child Abuse Prevention Month which is also Autism Awareness Month. She told the Board of law enforcement training that is upcoming. Ms. McGraw hoped that all of Saratoga County properties become smoke free and hopes Saratoga County remains the healthiest in the State.

Patty Garret – Saratoga Springs: Ms. Garret said she was there to speak for the League of Women Voters. She said the League has had a long time interest in transparency for local governments and applauds the efforts Saratoga County has made with providing information on the County's website. Ms. Garret provided a few suggestions the League would like to see on the County's website.

Gordon Eger – Saratoga Springs: Declined comment.

James Boshek – Malta: Mr. Boshek said he was the successful bidder on a 53-acre parcel in the Town of Wilton from the County's Auction. He thanked the Board for the opportunity to speak and told the Board he has been a sportsman all his life. He said he and his family enjoy outdoor activities such as hiking, biking and fishing. Mr. Boshek said they are excited about this property even though they may have difficulty in accessing it. He said he is confident the best outcome will come of it.

Tom Klepetar – Wilton: Mr. Klepetar thanked the Board for the opportunity to speak. He said he is one of the adjoining landowners of the property in Wilton that was previously mentioned. He spoke of a trail Saratoga Plan has been working on and asked the Board to object to the sale of the auction property. Mr. Klepetar said Saratoga County should hold the property as that's what's in the best interest of the County.

Marty Vanags, Executive Director of the Saratoga County Prosperity Partnership gave a presentation on Next Wave Communities. He has offered to develop a specific economic plan for the municipalities in the County. Mr. Szczepaniak asked what the time frame would be. Mr. Vanags said the interview process would take 4 to 5 months and for the plan it would be 3 to 5 years.

AUTHORIZING THE ACCEPTANCE OF A GRANT FROM THE NEW YORK STATE OFFICE OF TEMPORARY AND DISABILITY ASSISTANCE FOR THE PROVISION OF SHELTER TO THE HOMELESS DURING INCLEMENT WINTER WEATHER, AUTHORIZING AN AGREEMENT WITH SHELTERS OF SARATOGA, INC. FOR SHELTER SERVICES, AND AMENDING THE BUDGET IN RELATION THERETO

WHEREAS, pursuant to Resolutions 67-2016 and 131-2017, and in compliance with Governor Andrew M. Cuomo's Executive Order 151, this Board authorized contracts with Shelters of Saratoga, Inc. ("SOS") to provide funding assistance for SOS's operation of the Saratoga Code Blue Shelter, and the provision of shelter and shelter services to homeless individuals whenever inclement winter weather temperatures are at or below 32 degrees Fahrenheit, inclusive of National Weather Service calculations for windchill; and

WHEREAS, New York Codes, Rules and Regulations Part 304 and Section 304.1 of Title 18 directs local social services districts to continue to take all necessary steps to provide shelter for homeless individuals and families during periods of inclement winter weather including those individuals and families that are not otherwise eligible for emergency housing through normal public assistance programs, whenever inclement winter weather temperatures are at or below 32 degrees Fahrenheit for the time period/budget year of October 1, 2017 through September 30, 2018, and to submit plans that would meet said requirements; and

WHEREAS, grant funds from the New York State Office of Temporary and Disability Assistance ("OTDA") in the amount of \$163,479.50 are available to our County Department of Social Services for the provision of shelter and shelter services to the homeless in order to facilitate local compliance with Part 304 and Section 304.1 of Title 18 of the New York Codes, Rules and Regulations; and

WHEREAS, our Commissioner of Social Services proposes utilizing said OTDA grant funds to: 1) enter into a contract with Shelters of Saratoga, Inc. to provide funding assistance in the amount of \$149,679.50 to cover the costs associated with operating the Saratoga Code Blue Shelter for the time period October 1, 2017 through September 30, 2018; 2) cover any additional costs up to \$10,200 the Department of Social Services might incur for sheltering individuals or families that are not otherwise eligible for emergency housing and not able to be housed at the Code Blue Shelter; and 3) apply the remaining \$3,600 towards DSS staffing costs related to sheltering the homeless during inclement winter weather; and

WHEREAS, our Health and Social Services Committee has recommended that this Board approve the Commissioner's plan for compliance with Part 304 of Title 18 of the New York Codes, Rules and Regulations; and

WHEREAS, the acceptance of these State OTDA grant funds requires our approval and an amendment to the 2018 County Budget; now, therefore, be it

RESOLVED, that the Chair of the Board and/or the Commissioner of Social Services are hereby authorized to execute any and all documents required to accept from the New York State Office of Temporary and Disability Assistance a grant in the amount of \$163,479.50 for the provision of those shelter and shelter services to the homeless needed to comply with Part 304 of Title 18 of the New York Codes, Rules and Regulations; and, be it further

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Shelters of Saratoga, Inc. for the reimbursement and payment of expenses associated with sheltering the homeless in compliance with Part 304 and Section 304.1 of Title 18 of the New York Codes, Rules and Regulations, for the term October 1, 2017 through September 30, 2018 at a cost not to exceed \$149,679.50; and, be it further

COUNTY OF SARATOGA - LOCAL LAW - 2018

A LOCAL LAW AUTHORIZING THE SALE OF REAL PROPERTY OF THE COUNTY OF SARATOGA TO SKIDMORE COLLEGE

BE IT ENACTED by the Saratoga County Board of Supervisors as follows:

SECTION 1. TITLE

This Local Law shall be known as "A Local Law Authorizing the Sale of Real Property of the County of Saratoga to Skidmore College".

SECTION 2. LEGISLATIVE FINDINGS AND INTENT

- a. The County of Saratoga is the owner of real property located in the City of Saratoga Springs along County Road 67, also known as Staffords Bridge Road, consisting of a public right of way 50-55 ft. in width from the edge of road's pavement and 979± ft. in length, which is adjacent to real property owned by Skidmore College identified on the Tax Maps of the City of Saratoga Springs as Section 167.00, Block 3, Parcel 17 and Section 167.00, Block 3, Parcel 12, hereinafter referred to as the "Skidmore Property", upon which Skidmore College maintains a boat house and related facilities accessible to Fish Creek.
- b. Skidmore College desires to purchase a portion of the County's public right of way consisting of a strip of land 26 ft. in width and 979± ft. in length, totaling .584± acres, adjacent to the Skidmore Property, for purposes of expanding Skidmore College's boat house facilities by the construction of two new buildings and a parking lot.
- c. The Saratoga County Board of Supervisors hereby finds and determines that said .584± acre parcel, which is more fully described in Section 3 below, is no longer needed for the County's public use.
- d. The County of Saratoga has obtained a real estate appraisal for the conveyance of a fee interest in the .584± acre parcel from a New York State certified real estate appraisal company, Stroop Appraisal, which estimates the market value of the appraised compensation for said parcel to be \$9,000.
- e. The Saratoga County Board of Supervisors hereby finds and determines that the appraised value of \$9,000 is fair and adequate consideration for the sale and conveyance of the .584± acre parcel to Skidmore College.

SECTION 3. LEGAL DESCRIPTION OF PARCEL TO BE CONVEYED

The parcel to be conveyed by the County of Saratoga to Skidmore College is more particularly described as follows:

All that tract or parcel of land situate in the City of Saratoga Springs, Saratoga County, NY, bounded and described as follows:

Beginning at a concrete monument found at the intersection of the westerly line of County Road No. 67 aka Stafford Bridge Road and the southerly line of County Road No. 65 aka Meadow Brook Road, being the northwesterly corner of the lands herein described. Thence through the lands of the grantor the following four courses:

N85°31'59"E, 26.00 feet to a point S04°28'01"E, 378.55 feet to a point S05°46'48"E, 600.08 feet to a point S84°13'12"W, 26.00 feet to a point

Thence along the easterly line of lands of Skidmore College as recorded in the Saratoga County Clerk's Office in Book 1122 of Deeds, page 57, N05°46'48"W, 600.38 feet to a concrete monument found. Thence along the easterly line of lands of Skidmore College as recorded in Book 1122 of Deeds, page 59, N04°28'01"W, 378.85 feet to the point of beginning. Containing 25,452 square feet or 0.584 acres of land.

SECTION 4. AUTHORIZATION TO SELL AND CONVEY COUNTY REAL PROPERTY TO SKIDMORE COLLEGE

Notwithstanding the provisions of Section two hundred fifteen of the County Law, or any other law of the State of New York, the Saratoga County Board of Supervisors hereby authorizes the sale of the real property of the County of Saratoga described in Section 3 of this Local Law to Skidmore College for the sum of \$9,000, and further hereby authorizes the Chairman of the Saratoga County Board of Supervisors to execute a real estate sale contract, deed and any other required documents needed to convey a fee interest in said real property to Skidmore College. Said contract, deed and related documents are to be subject to the approval of the County Attorney, and shall include a reservation of rights in the contract and deed to the Saratoga County Department of Works to continue to use: 1) any driveway servicing the parcel to be conveyed, and 2) when needed, areas of the parcel away from the Skidmore College boathouse facilities for Department of Public Works equipment parking and staging for highway purposes.

This Local Law is subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law.

SECTION 6. SEVERABILITY

If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, or business shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this law, or in its specific application.

SECTION 7. EFFECTIVE DATE

This Local Law shall take effect after it is filed as provided in Section 27 of the Municipal Home Rule Law.

RESOLVED, that the Saratoga County Board of Supervisors hereby authorizes the sum of \$991,379 to pay in the first instance 100% of the federal and non-federal share of the cost of Design and Construction/Construction Inspection work for the Project or portions thereof; and it is further

RESOLVED, that the Saratoga County Board of Supervisors hereby agrees that the County of Saratoga shall be responsible for all costs of the project which exceed the amount of the NY Bridge Funding awarded to the County; and it is further

RESOLVED, that the sum of \$151,998 has been previously appropriated pursuant to Resolution 119-2017 and made available to cover the cost of participation in the Design phase of the Project; and it is further

RESOLVED, that the additional sum of \$839,381 is hereby appropriated from the County's Highway Fund and made available to cover the cost of participation in the above phases of the Project; and it is further

WHEREAS, pursuant to Saratoga County Board of Supervisors Resolution 28-13 adopted on January 15, 2013 (the "County Authorizing Resolution"), the County authorized the disposition of certain real estate and related improvements and equipment known as the Maplewood Manor Nursing Home (collectively, the "Facility") to the Corporation; and

WHEREAS, pursuant to a certain Purchase and Sale Agreement with Acknowledgment and Guaranty, dated as of December 16, 2013, as amended, the Corporation completed the sale of the Facility to Ballston Two, LLC (the "Purchaser") as of January 31, 2017; and

WHEREAS, by resolutions adopted March 21, 2018, the Corporation authorized (i) the transfer of \$9,220,408.00 in sale proceeds (the "Sale Proceeds") to the County, and (ii) initiation of the dissolution of the Corporation in accordance with the N-PCL (the "Dissolution"); and

WHEREAS, consistent with the mission and purposes of the Corporation, and with the sale of the Facility completed, the County, as sole member of the Corporation, desires to authorize (i) the acceptance of the Sale Proceeds, and (ii) authorize the Dissolution; now, therefore, be it

RESOLVED, that the County, as sole member of the Maplewood Manor Local Development Corporation, hereby authorizes the acceptance of the Sale Proceeds and the Dissolution to be undertaken by the Corporation in accordance with the N-PCL, whereby all remaining assets and liabilities of the Corporation shall be assumed by the County.

<u>BUDGET IMPACT STATEMENT</u>: The transfer will be booked as a General Fund revenue in the amount of \$9,220,408 and will be reserved as an offset to retiree health care costs.

A Not-For-Profit Local Development Corporation under Section 1411 of the Not-For-Profit Corporation Law of the State of New York

THE UNDERSIGNED, being over the age of eighteen years, for the purpose of forming a not-for-profit local development corporation pursuant to Section 1411 of the Not-For-Profit Corporation Law of the State of New York, hereby certifies as follows:

FIRST: The name of the corporation shall be: Maplewood Manor Local Development Corporation.

SECOND: The corporation will be a corporation as defined in subparagraph (a)(5) of Section 102 of the Not-For-Profit Corporation Law of the State of New York and, as provided in Section 1411 of the Not-For-Profit Corporation Law, will be a Type C Corporation as defined in Section 201 of the Not-For-Profit Corporation Law. The corporation is a public instrumentality of, but separate and apart from, the County of Saratoga, New York.

THIRD: The purposes for which the corporation is to be formed and operated are exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, to relieve and reduce unemployment, promote and provide for additional and maximum employment, improve and maintain job opportunities, and lessen the burden of government and act in the public interest. In furtherance of said purposes, the corporation's powers shall include:

- (a) To foster the creation, retention and expansion of jobs and economic opportunities for the benefit of the County of Saratoga, New York State and local economies; and
- (b) To construct, acquire, rehabilitate and improve for use by others, facilities in the territory in which its operations are principally to be conducted, to assist financially in such construction, acquisition, rehabilitation and improvement, to maintain and/or lease such facilities on its behalf or for others in such territory; to disseminate information and furnish advice, technical assistance and liaison with federal, state and local authorities with respect thereto;
- (c) To acquire by purchase, lease, gift, bequest, devise or otherwise real or personal property or interests therein;
- (d) To apply for loans and borrow money without limit as to amount; to make, draw, accept, endorse, execute and issue negotiable bonds, debentures, notes and other obligations therefor;
- (e) To sell, lease, mortgage or otherwise dispose of or encumber any such facilities or any of its real or personal property or any interest therein upon such terms as it may determine;
- (f) To enter into covenants and agreements and to comply with all the terms, conditions and provisions thereof, and otherwise to carry out its corporate purposes and to foster and encourage the location or expansion of facilities and related businesses in the territory in which the operations of the corporation are principally to be conducted;
- (g) To apply for and make grants and loans and to execute any and all documents necessary in connection therewith;

- (h) To do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors, officers or any private person.
- (i) In general, to perform any and all acts and things, and exercise any and all powers which may now or hereafter be lawful for the corporation to do or exercise under and pursuant to the laws of the State of New York for the purpose of accomplishing any of the foregoing purposes of the corporation.

FOURTH: The corporation's mission and public objective, which the corporation's purposes will achieve, include, but are not limited to, the lessening of the burdens of government by undertaking and promoting economic development initiatives in the Saratoga County, New York area that will include real estate leasing, acquisition, development and management, real estate project finance, and other community-based economic development activities permissible under the Not-For-Profit Corporation Law.

FIFTH: The operations of the corporation will be principally conducted within the territory of Saratoga County, New York and surrounding communities.

SIXTH: Pursuant to the requirements of Section 1411(e) of the Not-For-Profit Corporation Law:

(a) All income and earnings of the corporation shall be used exclusively for its corporate purposes with the intent being that all income and earnings will be expended or deposited in appropriate reserves for corporate purposes; to the extent not so used, the income and earnings will accrue and be paid to the Job Development Authority to the extent required by Section 1411 of the Not-for-Profit Corporation Law.

- (b) The property of the corporation is irrevocably dedicated to its corporate purposes. No part of the income or earnings of the corporation shall inure to the benefit or profit of, nor shall any distribution of its property or assets be made to, any member, director or officer of the corporation, or private person, corporate or individual, or to any other private interest, except that the corporation may repay loans made to it and may repay contributions (other than dues) made to it to the extent that any such contribution may not be allowable as a deduction in computing taxable income under the Internal Revenue Code of 1986, as amended.
- (c) If the corporation accepts a mortgage loan or loans from the New York Job Development Authority, the corporation shall be dissolved in accordance with the provisions of paragraph (g) of Section 1411 of the Not-For-Profit Corporation Law upon the repayment or other discharge in full by the corporation of all such loans.
- SEVENTH: (a) The corporation shall not attempt to influence legislation by propaganda or otherwise, or participate in or intervene, directly or indirectly, in any political campaign on behalf of or in opposition to any candidate for public office.
- (b) The corporation shall not engage in any activities not permitted to be carried on by an organization exempt from federal income taxation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and the regulations promulgated thereunder.

EIGHTH: In the event of the dissolution of the corporation or the winding up of its affairs, the Board of Directors shall, after paying or making provision for the payment of all debts and liabilities of the corporation of whatsoever kind or nature, distribute all of the remaining assets and property of the corporation to the County of Saratoga for furtherance of the purposes set forth in Section 1411 of the Not-for-Profit Corporation Law. Any of such assets not so disposed of shall be disposed of by order of the Supreme Court of the State of New York pursuant to Section 1008 of the Not-For-Profit Corporation Law.

NINTH: The office of the corporation shall be located in Saratoga County, New York.

TENTH: The offices of the corporation shall be functionally separate from those of the County of Saratoga or any of its affiliated entities (collectively, the "County Entities") (although such office may be in a facility leased from the County of Saratoga or any of its affiliates on arms-length terms). The corporation at all times shall:

- (a) maintain separate accounting records and other corporate records from those of the County Entities;
- (b) not divert the corporation's funds to any other person or for other than the use of the corporation and not commingle any of the corporation's assets with those of the County Entities;
- (c) pay any employee, consultant or agent of the corporation, or any other operating expense incurred by the corporation, from the assets of the corporation and not from the assets of any of the County Entities;
- (d) maintain its own deposit account or accounts, separate from those of the County Entities, with commercial banking institutions and/or trust companies;
- (e) to the extent that the corporation contracts or does business with vendors or service providers where the goods and services provided are partially for the benefit of any other person, the costs incurred in so doing shall be fairly allocated to or among the corporation and such persons for whose benefit the goods and services are provided, and the corporation and each such person shall bear its fair share of such costs;

- (f) conduct its business in its own name and conduct all material transactions between the corporation and the County Entities only on an arm'slength basis;
- (g) observe all necessary, appropriate and customary corporate formalities, including, but not limited to, holding all regular and special members' and directors' meetings appropriate to authorize all corporate action, keeping separate and accurate minutes of such meetings, passing all resolutions or consents necessary to authorize actions taken or to be taken, and maintaining accurate and separate books, records, and accounts, including, but not limited to, intercompany transaction accounts. Regular members' and directors' meetings shall be held at least annually;
- (h) ensure that decisions with respect to its business and daily operations shall be independently made by the corporation (although the officer making any particular decision also may be an employee, officer or director of the County Entities);
- act solely in its own corporate name and through its own authorized officers and agents, and use its own stationery;
- (j) other than as expressly provided herein, pay all expenses, indebtedness and other obligations incurred by it;
- (k) not enter into any guaranty, or otherwise become liable,
 with respect to any obligation of the County Entities;
- (1) cause any financial reports required of the corporation to be prepared in accordance with generally accepted accounting principles and be audited annually and be issued separately from, although they may be consolidated with, any reports prepared for any member of the County Entities; and

 (m) ensure that at all times it is adequately capitalized to engage in the transactions contemplated herein.

ELEVENTH: The County of Saratoga, acting by and through its Board of Supervisors, shall be the sole Member of the corporation.

TWELFTH: The corporation shall be managed by a Board of Directors consisting of seven (7) Directors, each appointed by and serving at the pleasure of the Saratoga County Board of Supervisors. The initial Directors shall serve for a term ending December 31, 2015. Subsequent appointments of Directors by the Saratoga County Board of Supervisors shall be made for a term of two (2) years ending in such case on December 31 of the last year of each such term, and such Directors may be removed by the Saratoga County Board of Supervisors without cause at any time for any reason. Vacancies occurring on the Board of Directors other than by expiration of terms of office shall be filled by appointment by the Saratoga County Board of Supervisors for the remainder of the unexpired terms. Any subsequent increase or decrease in the size of the Board of Directors will require the approval of the Member and the affirmative vote of a majority of the Directors.

FOURTEENTH: The corporation shall indemnify each Member, each Director, each officer, and, to the extent authorized by the Board of Directors, each other

person authorized to act for the corporation or on its behalf, to the full extent to which indemnification is permitted under the Not-For-Profit Corporation Law.

FIFTEENTH: The Secretary of State of the State of New York is designated as agent of the corporation upon whom process against it may be served. The post office address to which the Secretary of State shall mail a copy of any process against the corporation served upon him is as follows: Maplewood Manor Local Development Corporation, 40 McMaster Street, Ballston Spa, New York 12020.

SIXTEENTH: The By-laws of the corporation may be adopted, amended or repealed by a majority of the Directors of the corporation.

SEVENTEENTH: The corporation will not do any of the following:

- (a) Without the affirmative vote of all Members of the corporation and the affirmative vote of a majority of the Directors, increase or decrease the number of Members of the corporation or increase or decrease the number of Directors of the corporation.
- (b) Without the affirmative vote of a majority of the Directors of the corporation and all of the corporation's members, (i) dissolve or liquidate, in whole or in part, or institute proceedings to be adjudicated bankrupt or insolvent, (ii) consent to the institution of bankruptcy or insolvency proceedings against it, (iii) file a petition seeking or consenting to reorganization or relief under any applicable federal or state law relating to bankruptcy or insolvency, (iv) consent to the appointment of a receiver, liquidator, assignee, trustee, sequestrator or other similar official of the corporation or a substantial part of its property, (v) make a general assignment for the benefit of creditors, (vi) admit in writing its inability to pay its debts generally as they become due or (vii) take any corporate action in furtherance of the actions set forth in clauses (i) through (vi) of this paragraph.

(c) Without the affirmative vote of all of the Directors of the corporation and all of the corporation's members, merge or consolidate with any other corporation, company or entity or, except to the extent contemplated by paragraph THIRD hereof, sell all or substantially all of its assets or acquire all or substantially all of the assets or capital stock or other ownership interest of any other corporation, company or entity.

EIGHTEENTH: The corporation shall be deemed a public body (as such term is defined in the Open Meetings Law of the State of New York) and, as such, each meeting of the Board of Directors of the corporation will be conducted in the manner prescribed by the Open Meetings Law. The Directors will not receive compensation for services provided to or on behalf of the corporation.

RESOLUTION 120 - 2018

Introduced by Supervisors Tollisen, Allen, DeLucia, Lent, Pemrick, Szczepaniak, and Wright

APPROVING THE ISSUANCE OF CERTAIN OBLIGATIONS BY SARATOGA COUNTY CAPITAL RESOURCE CORPORATION TO FINANCE A CERTAIN PROJECT FOR HUDSON HEADWATERS HEALTH NETWORK

WHEREAS, Saratoga County Capital Resource Corporation (the "Issuer") is authorized and empowered by the provisions of Section 1411 of the New York State Not-For-Profit Corporation Law (the "NFPCL") to take steps to relieve and reduce unemployment, promote and provide for additional and maximum employment, better and maintain job opportunities, instruct or train individuals to improve or develop their capabilities for such jobs, carry on scientific research for the purpose of aiding a community or geographical area by attracting new industry to the community or area or by encouraging the development of, or retention of, an industry in the community or area, lessening the burdens of government and acting in the public interest; and

WHEREAS, to accomplish its stated purposes, the Issuer is authorized and empowered under the NFPCL and its certificate of incorporation (the "Certificate of Incorporation") to issue its revenue bonds to finance the cost of the acquisition, construction, reconstruction and installation of one or more "projects" (as described in the NFPCL and the Certificate of Incorporation), to acquire, construct, reconstruct and install said projects or to cause said projects to be acquired, constructed, reconstructed and installed, and to convey said projects or to lease said projects with the obligation to purchase; and

WHEREAS, Hudson Headwaters Health Network, a New York not-for-profit corporation (the "Borrower"), presented an application (the "Application") to the Issuer, which Application requested that the Issuer consider undertaking a project (the "Project") for the benefit of the Borrower, said Project to consist of the following: (A) (1) the construction of a new healthcare facility containing approximately 27,900 square feet consisting of (i) a health center including exam, procedure and behavioral consultation rooms, (ii) a physical and occupational therapy and imaging facility and (iii) a pharmacy (the "Facility") on a parcel of land located at Route 9 in the Town of Moreau, Saratoga County, New York (the "Land"), and (2) the acquisition and installation therein and thereon of certain machinery and equipment (the "Equipment") (the Land, the Facility and the Equipment being collectively referred to as the "Project Facility"); (B) the financing of all or a portion of the costs of the foregoing by the issuance of revenue bonds of the Issuer in one or more issues or series in an aggregate principal amount sufficient to pay the cost of undertaking the Project, together with necessary incidental costs in connection therewith, in an amount then estimated to be approximately \$7,700,000, but in any event not to exceed \$9,000,000 (the "Bond"); and (C) paying a portion of the costs incidental to the issuance of the Bond, including issuance costs of the Bond and any reserve funds as may be necessary to secure the Bond; and

WHEREAS, the Borrower has requested that interest on the Bond be treated by the federal government as excludable from gross income for federal income tax purposes pursuant to Section 103 and Section 142 of the Internal Revenue Code of 1986, as amended (the "Code"); and

WHEREAS, this Board of Supervisors has been advised by the Issuer that the Issuer proposes to issue, subsequent to the adoption of this resolution, the Bond in a principal amount sufficient to fund all or a portion of the costs of the Project; and

WHEREAS, interest on the Bond will not be excludable from gross income for federal income tax purposes unless, among other things, pursuant to Section 147(f) of the Code, the issuance of the Bond is approved by the "applicable elected representative" of Saratoga County, New York after the Issuer has held a public hearing (the "Public Hearing") on the nature of the Project and the issuance of the Bond; and

WHEREAS, in accordance with the requirements set forth in Section 147(f) of the Code, the Chief Executive Officer of the Issuer (A) caused notice of the Public Hearing to be published on March 23, 2018 in The Daily Gazette, a newspaper of general circulation available to the residents of the Town of Moreau, Saratoga County, New York, (B) conducted the Public Hearing on April 10, 2018 at 4:00 o'clock p.m., local time at the office of the Issuer located at 2911 NYS Route 9, Malta, New York and (C) prepared a report of the Public Hearing (the "Hearing Report") which fairly summarized the views presented at said Public Hearing and distributed same to the directors of the Issuer and to the Board of Supervisors; and

WHEREAS, pursuant to Section 147(f) of the Code, the Board of Supervisors desires to allow the interest on the Bond to be treated as excludable from gross income for federal income tax purposes; and

WHEREAS, the Certificate of Incorporation specifically provides that neither the Bond nor any other obligation of the Issuer shall be a debt of the County of Saratoga, New York, nor shall the County of Saratoga, New York be liable thereon; now, therefore, be it

RESOLVED by the Board of Supervisors of the County of Saratoga, New York as follows:

Section 1. For the sole purpose of qualifying the interest payable on the Bond for exclusion from gross income for federal income tax purposes pursuant to the provisions of Section 145(a) of the Code, the Board of Supervisors, as the elected legislative body of the County of Saratoga, New York, hereby approves the issuance by the Issuer of the Bond, provided that the Bond, and the premium (if any) and interest thereon, shall be special obligations of the Issuer and shall never be a debt of the State of New York, County of Saratoga, New York or any political subdivision thereof (other than the Issuer), and neither the State of New York, County of Saratoga, New York nor any political subdivision thereof (other than the Issuer) shall be liable thereon.

<u>Section 2</u>. This resolution shall take effect immediately.

BUDGET IMPACT STATEMENT: No budget impact.

RESOLUTION 121 - 2018

AUTHORIZING AN EXCEPTION TO THE COUNTY'S HEALTH INSURANCE POLICY TO EXTEND THE PERIOD OF HEALTH INSURANCE COVERAGE FOR THE CHILD DEPENDENTS OF A RECENTLY DECEASED COUNTY EMPLOYEE

WHEREAS, an employee of the Saratoga County Probation Department, Melissa Moore, passed away unexpectedly on March 28, 2018; and

WHEREAS, the County's Health Insurance Policy for employees, elected officials and retirees, set forth in Chapter 4, Section E, of the County's Policies and Procedures Manual, provides that upon the death of an active employee, Saratoga County will continue health insurance for dependents covered under the employee's policy for the remainder of the month of death plus one additional month; and

WHEREAS, Ms. Moore left behind two dependent children who were covered under her Blue Shield of Northeastern New York health insurance policy through the County; and

WHEREAS, while both children are expected to qualify for health insurance coverage through Healthy NY sometime within the next 60 days, such coverage will not be in place prior to the expiration of their coverage with Blue Shield on April 30, 2018, the expiration date presently required under the County's Health Insurance Policy; and

WHEREAS, it is appropriate to authorize an exception to the County's Health Insurance Policy to extend health insurance coverage to Ms. Moore's dependents through June 30, 2018 in order to ensure that their health insurance coverage is not interrupted; now, therefore, be it

RESOLVED, that an exception is hereby authorized to the coverage termination provisions of the County's Health Insurance Policy to extend the health insurance coverage provided by the County through Blue Shield of Northeastern New York for the two child dependents of former Saratoga County employee Melissa Moore through June 30, 2018.

BUDGET IMPACT STATEMENT: Funds are available in the MS Health Insurance Fund.
