AMENDING THE 2019 COMPENSATION SCHEDULE UNDER SHERIFF DEPARTMENT AND WIOA

WHEREAS, pursuant to Resolution 18-2019, this Board authorized an agreement with the Saratoga Springs City School District for the provision of a Saratoga County Sheriff's Department Road Patrol Deputy to serve as a School Resource Officer for the second half of the 2018-2019 school year; and

WHEREAS, the Human Resources and Insurance Committee, the Director of Human Resources and the Saratoga County Sheriff have recommended that the 2019 Saratoga County Compensation Schedule be amended under "Sheriff Department" to create one (1) Deputy Sheriff Road Patrol position at the base salary of \$52,068 in the Compensation Schedule; and

WHEREAS, the one (1) new Deputy Sheriff Road Patrol position will allow for the reassignment of one (1) current and trained Deputy Sheriff assigned to the Road Patrol to serve as a school resource officer for the Saratoga Springs City School District during times school is in session, while fulfilling normal Road Patrol duties when school is closed or not in session; and

WHEREAS, pursuant to Resolution 26-2019, this Board appointed Jenniffer McCloskey to the position of Director of Employment and Training effective January 25, 2019, thereby creating a vacancy in the position of Accounting Supervisor which was held by Ms. McCloskey; and

WHEREAS, the Human Resources and Insurance Committee, the Director of Human Resources and the Director of Employment and Training have recommended that the 2019 Saratoga County Compensation Schedule be amended under WIOA to reclassify the position of Accounting Supervisor-WIOA to Employment and Training Coordinator at the base salary of \$49,559, which amendment is requested because Director McCloskey believes she can continue to fulfill many of the accounting duties she previously performed as Accounting Supervisor in her new position of Director of Employment and Training; now, therefore, be it

RESOLVED, that the 2019 Saratoga County Compensation Schedule is amended effective March 8, 2019 as follows:

AMENDING RESOLUTION 277-2018 TO REVISE THE PAYMENT TERMS OF A POST-TERMINATION AGREEMENT WITH BLUESHIELD OF NORTHEASTERN NEW YORK

WHEREAS, Resolution 277-2018 authorized a Post-Termination agreement with BlueShield of Northeastern New York, Inc. ("BSNENY") for processing 2018 employee medical claims incurred on or before December 31, 2018 submitted to or received by BSNENY for payment on or after January 1, 2019; and

WHEREAS, due to conflicting interpretations by the County and BSNENY over proposed payment terms in the Post-Termination Agreement submitted by BSNENY, it is necessary to amend Resolution 277-2018 to clarify and revise the terms of payment to BSNENY during the first three (3) months of the Agreement from \$34.58 per employee claim to \$34.58 per employee; and

WHEREAS, our Human Resources and Insurance Committee and the Director of Human Resources have recommended that Resolution 277-2018 be amended to revise the terms of payment to BSNENY during the first three (3) months of the Post-Termination Agreement from \$34.58 per employee claim to \$34.58 per employee; now, therefore, be it

RESOLVED, that the last WHEREAS paragraph and the first RESOLVED paragraph of Resolution 277-2018 are hereby amended to replace the phrase "at a cost of \$34.58 per employee claim for the first three (3) months of 2019", with the phrase "at a cost of \$34.58 per employee for the first three (3) month of 2019".

BUDGET IMPACT STATEMENT: This amendment will result in an approximate savings of \$13,000.

AUTHORIZING AN AGREEMENT WITH SARATOGA HOSPITAL, INC., CORPORATE HEALTH SERVICES, FOR EMPLOYEE PHYSICAL EXAMINATIONS AND LABORATORY TESTING

WHEREAS, the County entered into an existing minor contract with Saratoga Hospital, Inc., Corporate Health Services, ("Saratoga Hospital") on September 29, 2010, for the performance of physical examinations and laboratory testing required for new and existing County employees at a cost not to exceed \$6,000; and

WHEREAS, said minor contract was amended in 2013, 2015, 2017 and 2018 to increase the minor contract's limit to \$15,000 and to update Saratoga Hospital's fee schedule to its current rates; and

WHEREAS, as a result of a significant increase in the number of new and current employees that needed to be tested in 2018, the minor contract amount of \$15,000 was exceeded; and

WHEREAS, it is necessary to enter into an agreement with Saratoga Hospital in the amount of \$30,000 for the term from December 1, 2018 through December 31, 2019 in order to authorize payment of said additional amounts expended in 2018 that were in excess of the annual minor contract amount of \$15,000; and

WHEREAS, our Human Resources and Insurance Committee and the Director of Human Resources have recommended that the County enter into an agreement with Saratoga Hospital for the performance of physical examinations and laboratory testing required for new and current County employees, for the term December 1, 2018 through December 31, 2019 at a cost of \$30,000; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Saratoga Hospital, Inc., Corporate Health Services, of Saratoga Springs, New York, for the performance of physical examinations and laboratory testing required for new and current County employees, for the term December 1, 2018 through December 31, 2019 at the rates set forth in Saratoga Hospital's Corporate Health Services Fee Schedule at the time the services are rendered, with the total cost of the contract not to exceed \$30,000; and, be it further

RESOLVED, that the form and content of such agreement shall be subject to the approval of the County Attorney.

WHEREAS, pursuant to Resolution 248-2018, this Board approved the Saratoga County Office for the Aging's 2019-2020 Annual Update and related subcontracts; and

WHEREAS, included in the subcontracts authorized by Resolution 248-2018 is an agreement with Critical Signal Technologies for the provision of Personal Emergency Response Systems (PERS) services for the term January 1, 2019 through December 31, 2019 at a cost of \$20,000; and

WHEREAS, subsequent to the adoption of Resolution 248-2018, our Office for the Aging learned that the Critical Signal Technologies conducts business in the State of New York under the name of GTL, Incorporated, d/b/a Link to Life, which is the proper business entity for the County to contract with for Personal Emergency Response Systems services; and

WHEREAS, our Health and Social Services Committee and the Director of the Office for the Aging have recommended that Resolution 248-2018 be amended to authorize an agreement with GTL, Incorporated, d/b/a Link to Life, in place of Critical Signal Technologies, for Personal Emergency Response Systems services for the term January 1, 2019 through December 31, 2019; now, therefore, be it

RESOLVED, that Resolution 248-2018, is hereby amended to name GTL, Incorporated, D/B/A Link to Life as the provider for Personal Emergency Response Systems Services as indicated below:

AUTHORIZING AN AMENDMENT TO THE SUBLEASE WITH GENOA HEALTHCARE, LLC FOR THE LEASE OF SPACE AT THE SARATOGA COUNTY MENTAL HEALTH AND ADDICTION SERVICES BUILDING, AND AMENDING RESOLUTION 31-2018 ACCORDINGLY

WHEREAS, pursuant to Resolution 207-12, the Saratoga County Board of Supervisors authorized a lease with Saratoga Prime Properties, LLC for the premises known as 135 South Broadway, in the City of Saratoga Springs, for occupancy by Saratoga County Mental Health and Addiction Services for a term of five years to commence on the date of occupancy; and

WHEREAS, pursuant to Resolution 257-12, the Saratoga County Board of Supervisors adopted Local Law No. 3 of 2012 authorizing the County's lease of said premises located at 135 South Broadway, Saratoga Springs, from Saratoga Prime Properties, LLC for a term of ten years, instead of the five year term authorized by County Law §215 and Resolution 207-12, in order to provide Saratoga Prime Properties, LLC with the financial assurances needed to recoup its renovation costs for the premises over the longer ten year term; and

WHEREAS, in order to improve the delivery of quality mental health treatment and addiction services, this Board authorized pursuant to Resolution 31-2018 the sublease of an area consisting of approximately 310 sq. ft. within its leased space at 135 South Broadway, Saratoga Springs, to Genoa Healthcare, LLC ("Genoa") for the operation of an on-site pharmacy for use by the County's clients, for a term of three (3) years, subject to renewal for an additional term of two (2) years, at annual rents stated in Resolution 31-2018; and

WHEREAS, due to concerns raised by the New York State Board of Pharmacy with regard to protecting the privacy of clients of Mental Health and Addiction Services, the Commissioner of Mental Health and Addiction Services and Genoa have revised the sublease plans to relocate the pharmacy from its originally planned location near the front entrance of the building to a location further back in the building that would have a separate entrance accessible to the parking lot; and

WHEREAS, the revised sublease plans call for Genoa to lease a larger space of approximately 513 sq. ft. for a term of three (3) years, subject to renewal for an additional term of up to two (2) years terminating on September 30, 2023, at the increased following rents:

with said rent to commence upon Genoa obtaining all required State and local municipal approvals and permits that are needed for Genoa to commence business as a pharmacy; and

WHEREAS, Genoa has also agreed to pay an increase in the rent it will pay to the County from \$650 per month to \$1,075 per month during the time that Genoa takes possession of the space to undertake construction of the improvements needed to fit up the sublet space for Genoa's operation as a pharmacy; and

WHEREAS, our Health and Social Services Committee and Commissioner of Saratoga County Mental Health and Addiction Services have recommended that the foregoing proposed amendments to the sublease of space to Genoa Healthcare, LLC for the operation of an on-site pharmacy at 135 South Broadway, Saratoga Springs be approved; now, therefore, be it

RESOLVED, that the Chair of the Board of Supervisors is authorized to execute an amendment to the sublease agreement with Genoa Healthcare, LLC of Tukwila, Washington, providing for an increase in the amount of space to be sublet by Genoa from 310± sq. ft. to 513± sq. ft. in the building located at 135 South Broadway, Saratoga Springs, for occupancy and use by Genoa Healthcare, LLC as a pharmacy, for a term of three (3) years, with an option to renew for an additional term of two (2) years terminating on September 30, 2023, at the following rents:

RESOLVED, that said amendment to the sublease agreement with Genoa shall provide that Genoa shall pay increased rent to the County in the amount of \$1,075 per month during the time that Genoa takes possession of the space to undertake construction of the improvements needed to fit up the sublet space for Genoa's operation as a pharmacy; and be it further

RESOLVED, that the form and content of such amendment to the sublease agreement shall be subject to the approval of the County Attorney; and be it further

RESOLVED, that Resolution 31-2018 is hereby accordingly amended to incorporate the foregoing authorized sublease amendments.

BUDGET IMPACT STATEMENT: The amended agreement will result in additional revenue from rent collection that will be used to offset other County lease obligations.

AUTHORIZING THE ACCEPTANCE OF STATE OMH FUNDING ADMINISTERED THROUGH THE SUICIDE PREVENTION CENTER OF NEW YORK STATE FOR THE SARATOGA COUNTY SUICIDE PREVENTION COALITION, AND AMENDING THE 2019 BUDGET IN RELATION THERETO

WHEREAS, the County of Saratoga is a member of the Saratoga County Suicide Prevention Coalition and provides administrative and fiduciary services for the Coalition; and

WHEREAS, State funding from the New York State Office of Mental Health (OMH) administered through the Suicide Prevention Center of New York State has been awarded to the Saratoga County Suicide Prevention Coalition in the form of a three year grant in the amounts of \$4,120 for year one, \$3,950 for year two, and \$4,500 for year three, totaling \$12,570, which funds may be used by Saratoga County Public Health Services and other members of the Coalition for suicide prevention program planning, participation in the New York State Suicide Prevention Conference, producing suicide prevention educational videos, and promoting awareness of suicide prevention help lines; and

WHEREAS, Public Health Services wishes to serve as fiduciary for and administrator of said grant funds on behalf of the Saratoga County Suicide Prevention Coalition; and

WHEREAS, the acceptance of these funds requires this Board's approval and an amendment to the 2019 County Budget; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby authorizes Saratoga County Public Health Services to accept on behalf of the Saratoga County Suicide Prevention Coalition a three year grant from the New York State Office of Mental Health in the amounts of \$4,120 for year one, \$3,950 for year two, and \$4,500 for year three, totaling \$12,570, which grant shall be administered through the Suicide Prevention Center of New York State and utilized for suicide prevention program planning; and, be it further

AUTHORIZING THE IMPLEMENTATION, AND FUNDING IN THE FIRST INSTANCE OF 100% OF THE FEDERAL-AID AND STATE "MARCHISELLI" PROGRAM-AID ELIGIBLE COSTS, OF A TRANSPORTATION FEDERAL-AID PROJECT, APPROPRIATING FUNDS THEREFOR, AND AMENDING THE BUDGET IN RELATION THERETO

WHEREAS, a Project known as the Zim Smith Trail Extension, Town of Halfmoon, City of Mechanicville, Villages of Ballston Spa and Round Lake, P.I.N 1760.39 (the "Project"), is eligible for funding under Title 23 U.S. Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal funds and 20% non-federal funds; and

WHEREAS, the County of Saratoga desires to advance the Project by making a commitment of 100% of the non-federal share of the costs of Construction and Construction Inspection services; and

WHEREAS, an amendment to the 2019 County Budget is needed to appropriate the necessary funding for the Project; and

NOW, THEREFORE, the Saratoga County Board of Supervisors duly convened does hereby

RESOLVE, that the Saratoga County Board of Supervisors hereby approves the above-subject Project; and it is hereby further

RESOLVED, that the Saratoga County Board of Supervisors hereby authorizes the County of Saratoga to pay in the first instance 100% of the federal and non-federal share of the cost of Construction and Construction Inspection work for the Project or portions thereof; and it is further

RESOLVED, that the sum of \$5,404,696.00 has been appropriated from the Zim Smith Capital Fund and made available to cover the cost of participation in the above phase of the Project; and it is further

RESOLVED, that the additional sum of \$24,559 is hereby appropriated from the Zim Smith Capital Fund and made available to cover the cost of participation in the above phases of the Project; and it is further

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, Saratoga County Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof; and it is further

RESOLVED, that the Chairman of the Saratoga County Board of Supervisors be and is hereby authorized to execute all necessary Agreements, certifications or reimbursement requests for Federal Aid and/or Marchiselli Aid on behalf of the County of Saratoga with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first instance funding of project costs and permanent funding of the local share of federal-aid and state-aid eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and it is further

RESOLVED, that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary Agreement in connection with the Project; and it is further

RESOLVED, that the 2019 Saratoga County Budget is amended as follows:

WHEREAS, the Board of Supervisors has received a petition from Barbara Lee Jensen, landowner in the Town of Clifton Park, to include within the boundaries of Saratoga County Consolidated Agricultural District #2 approximately 13 ± acres of predominately viable agricultural land located on Waite Road dedicated to use as a commercial horse farm and boarding facility, identified as Tax Parcel #264.-2-19; and

WHEREAS, the Board of Supervisors has received a petition from James Van Dyk, landowner in the Town of Greenfield, to include within the boundaries of Saratoga County Consolidated Agricultural District #2 67.5 ± acres of predominately viable agricultural land located on Daniels Road dedicated to the production of crops which include blueberries, strawberries, squash and garlic, with the forested portion of the parcels used as sugarbush, for agroforestry and as a wood lot, identified as Tax Parcels #151.-3-54.1 and #151.-3-54.2; and

including yarrow, motherwort, elderberry, goldenthread and blood root that are used for medicine and skin care products, identified as Tax Parcels #151.-3-17 and #151.-3-18; and

WHEREAS, the Board of Supervisors has received a petition from the Estate of Mary Ann Wadsworth, by her Executrix Valerie Wadsworth-Manios, landowner in the Town of Greenfield, to include within the boundaries of Saratoga County Consolidated Agricultural District #2 32.45 ± acres of predominately viable agricultural land located on Daniels Road and Locust Grove Road used for the production of row crops and for harvesting (wildcrafting) wild medicinal herbs that grow throughout the parcels, including yarrow, motherwort, elderberry, goldenthread and blood root that are used for medicine and skin care products, identified as Tax Parcel #151.20-1-1.1; and



CORRECTING A 2019 TAX BILL IN THE TOWN OF GREENFIELD

WHEREAS, the owner of Tax Parcel #162.8-1-10 in the Town of Greenfield has timely submitted an application requesting that the 2019 tax rolls for the Town of Greenfield be corrected relative to said Tax Parcel for the following reasons: On November 9, 2017 the Greenfield Town Board adopted Resolution 129 of 2017 authorizing the demolition of an unsafe garage structure and the removal of all refuse and debris located on said Tax Parcel, and further authorizing the assessment of all costs incurred during such demolition to be charged to the Town and County tax bill for the parcel. On December 7, 2017, the Town of Greenfield Highway Department demolished the unsafe building and removed all refuse and debris from the property. The Greenfield Town Board neglected to file a Notice of Pendency in the Saratoga County Clerk’s Office relative to the special assessment of the demolition charges in the amount of \$5,395.37 as required by Town ordinance. Thomas W. Merrills, Jr. purchased the property on October 19, 2018, but was unaware of the special assessment/lien of the demolition charges against the property as a Notice of Pendency had not been filed in the County Clerk’s Office, and was therefore not discoverable by the title searcher performing the title search he commissioned for the property. WHEREAS, Resolution 194-2017 authorized the acceptance of a 2017 New York State Homeland Security Program grant in the amount of \$217,457 to pay for radio equipment; portable batteries; mobile chargers; training for the County hazardous material response team; the Office of Emergency Services' Rail Car Training System Project; two yearly payments for the "I Am Responding" communications system; Time Warner's service for the Emergency Operations Center; dive equipment; a firearms training system for the Sheriff's Office; to update, calibrate, repair and replace supported equipment; the purchase of a decontamination equipment trailer; payment of Verizon Wireless service charges; and a copier lease for the Emergency Operations Center; and

WHEREAS, unexpended funds from such 2017 SHSP grant in the amount of \$169,082 need to be reappropriated for the Office of Emergency Services to the 2019 County budget; and

AUTHORIZING THE CHAIRMAN TO EXECUTE A MUNICIPAL COOPERATION AGREEMENT WITH THE COUNTIES OF ALBANY, RENSSELAER AND SCHENECTADY PROVIDING FOR THE SHARING OF COSTS TO BE INCURRED IN MAKING IMPROVEMENTS TO THE CAPITAL DISTRICT YOUTH CENTER, INC. SECURE DETENTION FACILITY TO BRING THE FACILITY INTO COMPLIANCE WITH THE REQUIREMENTS OF THE RAISE THE AGE LEGISLATION

WHEREAS, pursuant to Article 3 of the Family Court Act of the State of New York, it is the County's duty and responsibility to provide secure detention services for juvenile delinquents under court order; and

WHEREAS, the County developed a cost-effective means to provide secure detention to juveniles on a regional basis by joining with the neighboring counties of Albany, Rensselaer and Schenectady to construct a regional secure detention facility known as the Capital District Juvenile Secure Youth Detention Facility ("Youth Detention Facility") in the Town of Colonie, operated by the Capital District Youth Center, Inc. ("CDYCI"); and

WHEREAS, as a result of the Raise the Age legislation enacted by the New York State Legislature and the Governor in 2017, the age of criminal responsibility for youths who commit crimes as defined in the Penal Law has been increased to 16 years of age effective October 1, 2018 and to 17 years of age effective October 1, 2019; and

WHEREAS, the Raise the Age legislation and the regulations established thereunder provide that youths subject to the legislation who require placement in a secure placement facility may not be detained in local jail facilities, but rather must be placed in "specialized secure detention facilities", which are new highly regulated secure detention facilities governed by novel and specific regulations as to their physical layout and the specialized services that must be provided to those youths detained at such facilities; and

WHEREAS, the CDYCI has made some improvements to the Youth Detention Facility, including adding more beds and hiring additional staff, so that the Facility could be conditionally certified by the State of New York Office of Children and Family Services ("NYSOCFS") as a specialized secure detention facility as of October 1, 2018; and

WHEREAS, additional capital improvements need to be made to renovate and expand the Youth Detention Facility to bring it into compliance with the standards mandated by the Raise the Age legislation in order for it to be unconditionally certified as a specialized secure detention facility by the NYSOCFS; and

WHEREAS, CDYCI has been working with the Dormitory Authority of the State of New York (“DASNY”) on plan to finance the construction of the necessary capital improvements, which financing is anticipated will take about six (6) months to close; and

WHEREAS, CDYCI retained SMRT Architects and Engineers, P.C. (“SMRT”) to provide cost estimates for schematic design, design development, construction documents, bidding, and construction administration services for the required capital improvements to the Youth Detention Facility, which cost estimates range from \$621,000 to \$725,000, depending on the extent of the services actually provided; and

WHEREAS, NYSOCFS has advised CDYCI that it may not include such “non-care” related pre-construction expenses in the per diem rate it charges through the use of the Youth Detention Facility, and CDYCI has exhausted its capital reserve account in making the improvements needed to obtain its conditional certification as a specialized secure detention facility by October 1, 2018; and

WHEREAS, CDYCI’s certificate of incorporation provides that CDYCI will be managed by a Board of Directors (“CDYCI Board”) consisting of one representative each from Albany, Rensselaer, Saratoga, and Schenectady Counties and five members appointed by the Capital District Regional Planning Commission; and

WHEREAS, the CDYCI Board has recommended that all non-care Raise the Age related costs, including pre-construction expenses, be allocated among the Counties of Albany, Rensselaer, Saratoga and Schenectady and paid to CDYCI in the same proportion as the number of Adolescent Offender Beds leased by each County bears to the number of Adolescent Offender beds being leased by all four Counties at the Youth Detention Facility pursuant to existing Use and Lease Agreements with the CDYCI; and

WHEREAS, Saratoga County leases one (1) Adolescent Offender bed out of 12.5 available Adolescent Offender beds at the Youth Detention Facility, and would therefore be responsible for eight (8%) percent of all non-care related costs pursuant to the allocation proposed by the CDYCI Board; and

WHEREAS, all such non-care costs paid by each County to CDYCI would be eligible for reimbursement by the State as a Raise the Age expense, if such non-care expenses are included in the Raise the Age Plan the County submits to NYSOCFS for approval; and

WHEREAS, in order to formalize the proposed cost-sharing and payment structure for non-care, pre-construction and Raise the Age expenses, the CDYCI has requested that the four Counties execute a new municipal cooperation agreement providing for the pre-funding or reimbursement to CDYCI of each County’s proportionate share of the non-care costs of all services, materials and equipment, including but not limited to pre-construction services, procured by CDYCI for implementation of Raise the Age required improvements to the Youth Detention Facility and related expenditures prior to the issuance of any indebtedness financing through DASNY for such non-care costs; and

WHEREAS, our Public Safety Committee and the Director of the County Probation Department have recommended that the County enter into the proposed municipal cooperation agreement requested by the CDYCI; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute a municipal cooperation agreement on behalf of the County with the Counties of Albany, Rensselaer and Schenectady providing for the pre-funding or reimbursement to the Capital District Youth Center, Inc. of each County's proportionate share of the non-care costs of all services, materials and equipment, including but not limited to pre-construction services, procured by CDYCI for implementation of Raise the Age required improvements to the Capital District Juvenile Secure Youth Detention Facility and related expenditures prior to the issuance of any indebtedness financing through the Dormitory Authority of the State of New York for such non-care costs; and be it further

RESOLVED, that the form and content of such municipal cooperative agreement shall be subject to the approval of the County Attorney.

AUTHORIZING AN AGREEMENT WITH GENERAL CONTROL SYSTEMS, INC. FOR MAINTENANCE SERVICES FOR THE INSTRUMENTATION SYSTEMS AT SARATOGA COUNTY SEWER DISTRICT NO. 1'S WASTEWATER TREATMENT PLANT AND COLLECTION SYSTEM

WHEREAS, the County entered into an existing minor contract with General Control Systems, Inc. dated August 18, 2016, as amended on September 19, 2017, for professional services, equipment and hardware to repair and update instrumentation systems, including the Supervisory Control and Data Acquisition ("SCADA") system, and ancillary equipment, throughout the Saratoga County Sewer District No. 1's Wastewater Treatment Plant and collection system, at the rates set forth in General Control Systems' Engineering and Field Rate Schedule in effect at the time services were provided; and

WHEREAS, as a result of increasing maintenance needs for the SCADA system due to its age, services rendered by General Control Systems, Inc. exceeded the minor contract amount by an additional \$976.38 in 2017 and an additional \$2,736.17 in 2018; and

WHEREAS, it is necessary to enter into an agreement with General Control Systems, Inc. in the amount of \$34,000 for the term from January 1, 2017 through December 31, 2018 in order to authorize payment of said amounts expended in 2017 and 2018 that were in excess of the annual minor contract amount of \$15,000; and

WHEREAS, General Control Systems, Inc. is in the process of installing upgrades and replacement equipment to the SCADA system as authorized by Resolution 211-2018, which improvements will keep the costs for future maintenance of the system within the annual minor contract amount of \$15,000; and

WHEREAS, the Saratoga County Sewer District Commission and the Executive Director of the Saratoga County Sewer District No. 1 have recommended that the County enter into an agreement with General Control Systems, Inc. for professional services, equipment and hardware to repair and update instrumentation systems, including the SCADA system, and ancillary equipment, throughout the Sewer District's Wastewater Treatment Plant and collection system, for the term January 1, 2017 through December 31, 2018 at a cost of \$34,000; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with General Control Systems, Inc., of Green Island, New York for professional services, equipment and hardware to repair and update instrumentation systems, including the SCADA system, and ancillary equipment, throughout the Sewer District's Wastewater Treatment Plant and collection system, for the term January 1, 2017 through December 31, 2018 at a cost of \$34,000; and, be it further

RESOLVED, that the form and content of such agreement shall be subject to the approval of the County Attorney.

AUTHORIZING AN AGREEMENT WITH ARCADIS OF NEW YORK, INC. FOR DESIGN, CONSTRUCTION ADMINISTRATION AND INSPECTION SERVICES FOR THE CONSTRUCTION OF A REGIONAL BIOSOLIDS DIGESTER FACILITY

WHEREAS, pursuant to Resolution 135-2017, this Board authorized the Chairman to execute a cooperative agreement with the County of Albany, on behalf of the Albany County Water Purification District, to retain the services of a qualified professional engineering firm to perform a feasibility study for the construction of a regional biosolids digester facility that would dispose of biosolids from both the Albany County Water Purification District ("ACWPD") and Saratoga County Sewer District No. 1 ("SCSD1"), and to share the costs of such regional study in the following percentages: NYSERDA-50%, ACWPD-25% and SCSD1-25%; and

WHEREAS, pursuant to Resolution 136-2017, the County of Saratoga, on behalf of SCSD1, entered into an agreement with Arcadis of New York, Inc. for the preparation of said feasibility study at a cost of \$100,000 to be shared and paid as follows: NYSERDA-\$50,000; ACWPD-\$25,000; and SCSD1-\$25,000; and

WHEREAS, the completed feasibility study determined that the construction of a regional biosolids handling facility, to be located at the existing site of the ACWPD North Wastewater Treatment Plant in the Village of Menands, would provide a long-term, cost-effective and environmentally friendly means for the Counties of Albany and Saratoga to dispose of sludge/biosolids, provide for energy recovery, and result in significant annual savings for both the ACWPD and SCSD1; and

WHEREAS, said feasibility study estimated the maximum cost of construction of the regional biosolids handling facility at \$48,500,000, and proposed a plan to finance for the construction of the facility which provided for the County of Saratoga and the County of Albany to each pay fifty percent (50%) of said maximum estimated cost, with the cost to each County being \$24,250,000; and

WHEREAS, Resolution 98-2018 authorized the execution of an intermunicipal cooperative agreement pursuant to General Municipal Law §11 between the County of Albany, on behalf of the Albany County Water Purification District, and the County of Saratoga, providing for the joint construction, financing, operation and governance of the regional biosolids handling facility; and

WHEREAS, following a public hearing held by this Board on July 11, 2018 upon the proposal of SCSD1 and the ACWPD to jointly construct, operate and maintain a regional biosolids digester facility at ACWPD's North Wastewater Treatment Plant in the Village of

Menands, this Board of Supervisors adopted Resolution 170-2018 approving the proposed project to jointly construct, operate and maintain said regional biosolids digester facility, and the financing of the County's fifty percent (50%) share of the costs of constructing said facility through the issuance of bonds in an amount not to exceed \$24,500,000; and

WHEREAS, the Board of Commissioners of the ACWPD, acting as lead agency on this project, solicited proposals from professional engineering firms for the provision of design, construction administration and inspection services for the construction of the joint regional biosolids digester facility; and

WHEREAS, a committee consisting of four (4) representatives of SCSD1 and four (4) representatives of ACWPD scored the proposals received, and recommended that the proposal of Arcadis of New York, Inc. be accepted; and

WHEREAS, the Saratoga County Sewer District Commission and the Sewer District's Executive Director have recommended that a contract for design, construction administration and inspection services be awarded to Arcadis of New York, Inc. at a cost of \$5,806,200 to be shared equally by the Counties of Albany and Saratoga; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute a joint agreement on behalf of County of Saratoga with the County of Albany, as contractees, retaining the professional engineering services of Arcadis of New York, Inc. for the provision of design, construction administration and inspection services for the construction of a joint regional biosolids digester facility at a total cost of \$5,806,200, to be paid by each County in equal shares not to exceed \$2,903,100 per County; and be it further

RESOLVED, that the foregoing contract award to Arcadis of New York, Inc. shall be subject to and conditioned upon the Albany County Legislature adopting a similar resolution obligating the County of Albany, on behalf of the Albany County Water Purification District, to jointly execute such contract with the County of Saratoga and to pay for its equal share in the amount of \$2,903,100 of the total contract cost of \$5,806,200; and be it further

RESOLVED, that the form and content of such agreement shall be subject to the approval of the County Attorney.

BUDGET IMPACT STATEMENT: None. Costs associated with 2019 expenses for this contract are included in the Sewer District's 2019 budget.

AUTHORIZING THE ACCEPTANCE AND DISBURSEMENT OF NEW YORK STATE SEPTIC SYSTEM REPLACEMENT PROGRAM GRANT FUNDS, AND AMENDING THE 2019 COUNTY BUDGET IN RELATION THERETO

WHEREAS, the New York State Clean Water Infrastructure Act of 2017 established the Septic System Replacement Fund (“the Fund”) to provide property owners a source of funding for the replacement of failing cesspools and septic systems servicing residences and small businesses in New York State; and

WHEREAS, the Septic System Replacement Program (“the Program”) is a grant program that seeks to reduce the environmental and public health impacts associated with the discharge of effluent from cesspools and septic systems on groundwater used as drinking water, as well as threatened or impaired waterbodies; and

WHEREAS, pursuant to Resolution 79-2018, this board authorized the County to participate in the New York State Environmental Facilities Corporation (“EFC”) Septic System Replacement Program (“the Program”) for the term March 1, 2018 through December 31, 2022, and authorized the execution of a County Participation Agreement with the EFC; and

WHEREAS, the Program is being administered for the County by the Saratoga County Soil and Water Conservation District; and

WHEREAS, a property owner in the Town of Clifton Park submitted a grant application to the Saratoga County Soil and Water Conservation District requesting an award of Program funds for the replacement of the aging septic system on her property; and

WHEREAS, the Saratoga County Soil and Water Conservation District determined that said proposed septic system project would significantly and quantifiably reduce potential environmental and/or public health impacts that could result from the aging septic system, and issued an award letter to the applicant notifying her of the award of Program funds for the reimbursement of her eligible project costs; and

WHEREAS, the property owner has completed her septic system replacement project, and has submitted an application to the Saratoga County Soil and Water Conservation District for the disbursement of her grant award of Program funds; and

WHEREAS, the Saratoga County Soil and Water Conservation District made an application to the EFC for disbursement of the Septic System Replacement Program funds awarded for this septic system project, and EFC has distributed total funds in the amount of \$4,800 to the County in reimbursement of the eligible costs of said project; and

WHEREAS, the acceptance and disbursement of these Septic System Replacement Program grant funds requires this Board's approval, and an amendment to the 2019 Saratoga County Budget; now, therefore, be it

RESOLVED, that the Chair of the Board of Supervisors is hereby authorized to execute all necessary documents with the New York State Environmental Facilities Corporation for the acceptance of Septic System Replacement Program grant funds in the amount of \$4,800, with the form and content of such documents being subject to the approval of the County Attorney; and, be it further

RESOLVED, that the 2019 Saratoga County Budget is hereby amended as follows:
