WHEREAS, it is anticipated that these CAPTA/CARA grant funds will be available on an annual basis for up to an additional four (4) years, subject to federal appropriation; and

WHEREAS, eligibility requirements for the CAPTA/CARA grant monies mandate that the behavioral health consultant must be located on-site at the County DSS offices; and

WHEREAS, the Commissioner of the Department of Social Services solicited proposals for the provision of behavioral health clinician services to assist DSS Child Protective Services and Preventive Services caseworkers to identify and support the behavioral health needs of both adults and children where substance abuse is an issue; and

WHEREAS, our Health and Social Services Committee and the Commissioner of the Department of Social Services have recommended that the proposal of ECS Psychological Services, P.C. be accepted; and

WHEREAS, the acceptance of these State OCFS grant funds requires this Board's approval and an amendment to the 2019 County Budget; now, therefore, be it

PROCLAIMING APRIL 2019 AS "DONATE LIFE MONTH" IN SARATOGA COUNTY

WHEREAS, through Saratoga County's membership with the New York State Association of Counties (NYSAC) and New York State Association of County Clerks (NYSACC) New York's Counties have come together to collectively support Donate Life Month in New York State; and

WHEREAS, nationally, one person is added to the organ transplant waiting list every ten minutes, nearly 115,000 men, women and children are awaiting organ transplants and 22 people die each day because the organ they need is not donated in time; and

WHEREAS, organ, tissue, marrow and blood donation are life-giving acts recognized worldwide as expressions of compassion to those in need; and

WHEREAS, a single individual's donation of the heart, lungs, liver, kidneys, pancreas and small intestine can save up to eight lives; donation of tissue can save and heal the lives of up to 75 others; and a single blood donation can help three people in need; and

WHEREAS, in New York State there are approximately 10,000 people waiting for an organ transplant which represents the third highest need in the nation; and there is an estimated 500 New Yorkers that die every year while waiting for an organ transplant; and

WHEREAS, New York State's County governments play a key role in raising awareness of the need for organ and tissue donation through the interactions County officials have with the public with regard to this subject through local DMV offices, local boards of elections, departments of health, naturalization ceremonies and veterans' programs; and

WHEREAS, such interactions by Saratoga County officials with the public provide opportunities for the provision of information on how individuals can help their fellow New Yorkers by signing up as organ and tissue donors; and

WHEREAS, Counties across New York State are proclaiming the month of April 2019 as "Donate Life Month", and engaging in various activities designed to promote an increase in the number of registered organ and tissue donations; and

WHEREAS, efforts by our County Clerk's Office to educate and encourage patrons of its Department of Motor Vehicles to register as organ and tissue donors have contributed to a remarkable increase in enrolled donors in Saratoga County from 68,576 in 2013 (39.43% of eligible population) to 98,355 in 2018 (53.8% of eligible population); and

WHEREAS, one activity that the New York Alliance for Donation has encouraged counties to undertake in order to raise awareness of the need for organ and tissue donations is to raise the "Donate Life Flag" at their county municipal offices; and

WHEREAS, our Health and Social Services Committee and the Saratoga County Clerk's Office, through its Department of Motor Vehicles, wish to promote the month of April 2019 as "Donate Life Month" in Saratoga County; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby proclaims the month of April 2019 as "Donate Life Month" in Saratoga County, and encourages those Saratoga County departments and agencies involved in providing information on organ and tissue donations or in registering organ and tissue donors to engage in activities throughout the month to increase the number of organ and tissue donors and promote awareness of the need for organ and tissue donations in Saratoga County; and be it further

WHEREAS, Axon will also provide on-site spare equipment, as well as replacements for defective or damaged equipment and upgrades to new Taser models; and

WHEREAS, Axon Enterprise, Inc. is a sole source vendor for the purchase of Taser brand CEWs; and

WHEREAS, our Public Safety Committee and Sheriff Michael Zurlo have recommended that the proposal of Axon Enterprise, Inc. be accepted; now, therefore, be it

WHEREAS, the communication of such dispatch information to subscribing emergency responders saves critical time, and reduces response times for fire departments, EMS agencies, Search and Rescue teams (SAR), technical rescue teams, and other incident response teams responding to emergencies; and

WHEREAS, the "iamresponding.com" system includes many other features that greatly assist emergency responders in the performance of their duties, including hydrant and water source mapping, apps with fully integrated Google Maps, and instant mass-messaging within agencies; and

WHEREAS, Emergency Services Marketing Corp., Inc. has submitted a proposal to renew its subscription agreement to continue to provide "iamresponding.com" system services for a term commencing on June 16, 2019 and terminating on August 31, 2024, at a cost of: i) \$6,408 for the period June 16, 2019 through August 31, 2019, payable by June 16, 2019; and ii) at a cost of \$31,270 per year for five (5) years payable on August 31 of each year commencing on August 31, 2019 and continuing through August 31, 2023; and

WHEREAS, our Public Safety Committee and the County Fire Coordinator have recommended that the proposal of Emergency Services Marketing Corp., Inc. be accepted; now, therefore, be it

WHEREAS, a real estate appraisal obtained by the County from Sterling Commercial Appraisals, LLC, a duly licensed appraisal company, established the market value of the Reserve Station parcel at \$250,000; and

WHEREAS, our Public Safety Committee, the County's Commissioner of Emergency Services and the County Fire Coordinator have recommended that the County accept the proposal of the Round Lake Hose Company, No. 1, Inc. and purchase the Reserve Station parcel on Taddeo Road in the Town of Malta for the sum of \$161,000; and

RESOLVED, that the Chair of the Board is authorized to execute any and all documents necessary to effect the County's purchase of the .6 acre Reserve Station parcel on Taddeo Road in the Town of Malta from the Round Lake Hose Company, No. 1, Inc., with all such documents being subject to the approval of the County Attorney; and be it further

WHEREAS, the County Recycling Centers in the Towns of Clifton Park, Corinth and Moreau and the City of Saratoga Springs are located at waste transfer stations respectively owned and operated by the four

municipalities, and whereat the solid waste transfer function is managed by Town/City employees, and prior to March 2015 the recyclables collection function was managed by a County employee; and

WHEREAS, in order to promote efficiencies and reduce costs through a consolidation of municipal services, the County adopted a plan in 2014 to: 1) convert the collection of recyclables from multi-stream recycling to single-stream recycling; 2) privatize the transportation of recyclables from all County recyclables transfer stations; and 3) transfer the oversight of the collection of recyclables at all County recyclables transfer stations to the respective local municipalities operating the solid waste transfer station at the site of each County recyclables transfer station; and

WHEREAS, pursuant to Resolution 257-2014, this Board of Supervisors authorized intermunicipal agreements with the Towns of Clifton Park, Corinth and Moreau and the City of Saratoga Springs to transfer the management and oversight of the collection and removal of recyclable materials and scrap metal at the County Recycling Centers located in each Town and City from the County to the respective municipality where each Recycling Center is located, for the term from February 1, 2015 through December 31, 2016, at an annual rate and cost to the County of \$35,000 per municipality, upon the condition that the Towns and the City utilize said monies paid by the County for solid waste and/or recycling purposes; and

WHEREAS, pursuant to Resolution 206-2016, this Board authorized the renewal of the intermunicipal agreements with the County, the Towns of Clifton Park, Corinth and Moreau, and the City of Saratoga Springs for an additional term of two (2) years from January 1, 2017 through December 31, 2018, at an annual rate and cost to the County of \$35,000 per municipality, upon the condition that the Towns and the City utilize said monies paid by the County for solid waste and/or recycling purposes; and

WHEREAS, Resolution 206-2016 further provided that each intermunicipal agreement was subject to a right of renewal for up to two (2) additional terms of two (2) years each upon the respective adoption of a resolution by this Board of Supervisors and the governing body of each municipality authorizing the renewal of the agreement upon terms and conditions mutually agreeable to the County and each municipality by no later than sixty (60) days prior to the expiration date of the agreement or any renewal term thereof; and

WHEREAS, said intermunicipal agreements expired on December 31, 2018, and the County, the Towns of Clifton Park, Corinth and Moreau, and the City of Saratoga Springs wish to renew their respective intermunicipal agreements for an additional term of one (1) year from January 1, 2019 through December 31, 2019 at an annual rate and cost to the County of \$35,000 per municipality, upon the condition that the Towns and the City utilize said monies paid by the County for solid waste and/or recycling purposes; now, therefore, be it

WHEREAS, our Buildings and Grounds Committee and the Director of Information Technology have recommended that the proposal of Twinstate Technologies, Inc. be accepted; now, therefore, be it

RENEWING AND AMENDING THE AGREEMENT WITH NEW ENGLAND WASTE SERVICES OF ME, INC. D/B/A CASELLA ORGANICS FOR SLUDGE HAULING FROM SARATOGA COUNTY SEWER DISTRICT NO 1'S WASTEWATER TREATMENT PLANT

WHEREAS, pursuant to Resolution 137-2017, this Board authorized an agreement with New England Waste Services of ME, Inc. d/b/a Casella Organics ("Casella Organics") for the removal, transportation and disposal of sludge/biosolids from Saratoga County Sewer District No. 1's ("SCSD") Wastewater Treatment Plant for a term of two years commencing on June 1, 2017, subject to a one year extension upon the mutual agreement of the parties, at a cost of \$90.76 per wet ton, plus a surcharge of \$10 per wet ton for each ton collected and transported above 430 wet tons per week and a demurrage fee of \$47.50 per half hour for load times greater than 6 hours caused by the Sewer District's maintenance of its belt filter press; and

WHEREAS, SCSD has been very satisfied with the services provided by Casella Organics for the transportation and disposal of sludge/biosolids from the Wastewater Treatment Plant, and wishes to extend its agreement with Casella Organics for an additional year; and

WHEREAS, Casella Organics is willing to extend its agreement with SCSD for an additional year subject to SCSD's agreement to pay a flat \$2.50 per ton fuel surcharge due to escalating fuel prices, bringing the total cost per ton to \$93.26; and

WHEREAS, SCSD's Executive Director has conducted an analysis of the market for transportation and disposal of sludge/biosolids and determined that the base cost of \$93.26 per ton proposed by Casella Organics is at or below average market cost; and

WHEREAS, the Saratoga County Sewer District Commission and the Sewer District's Executive Director have recommended the acceptance of the proposal of Casella Organics to renew and amend its agreement with the County for the removal, transportation and disposal of sludge/biosolids for an additional term of one (1) year at a cost of \$93.26 per wet ton, inclusive of a \$2.50 fuel surcharge, plus a surcharge of \$10 per wet ton for each ton collected and transported above 430 wet tons per week and a demurrage fee of \$47.50 per half hour for load times greater than 6 hours caused by the Sewer District's maintenance of its belt filter press; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement renewing and amending the County's agreement with New England Waste Services of ME, Inc. d/b/a Casella Organics of Saco, Maine for the removal, transportation and disposal of sludge/biosolids from Saratoga County Sewer District No. 1's Wastewater Treatment Plant, for a term of one (1) year commencing on June 1, 2019 and terminating on May 31, 2020, subject to the right of the County to terminate the agreement upon ninety (90) days written notice, at a cost of \$93.26 per wet ton, plus a surcharge of \$10 per wet ton for each ton collected and transported above 430 wet tons per week and a demurrage fee of \$47.50 per half hour for load times greater than 6 hours caused by the Sewer District's maintenance of its belt filter press; and, be it further

RESOLVED, that the form and content of such agreement shall be subject to the approval of the County Attorney

<u>BUDGET IMPACT STATEMENT</u>: None. Costs associated with this contract are included in the Sewer District's 2019 budget.
