WHEREAS, based upon the recent recommendations of the Maddie's Shelter Medicine Program of Cornell University, the Human Resources and Insurance Committee, the Director of Human Resources and the Director of the Animal Shelter have requested that the 2019 Saratoga County Compensation Schedule be amended under the Animal Shelter to: i) reclassify the position of Veterinarian, PT to Veterinarian, Grade 19; ii) create the position of Operations Coordinator, Grade 10; iii) abolish the position of Veterinary Technician, Per Diem, \$20.00/hr.; iv) reclassify one position of Animal Shelter Aide (40 hr/wk) to the position of Shelter Service Aide, Base \$36,831; v) create one position of Shelter Service Aide, with a base salary of \$36,831; vi) reclassify two positions of Animal Shelter Aide (35 hr/wk) to two positions of Animal Shelter Aide (40 hr/wk); and vii) abolish two positions of Animal Shelter Aide, Per Diem; and

WHEREAS, the Human Resources and Insurance Committee, the Director of Human Resources and the County Attorney have recommended that the 2019 Saratoga County Compensation Schedule be amended under County Attorney to reclassify the position of Legal Assistant - Contracts to Paralegal Specialist with a base salary of \$50,965 to reflect the need for a more skilled position within said department, and one that will also assist the Assistant County Attorneys assigned to represent the County in Family Court proceedings in drafting court orders, subpoenas, motions, briefs and other legal documents; and

WHEREAS, the Human Resources and Insurance Committee and the Director of Human Resources have recommended that the 2019 Saratoga County Compensation Schedule be amended under Human Resources to reclassify the position of Labor Attorney to Labor Attorney (18-B Administrator/Data Officer) to better serve the demand for legal representation of indigent defendants in cases where the Public Defender's Office has a conflict, in accordance with the recommendations and funding requirements of the New York State Office of Indigent Legal Services; and

WHEREAS, the Human Resources and Insurance Committee, the Director of Human Resources and the Public Defender have recommended that the 2019 Saratoga County Compensation Schedule be amended under Public Defender's Office to create two positions of Assistant Public Defender and to create one position of Paralegal Specialist to better serve the demand for legal representation of indigent defendants in local criminal courts, in accordance with the recommendations and funding requirements of the New York State Office of Indigent Legal Services; and

WHEREAS, our Human Resources and Insurance Committee has approved the proposed revisions to the County's Title VI Plan; and

WHEREAS, a copy of the proposed revised Saratoga County Title VI Plan was provided to each member of this Board; and

WHEREAS, the implementation of legislature revisions to the Manual requires the approval of this Board; now, therefore, be it

WHEREAS, our Human Resources Department and the County Attorney's Office have revised and updated the Saratoga County Health Information Policy and Procedures, and it is appropriate that said Policy and Procedures be incorporated into and made a part of the County's Policies and Procedures Manual; and

WHEREAS, our Human Resources Department has distributed to each member of this Board a copy of the revised "Saratoga County Health Information Policy and Procedures", the provisions of which comply with the federal requirements set forth in the Health Insurance Portability and Accountability Act; and

WHEREAS, in Saratoga County, the caseworkers of the Children's Services Protective/Preventive and Foster Care units of our Department of Social Services work diligently to provide support to at-risk families through services such as mental health and substance abuse treatment, as well as parenting skill-based programs, so that more children may remain safely in or return to their homes; and

WHEREAS, the Saratoga County Board of Supervisors is committed to strengthening families, raising awareness of the need to identify and protect children at-risk, focusing on the prevention of child abuse and neglect, and working to help parents and children thrive; and

WHEREAS, all citizens share a responsibility in preventing child abuse through diligent reporting of child abuse or maltreatment to the Statewide Central Register of Child Abuse and Maltreatment, the State's child abuse hotline service that is available 24 hours a day, seven days a week, by calling 1-800-342-3720; now, therefore, be it

RESOLVED, that this Board of Supervisors proudly proclaims the month of April 2019 as "Child Abuse Prevention Month" in the County of Saratoga, and encourages every resident to join in the effort to make the safety, welfare and well-being of our precious children among our highest priorities.

OPPOSING THE DRIVER'S LICENSE ACCESS AND PRIVACY ACT CONCERNING UNDOCUMENTED INDIVIDUALS

WHEREAS, holding a driver's license in New York State is a privilege, not a right; and

WHEREAS, the granting of a driver's license is a privilege for people who have followed the law and have proven themselves capable of operating an automobile; and

WHEREAS, this Board of Supervisors supports current statutes that authorize the issuance of driver's licenses to eligible individuals who enter the country in accordance with laws of the United States of America and New York State; and

WHEREAS, a bill known as the "Driver's License Access and Privacy Act" has been introduced in the New York State Senate (S.1747) and the New York State Assembly (A.3675) which if enacted into law, would permit undocumented individuals who are present in the United States of America illegally under federal law to obtain a driver's license; and

WHEREAS, New York State presently suspends or revokes driver's licenses for various illegal acts, including non-payment of child support, delinquent taxes, and refusal to submit to a breathalyzer, yet this Act would reward illegal entry into the United States with a driver's license; and

WHEREAS, adoption of the Act would create unacceptable security risks because:

- there is no guarantee the identity of undocumented individuals can be properly verified by the State of New York if the federal government has not issued a green card or visa, and the Act's proposed privacy protections may frustrate federal immigration enforcement efforts; and
- local Department of Motor Vehicles (DMV) offices do not have the expertise needed to determine the authenticity of foreign birth certificates, foreign passports, consular cards or to verify evidence of an undocumented individual's residency in the state; and
- driver licenses can be used to obtain additional official identification documents intended only for United States citizens; and
- the Act would eliminate the NYS DMV's 2002 requirement that Social Security Numbers be verified with the Social Security Administration to confirm an applicant's full identity when obtaining a standard driver's license or non-driver ID, which requirement has led to the discovery of massive amounts of fraudulent activity, including identity theft, bank fraud, insurance fraud, and multiple licenses to avoid loss of driving privileges or active warrants; and

WHEREAS, there is no guarantee that passage of the Act would make New York State roads safer; and WHEREAS, the approval of the Act would increase opportunities for voter fraud as illegal immigrants applying for a driver's license would be prompted by the NYS DMV's license registration system to register to vote, and there are currently no protections in the system that would prevent an illegal immigrant from registering to vote; and

WHEREAS, the Saratoga County Board of Supervisors encourages all immigrants to pursue the path to legal citizenship, and recognizes and honors the process immigrants must undertake to become United States citizens, culminating in Saratoga County in the annual citizenship ceremony held at the Saratoga National Battlefield; and

WHEREAS, legal immigrants are lawfully entitled to receive a non-driver ID or license during their stay; and

WHEREAS, our Legislative and Research Committee, and the Saratoga County District Attorney Karen A. Heggen, Saratoga County Clerk Craig A. Hayner and Saratoga County Sheriff Michael H. Zurlo have all recommended that this Board express its strong opposition to the adoption and enactment into law of the "Driver's License Access and Privacy Act"; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby opposes the adoption of the "Driver's License Access and Privacy Act" which would allow the issuance of licenses to undocumented individuals and create security risks, and because driving is a privilege, not a right; and, be it further

RESOLVED, that the Clerk of this Board shall send a copy of this resolution to the Governor Andrew M. Cuomo, Temporary President and Majority Leader of the Senate Andrea Stewart-Cousins, Speaker of the Assembly Carl E. Heastie, Senate Minority Leader John J. Flanagan, Assembly Minority Leader Brian M. Kolb, and our local State legislators.

WHEREAS, Creighton Manning, LLP has submitted a proposal for engineering services for the Final Design and ROW Acquisition phases of the rehabilitation of the Ashdown Road Bridge at a cost of \$151,671; and WHEREAS, our Public Works Committee and the County's Commissioner of Public Works have recommended that the County's agreement with Creighton Manning, LLP be amended to authorize Creighton Manning, LLP to provide Phase V (ROW Acquisition) and Phase VI (Final Design) services in connection with the rehabilitation of the Ashdown Road Bridge over CP Rail at an additional cost not to exceed \$151,671; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an amendment to the agreement with Creighton Manning Engineering, LLP of Albany, New York, for Phase V (ROW Acquisition) and Phase VI (Final Design) services related to the rehabilitation of the Ashdown Road Bridge over CP Rail in the Town of Clifton Park, at an additional cost not to exceed \$151,671, with the form and content of said amendment being subject to the approval of the County Attorney.

AUTHORIZING A RENEWAL ENTERPRISE ENROLLMENT AGREEMENT WITH MICROSOFT THROUGH DELL MARKETING, L.P. FOR EMAIL HOSTING SERVICES

WHEREAS, pursuant to Resolution 129-2016 as amended by Resolution 96-2018, the County entered into an Enterprise Enrollment Agreement with Microsoft for the provision of Microsoft Office Exchange email services through Dell, Inc. for a term of three (3) years commencing on or about June 15, 2016 at a cost not to exceed \$35,000 the first year, \$57,500 the second year, and \$63,000 the third year; and

WHEREAS, the Enterprise Enrollment Agreement with Microsoft for the provision of email services through Dell, Inc. will expire on June 30, 2019; and

WHEREAS, Microsoft has submitted a proposed renewal Enterprise Enrollment Agreement authorizing the provision of 725 Microsoft Exchange email accounts and 35 Office 365 email accounts through Dell Marketing, L.P. for a renewal term of three (3) years at a cost not to exceed \$71,923.80 the first year, and \$71,923.80 plus a contingency in the amount of \$3,076.20 per year for additional email account licenses for a total of \$75,000 per year for the second and third years; and

WHEREAS, the Microsoft Exchange/Office 365 solution is currently the only New York State approved email provider that satisfies current federal and state email security and encryption requirements and incorporates Health Insurance Portability and Accountability Act (HIPAA), Personally Identifiable Information (PII) and Criminal Justice Information Services (CJIS) compliance and certification; and

AUTHORIZING THE CHAIRMAN TO ENTER INTO AN AGREEMENT WITH O'CONNELL & ARONOWITZ, P.C. FOR PROFESSIONAL LEGAL SERVICES RELATIVE TO OBJECTIONS FILED IN THE JUNE R. JOHNSON TRUST AND ESTATE PROCEEDINGS

WHEREAS, pursuant to Resolution 72-2017, the County Attorney was authorized to pursue the prosecution of Objections filed on behalf of the Saratoga County Animal Shelter to the Accountings filed by Trustco Bank in the June R. Johnson Trust and Estate proceedings pending in Schenectady County Surrogate's Court, and to retain expert consultants if needed; and

WHEREAS, efforts to settle the Objections with counsel for Trustco Bank were contentious and unsuccessful, and the Objections were scheduled for trial on March 11-12, 2019 in the Schenectady County Surrogate's Court; and

WHEREAS, the County Attorney recommended that an experienced trial counsel in Surrogate's Court matters be retained to assist in negotiating a settlement of the County's Objections, and if necessary, to try the County's Objections; and

WHEREAS, the County entered into a minor contract with the law firm of O'Connell & Aronowitz, P.C., Scott Iseman, Esq. of counsel, to prepare for and conduct the trial of the County's Objections in the Schenectady County Surrogate's Court at a municipal rate of \$275 per hour for partner time and \$150 - \$225 per hour for associate time; and

WHEREAS, the trial of the County's Objections was held on March 11-12, 2019 as scheduled, and after the close of testimony a settlement was facilitated with assistance of the Schenectady County Surrogate Court Judge; and

WHEREAS, it is necessary to increase the County's contract with O'Connell & Aronowitz, P.C. above the minor contract limit of \$15,000 in order to pay for O'Connell & Aronowitz's anticipated final bill for legal services in preparing for and trying the County's Objections, and in negotiating and finalizing the settlement of the proceedings; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute a retainer agreement with O'Connell & Aronowitz, P.C. of Albany, New York, for the provision of professional legal services as trial counsel in connection with the preparation for and conduct of the trial and resulting settlement of the Objections filed on behalf of the Saratoga County Animal Shelter to the Estate and Trust Accountings for the June R. Johnson Estate and Trust filed by Trustco Bank in the Schenectady County Surrogate's Court, with said legal services to be provided at a cost of \$275 per hour for partner time and \$150 - \$225 per hour for associate time, plus any out-of-pocket disbursements and travel time, with the form and content of such retainer agreement to be subject to the approval of the County Attorney.

BUDGET IMPACT STATEMENT: None. Funds are available in the County Attorney's 2019 budget.
