DESIGNATING THE COUNTY OF SARATOGA AS A HIDDEN HEROES COUNTY

WHEREAS, the series of wars and conflicts in which our nation has been engaged over time, since World War II, has resulted in 5.5 million military and veteran caregivers who are parents, spouses, siblings and friends, caring for those wounded, ill or injured who have served our nation, as documented by the 2014 RAND study commissioned by the Elizabeth Dole Foundation; and

WHEREAS, the daily tasks of these military and veteran caregivers can include bathing, feeding, dressing, and caring for the grievous injuries of wounded warriors, administering medications, providing emotional support, caring for the family and the home, and working outside the home to earn essential income; and

WHEREAS, the nation provides multi-faceted support to our wounded, ill and injured veterans and service members through public, private and philanthropic resources, but their caregivers receive little support or acknowledgement; and

WHEREAS, most military and veteran caregivers consider the challenging work they do as simply carrying out their civic and patriotic duty, without realizing they are, in fact, caregivers, and do not identify themselves as such; and

WHEREAS, an alarming number of military and veteran caregivers, according to research, are suffering numerous debilitating mental, physical and emotional effects as a result of their caregiving duties; and

WHEREAS, the County of Saratoga desires to recognize and support those who are serving in these vital roles in our own community; now, therefore, be it

RESOLVED by the Saratoga County Board of Supervisors as follows:

- I. That the County of Saratoga is hereby designated a Hidden Heroes County in support of military and veteran caregivers; and
- II. That the County of Saratoga will seek to identify military and veteran caregivers residing in our community and determine the unique challenges they face; and

- III. That the County of Saratoga will work to ensure that our government, organizations, employers and non-profits are aware of the unique challenges of military and veteran caregivers and are encouraged to create supportive environments and opportunities for assistance; and
- IV. That the County of Saratoga will encourage all who care for and support veterans and service members to extend that support to their caregivers; and
- V. That the Saratoga County Veterans Service Agency and Veterans Peer Connection Program are hereby designated as a point of contact for our community, from the public or private sector, for citizens and organizations wanting to offer support, and caregivers who need that support; and
- VI. That the County of Saratoga will use the Elizabeth Dole Foundation's Military Caregiver Experience Map to understand the stages of the military caregiver journey and use it as a tool to encourage community understanding and support.

AUTHORIZING A HEALTH INSURANCE CONTRACT WITH CAPITAL DISTRICT PHYSICIANS' HEALTH PLAN, INC. FOR 2020

WHEREAS, pursuant to Resolution 240-2018, this Board authorized an agreement with Capital District Physicians' Health Plan, Inc. for the provision of medical and prescription health care insurance and administrative services for County employees for the term from January 1, 2019 through December 31, 2019 at a cost not to exceed \$22,828,956.48 subject to the agreement excluding the imposition of any late payment interest penalties; and

WHEREAS, Capital District Physicians' Health Plan, Inc. ("CDPHP") has submitted a proposal for the renewal of its contract for the provision of medical and prescription health insurance and administrative services for 2020 in the amount of \$22,969,841.28, which include additional benefits for County management employees which consist of, but are not limited to, increased reimbursement for specified medical procedures and access to CDPHP's Wellness and Rewards Programs; and

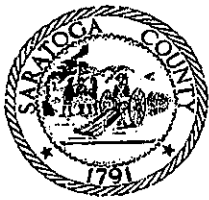
WHEREAS, the performance of CDPHP has been satisfactory; and

WHEREAS, our Human Resources and Insurance Committee and the County's Director of Human Resources have recommended that the County accept the proposal of Capital District Physicians' Health Plan, Inc. for the provision of medical and prescription health care insurance and administrative services for County employees for the term January 1, 2020 through December 31, 2020 at a cost not to exceed \$22,969,841.28, subject to the resulting agreement excluding the payment of any late payment interest penalties; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized and directed to execute any and all agreements including Stop/Loss insurance agreements needed with Capital District Physicians' Health Plan, Inc. for the provision of medical and prescription health care insurance and administrative services for County employees for the term from January 1, 2020 through December 31, 2020 at a cost not to exceed \$22,969,841.28, subject to such agreements excluding the imposition of any late payment interest penalties; and, be it further

RESOLVED, that the form and content of such agreements shall be subject to the approval of the County Attorney.

AMENDING THE 2019 COMPENSATION SCHEDULE UNDER ELECTION BOARD

WHEREAS, Chapter 6 of the Laws of 2019 of the State of New York added a new Title 6 to Article 8 of the Election Law of the State of New York mandating early voting in most elections in New York State, with voting to commence on the tenth day prior to the election date and terminate on the second day prior to the election date; and

WHEREAS, the Saratoga County Board of Elections needed to retain the services of election inspectors to work the three polling places established for early voting in Saratoga County; and

WHEREAS, the Human Resources and Insurance Committee, the Director of Human Resources and the Saratoga County Commissioners of Election have recommended that the 2019 Saratoga County Compensation Schedule be amended under "Election Board" to create twenty-four (24) Election Inspector positions for Early Voting at a compensation rate of \$125 per day, effective October 26, 2019, the first day of early voting in Saratoga County; now, therefore, be it

RESOLVED, that the 2019 Saratoga County Compensation Schedule is amended effective October 26, 2019 as follows:

WHEREAS, the Federal Act requires the preparation of a Four-Year Service Plan, annual updates and funding applications for the provision of listed services; and

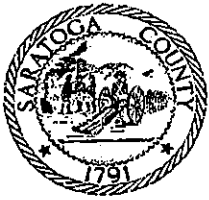
WHEREAS, the Office for the Aging has submitted its proposed 2020-2024 Four Year Service Plan for approval; and

RENEWING AND AMENDING THE SOFTWARE LICENSE AGREEMENT WITH COMPLIA HEALTH, LLC FOR SARATOGA COUNTY PUBLIC HEALTH SERVICES

WHEREAS, pursuant to Resolution 151-2017, as amended by Resolution 200-2017, this Board authorized the current License Agreement with Complia Health, LLC, for the electronic storage of medical records for Saratoga County Public Health Services for the term July 1, 2017 through December 31, 2019; and

WHEREAS, pursuant to said license agreement with Complia Health, LLC, Saratoga County Public Health Services electronically stores medical records in the cloud that it must contain to maintain from its former electronic medical records system provider, Progres; and

WHEREAS, Saratoga County Public Health Services desires to renew its License Agreement with Complia Health, LLC for the term from January 1, 2020 through December 31, 2020; and

WHEREAS, Complia Health, LLC is requesting an amendment to its License Agreement for the renewal term of January 1, 2020 through December 31, 2020 to increase their license fees at the rate of 3%; and

WHEREAS, our Public Health Committee and the Director of the Public Health Services have recommended that the County's License Agreement with Complia Health, LLC be renewed and amended to increase the following monthly license fees: Progres Hosting Fee from \$409.69 to \$421.98; ClinDoc Office maintenance for one user from \$32.84 to \$33.83; and HCMS maintenance for one user from \$67.08 to \$69.09; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an amendment to the County's software license agreement with Complia Health, LLC of Westmont, Illinois to renew and amend said license agreement to increase the following monthly fees: Progres Hosting Fee from \$409.69 to \$421.98, ClinDoc Office maintenance for one user from \$32.84 to \$33.83, and HCMS maintenance for one user from \$67.08 to \$69.09; which increases will increase the total contract amount from \$509.61 to \$524.90 per month, for the term from January 1, 2020 through December 31, 2020; and, be it further

AUTHORIZING THE ACCEPTANCE OF FUNDS IN THE AMOUNT OF \$5,000 FROM SARATOGA HOSPITAL AND AMENDING THE 2019 BUDGET IN RELATION THERETO

WHEREAS, the County of Saratoga and Saratoga Hospital have collaboratively written a Community Health Improvement Plan which has identified a high rate of obesity in children under the age of five in certain communities in Saratoga County, the causes of which obesity are believed to be partially due to low breastfeeding rates; and

WHEREAS, Saratoga Hospital has offered to Saratoga County Public Health Services a donation in the amount of \$5,000 in 2019 and an additional donation of \$5,000 in 2020 for the purpose of establishing a Baby Café, a community based, drop-in breastfeeding support site where certified lactation consultants will offer lactation advice and social support to breastfeeding mothers; and

WHEREAS, Saratoga County Public Health Services has selected the Town of Corinth as the first location in the County for the opening of a Baby Café; and

WHEREAS, Saratoga County Public Health Services proposes to use the \$5,000 donated by Saratoga Hospital for 2019 to: 1) train two Public Health staff members to become certified lactation consultants; 2) provide professional services through a WIC employee and pay for their re-certification; 3) obtain required licenses and permits for the operation of the Baby Café; 4) advertise the Baby Café; and 5) provide refreshments to be served at the Baby Café; and

WHEREAS, the acceptance of these funds requires this Board's approval and an amendment to the 2019 County Budget; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby accepts funds in the amount of \$5,000 from Saratoga Hospital for the purpose of establishing a Baby Café in the Town of Corinth for the benefit of area breastfeeding mothers and their babies; and, be it further

RESOLVED, that the 2019 Saratoga County Budget is hereby amended as follows:

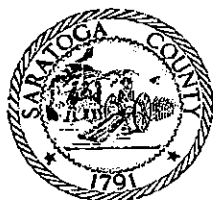

WHEREAS, NYSDOH received the funding it requested, and in conjunction with the New York State Association of Counties ("NYSAC") is coordinating the distribution of laptops and tablets to county coroners and medical examiners throughout the State; and

WHEREAS, our County Coroners and Assistant County Coroners have been advised by NYSAC that they will be receiving three (3) Samsung Galaxy Tab S4 tablets and two (2) Dell laptop computers for use by the Saratoga County Coroners' Office in reporting deaths to the State's Electronic Death Registration System; and

WHEREAS, NYSDOH has also explored a variety of options for case management software which will facilitate the electronic reporting to the NYS Department of Motor Vehicles Fatal Accident Reporting System and the NYSDOH National Violent Death Reporting System, and NYSDOH is expected to offer ImageTrend software free of charge to counties in the near future; and

WHEREAS, our Public Safety Committee and the County Coroners have recommended that the County accept the donation of computer equipment from the CDC, NYSDOH and NYSAC; now, therefore be it

URGING THE STATE OF NEW YORK TO IMMEDIATELY AMEND OR DELAY IMPLEMENTATION OF BAIL AND DISCOVERY REFORM LAWS THAT WILL ENDANGER THE PEOPLE OF NEW YORK AND REVERSE DECADES OF BIPARTISAN PROGRESS IN REDUCING CRIME

WHEREAS, protecting the people from harm by enforcing the rule of law is the foundational role of government; and

WHEREAS, County governments are vested by the State of New York with the responsibility to protect the most vulnerable among us, including the socioeconomically disadvantaged, the disabled, the elderly, and children; and

WHEREAS, no group is more vulnerable than the victims of crime, and a just society demands that crime victims should be recognized as key participants within the criminal justice system and be treated with dignity, fairness, and respect; and

WHEREAS, for the past twenty-five years the State of New York has committed itself to reducing crime, and has succeeded as evidenced by official U.S. Department of Justice Uniform Crime Reporting Statistics showing that New York transformed from the second most dangerous state in America in the early 1990s to the safest large state in America by the early 2000s; and

WHEREAS, in the final stages of adopting its FY 2020 budget, the State of New York enacted sweeping criminal justice reforms including the elimination of cash bail for many crimes and the imposition of stringent discovery mandates on police and prosecutors; and

WHEREAS, under bail reform, beginning January 1, 2020, judges will no longer be permitted to set bail for many crimes, which means those who have committed these crimes can no longer be held in jail after their arrest and will instead be released back into the general public; and

WHEREAS, these crimes include those that result in the deaths of innocent people, including several categories of homicide and manslaughter, resulting in those responsible for these deaths being released back into the midst of grieving families; and

WHEREAS, the crimes for which bail cannot be set include **Making a terroristic threat** and **Money laundering in support of terrorism in the third and fourth degree**, resulting in those who have supported terrorism and threatened to commit acts of terrorism being released immediately from police custody; and

WHEREAS, the crimes for which bail cannot be set also include **Promoting an obscene sexual performance by a child; Possessing an obscene sexual performance by a child; Failure to register as a sex offender; and Patronizing a person for prostitution in a school zone**, resulting in dangerous child predators being released back into our communities; and

WHEREAS, other serious crimes for which bail cannot be set include **Reckless assault of a child by a daycare provider; Criminal sale of a controlled substance to a child; Abandonment of a child; and Criminal possession of a weapon on school grounds**, resulting in those who have physically harmed or endangered children being freed from supervision; and

WHEREAS, additional crimes for which bail cannot be set shockingly include **Female genital mutilation; Stalking in the second degree; and Aggravated harassment**, resulting in those who have violated women being returned to the company of their victims; and

WHEREAS, also included among the crimes for which bail cannot be set are **Endangering the welfare of a vulnerable elderly person**, resulting in the potential for further endangerment of seniors; and

WHEREAS, the crimes for which bail cannot be set also include **Endangering the welfare of an incompetent or physically disabled person**, resulting in exposure of these defenseless individuals to repeat offenses; and

WHEREAS, these no-bail crimes also include **Aggravated cruelty to animals and Torturing animals and injuring animals**; resulting in the immediate release of these deprived individuals who deliberately injure, torture and kill animals; and

WHEREAS, other violent crimes for which bail cannot be set alarmingly include **Assault in the third degree, Aggravated vehicular assault**, and other crimes of physical violence against people; and

WHEREAS, additional no-bail crimes include **Burglary of a residence**, resulting in the immediate release of these individuals back into the neighborhoods they targeted, and

WHEREAS, crimes for which no bail can be set inexplicably include **Bail jumping and Unlawfully fleeing a police officer in a motor vehicle**, resulting in appearance tickets being issued to the very individuals who have demonstrated a propensity to knowingly and intentionally evade the law; and

WHEREAS, all of the offenders mentioned heretofore are at risk of not showing up for court, thereby placing a burden on public employees who under this law are required to send multiple court appearance reminders to these offenders, as well as police officers and District Attorneys who must commit resources to tracking and pursuing those who evade prosecution; and

WHEREAS, all offenders who are currently being held in custody for the crimes mentioned heretofore will be eligible for release from prison on January 1, 2020, and their attorneys are currently completing applications for their release; and

WHEREAS, the discovery mandates imposed by the State of New York will require police and District Attorneys, beginning January 1, 2020, to turn over voluminous trial-related materials to defense attorneys within 15 days, creating a mandate that will inevitably not be

achieved in some cases and will result in the inability of the People to prosecute cases against criminal defendants; and

WHEREAS, New York State's chief law enforcement officer, Attorney General Letitia James, has testified that there will be implementation difficulties because prosecutors across the state lack the resources required to fully comply with discovery mandates; and

WHEREAS, Attorney General James has testified that her own office, which carries a limited criminal caseload, lacks resources required to fully comply with discovery mandates and therefore needs an additional \$10 million in state funding; and

WHEREAS, the issues mentioned heretofore undeniably impact past, present and future victims of crime in a negative manner, and in so doing, the bail and discovery reforms adopted by the State of New York will themselves further victimize these innocent individuals; and

WHEREAS, these bail and discovery laws, in their current form, represent a clear and present danger to society, will tilt the scales of justice in favor of criminals and away from crime victims, will reverse decades of bipartisan progress made by the State of New York in reducing crime; and

WHEREAS, the fundamental responsibility of governments to protect the vulnerable in society demands that the shortcomings of these laws be remedied prior to their effective date of January 1, 2020; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby urges the New York State Legislature, Governor Andrew Cuomo and involved State agencies to immediately amend or otherwise delay implementation of these laws by convening an emergency session of the State Legislature, or by emergency executive authority, or by any other means deemed possible by the State, and to do so before December 31, 2019; and be it further

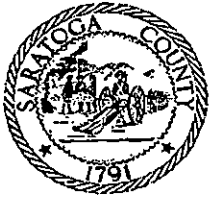
RESOLVED, that the Saratoga County Board of Supervisors hereby demands that the following improvements to these laws be implemented as soon as possible:

1. Give judges the ability to impose bail when appropriate for all of the crimes enumerated herein;
2. Increase the discovery timeline from 15 days to a minimum of 45 days;
3. Phase in discovery reform by applying these new mandates to misdemeanors effective January 1, 2020, and felonies effective January 1, 2021;
4. Require that court appearance reminders are sent not only to defendants but also to the victims of their crimes; and
5. Extend appropriate dignity, fairness and respect to crime victims by soliciting input from victim advocate organizations and considering their suggestions for improving these laws, and be it further

RESOLVED, that the Saratoga County Board of Supervisors asks all counties in New York State to urge their state representatives to take immediate action on the foregoing issues; and be it further

RESOLVED, that the Clerk of this Board shall send a copy of this Resolution to Governor Andrew M. Cuomo, Attorney General Letitia James, Temporary President and Majority Leader of the Senate Andrea Stewart-Cousins, Speaker of the Assembly Carl E. Heastie, Senate Minority Leader John J. Flanagan, Assembly Minority Leader Brian M. Kolb, our local State legislators, the New York State Association of Counties, the New York State Sheriffs' Association, the District Attorneys Association of New York, the New York State Defenders Association, the New York State Probation Officers Association, and the County Attorneys' Association of the State of New York.

WHEREAS, intense rains and resulting high creek flow caused the County's bridge over Paul Creek, CR 4 (North Shore Road) in the Town of Day, to collapse along with the surrounding road surface, during the night of October 31, 2019/November 1, 2019; and

WHEREAS, County Department of Public Works highway personnel responded immediately, and closed and barricaded the bridge, added detour signage, safety fencing and hazard lighting; and

WHEREAS, Governor Cuomo declared a state of emergency in Saratoga County due to storm related damage sustained throughout the County, which included the collapse of the CR 4 bridge; and

WHEREAS, our County Commissioner of Public Works engaged the services of engineering consultants from Creighton Manning Engineering, LLP ("CME") to perform an emergency evaluation of the collapsed bridge and outline options for the temporary and permanent replacement of the bridge; and

WHEREAS, CME determined that the existing bridge could neither be repaired nor reconstructed, and was therefore a total loss; and

WHEREAS, at the request of the County Commissioner of Public Works, CME submitted a lump sum proposal for the performance of engineering services related to both the assessment and removal of the collapsed CR 4 (North Shore Road) bridge, and the provision of design services for the installation of a temporary two-lane bridge; and

WHEREAS, our Public Works Committee and the County's Commissioner of Public Works have recommended that the proposal of CME for the performance of engineering services related to the removal of the CR4 (North Shore Road) bridge over Paul Creek in the Town of Day, and the provision of design services for the installation of a temporary two-lane bridge, at a cost of \$16,500, be accepted; and

WHEREAS, an appropriation from Fund Balance and an amendment to the 2019 County Budget is needed to fund this expense; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Creighton Manning Engineering, LLP of Albany, New York for the provision of engineering services for the removal of the CR 4 (North Shore Road) bridge over Paul Creek in the Town of Day and the design of the installation of a temporary two-lane bridge, at a cost not to exceed \$16,500, with the form and content of said agreement to be subject to the approval of the County Attorney; and be it further

WHEREAS, pursuant to Resolution 248-2019, this Board authorized an agreement with Creighton Manning Engineering, LLP for the provision of engineering services related to the removal of the CR 4 (North Shore Road) bridge over Paul Creek in the Town of Day, and the design of the installation of a temporary bridge, necessitated by the collapse of the CR 4 bridge after intense rains and high creek flow during the night of October 31, 2019/November 1, 2019; and

WHEREAS, Governor Cuomo declared a state of emergency in Saratoga County due to storm related damage sustained throughout the County, which included the collapse of the CR 4 bridge; and

WHEREAS, our County Commissioner of Public Works Keith Manz engaged the services of engineering consultants from Creighton Manning Engineering, LLP ("CME") to perform an emergency evaluation of the collapsed bridge and outline options for the temporary and permanent replacement of the bridge; and

WHEREAS, CME determined that the existing bridge could neither be repaired nor reconstructed, and in conjunction with Commissioner Manz determined that a two lane temporary bridge should be installed, instead of a one lane temporary bridge, due to considerations of public safety and winter snow plowing; and

WHEREAS, ING Civil, Inc. of Watervliet, New York, was known to CME to have temporary two lane bridges available for rent; and

WHEREAS, under his emergency authority, Commissioner Manz requested that ING Civil, Inc. submit a proposal for the removal of the CR 4 bridge, and the rental and installation of a temporary two lane bridge over Paul Creek; and

WHEREAS, ING Civil, Inc. submitted a cost proposal for the removal of the existing bridge over Paul Creek and the rental and installation a temporary two-lane bridge on the up-stream side of the existing bridge at a cost of: 1) \$69,400 for the removal of the bridge; 2) \$43,200 for the rental of the temporary bridge at rental rate of \$5,400 per month for approximately eight (8) months; and 3) \$348,000 for the installation and later removal of the temporary bridge; for a total cost of \$460,600; and

WHEREAS, our Public Works Committee and Commissioner Manz have recommended that the proposal of ING Civil, Inc. for the removal of the existing CR 4 bridge over Paul Creek and the rental, installation and removal of a temporary two-lane bridge be accepted; and

WHEREAS, an appropriation from Fund Balance and an amendment to the 2019 County Budget is needed to fund this expense; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with ING Civil, Inc. of Watervliet, New York for the removal of the CR 4 (North Shore Road) bridge over Paul Creek in the Town of Day and the rental, installation and removal of a temporary two-lane bridge, at a cost of: 1) \$69,400 for the removal of the bridge; 2) \$43,200 for the rental of a temporary bridge at the rental rate of \$5,400 per month for approximately eight (8) months; and 3) \$348,000 for the installation and removal of the temporary bridge; for a total contract cost of \$460,600, with the form and content of said agreement to be subject to the approval of the County Attorney; and be it further

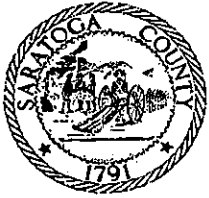

WHEREAS, the 2019 County Budget includes \$100,000 for the Farmland and Open Space Preservation Program; and

WHEREAS, the County Land Preservation Committee solicited applications for various land preservation projects in the County; and

WHEREAS, the Committee has reviewed the four applications submitted for funding, and has recommended that funding for all three farmland preservation projects as well as the open space acquisition project be approved at a cost of \$274,377; and

WHEREAS, the recommended award of \$274,377 will necessitate the transfer of up to \$174,377 from the Open Space Reserve Fund at a later date to cover the total requested project funding in the amount of \$274,377; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors authorizes the payment, under the Farmland and Open Space Preservation Program, of the following amounts to the following entities, for the purposes and upon the conditions stated:

1. To the Town of Northumberland, the sum of \$100,000 upon Saratoga PLAN completing a bargain sale, plus in-kind donations, of an estimated price of \$4,000 per acre for the purchase of the development rights of a 50.9 acre farm in order to place a perpetual conservation easement over the Bolesh Farm (Tax Parcel #s 103.-2-22.1; 103.-2-22.2; 103.-2-22.3). Total project cost is estimated at \$261,107. The balance of the project costs is to be paid by a combination of contributions and in-kind donations from the landowner, Saratoga PLAN and/or the Town.
2. To the Town of Greenfield, the sum of \$50,000 upon Saratoga PLAN completing a bargain sale, plus in-kind donations, towards an estimated price of \$4,000 per acre for the purchase of a 69 acre wooded open space parcel referred to as the Conant Family

Woodlands (Tax Parcel #139.-1-35.1). Total project cost is estimated at \$330,973. The balance of the project costs is to be paid by a combination of contributions and in-kind donations from the landowner, Saratoga PLAN and/or the Town.

3. To the Town of Clifton Park, the sum of \$34,450 upon the condition that the Town of Clifton Park contributes no less than \$34,450 to serve as a local match, plus in-kind donations towards an estimated price of \$62,000 per acre for the purchase of a 1.03 acre open space parcel for the Town's Trail Head Park (Tax Parcel #283.12-1-92). Total project cost is estimated at \$68,900. In accordance with the determination of the Land Preservation Committee, the foregoing funding is contingent on the Town of Clifton Park relinquishing a 2015 Open Space grant award for \$50,000, as the project is no longer feasible, and the Town completing its 2015 Saratoga County Trails project for which the County granted the Town an award of \$12,500, prior to the 2019 Open Space grant being paid as both the 2015 Trail and 2019 Open Space projects are related.
4. To the Town of Milton, the sum of \$89,927 upon Saratoga PLAN completing a bargain sale, plus in-kind donations, of an estimated price of \$5,200 per acre for the purchase of the development rights of a 24.3 acre farm in order to place a perpetual conservation easement over the Smassanow Farm (Tax Parcel #: 215.-1-17). Total project cost is estimated at \$179,854. The balance of the project costs is to be paid by a combination of contributions and in-kind donations from the landowner, Saratoga PLAN and/or the Town.

and, be it further

RESOLVED, that the foregoing grant amounts may be adjusted by the Land Preservation Committee by up to 10% of each grant amount provided the requirements of each grant are satisfied and sufficient grant monies are available; and, be it further

RESOLVED, that the acreage amounts listed herein may be revised to conform with the acreage as determined by any subsequent survey conducted of one of the foregoing parcels; and, be it further

RESOLVED, that the Land Preservation Committee may place such further conditions and requirements on said grants as it may deem necessary and advisable to fulfill the intent and purpose of the Farmland Protection and Open Space Preservation Program; and, be it further

WHEREAS, the 2019 Saratoga County Budget included a Trails Grant Program to give matching grants to local municipalities to fund trail development and construction projects; and

WHEREAS, the 2019 Trails Grant Program provides a pool of up to \$50,000 to fund trail feasibility studies, engineering work, and construction in local municipalities; and

WHEREAS, the Trails Committee received ten applications for funding totaling \$92,022.68, which the Committee recommended be funded in full; and

WHEREAS, our Law and Finance Committee and Economic Development Committee approved fully funding all ten grant applications submitted at a cost of \$92,022.68 through the utilization of the balance of \$18,535.44 remaining in the Trails Reserve Account and \$23,488 from the County Fund Balance; and

WHEREAS, the funding in full of all 2019 Trails Grant Program applications received requires an amendment to the 2019 Saratoga County Budget; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors authorizes the payment under the 2019 Trails Grant Program of the sum of \$50,000, plus \$18,535.44 from the Trails Reserve Account and \$23,488 from Fund Balance, of the following amounts to the following municipalities for the purposes stated, upon the condition that each municipality provide matching funds or services in kind:

1. Town of Charlton – in the amount of \$9,820 for the construction of an 8 ft. wide stone dust trail named the Elmer Smith Pedestrian Trail that traverses the perimeter of the Town's 16-acre recreation park along with a trail spur that visits a historic cemetery.
2. Town of Edinburg – in the amount of \$9,095.68 for the proposed purchase of engineered wood fiber to surface 3000 feet of a nature trail on an 87 acre town-owned parcel providing passive exercise stations, educational posters and signage for trail users.
3. Town of Galway – in the amount of \$10,000 for the construction of the Carpenter, Rhodes, Milton Trail, a proposed 2.5 mile trail through a 156-acre, ecologically diverse property that connects County Route 45 and Old Mill Road along with an interior trail loop system. An existing and separate snowmobile trail is located on the lands. This project is being sponsored by Saratoga P.L.A.N.

4. Towns of Galway and Providence – in the amount of \$10,000 for the construction of a proposed trail with two interior loops that traverses a 168-acre parcel that contains two tributaries of the Kayderosseras Creek. The property has historically been used privately to ride horseback and is now being offered to the public for horseback riding and hiking. This project is being sponsored by Saratoga P.L.A.N.
5. Town of Halfmoon – in the amount of \$10,000 for the Crescent Park Trail to rehabilitate an existing trail by resurfacing the existing stone dust surface with asphalt. The Crescent Park Trail traverses along the Mohawk River from the parking area on Canal Road to the Crescent Bridge (US Route 9).
6. Town of Malta – in the amount of \$3,107 for the Malta Nature Preserve Trail to rehabilitate the existing nature trail with the purchase of 260 ton of crusher run.
7. Town of Milton – in the amount of \$10,000 for a feasibility study plan to take all of the Town owned parklands into consideration for planning a trail network amongst them and to connect to the Village of Ballston Spa.
8. Town of Moreau – in the amount of \$10,000 for a proposed walking and biking trail that traverses along the Hudson River and connects Nolan Road with Old Bend/Dyke Road. The trail offers a connection to the existing Big Boom Trail and Feeder Canal Trail and the possibility of future connections to the Moreau State Park, Palmer Ridge and the Town of Corinth.
9. Towns of Stillwater, Saratoga, Northumberland and the City of Mechanicville – in the amount of \$10,000 for a proposed feasibility study plan to evaluate the gaps in the Champlain Canal Trail system within the respective municipalities' limits, and to ascertain needed resources to complete the Trail.
10. Town of Wilton – in the amount of \$10,000 for the planning and reconstruction of the dilapidated Deegan Pond Footbridge that is an integral part of the existing trail system that traverses State, County and Town land at Camp Saratoga on Scout Road. The foot bridge allows users to be “off road”, and provides a scenic view of the pond, and fishing access.

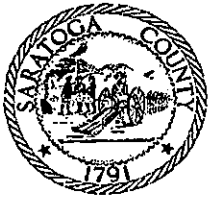

AUTHORIZING THE CHAIRMAN TO ENTER INTO AN AGREEMENT WITH NIAGARA MOHAWK POWER CORPORATION D/B/A NATIONAL GRID FOR THE PROVISION OF GENERAL CONTRACTOR SERVICES IN MANAGING THE CONSTRUCTION OF SARATOGA COUNTY SEWER DISTRICT NO. 1'S SOLAR ENERGY SYSTEM ENVIRONMENTAL BENEFIT PROJECT REQUIRED BY ITS CONSENT ORDER WITH THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION

WHEREAS, pursuant to Resolution 226-2019, this Board authorized the execution of a Consent Order with the New York State Department of Environmental Conservation ("DEC") in order to resolve 69 effluent exceedances by Saratoga County Sewer District No. 1 in violation of the Sewer District's State Pollution Discharge Elimination System ("SPDES") permit; and

WHEREAS, one of the conditions of the Consent Order requires the Sewer District to complete an Environmental Benefit Project (EBP) in the form of the installation of a solar energy system to provide electrical service to the Sewer District's Wastewater Treatment Plant by December 31, 2020; and

WHEREAS, it is expected that the EBP will generate approximately 802,000 KW of energy, which it is estimated will result in approximately \$61,000 in annual savings at the Sewer District's Wastewater Treatment Plant; and

WHEREAS, Niagara Mohawk Power Corporation d/b/a National Grid ("National Grid") has offered its services to the Sewer District, at no cost, to serve as General Contractor to manage the Sewer District's energy conservation project, which services may include, but not be limited to, arranging for the provision of engineering and design studies, and initial labor, material, supplies and equipment, which services National Grid will assign to subcontractors via Task Orders; and

WHEREAS, under National Grid's proposal, the Sewer District will be responsible for paying all subcontractors directly; and

WHEREAS, our Law and Finance Committee and the Saratoga County Sewer District Commission have recommended that the County enter into a Master Agreement for Energy Conservation and Management Services with National Grid for General Contractor services in constructing the solar energy system EBP outlined in the Sewer District's Consent Order with DEC; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute a Master Agreement for Energy Conservation and Management Services with Niagara Mohawk Power Corporation, d/b/a National Grid, of Syracuse, New York for the provision of General Contractor services in

managing the Sewer District's construction of the solar energy system Environmental Benefit Project required pursuant to the Consent Order executed by Saratoga County Sewer District No.1 with the New York State Department of Environmental Conservation; which General Contractor services shall be provided at no cost to the County; and, be it further

RESOLVED, that the form and substance of said Master Agreement shall be subject to the approval of the County Attorney.

WHEREAS, a qualified financial consultant is needed to advise the County on public financing options that include the issuance of bond anticipation notes, serial bonds, and/or energy performance contracts, as well as financing through the New York State Environmental Facilities Corporation; and

WHEREAS, Fiscal Advisors & Marketing, Inc. of Syracuse, New York, has submitted a proposal to serve as financial advisor and to provide financial services to the County in connection with the planned public financing of said capital projects, at a cost not to exceed \$155,000; and

WHEREAS, our Law and Finance Committee and County Administrator have recommended that the proposal of Fiscal Advisors & Marketing, Inc. be accepted; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Fiscal Advisors & Marketing, Inc., of Syracuse, New York, to act as financial advisor for the issuance of Bond Anticipation Notes, Serial Bonds and/or Energy Performance Contracts, as well as short- and long-term financings through the New York State Environmental Facilities Corporation, to finance pending Saratoga County Sewer District No. 1 capital projects to include the Interceptor Rehabilitation, the construction of the Joint Regional Biosolids Facility and Wastewater Treatment Plant Ammonia Capacity Upgrades, at a cost not to exceed \$155,000; and, be it further

RESOLVED, that the form and content of such agreement shall be subject to the approval of the County Attorney.

WHEREAS, pursuant to Resolution 100-2019, this Board authorized the renewal and amendment of the County's agreement with New England Waste Services of ME, Inc. d/b/a Casella Organics ("Casella Organics") for the removal, transportation and disposal of sludge/biosolids from Saratoga County Sewer District No. 1's Wastewater Treatment Plant, for a term of one (1) year commencing on June 1, 2019 and terminating on May 31, 2020, subject to the right of the County to terminate the agreement upon ninety (90) days written notice, at a cost of \$93.26 per wet ton, plus a surcharge of \$10 per wet ton for each ton collected and transported above 430 wet tons per week and a demurrage fee of \$47.50 per half hour for load times greater than 6 hours caused by the Sewer District's maintenance of its belt filter press; and

WHEREAS, due to landfills in the western part of the State reducing the amount of sludge they were willing to accept, Casella Organics exercised its right to withdraw its proposal for the renewal agreement authorized pursuant to Resolution 100-2019 as the increased costs of transporting the sludge to alternative locations no longer made the terms and conditions of its proposal for renewal of the agreement financially viable for the company; and

WHEREAS, the Saratoga County Sewer District Commission solicited and received bids for a contract for the removal, transportation and disposal of sludge/biosolids by qualified haulers; and

WHEREAS, pursuant to Resolution 138-2019, this Board rescinded Resolution 100-2019 and authorized the Chair of the Board to execute an agreement with Casella Organics, for the removal, transportation and disposal of sludge/biosolids from Saratoga County Sewer District No. 1's Wastewater Treatment Plant for a term of two (2) years commencing June 1, 2019 and terminating on May 31, 2021, subject to a one year extension upon the mutual agreement of the County and Casella Organics and the right of either party to terminate the agreement upon ninety (90) days written notice, at a cost of \$129 per wet ton, plus a demurrage fee of \$40 per half hour for load times greater than 6 hours caused by the Sewer District's maintenance of its belt filter press; and

WHEREAS, the approximately \$36 per wet ton increase in the sludge hauling contract was unanticipated, and will result in a 2019 budget shortfall for Saratoga County Sewer District No. 1 estimated to be in the amount of \$500,000; and

WHEREAS, our Law and Finance Committee and the Saratoga County Sewer District Commission have recommended that this Board approve and authorize a transfer of funds in the amount of \$500,000 from the Sewer District's unappropriated fund balance to cover the increased sludge hauling costs; and

WHEREAS, an amendment to the 2019 Saratoga County Budget is needed to transfer said funds from the Sewer District's fund balance; now, therefore be it

RESOLVED, that the 2019 Saratoga County Budget is amended as follows:

WHEREAS, the nationwide negotiating class certified by Judge Polster is defined to include “all counties, parishes, and boroughs; and all incorporated places, including without limitation cities, towns, townships, villages, and municipalities”; and

WHEREAS, pursuant to the foregoing definition, the County of Saratoga is necessarily included within the negotiating class certified by Judge Polster; and

WHEREAS, while it is advantageous to negotiate in a group, New York cities and counties are currently coordinated in a state litigation pending in Suffolk County, New York; and

WHEREAS, the coordinated litigation in Suffolk County will be the next county case to be tried, with the Counties of Nassau and Suffolk commencing trial on January 20, 2020; and

WHEREAS, the County of Saratoga, as a party to the coordinated litigation pending in New York State, is already in a unique situation to negotiate as a group; and

WHEREAS, the County’s counsel, Napoli Shkolnik PLLC, has recommend to all counties it represents in New York State that they opt out of the negotiation class certified in the federal litigation pending against opioid manufacturers, distributors and retailers in the United States District Court, Northern District of Ohio; and

WHEREAS, to opt out of the class, an *Exclusion Request Form* needs to be signed on behalf of the County of Saratoga and submitted to the County’s counsel, Napoli Shkolnik PLLC prior to November 22, 2019; now, therefore, be it

RESOLVED, that the Chairman of this Board of Supervisors is hereby authorized to execute an *Exclusion Request Form* to opt the County of Saratoga out of the *Negotiation Class* as is advised by the County’s legal counsel, Napoli Shkolnik PLLC, in this matter.

YOUR PROPERTY TAXES...

The Saratoga County Board of Supervisors is providing this information to all property taxpayers in Saratoga County to inform them about how State & Federal mandates affect their annual property tax bills.

- The 2020 County General Fund Budget totals \$275,378,963. Of that amount, \$101,507,909 is for programs mandated by New York State Government with a net cost of \$64,861,900 to the taxpayers of Saratoga County. County government has little or no control over these costs.

“Mandates” are Federal or State created programs that are required to be operated by lower level governments. In New York State, most of these mandates are not accompanied by State money to pay for them or are only partially paid for. Because County government relies upon property taxes to operate, expensive State mandates become expensive property taxes on local taxpayers.

- In 2020, these Unfunded Mandates **will consume 100% of the \$62,927,257 Property Tax Levy**. This means that all County property taxes and an additional **\$1,934,643** from sales tax revenue will be spent covering these State mandates.
