Chairman Tollisen called the meeting to order.

On a motion by Mr. Wood, seconded by Mr. Peck, Resolutions 269 & 270 were removed from the table unanimously.

On a motion by Mr. Szczepaniak, seconded by Mr. Ostrander the 2020 Tentative Budget was amended to fund the Saratoga County Prosperity Partnership at the amount provided for statutorily which is half the occupancy tax which is approximately \$550,000 by the following vote:

Mr. Lawler said he is disappointed to see the amendment come forward at this late hour. We have gone through an exhaustive budget process. He thanked the administration, Law & Finance and the Vice Chairman on their hard work on the budget. We have had budget workshops. This has come through various committees. When we left here, it was obvious to some of us that we believed we had come to a fair compromise on how to handle the Partnership and SEDC issue. That compromise involved funding SEDC at the requested \$150,000 and also involved accepting the contract put forth by the Economic Development Committee Chairman Phil Barrett. It also included understanding how a refund of expenses incurred would be made by SEDC if in the event they were forced to comply and chose not to our contract call for the refund of the entire amount of any funds they received. It is disappointing at this late hour and we all know what this is about. This is not how this Board has done business in all the many years he has been here. It is certainly allowed and legal and within the rules of the Board. But it goes against the traditional collegial compromise that this Board prides itself on. This is a major step back for this Board and is a sad situation to find ourselves in at the eleventh hour. A contract is handed to Board Members literally five minutes before the meeting and this is disappointing especially after so many years of cooperating and working together as a board to find solutions and common ground. This is incredibly disappointing.

Mr. Johnson said this Board has approved a unity agreement to try to bring these two organizations together. This Board also approved the separation of duties. Duties were assigned to the Partnership and to SEDC. Both organizations put budgets forward through the process that would enable them to perform those duties, Now at this time to lower the funds for one organization, how will they be able to perform those duties without the appropriate funding. It does not make sense at this time. Mr. Johnson asked if the contract that was just handed out if it was the same one that was approved by the Economic Development Committee and asked if there were changes. Mr. Hellwig said the contract is based on the one prepared by Supervisor Barrett with the changes that were approved. He added that upon review of that contract, Mr. Barrett discovered some.....Mr. Kusnierz asked for point of order as this was a question and getting away from the motion of amending the budget. Chairman Tollisen asked Mr. Hellwig to continue. Mr. Hellwig continued and said Mr. Barrett said there was a contradiction in two of the sections of the agreement. He said the section in question references how the payment would be returned by SEDC.

Mr. Barrett said he had told Mr. Hellwig that he was going to bring up the contract due to the inconsistency within the document itself. He reminded everyone in June that there was a memo provided to the Economic Development

Committee that did go through the committee process right up to the Board of Supervisors and within that there were the roles and responsibilities that were worked out between SEDC and the Partnership. That was included and was worked out amongst themselves. There were three other initiatives: 1. Contract with SEDC, 2. New Economic Development fund and 3. That the Partnership would receive half of the bed tax, which would be approximately \$543,000/\$550,000. He said he does not know why this would surprise anyone as this was voted on even if it wasn't a unanimous vote, it was voted on.

Mr. Grattidge said he agrees with Supervisor Lawler. He said he thought when the unity agreement was voted on it was a way to have both entities work together going forward. At budget time there was an oversight and an incorrect number was used. All through the budget process, he said, there was a reduced number for the Partnership, new money for SEDC and new money for the Economic Development Plan. This went through Law & Finance and the Budget Workshops and the budget could have been amended at that time. Now to come in at this point is very disappointing to see this brought up.

On a motion by Mr. Schopf, seconded by Ms. Gaston the 2020 tentative budget was amended to add a \$25,000 line for discretionary funding in the Historian's budget. The motion passed by the following vote:

Mr. Schopf said he has an amendment request with no budget impact and is an amendment to the general fund, unallocated amount. He requested a line item be added providing \$25,000 and is restricted/designated for use by the County Historian if necessary for the preservation and collection of artifacts with a countywide historical significance. This will allow for the focus on countywide history since the bulk of the county's historical tourism is located within Saratoga Springs it will help obtain historical collections on a countywide basis. He asked that if disbursements were made from this funding, approval be given by Law & Finance and voted by the full Board before disbursement is made.

Ms. Gaston thanked Mr. Schopf for coming up with this plan that will relieve some of her concerns with maintain physical objects that the County Historian is not currently able to keep herself and this will allow for the maintenance of our County's history, securely.
