WHEREAS, the acceptance of these funds requires this Board's approval and an amendment to the 2020 County Budget for the purchase of software and supplies only; now, therefore, be it

WHEREAS, the National Association of County and City Health Officials (NACCHO) has awarded a 2020 Medical Reserve Corps Operational Readiness Award grant in the amount of \$2,500 to Saratoga MRC, that needs to be accepted by the County and passed through Saratoga County Public Health Services to Saratoga MRC, for the grant period January 1, 2020 through August 31, 2020; and

WHEREAS, Saratoga MRC intends to utilize said grant funds to strengthen unit response capabilities through continuous recruitment of members, provide initial orientation to volunteers, bind and distribute guidance handbooks, offer training seminars to prepare volunteers for responses to public health emergencies, and supply volunteers with emergency preparedness equipment in the event of a medical deployment; and

WHEREAS, Saratoga MRC also plans to use said grant funds to purchase various supplies to include envelopes, postage, waterproof bags, sanitizing wipes, MRC unit banner, tourniquets, pens, notepads, and food; and

WHEREAS, the acceptance of these funds requires this Board's approval and an amendment to the 2020 County Budget; now, therefore, be it

WHEREAS, pursuant to Resolution 286-2019, as amended by Resolution 29-2020, this Board further authorized the payment of stipends to attorneys accepting assignments to represent indigent defendants at arraignments in local criminal courts after normal business hours and on weekends, which stipends were set in the amount of: i) \$100 per attorney assigned on Monday through Friday from 5:00 pm to 9:00 am (16 hour shift); ii) \$250 per attorney assigned on Saturday and Sunday from 9:00 am to 9:00 am (24 hour shift); and iii) \$250 per attorney assigned to represent indigent defendants at arraignments in local criminal courts on a Monday through Friday weekday that is one of the eleven County holidays that the County of Saratoga closes for business, with the shift to commence at 9:00 am on the day of the Holiday, and continue until 9:00 am the following day; and

WHEREAS, the Public Defender's Office and the Human Resources Department propose to use said CAFA grant funds to pay for the cost of the stipends to attorneys representing indigent clients at first appearance at afterhours arraignments in local criminal courts, and to pay for their mileage costs; and

WHEREAS the acceptance of this CAFA grant requires this Board's approval and an amendment to the 2020 County Budget under the Human Resources Department; now, therefore, be it

WHEREAS, our Public Safety Committee and the County Coroners have recommended that the contract for post-mortem toxicology services with NMS Labs be renewed for an additional term of one (1) year term commencing on January 1, 2020 and terminating on December 31, 2020, at the foregoing rates proposed by NMS Labs, with total contract costs not to exceed \$50,000; now, therefore, be it

RESOLVED, that in the event the full federal and non-federal share costs of the project exceeds the amount appropriated above, Saratoga County Board of Supervisors shall convene as soon as possible to appropriate said excess amount immediately upon the notification by the New York State Department of Transportation thereof; and it is further

WHEREAS, pursuant to Resolution 245-2016, the Saratoga County Board of Supervisors authorized a two (2) year renewal of a lease agreement for Judge Nolan's chambers with Vinny DiMartino, Enzo Bonello and Domenico Nuzzi of Brooklyn, New York, for the lease of 1,666± square feet of office space commonly known as Suite 201 in the building located at 433 Broadway in the City of Saratoga Springs, for a term of two (2) years to commence on February 1, 2017, with an option to renew for up to two additional terms of one year each, at a rental of \$3,558.85 per month, inclusive of real property taxes, utilities and cleaning services, subject to an annual rent increase of 2% of the prior year's rent for the second year and any renewal term thereof; and

WHEREAS, the County exercised its right to renew the lease for Judge Nolan's chambers for an initial one year term that will expire on January 31, 2020; and

WHEREAS, the owners of the building located at 433 Broadway in Saratoga Springs have offered to renew the lease for Justice Nolan's chambers for a term of one (1) year at a rent of \$3,702.63 per month, subject to renewal for an additional term of one year at a rent increase of 2%; and

WHEREAS, the owners of the building located at 433 Broadway in Saratoga Springs now conduct business under the name of 431-433 Broadway, LLC; and

WHEREAS, our Buildings and Grounds Committee and the County's Commissioner of Public Works have recommended the acceptance of the lease renewal offer by 431-433 Broadway, LLC; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute a lease renewal agreement with 431-433 Broadway, LLC of Brooklyn, New York, for the lease of 1,666± square feet of office space commonly known as Suite 201 in the building located at 433 Broadway in the City of Saratoga Springs, for a term of one (1) year to commence on February 1, 2020, at a rent of \$3,702.63 per month, with an option to renew for one additional term of one (1) year at a rent of \$3,776.68 per month, inclusive of real property taxes, utilities and cleaning services; and, be it further

WHEREAS, this Board of Supervisors has received a petition from John Hartzell and Julie Hartzell, landowners in the Town of Malta, to include 15.53± acres of predominately viable agricultural land along Rowley Road, identified as Tax Parcel #192.-1-31.2, and dedicated to use as a horse boarding operation, with plans to add a use as a sheep fiber farm in the future, within the boundaries of Saratoga County Consolidated Agricultural District #2; and

WHEREAS, pursuant to Agriculture and Markets Law §303-b(3), this Board of Supervisors is required to hold a public hearing to consider the requests for inclusion and the recommendations of the Saratoga County Agricultural and Farmland Protection Board; now, therefore, be it

Hayes Co., Inc. for the annual maintenance of the County's Kronos automated employee time and attendance reporting system hardware, software and custom software, which agreement included a 20% discount on any additional Kronos hardware, software or custom software purchased by the County during the term of the agreement, for a term of six years commencing on February 1, 2018 and terminating on January 31, 2024, at a cost of \$236,639 to be paid as follows:

- 3) February 1, 2020 January 31, 2021: \$38,801
- 4) February 1, 2021 January 31, 2022: \$39,984

WHEREAS, Saratoga County Sewer District No. 1 ("SCSD #1") operates pursuant to the terms and conditions of a State Pollution Discharge Elimination System ("SPDES") Permit issued and regulated by the Department of Environmental Conservation ("DEC"); and

WHEREAS, the United States Environmental Protection Agency Region 2 ("EPA") has issued an Administrative Order On Consent ("AOC") pursuant to the Clean Water Act, 33 U.S.C. §1251, et seq. ("CWA") requiring SCSD #1 to undertake specified measures to fully comply with the requirements of the CWA by updating SCSD #1's Sewer Use Ordinance originally adopted pursuant to Local Law No. 3 of 1984; by updating SCSD#1's Enforcement Response Plan to better address noncompliance with or violations of its Industrial Pretreatment Program; and by establishing lower ammonia discharge limits based on appropriate technical data; and

WHEREAS, the EPA is requiring SCSD #1 to complete the foregoing projects by July 15, 2020, but is not imposing a civil monetary penalty upon SCSD #1 at this time; and

WHEREAS, the Saratoga County Sewer District Commission has approved the terms and conditions of the AOC presented by the EPA; and

WHEREAS, the settlement of these matters on the terms stated in the AOC is in the best interests of the County of Saratoga and Saratoga County Sewer District No. 1; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an Administrative Order On Consent with the United States Environmental Protection Agency to include the following terms:

- 1. Amend and update Saratoga County Sewer District No. 1 Sewer Use Ordinance Rules and Regulations as set forth in Local Law No. 3 of 1984 of the County of Saratoga; and
- 2. Update the Saratoga County Sewer District No.1's Enforcement Response Plan; and
- 3. Implement a local ammonia limit based on appropriate technical data.

and, be it further

RESOLVED, that the form and substance of said Administrative Order On Consent shall be subject to the approval of the County Attorney.

BUDGET IMPACT STATEMENT: No budget impact.
