REGULAR MEETING TUESDAY, March 16, 2021 AT 4:00 p.m., E.S.T.

Board called to order by Chairman Kusnierz.

The invocation was given by Thomas N. Wood, III, Chaplain. "Let us pray. Our Heavenly Father, as we celebrate the beginning of the spring season, let us go forth with the fresh optimism and the vision of new life and new hope that we associate with this season. May we approach all issues with an open mind, let us be receptive to new approaches and be respectful and tolerant of different opinions. Give us strength, patience, and perseverance and may we always remain enthusiastic and take the positive road of life. May we always appreciate the bountiful life that we enjoy and never forget that we in Saratoga County are the most fortunate people in the country. Let us express our thanks and appreciation for all of the Saratoga County public health department employees and all others that worked especially hard the last few weeks assisting in the mass COVID 19 vaccination effort to make our county residents safe. As we celebrate St Patrick's Day tomorrow let us remember the contributions that the Irish and all of the immigrants to this country have made and how through their ethnic diversity and the skills and knowledge they brought with them, our country and county are better, more complete places in which to live. We ask that you watch over all members of our armed services and see that they are free from harm and come home safely. In your name we pray, Amen.

Mr. Kusnierz said it is highly appropriate to give a brief update on COVID here in Saratoga County. It will be reported later today that the total number of cases in the County is presently 12,577. The number of active cases is 229. Presently, 14 individuals are hospitalized. The total number of recovered cases is 12,197 and unfortunately, the number of deaths 151. On the lighter side, the number of individuals in the County that have received at least one dose of the vaccine is now 62,967, which equates to 27.4% of our residents. The number of individuals that have completed this series is 33,018, which is 14.3% of our residents. He is thrilled to be able to report this as it is a testament to the fantastic job that our Public Health Department is doing. Those individuals 65 and older, he number of individuals vaccinated in that category is 67,903, which is 65.4% of those individuals. The number of individuals that have received a completed series is at 13,957, which is 32.3% of our seniors 65 and older. That is fantastic news, and our positivity rate has dipped a little bit. We are currently at 2.2%. So kudos to the Public Health Department and everybody working there.

Mr. Kusnierz said yesterday marked the one-year anniversary of the County Emergency Operations Center as everyone here knows and he wanted the public to be aware. They have been very involved in our Covid 19 pandemic response. The EOC was open to help support a collaborative effort and coordinated response across all County departments, as well as with municipal and private partners. Since then, the staff within the County Emergency Operation Center have distributed vaccines, carried out testing and contact tracing, helped secure and distribute critical supplies and equipment, distributed food to those in need, and kept our residents and business owners informed as to how to reduce the spread of the virus. He said he wanted to take a moment to recognize their efforts since we are talking about COVID.

Mr. Kusnierz said the next item on the agenda is a presentation. He said there would be a brief presentation and are very fortunate to have Tim Welch who is the President and Steve Porto, Executive Director of the Friends of Grant Cottage. He is sure everybody in the room knows that Grant's Cottage is a National Historic Landmark that was recently designated such by the Federal Government. It is the final home of Ulysses S. Grant, who everyone here knows was a Civil War Commanding General, US Army and our 18th. President. With that, he did not want to cut into the time. Mr. Welch, the floor is yours.

Mr. Welch thanked the Chairman. He said he appreciated the opportunity to present to the Board. Mr. Welch gave a brief history of Grant Cottage after introducing the people he brought with him. The presentation included

detailed plans to expand the area. They encouraged Board members to visit the site and they expect to be open to the public again soon. The power point presentation is included with these minutes.

Mr. Kusnierz thanked Mr. Welch. He had the good fortune being there several times to tour the site. Last year, Supervisor Lant and Supervisor Barrett joined him to tour the site. The Town of Moreau and Town of Wilton do financially support Grant's Cottage as best they can. It is a significant historical site. Mr. Kusnierz encouraged everyone that has an opportunity take advantage of a tour there. He said he knows Mr. Porto would be more than happy to set that up. He said we heard about the overlook in today's presentation. The views are spectacular. If you go out on the monument area there, you can see all the way to Lake George. On a clear day, you can see all the way down to the Capitol. You can see the Agency buildings in the background. It is spectacular.

Mr. Lucia said that was a great presentation.

Mr. Lawler said thank you for the presentation. He was a little ashamed to say that he had not been there. He said he had read a lot about it; and thinks it is a tremendously significant historical site. With the kind of planning and effort that has been outlined this will be something the County will be very proud of and has tremendous value.

Mr. Kusnierz said he appreciated their time today.

AUTHORIZING CONTACT TRACING SERVICES AGREEMENTS WITH KAITLYN ELLIS, ALANA MARTIN, AND DEIDRE HUGHES

WHEREAS, pursuant to Resolution 111-2020, as amended by Resolution 281-2020, this Board authorized the County Administrator to execute up to Seventy Five (75) minor contracts with individuals identified by Saratoga County Public Health Services as willing to serve and complete the required training to work as contact tracers on an as needed basis, at a rate of compensation of \$25.00 per hour; and

WHEREAS, the County entered into existing minor contracts with Kaitlyn Ellis dated September 29, 2020, Alana Martin dated September 15, 2020 and Deidre Hughes dated August 18, 2020 for contact tracer services to rapidly interview positive COVID-19 patients; identify their close contacts; interview and alert those contacts to the risk of infection; instruct the contacts to quarantine or isolate for 14 days and monitor those in quarantine or isolation to ensure their compliance and to ascertain if they are showing any symptoms of COVID-19; and

WHEREAS, as there continues to be cases of COVID-19, it is imperative to maintain the services of quality contractors to perform essential contact tracing services; and

WHEREAS, Kaitlyn Ellis has been a dependable contact tracer who is a college graduate who is able to work full time; and

WHEREAS, Alana Martin, an on-line college student who has been a dependable contact tracer and is available to perform contact tracing services on a full time basis; and

WHEREAS, Deidre Hughes, is a retired nurse and is available to work as a contact tracer four days a week; and

WHEREAS, the cost of services performed by Kaitlyn, Alana and Deidre have met or exceeded their minor contract limits of \$15,000; and

WHEREAS, our Health and Social Services Committee and Commissioner of Health have recommended that the County enter into new one year agreements with the following contact tracers, effective at the signing of said contracts: 1) Kaitlyn Ellis, at a rate of \$25.00 per hour, for a maximum of 35 hours per week, with the total contract amount not to exceed the sum of \$45,500; 2) Alana Martin, at a rate of \$25.00 per hour, for a maximum of 40 hours per week, with the total contract amount not to exceed the sum of \$52,000; and 3) Deidre Hughes at a rate of \$25.00 per hours, for a maximum of 30 hours per week, with the total contract amount not to exceed the sum of \$39,000; and

WHEREAS, pursuant to Resolution 201-2020, this Board accepted a New York State Department of Health grant administered by Health Research, Inc. that includes \$478,215 for temporary and contracted employees that are hired exclusively for COVID-19 response activities, which grant funds will be used to cover the cost of these three contact tracing agreements; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute one year agreements with the following contact tracers, effective at the signing of said contracts: 1) Kaitlyn Ellis, at a rate of \$25.00 per hour, for a maximum of 35 hours per week, with the total contract amount not to exceed the sum of \$45,500; 2) Alana Martin, at a rate of \$25.00 per hour, for a maximum of 40 hours per week, with the total contract amount not to exceed the sum of \$52,000; and 3) Deidre Hughes at a rate of \$25.00 per hours, for a maximum of 30 hours per week, with the total contract amount not to exceed the sum of \$39,000; and, be it further

RESOLVED, that the form and content of said agreements shall be subject to the approval of the County Attorney.

WHEREAS, pursuant to Real Property Tax Law 1138(6), a taxing district may cancel a delinquent tax lien if the taxing district determines that there is no practical method to enforce the collection of the delinquent tax lien and that a supplementary proceeding to enforce collection of the tax would not be effective; and

WHEREAS, from time to time parcels of taxable real property in Saratoga County which are in fact private roads or rights of way which serve as access to multiple adjoin parcels are included in the tax foreclosure proceeding for unpaid taxes; and

WHEREAS, the lack of proper construction, maintenance and repair of these roads create potential liability substantially in excess of the amount that could be recovered by enforcing the tax lien; and

WHEREAS, amounts bid at auction sales of these private road parcels in the past have been significantly less than the unpaid taxes, and in many cases the purchasers of these parcels at auction later default in payment of taxes, causing the parcel to return to tax lien foreclosure; and

WHEREAS, there is no practical method of enforcing the collection of delinquent tax liens in the roads without incurring the potentially liability of ownership of the roads; and

WHEREAS, 2018 delinquent taxes in the amount of \$330.87 are outstanding on parcel 87.-1-28.1-6 in Town of Corinth and the aforementioned parcel was a mobile home that has since been removed; and

WHEREAS, 2011 delinquent taxes in the amount of \$356.88 are outstanding on parcel 151.-2-7.-1 in the Town of Greenfield and parcel 151.-2-7.-1 was a mobile home that has since been removed; and

WHEREAS, 2011 delinquent taxes in the amount of \$225.94 are outstanding on parcel 190.-7-6.-2 in the Town of Milton and parcel 190.-7-6.-2 was a mobile home that has since been removed; and

WHEREAS, parcel 193.5-1-36.21 in the Town of Saratoga has delinquent taxes outstanding in the amount of \$540.24 for 2018; \$319.00 for 2019; \$273.23 for 2020; and \$79.98 for 2021. Parcel 193.5-1-36.21 is a private road servicing multiple residents over which there is a common right of way; and

WHEREAS, 2015 delinquent taxes in the amount of \$275.79 are outstanding on parcel 295.12-1-55 in the Town of Waterford. Parcel 295.12-1-55 was conveyed to the State of New York as a highway right of way in 2014 and the tax parcel no longer exists; and

WHEREAS, 2010 delinquent taxes in the amount of \$421.03 are outstanding on parcel 153.-3-16.1 in the Town of Wilton, said parcel being a private road servicing multiple residents over which there is a common right of way; and

WHEREAS, the Tax Enforcement Officer has determined there is no practical method to enforce the collection of delinquent tax liens on the aforementioned properties and a supplementary proceeding to collect the taxes would be ineffective; and

WHEREAS, Real Property Tax Law §1138(6) allows the County to cancel the tax liens, both current and prospective, on these parcels; now, therefore, be it

RESOLVED, that the following delinquent tax liens on the following parcels are hereby cancelled pursuant to Real Property Tax Law §1138

WHEREAS, Real Property Tax Law §1182 authorizes the governing body of any tax district, upon a determination that it is in the best interest of the tax district, by resolution may cancel, in whole or in part, any interest imposed by law to which the tax district shall be lawfully entitled; and

WHEREAS, Tax Parcels #262.-1-4.122 and #262.-1-4.2, in the Town of Stillwater, are collectively known as the "Patenaude Properties" and are currently occupied by dilapidated industrial buildings and a 5,000 square foot industrial building containing hazardous materials that pose both an environmental and fire risk; and

WHEREAS, the Patenaude Properties are unoccupied and vacant and are a significant blight on the Stillwater and Mechanicville communities; and

WHEREAS, since 2017 the Tax Enforcement Officer having declined to pursue an In Rem Tax Foreclosure of the Patenaude Properties as being impractical after having assessed and determined that exposure of the county to environmental liability and costs associated with environmental remediation on the properties; and

WHEREAS, Tax parcel #262.-1-4.122 is currently subject to a County tax lien including \$30,165.72 in interest; and

WHEREAS, Tax parcel #262.-1-4.2 is currently subject to a County tax lien including \$26,288.90 in interest; and

WHEREAS, Best Avenue Ventures, LLC is an independent affiliate of DeCresente Distributing, Inc. Best Avenue Ventures, LLC has expressed and committed to both purchase the Patenaude properties and remediate the underlying environmental concerns including removing stored barrels of paint from the site, removing asbestos, demolishing the abandoned buildings, excavating contaminated soils and replacing said soils with clean soils, at an anticipated cost in excess of \$700,000; and

WHEREAS, it would be in the best interests of the County for a private owner to purchase the properties, remediate the environmental concerns, restore and redevelop the properties, and positively restore the properties to the County tax rolls; now, therefore, be it

RESOLVED, that, upon the joint recommendation of the Real Property Tax Committee and the County Treasurer, the Tax Enforcement Officer is, contingent upon the sale of the property and upon the written commitment of the buyers to remediate the environmental concerns, permitted to cancel in whole any interest assessed to Tax Parcels #262.-1-4.122 and #262.-1-4.2.

COUNTY OF SARATOGA LOCAL LAW 1 - 2021

A LOCAL LAW AUTHORIZING THE LEASING OF REAL PROPERTY OF THE COUNTY OF SARATOGA TO GATEWAY HOUSE OF PEACE, INC.

BE IT ENACTED by the Saratoga County Board of Supervisors as follows:

SECTION 1. The County of Saratoga is the owner of real property located in Town of Milton which is identified on the Tax Maps of the Town of Milton as Section 177.14, Block 2, Parcel 21.1, which was conveyed to the County of Saratoga by Warranty Deed from Henry P. Witthohn and Judith Witthohn, recorded in the Saratoga County Clerk's Office in Book 1247 of Deeds at Page 520 on November 7, 1988. There is an existing brick building on the premises which Gateway House of Peace, Inc., a not-for-profit corporation, has been leasing from the County since May of 2011 and has requested a renewal of its lease for the purposes of operating a hospice home for terminally ill people and their families and providing related services. The term of such lease is for an initial five (5) years, with the tenant to have the option of renewal for an additional five (5) years. The rent to be paid to the County of Saratoga shall be One (\$1.00) Dollar per year with the tenant agreeing to maintain and/or upgrade the property as necessary and to use it solely for the quasi-public purpose of operating a hospice home for terminally ill people and their families and providing related services. The lease shall be a net lease with the tenant assuming all costs relative to the operation and maintenance of the property. The form and content of the lease agreement shall be subject to the approval of the County Attorney.

SECTION 2. Notwithstanding the provisions of Section two hundred fifteen of the County Law, or any other law of the State of New York, authorization is hereby given to the Chairman of the Saratoga County Board of Supervisors to execute a lease of the real property identified on the Tax Maps of the Town of Milton, Saratoga County New York as Section 177.14, Block 2, Parcel 21.1 to Gateway House of Peace, Inc. for its quasi-public purposes of operating a hospice house and providing related services, and for the municipal purposes of maintaining the County's property in a structurally sound and usable condition, with such lease to be subject to the approval of the County Attorney.

<u>SECTION 3.</u> This Local Law is subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law.

SECTION 4. This Local law shall take effect after it is filed as provided in Section 27 of the Municipal Home Rule Law.

AMENDING THE POLICIES AND PROCEDURES MANUAL TO REVISE THE VACATION CARRYOVER POLICY AND PROCESS

WHEREAS, Resolution 330-82 adopted a manual of Policies and Procedures for the conduct of Saratoga County government; and

WHEREAS, since adoption, the Board of Supervisors has enacted several amendments to the Manual; and

WHEREAS, pursuant to Resolution 118 – 2020, the Board of Supervisors authorized an amendment to the Vacation Carryover Policy and Process as a result of the impacts of the COVID-19 pandemic on staffing and departmental operations, said amendment affecting accruals earned on or before December 31, 2020; and

WHEREAS, staffing and departmental operations continue to be heavily impacted by the COVID-19 Pandemic, including requiring employees in certain instances to not utilize accrued vacation time in response to maintaining departmental operations and ensuring adequate staffing to serve the public; and

WHEREAS, authorizing County employees who have staggered accrual anniversary dates an extension of time in which to use their unused vacation time will minimize the impact on department operations and help ensure adequate staffing to serve the public; and

WHEREAS, our Human Resources and Insurance Committee has recommended that the time in which County employees with staggered accrual anniversary dates through December 31, 2021 must use their accrued vacation time be extended through the employee's accrual anniversary date in 2022 in accordance with the Collective Bargaining Agreements; and that the following section be added at the end of the County's Vacation Carryover Policy:

TEMPORARY VACATION CARRYOVER AMENDMENTS RESULTING FROM THE COVID-19 PANDEMIC

Effective March 17, 2021 any currently approved vacation carryover request will be extended until the employee's 2022 accrual anniversary date. Upon the employee's 2022 accrual anniversary date, any unused vacation time will be removed from the employee's vacation accrual bank.

Upon the approval of an employee's Department Head and the Human Resources Department, all vacation carryover requests made by the employee through December 31, 2021 will expire on the employee's accrual anniversary in 2022. Upon the employee's 2022 accrual anniversary date any unused vacation accruals will be removed from the employee's vacation accrual bank.

The provisions set forth in this section shall expire on January 1, 2022.

; and

WHEREAS, implementation of any legislative revisions to the Manual requires the approval of the Board; now, therefore, be it

RESOLVED, that the time in which County employees with staggered accrual dates through December 31, 2021 are required to use their accrued vacation time is hereby extended through the employee's accrual anniversary date in 2022 in accordance with the Collective Bargaining Agreements; and be it further

RESOLVED, that the following section of the Saratoga County Policies and Procedures Manual is amended to revise the Vacation Carryover Policy, as more particularly described in the Human Resources and Insurance Committee's proposal hereinabove:

WHEREAS, the Human Resources and Insurance Committee, the Saratoga County Sheriff, and the Director of Human Resources have recommended that the 2021 Compensation Schedule be amended to allow the Saratoga County Sheriff to hire transfers for both the Corrections Unit and Road Patrol Unit at Step 1 rather than at base salary, and after the first year of employment the terms of the operating collective bargaining agreement would determine any longevity increases in salary; now, therefore, be it

RESOLVED, that the 2021 Compensation Schedule be amended to authorize the Saratoga County Sheriff to hire transfers for both the Corrections Unit and Road Patrol Unit at Step 1 rather than at base salary, and after the first year of employment the terms of the operating collective bargaining agreement would determine any longevity increases in salary; and it is further

WHEREAS, a section of the Empire State Trail known as the Champlain Canalway Trail is a 61 mile long linear trail area primarily along the old Champlain Canal Towpath from the Village of Waterford in Saratoga County in the south to the Village of Whitehall in Washington County in the north; and

WHEREAS, the Greenway Conservancy for the Hudson River Valley, Inc. (hereinafter "Greenway Conservancy") is a public benefit corporation established by the State of New York in 1991, which is provided funding by the State for the purposes of creating and upgrading the Empire State Trail; and

WHEREAS, pursuant to Resolution 174-2018, a cooperative agreement with the Greenway Conservancy for the Hudson River Valley, Inc. authorized the County of Saratoga to act as contract administrator and project manager for the construction of a 1.2 mile section of the Champlain Canalway Trail over the lands of the City of Mechanicville and Town of Waterford in the Town of Waterford, and to construct said section of the Champlain Canalway Trail at a cost not to exceed \$408,000 with the Greenway Conservancy for the Hudson River Valley, Inc. to reimburse the County for its costs in constructing said section of the Champlain Canalway Trail up to an amount not to exceed \$408,000

WHEREAS, the Greenway Conservancy has proposed to provide the reimbursement funding to the County of Saratoga in an amount not to exceed \$210,000 to allow the County to administer as project manager

The Treasurer shall account for the Reserve Fund in a manner which maintains the separate identity of the Reserve Fund and shows the date and amount of each sum paid into the fund, interest earned by the fund, capital gains or losses resulting from the sale of investment of the fund, the amount and date of each withdrawal from the fund and the total assets of the fund, showing cash balance and a schedule of investment, and shall, at the end of each fiscal year, render to the Board of Supervisors a detailed report of the operation and condition of the Reserve Fund.; and, be it further

RESOLVED, that except as otherwise provided by law, expenditures from this Reserve Fund shall be made only for the purpose for which the Reserve Fund is established. No expenditure shall be made from this Reserve Fund without the approval of the Board of Supervisors and such additional actions or proceedings as may be required by Section 6-c of the General Municipal Law or any other law, including a permissive referendum if required by subdivision 4 of Section 6-c.

WHEREAS, pursuant to Resolution 210-2018, this Board authorized an amendment to the foregoing agreement with Barton & Loguidice, D.P.C. for the provision of additional engineering services required by the New York State Department of Environmental Conservation ("NYSDEC") to include the evaluation of alternative ammonia reduction technologies and the possible need for upgrades to Aeration Tanks 5-8 at the Sewer District's Wastewater Treatment Plant, at an additional cost of \$32,200, thereby increasing the total contract cost to \$315,700; and

WHEREAS, pursuant to Resolution 136-2019, this Board authorized a second amendment to the foregoing agreement with Barton & Loguidice, D.P.C. for the provision of additional engineering services required by the NYSDEC to include an in-depth investigation of other technologies that will be included in the Basis of Design Report for upgrades to the Wastewater Treatment Plant for nutrient removal, a preliminary analysis of off-site treatment as well as a modified Basis of Design Report that evaluates the treatment capacity of the Plant in its entirety taking into account amended industrial loading projections and advanced treatment technologies, at an additional cost of \$90,600, thereby increasing the total contract to the not to exceed amount of \$406,300; and

WHEREAS, pursuant to Resolution 187-2019, this Board authorized a third amendment to the foregoing agreement with Barton & Loguidice, D.P.C. for the provision of additional engineering services to include the design, installation, and monitoring of a pilot Integrated Fixed Film Activated Sludge plant, analysis of the resulting data, and preparation of a final summary report, at an additional cost of \$153,200, thereby increasing the contract total to the not to exceed amount of \$559,500; and

WHEREAS, through Saratoga County's membership with the New York State Association of Counties (NYSAC) and New York State Association of County Clerks (NYSACC) New York's Counties have come together to collectively support Donate Life Month in New York State; and

WHEREAS, nationally, one person is added to the organ transplant waiting list every ten minutes, 113,000 men, women and children are awaiting organ transplants and 22 people die each day because the organ they need is not donated in time; and

WHEREAS, organ, tissue, marrow and blood donation are life-giving acts recognized worldwide as expressions of compassion to those in need; and

WHEREAS, a single individual's donation of the heart, lungs, liver, kidneys, pancreas and small intestine can save up to eight lives; an eye and tissue donation can save and heal the lives of up to 75 others; and a single blood donation can help three people in need; and

WHEREAS, no one is too old or too sick to register with the NYS Donate Life Registry. Anyone 16 years of age or older can register; and

WHEREAS, in New York State there are approximately 10,000 people waiting for an organ transplant; with more than 1,500 New Yorkers having been waiting more than five years for an organ transplant; and an estimated 500 New Yorkers dying every year while waiting for an organ transplant; and

WHEREAS, more than 2,600 transplants were performed in New York State in 2019; and

WHEREAS, New York State's County governments play a key role in raising awareness of the need for organ and tissue donation through the interactions County officials have with the public with regard to this subject through local DMV offices, local boards of elections, departments of health, naturalization ceremonies and veterans' programs; and

WHEREAS, such interactions by Saratoga County officials with the public provide opportunities for the provision of information on how individuals can help their fellow New Yorkers by signing up as organ and tissue donors; and

WHEREAS, Counties across New York State are proclaiming the month of April 2021 as "Donate Life Month", and engaging in various activities designed to promote an increase in the number of registered organ and tissue donations; and

WHEREAS, one activity that the New York Alliance for Donation has encouraged counties to undertake in order to raise awareness of the need for organ and tissue donations is to raise the "Donate Life Flag" at their county municipal offices; and

WHEREAS, our Law and Finance Committee and the Saratoga County Clerk's Office, through its Department of Motor Vehicles, wish to promote the month of April 2021 as "Donate Life Month" in Saratoga County; now, therefore, be it

RESOLUTION 67 - 2021

Introduced by Supervisors Raymond, Allen, Lucia, Peck, Pemrick, Smith and Wright

ADOPTING 2021 SARATOGA COUNTY LEGISLATIVE PROGRAM

WHEREAS, our County is recognized as a statewide leader in economic growth and opportunity; and WHEREAS, we wish to continue the reforms of non-productive state laws and policies, obtain greater flexibility in resource allocation for local governments, seek relief from unfunded State mandates, and promote economic development in Saratoga County; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors requests enactment of the following legislative initiatives:

Saratoga County 2021 Legislative Program

- 1. Restore Full 20% Local Assistance Withholdings. The 2022 Executive Budget proposes a restoration of 15% of the 20% State Aid withheld to help close the State's budget gap. This proposal assumes at least \$6 billion in new Federal aid, which is not a given. Regardless, the State should restore the entire 20% of aid withholding to counties, who face their own fiscal challenges due to the COVID-19 pandemic. Should Federal aid not close the State's budget gap sufficiently, additional local assistance cuts must not be used to close the deficit.
- 2. End Mandatory Sales Tax Diversions for State Purposes. The 2019 Enacted Budget changed how AIM payments to cities, towns and villages is funded, authorizing the Comptroller to withhold County sales tax disbursements to make AIM payment instead of the from the State's General Fund. The withholding amount for Saratoga County is about \$1.5 million. The State also enacted a program to withhold \$250 million in local sales tax collections from counties in quarterly installments into the Distressed Provider Assistance Account, to fund financially distressed hospitals and nursing homes. Saratoga County's estimated share of this withholding is also \$1.5 million. While aid to local governments and medical facilities is important, the shift of funding from the State to counties, who are dealing with their own fiscal stress, is unfair and they should be made whole.
- 3. Restore VLT Aid. The County of Saratoga and City of Saratoga Springs jointly cover costs associated with public safety services in order to provide a venue for video lottery terminals. The County and City rely on VLT aid to offset these costs together with the growing list of unfunded mandates while the State continues to reap the benefits that these venues provide. This aid amounts to \$775,000 for the County and \$2.3 million for the City.

- 4. Ensure Regional Equity in the Pandemic Recovery and Restart Program. The 2022 Executive Budget proposes tax credits aimed at two industries most adversely affected by the COVID-19 pandemic. First is the Small Business Return-To-Work Tax Credit which provides refundable tax credits to small businesses in the accommodations, arts, entertainment, or recreation sectors with 40% or greater revenue or job loss. Second is the Restaurant Return-to-Work Tax Credit Program, available to small restaurants located within New York City or outside of New York City in areas that were designated as a red or orange zone for at least 30 days. Under both programs, businesses that increase their employment will be eligible for a tax credit of \$5,000 for each net full-time equivalent position added, up to \$50,000 per business. The total refunds for both programs would be capped at \$50 million each. While this is a laudable program, it is important the rules for distributing these credits ensure equitably between NYC and upstate, which has also suffered economic lose due to the pandemic. A \$25 million program specifically for NYC Musical and Theatrical Production is also established in this section, already providing targeted aid to the City.
- 5. Enact "No New Unfunded Mandates" Legislation. While counties are constrained from raising revenue by the tax cap, the State is free to enact new unfunded mandates and shift more costs on local governments for existing mandates with impunity. In 2021, all of the County's property tax revenue will be consumed by unfunded mandates, plus an additional \$725,000 in General Fund revenue. Especially in this time of fiscal stress due to the COVID-19 pandemic and the fact that the State is already withholding aid and sales tax payments from counties, it is imperative that the State does not apply additional weight to local government's already hefty fiscal burden.
- 6. Continued Support for an Overhaul of Recent Criminal Justice Reforms. Saratoga County supports Senator Tedisco's S.1523 bill to repeal bail and discovery reform laws. These recent reforms have caused widespread concern for public safety and are placing additional unfunded burdens on law enforcement agencies, District Attorney's Office, and Public Defenders Offices across the State. Saratoga County also supports Senator Tedisco's S.1522 bill to protect emergency first responders and provide them with the same personal information disclosure protections that are afforded to law enforcement personnel. The County also supports S.1521, which provides courts with more discretion when addressing felony convictions. As of 2/8/21, these bills are currently at the committee level, awaiting addition to the Floor Calendar.
- 7. Continued Effort to Restore Community College Funding. The State's reduction in community college tuition is driven by enrollment but fails to consider the rising costs of tuition. Historically, funding for community colleges was designed to be a three-way split between the State, counties, and students. Initially, the State offered financial support of 40% to encourage counties to develop campuses. This state commitment was later changed to "up to" 40%. Even with an increase in the per student rate, dropping enrollment can mean less state support for individual campuses and could ultimately lead to increased chargeback between counties based on the current chargeback methodology. State funding is currently well below the one-third promised and far short of 40%.
- 8. Support Enchantments to NYS Historic Tax Credit. Assemblywoman Woerner is advocating for enhancements to the NYS Historic Tax Credit be included in the 2022 Enacted Budget. The proposed changes would increase the credit for smaller projects, defined as projects with expenditures under \$2.5 million, from 20% to 30%. The proposed amendments would also ensure that smaller cities will qualify for the NYS Historic Tax Credit. Expansion of this eligibility threshold will open the credit for more upstate cities and provide an economic and tourism boon for communities looking to rehabilitate historic buildings.
- 9. Restore Funding for Veterans Peer-to-Peer Program. The 2022 Executive Budget does not provide funding for the Joseph P. Dwyer Veterans Peer-to-Peer Support Program, which provides coordination and cultivation of a safe atmosphere for veterans to connect and share their experiences. In Saratoga County, this program has been a tremendous success in providing outreach to the veteran community and connecting veterans with their peers. Saratoga County has been eligible for funding of up to \$185,000 in the last two budget cycles, and any residual funding still available should be released to counties if the program is not fully funded in the 2022 budget. Senator Jordan recently lent her support to the restoration of these funds.
- 10. Support Funding for the New Generation Farmland Protection Fund. Supporting Assemblywoman Woerner's request that \$400,000 in funding for the Farmland for a New Generation Program specifically named to

American Farmland Trust (AFT) - be included in the 2022 Enacted Budget. With nearly a third of New York's farmers over the age of 65 and cultivating almost two million acres of farmland, it is imperative that New York does its share to cultivate the next generation farmers. An aging farm workforce is not the only thing threatening the future of farming in New York – scarcity affordable land is a major barrier for new farmers. Since launching in 2018, The Farmland for a New Generation New York Resource Center has had over 55,000 users visit the site to browse resources and listings, 827 farmland seekers and owners have posted profiles, and their expert staff has provided one-on-one guidance to 649 farmers and landowners.

11. Support the Creation of the Safe Water Infrastructure Action Program (SWAP). Continuing support for Senator Tedisco's Safe Water Infrastructure Action Program. This bill (S.224) establishes a program to fund the replacement and rehabilitation of existing municipally-owned and funded drinking water, storm water and sanitary sewer systems, similar to the Consolidated Street and Highway Improvement Program (CHIPS). The program would apply to any county, city, town or village drinking water system, storm water system or sanitary sewer system within the state that is not under the maintenance and/or operational jurisdiction of the state nor any private entity. Annual funding for this program would be at least the same amount appropriated for CHIPS.

Federal

- 1. Support 100% Airport Improvement Program (AIP) Funding There is a bill being considered for reconciliation in the House includes 100% AIP (Airport Improvement Program) funding. This would mean there would be no County share needed for the airport grants in 2021. This would be a savings of about \$250,000 for Saratoga County. The County airport has a critical safety improvement scheduled for construction this year. A new partial parallel taxiway to separate jet traffic from two glider clubs that operate at our airport greatly reducing the potential for aircraft conflicts and accidents. Included in this project is the creation of essential habitat for the Federally protected Karner Blue Butterfly. A 100% percent Federal share of AIP projects will ensure that these critical improvements are accomplished.
- 2. Support Federal COVID Relief Funds for Municipalities There is currently legislation in the House to provide resources for municipalities hard hit by the COVID pandemic and provide stability so their pre-COVID economy can be restored and reinvigorated. The plan is designed to provide all local governments with funding to respond to, or mitigate, the impact of the COVID, cover costs related to the public health emergency, replace lost and/or delayed revenues, and provide relief from the negative economic impacts of the pandemic emergency.
- 3. Support Federal Broadband Infrastructure Expansion Funding. This includes the Emergency Broadband Benefit Program, the American Rescue Act, and any additional federal broadband infrastructure legislation that will be considered in 2021. It is particularly important that the Federal Communications Commission finish updated their broadband and cellular service coverage maps in order to effectively deploy the 5G Fund for Rural America as well as other broadband infrastructure programs. There is a recognized and critical need for providing broadband access to rural areas for public safety, health, education, economic development, and quality of life, which has only been highlighted by the pandemic.

BUDGET IMPACT STATEMENT: No budget impact.

Discussion on Resolution #88:

Ms. Gaston said she knows there were comments after the distribution of the draft and during the public comment. She asked if there was any work taken to amend because she had not received a different copy and what she saw online was the one originally received. She asked if there was any discussion about changing any of those recommendations strengthening them, essentially.

Mr. O'Connor said he had reviewed the comments, as he was sure many other Supervisors did. There weren't very many, maybe four or five. He reviewed the information provided. He also, linked up to the 13 demands that had been suggested to the Committee but not provided. Mr. O'Connor said he looked at them. Some are good. Some are not, in his view and some would need further consideration. Mr. O'Connor said that they were

considered but at least speaking for himself, he didn't think that any changes were warranted in the report recommendations.

Ms. Gaston said that her concerns stated last time when it was brought forward, she thought they're good recommendations. She said her problem was that the recommendations are couch. And language does not require a plan or any actual movement forward, explore for the consideration, etcetera. She thinks things like body cameras and vehicle cameras have been explored enough both within the County and outside of the County. That should not be a recommendation to explore. That should be something that we move forward, obviously, with the Sheriff's Department who maintains this equipment. But that could be a plan that we develop now and explore She would like more the possibility. The first item is "facilitate and establish an Advisory Committee". information on how that's going to happen. She thinks one of the concerns in the comments prior to the publish of this and after have indicated that there was a concern that there were a number of populations of individuals in the County that were not having good relationships, not receiving communication from the Sheriff's Department. She thinks improving that can only improve our service and relationships in the community; even if it explains better how each sides are feeling. Also the recommendations for bias and de-escalation and what sort of demographic data, she said she would be shocked if they're not already guidelines set forth by law enforcement, either New Ms. Gaston said, again, she thinks the recommendations are good; but because the York or Federally. recommendations are couched in so much, as there is nothing solid here, she can't in good conscience vote for this, despite the fact that she does think many of the recommendations themselves would be good. Ms. Gaston appreciates the work that went into it and would like to see a more specific plan. Thank you.

Mr. Kusnierz thanked Supervisor Gaston. On the issue of body cameras, he said he has met with the Sheriff and his leadership, his management team. He said anybody who's negotiated contracts with unions, particularly law enforcement, understands that body cameras are something that must be negotiated with the unions. He had a great conversation with the Sheriff and there will be more conversations had on that. He thinks that there is a willingness to address that issue; and is something that has to be taken up at budget time.

Ms. Gaston said absolutely. And to be clear, she doesn't expect any of these recommendations or any changes to take place overnight. But would like to see there be more specific in it so that the public feels as though that import is behind it. That is good to hear that those conversations are taking place and she looks forward to them happening in the public.

Mr. Barrett said to Ms. Gaston that she was correct. The idea of implementing body cameras has been researched at some length. As Public Safety Chairman a few years ago, our committee reviewed the use and procurement of body cameras. He said he thinks implementing the cameras after purchasing them there is a lot to it. He thinks there is much more to it than you may see on the surveys. That being said, the recommendation from the Committee was positive one. Mr. Barrett said the Sheriff and his team supported it back then; and he thinks the same is true now. He said he would personally support the Board investing in body cameras. There is the initial cost for the cameras and the equipment. And then there's a lot of back end costs with personnel and other ancillary items that are important to the record keeping and also review of all of that tape that's being collected. So that coupled with the fact that technology obviously changes very quickly. Between the last time we reviewed it to now, obviously there's going to be a vast difference in the technology and how the systems operate. He said he thinks, as a Board of Supervisors that would behoove of us to start that process, because it is involved and it will take some time to get to the point where we are ready to move forward and purchase and implement the system. He would support that initiative moving sooner than later.

Mr. Kusnierz thanked Mr. Barrett and called on Mr. Lawler.

Mr. Lawler said he has a full time police department in his town. Certainly nowhere near the scale of the Sheriff's Office but it is 10 full time officers. He said their department had cameras for several years and was one of the first departments to get them. The size of the police force made the investment not overly burdensome. They were about to upgrade to new technologies; and, one of the things you run into is, after you buy cameras, the cameras are no longer supported by the companies that sold them to you. They want to buy new cameras because they don't continue to supply the support for the older cameras. It is not a one-time cost. The more overriding reason why the cameras were discontinued, was there's a tremendous burden on the part of the law enforcement agency to comply with the recent reforms in the criminal justice system and the disclosure rules. The disclosure

rules require very fast turnaround of that footage. Defendants are entitled to that, and they should be entitled to. However, the requirement is a relatively short window to get that to the District Attorney's Office and that was really creating some administrative problems. He thinks cameras are a very good idea. He thinks they solve many problems and avoid many problems. One of the anecdotes his officers told him was they had less confrontation. Because all of a sudden, a couple of people who were being most disruptive realize they were being recorded. The officer would say that he was recording all of this and suggest they calm down. People would. The obvious benefit is if an allegation against an officer true or not. If an officer behave in a way that was unprofessional, illegal the camera is important for determining that. He said the point he's trying to make is that this is very complex and not an easy decision to make. There is going to be personnel costs. People are going to have to be hired to provide this information to the District Attorney's Office who in turn are obligated by law to make this information available to defense attorneys. He said he thinks this is a good idea but hopes the County takes its time to plan from A to Z. This assumes the contract negotiations get to that point. How we go from that point, to actually all the administrative functions that are going to have to take place to comply with the law, the way it's written. He thinks it is a good idea. He added Supervisor Barrett is right that this is much more complicated than just putting a camera on somebody's uniform. There's a lot on the back end of this that has to be considered. Mr. Lawler said he hopes when the County does this it is planned out completely, and not just jump in without a plan.

Mr. Kusnierz thanked Supervisor Lawler and called on Supervisor Connolly.

Mr. Connolly said he fully supports our police departments and sheriff's. He had the privilege of filming zone five police academy for two and a half years straight. He watched five groups of cadets go through the training and it is intense. He said he has a new level of respect because of that, how hard the job is, how dedicated the officers are. Mr. Connolly said he had many of the same sentiments that Supervisor Gaston had when he reviewed all the materials that were emailed. He is glad to hear that cameras are seriously being considered as it would benefit the public, the officers and everybody involved to ensure equal justice.

Ms. Gaston said she had one more comment. She would say she is appreciative of the recommendation for increased mental health for both the public in general in response, and for officers. She grew up in a law enforcement family and when she wanted to get her driver's license, she had to pass the Alabama State Police Defensive Driving Course. She understands and appreciates the recommendations to support law enforcement officers. Much like with the military in general, the things that they are dealing with will only benefit them as well.

WHEREAS on July 12, 2020, Governor Andrew M. Cuomo issued Executive Order 203, entitled the "New York State Police Reform and Reinvention Collaborative;" and

WHEREAS, Executive Order 203 requires that all municipalities within New York State who have a law enforcement agency must perform a comprehensive review of strategies, deployment practices, and policies for the purpose of addressing the needs of communities served by the police agency and promote community

engagement to foster trust, fairness, and legitimacy and to address any racial bias and disproportionate policing of communities of color; and

WHEREAS, on October 14, 2020, the Chairman of the Board appointed the seven-member "Executive Order 203 Compliance Group" to conduct a comprehensive review of the Saratoga County Sheriff's Office, including strategies, deployment practices, and policies; to consult with stakeholders and thereafter submit a report and any recommendations to the Board of Supervisors for consideration; and

WHEREAS, the Executive Order 203 Compliance Group sought public input through written comments and survey responses, held forums with stakeholder groups on November 4, 2020, November 10, 2020, November 18, 2020, December 2, 2020, December 10, 2020, and December 16, 2020; and held public forums on January 5, 2021 and January 7, 2021, to consider and discuss policing strategies, deployments and policies; and

WHEREAS, on February 23, 2020, per Resolution 46 – 2021, the Saratoga County Board of Supervisors accepted the Executive Order 203 Compliance Group Report for consideration and established a public comment period to elicit community input regarding the report and recommendations therein; and

WHEREAS, the Executive Order 203 Compliance Group January 2021 Report provides ten (10) recommendations to the Saratoga County Sheriff's Office, and implementation of those recommendations by the Saratoga County Sheriff's Office will ensure that all of the citizens of Saratoga County are continued to be treated equally, fairly, and justly before the law with greater transparency, and

WHEREAS, after consideration of the input offered from the Stakeholders and the public, now therefore, be it

WHEREAS, pursuant to Resolution 95-2021, this Board of Supervisors authorized a cooperative agreement with the Greenway Conservancy for the Hudson River Valley, Inc. providing for the County to act as contract administrator and project manager for the construction of a 1.2 mile section of the Champlain Canalway Trail over the lands of the State of New York in the Town and Village of Waterford, and to construct said section of the Champlain Canalway Trail at a cost of not to exceed \$210,000; and

WHEREAS, pursuant to Resolution 95-2021, the Greenway Conservancy for the Hudson River Valley, Inc. is to reimburse the County for its costs in constructing said section of the Champlain Canalway Trail up to an amount not to exceed \$210,000; and

WHEREAS, the 1.2 mile section of Champlain Canalway Trail to be constructed originates in the Village of Waterford at Broad Street (CR 32) and terminates at the Southern portion of the previously constructed section of the Champlain Canalway Trail over the lands of the City of Mechanicville and the Town of Waterford; and

WHEREAS, through a competitive proposal process, the Greenway Conservancy for the Hudson River Valley, Inc. previously retained CHA Consulting, Inc. to prepare the original professional engineering design work for portions of the Champlain Canalway Trail; and

WHEREAS, CHA Consulting, Inc. submitted a proposal for the provision of construction administration and inspection services for the construction of the 1.2 mile section of the Champlain Canalway Trail, which services include, but are not limited to: preparation of contract design documents, bidding services, and construction administration and inspection services, at a cost of \$35,000; and

WHEREAS, our Trails and Open Space Committee and the Director of Planning have recommended that the proposal of CHA Consulting, Inc. for the provision of professional engineering construction bid phase, administration and inspection services at a cost not to exceed \$35,000, be accepted; and

WHEREAS, the costs incurred by the County pursuant to this contract with CHA Consulting, Inc. will be reimbursed by the Greenway Conservancy for the Hudson Valley, Inc. now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with CHA Consulting, Inc. of Albany, New York for the provision of construction bid phase, administration and inspection services for the construction of a 1.2 mile section of the Champlain Canalway Trail in the Village of Waterford, at a cost not to exceed \$35,000, with the form and content of such agreement to be subject to the approval of the County Attorney; and, be it further

RESOLVED, that this Board of Supervisors, on this 16th day of March, 2021, hereby adopts a Local Law identified as Introductory No. 2, Print No. 1 of 2021, entitled "A Local Law Limiting Third-Party Food Delivery Service Fees During a Declared Emergency", as set forth in the annexed Schedule A, which once filed with the New York Secretary of State shall be known as Local Law No. 2 of 2021.

COUNTY OF SARATOGA - LOCAL LAW NO. 2 OF 2021

A LOCAL LAW LIMITING THIRD-PARTY FOOD DELIVERY SERVICE FEES DURING A DECLARED EMERGENCY

BE IT ENACTED by the Board of Supervisors of the County of Saratoga as follows:

<u>SECTION 1. Title.</u> This Local Law shall be known as "A Local Law Limiting Third-Party Food Delivery Service Fees During a Declared Emergency".

SECTION 2. Definitions.

A. The following words when used in this local law, shall have the meanings ascribed to them except in those instances where the context clearly indicated otherwise:

- a. The term "declared emergency" shall mean the period of time during which a State disaster emergency has been declared by the Governor of the State of New York or a state of emergency has been declared by the Chairman of the Board of Supervisors of Saratoga County, and such declaration is in effect in the County, and there are restrictions imposed on on-site dining at food service establishments in the County.
- b. The term "delivery fee" shall mean a fee charged by a third-party food delivery service for providing a food service establishment with a service that delivers food from such food service establishment to customers. The term does not include any other fee that may be charged by a third-party food delivery service to a food service establishment, such as fees for listing or advertising the food service establishment on the third-party food delivery service platform or fees related to processing an online order.
- c. The term "food service establishment" shall mean any fixed or mobile restaurant; drive-in; coffee shop; cafeteria; short-order café; delicatessen; luncheonette; grill; tea room; sandwich shop; soda fountain; bar; tavern; cocktail lounge; night club; roadside stand; take-out prepared food place; retail bakery; industrial feeding establishment; private, public, or nonprofit organization, including: schools; nursing homes; day care centers and hospitals; religious and fraternal organizations routinely serving food; catering kitchens; commissary or similar places in which food is prepared for sale on the premises or elsewhere; and any other establishment or operation where food is served or provided to the public, with or without charge.
- d. The term "online order" shall mean any order placed by a customer through or with the assistance of a platform provided by a third-party food deliver service, including a telephone order.
- e. The term "purchase price" shall mean the total price of the items contained in the online order that are listed on the menu of the food service establishment where such order is placed. Such term does not include taxes, gratuities, and any other fee that make up the total cost to the customer of an online order.
- f. The term "third-party food delivery service" shall mean any website, mobile application, or other internet service that offers or arranges for the sale of food and beverages offered by food service establishments, and the same-day delivery or same-day pickup of food and beverages from food service establishments located in the County that are owned and operated by different persons.

B. Unless otherwise indicated above or by the context in which they might be used, all words used herein shall have the meanings ascribed to them by the General Construction Law of the State of New York.

SECTION 3. Fee Limits During Declared Emergencies.

- A. It shall be unlawful for a third-party food delivery service to charge a food service establishment a delivery fee that totals more than fifteen percent (15%) of the purchase price of each online order.
- B. It shall be unlawful for a third-party food delivery service to charge a food service establishment any fee or fees other than a delivery fee for the use of their service greater than five percent (5%) of the purchase price of each online order. Any fees or other charges from a third-party food delivery service to a food service establishment beyond such maximum five percent (5%) per online order, and a delivery fee collected pursuant to subdivision (A) of this section, are unlawful, provided that such cap shall not apply to a credit card fee that is charged to the third-party food delivery service and is charged in the same amount to by the third-party food delivery service to such food service establishment.
- C. It shall be unlawful for a person to cause a third-party food delivery service platform to reduce the compensation rate paid to a delivery service driver or garnish gratuities in order to comply with this section.
- D. The requirements of this section shall only apply during a declared emergency and for a period of ninety (90) days after the end of the declared emergency.
- SECTION 4. Enforcement. If a third-party food delivery service charges a food service establishment fees in violation of this law, the food service establishment shall provide written notice to the third-party food delivery service requesting a refund within seven (7) days. If the third-party food delivery service does not provide the refund requested within seven (7) days of receipt of the written notice or the third-party food delivery service continues to charge fees in violation of this law after the initial written notice and seven-day cure period, a food service establishment may enforce this law by means of a civil action seeking damages and injunctive relief. The prevailing party in any such action shall be entitled to an award of reasonable attorney fees.
- SECTION 5. Severability. In the event any section, part of section, sentence, clause or phrase of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment will not affect the validity of any other provision of this local law.
- <u>SECTION 14. Effective Date.</u> This local law shall take effect upon its filing with the Secretary of State in accordance with the Municipal Home Rule Law.
- Mr. Lawler said he asked for a separate vote because he has a couple simple questions. He said he has no issue with the substance of the resolution. He asked if this required an RFP. Mr. Bulger said an RFP was not required because of the State's Covid emergency. Mr. Lawler asked if the contract contains a hold harmless agreement. Mr. Hartnett said the proposed contract does have a hold harmless agreement. Mr. Lawler said his concern was the people on the phone representing the County. If somebody says something that perhaps gives bad advice or tell somebody that when they are eligible when they are not, then the liability would be an issue. Mr. Lawler thanked them for their responses.
- Mr. Kusnierz said thank you, Supervisor. And before we vote, he asked the Public Health Commissioner, Dr. Kuhles if he would provide an update on the call center.
- Dr. Kuhles said they have taken approximately 1850 calls. It has been a tremendous help to the staff. There is a lot of work that goes into scheduling. He said you might have seen in the news where counties have had their links hacked or people showing up that are not registered. He is very thankful to the Board for the support on this. He thought the last time we spoke about this, he talked about quality assurance and how important it was to make sure that the residents were getting the white glove service. We have a number of staff that audit calls live and these calls are recorded every day. DiRad has been a real gem for us.
- Mr. Kusnierz asked if anyone had any questions for Dr. Kuhles.

Ms. Gaston said Dr. Kuhles has reported that staff has reviewed and listened to some of the calls. They have been quite pleased with how the calls are being handled. Threading is important. This contract also allows them to assist more with outbound whereas the minor contract was primarily limited to inbound registration. That means that this contract will be an even larger help because it will take staff that is currently calling to set up appointments, and allow them to do other public health work. This is going to allow Public Health to increase their reach out in the County instead of just on the phone. She is very appreciative of the Board for continuing to move forward.

On a motion by Ms. Gaston, seconded by Mr. Lawler Resolution #103 was adopted by a unanimous vote.

AUTHORIZING AN AGREEMENT WITH DIRAD TECHNOLOGIES, INC. FOR INBOUND AND OUTBOUND CALL SERVICES TO ASSIST PUBLIC HEALTH SERVICES WITH COVID-19 VACCINE DISTRIBUTION

WHEREAS, on March 17, 2020, Chairman Preston Allen, pursuant to Resolution 84-2020 declared a County State of Emergency due to the COVID-19 pandemic; and

WHEREAS, on March 17, 2020, the Board of Supervisors, pursuant to Resolution 84-2020 allocated \$1,000,000 to fight COVID-19; and

WHEREAS, the State of New York has indicated that significant numbers of vaccine doses may be available in the near future; and

WHEREAS, Saratoga County Public Health Services is in need of assistance to provide residents with accurate up-to-date information regarding COVID-19 vaccine distribution, as the volume of inbound inquires have diverted staffing resources from COVID-19 pandemic response; and

WHEREAS, in the event of a substantial increase in the availability and quantity of COVID-19 vaccine, Saratoga County Public Health Services has identified a need to dispense accurate and up-to-date information regarding COVID-19 vaccine distribution to residents, and the potential volume of outbound calls may exceed the operational capacity of the Saratoga County Public Health Services; and

WHEREAS, DiRad Technologies, Inc., has provided inbound call solutions in connection with Public Health Service COVID-19 response under a minor contract not to exceed \$15,000 and it is anticipated that the cost of services performed by DiRad Technologies, Inc. will meet or exceed the minor contract limit of \$15,000 before the end of March 2021; and

WHEREAS, Our Law and Finance Committee and the Commissioner of Public Health Services have recommended that this Board authorize an agreement with DiRad Technologies, Inc. for inbound and outbound calling services at a cost not to exceed \$50,000; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute an agreement with DiRad Technologies, Inc. of Clifton Park, New York, for inbound and outbound call services to assist Saratoga County Public Health Services with COVID-19 vaccine distribution at a cost not to exceed \$50,000; and, be it further

RESOLVED, that the form and content of such agreement shall be subject to the approval of the County Attorney.

BUDGET IMPACT STATEMENT: No budget impact. Funds are allocated in the 2021 Budget.

Mr. Zlotnick said back in December, the Board tabled the appointment of an individual. He doesn't remember the reason why. Then, earlier this year, we received another. As a Board member of SCPP, we received another individual who is interested in becoming a Board member. He said someone has said that this is a great family whom she knows well and sees them quite often prior to the pandemic. There are people who have expressed interest on occasion and others who have been contacted to gauge interest as part of the normal recruiting process, This person would add Ken to their list of terrific prospects and plan to contact him. Mr. Zlotnick said now we are going to replace a man who, according to the records made one meeting in 2020 and replace them with a previous supervisor who made one meeting in 2019. When we have two very qualified individuals who expressed

an interest in becoming members of the Prosperity Partnership. He said, as a board member of both organizations, he thinks we are doing a great disservice.

Mr. Kusnierz asked that the record reflect that Ms. Gaston needed to step out of the meeting to take a phone call.

Mr. Barrett asked what email Mr. Zlotnick was referring to. Mr. Zlotnick said "yours".

Mr. Connolly asked if the SCPP Board was consulted regarding this appointment. Mr. Kusnierz said Board of Supervisors has the sole authority to the appointment, not the Prosperity Partnership Board. Mr. Connolly asked if it was normal to not consult with an organization. Mr. Kusnierz said it was his experience and he has been on the Partnership Board for a number of years and as a member of that board, as a board member, and he was never consulted. Mr. Connolly said one of the candidates that Supervisor Zlotnick did not mention was Steve Overmeyer, who was the owner of BBL construction. And, as a board member of SCPP, he was looking forward to considering him as a board member. He said he thought he would bring a lot of talent to the board as we strive to promote the County's economy. He added for the record, he was not in support of this appointment.

Mr. Lawler said he was sorry that he did not have the gentleman's name from BBL but did see the resume. He said he was probably one of the most accomplished business executives in the Capital District. He's also President of their hotel division and the Chief Financial Officer of what some would argue is the largest if not one of the largest construction firms in the Capital District. No reason was ever given for not appointing him without a vote. He thinks we missed an opportunity there to put an eminently qualified on the Board. He said he doesn't know him but anyone who could look at the resume and not think that he should be heavily involved in County's economic development efforts, because they do so much construction in Saratoga County and elsewhere. He thinks we missed an opportunity there. Having said that, he said he has worked with Mr. Szczepaniak for a number of years now on the Water Authority. He said he could not speak to his tenure at the Partnership that that is not an impressive attendance record; but as far as the Water Authority goes, Tim is a very diligent and attentive board member. He attends the meetings, volunteers for committees and he does it all around the job. I would hope that that this turn around, if he were to be appointed, certainly more diligence would be appropriate and would be appreciated. He said he has found him to be an intelligent, hardworking guy who takes his position on Water Authority seriously. He said with respect, he supports him based on what he knows the job he can do having worked with him for a number of years on the Water Authority.

Mr. Kusnierz said for the record Ms. Gaston has re-joined the meeting.

Mr. Barrett said Supervisor Lawler stole some of his thunder. He concurred with what he said as far as Mr. Szczepaniak's involvement on the Water Authority, but also as a member of the Board of Supervisors, he was very involved and had a good attendance record. He said he could not verify what happened at the Partnership during that small period of time; but over the course of years, he is known to have very good attendance record, be a very involved participant and very talented.

Mr. Connolly said please just let me know that this is not in line with the normal things as he is relatively new to this. He asked if it would be appropriate to have Shelby share what type of relationship this candidate had with the Board when he was on the Board. He understood it was not positive.

Mr. Kusnierz said his position on that is that the Executive Director works for the Board of Directors and the Board of Directors are appointed by the Board of Supervisors. He thinks it would be highly inappropriate.

Mr. Kusnierz said Board members have been given copies of Chairman's appointments. He added Supervisor Gaston to the Long Range Capital Planning Committee and Mr. Paul Iachetta to the Self Insurance Labor Management Safety Board. (*Appointments are listed after the adjournment*.)

Mr. Kusnierz said he has two additional items under other business. The first is to congratulate our new County Attorney, Mike Hartnett. We are very thrilled to have him here with us in his new capacity. Mr. Kusnierz thanked Hugh Burke who stepped up in very challenging times these past several months to fill a very critical role in the position of acting County Attorney while the board deliberated where we wanted to go with a full time County Attorney. We all know Hugh has down a fantastic job for us in the County Attorney's office. Mr. Burke has served many years as our First Assistant. He is recognized on all legal matters involving foil requests as a County expert. He has been with us for over 20 years of service. He has just done a fantastic job on behalf of the County and the residents of Saratoga County as well as each of us. We want to wish him well and while he is entitled to and has the time to retire, he is going to remain in the County Attorney's Office. Mr. Kusnierz thanked him for all his efforts during the interim period.

Mr. Kusnierz said the last item he had was recognition of a lifesaving awards. He said that a while back, Sheriff Zurlo presented lifesaving meritorious service awards to two County employees. The employees are Deputies Eddie Hernandez and Jeffrey Kaplan who took immediate and decisive action to save the lives of two of our residents who were immediate imperil. To quote Sheriff Zurlo "he had no doubt that the decisive actions taken by these two individuals saved the lives of the residents". This incident happened back on January 28, 2021. Just briefly at approximately 2:42 am members of Saratoga County Sheriff's Office responded to an EMS assist call from a resident of the Town of Halfmoon. It was reported that two residents of a home at Oakley Drive had lost consciousness for unknown reasons. Upon arriving on the scene, the Deputies were met with a strong noxious odor from the residence. Upon making entry, they immediately located two residents of the home. Both individuals were in their 60's and were having difficulty maintaining consciousness. The female resident was carried from the second floor of the residence to the outside by Deputy Jeffrey Kaplan. The male resident was dragged from the first floor to the outside by Deputy Eddie Hernandez. Both subjects were treated at the scene by EMS personnel and transported to Samaritan Hospital. It was later determined that both had suffered from carbon monoxide poisoning due to an issue at the residence. Both subjects were conscious and alert after being treated by EMS personnel and are expected to make a full recovery. Mr. Kusnierz said he wanted to recognize on

the record the fine job that our Sheriff's Department does every day for us, in particular the heroic efforts of these two individuals. He thanked the Sheriff and thank you to your employees.

On a motion by Mr. Richardson, seconded by Mr. Schopf the meeting adjourned by a unanimous vote.
