REGULAR MEETING TUESDAY, April 20, 2021 AT 4:00 p.m., E.S.T.

Board called to order by Chairman Kusnierz.

The invocation was given by Thomas N. Wood, III, Chaplain. "Let Us Pray. Our heavenly father we thank you for all of the blessings that you have given us and may we always appreciate the rich and bountiful life that you make possible. May we be grateful for and enjoy the new life and changes which the spring season brings. Change is a constant part of all of the aspects of our life and may we accept and embrace the changes that we both initiate and with which we are presented. Changes provide us with new challenges and the opportunity to grow and pursue new directions. As we start the second quarter of the year, let us take a moment and reflect back on our accomplishments that we are thankful for during the first quarter including: the ability to provide a great number of Covid vaccinations, providing the needed social services to our residents, and the ability for all departments of County government to continue to efficiently conduct without gaps the daily business of Saratoga County. Without your help and guidance, these accomplishments would not have been possible. We are thankful for the hard work and dedication of all county employees and look forward to the second quarter of the year to continue to make positive achievements. Grant us the wisdom to make good decisions and always keep things in perspective. Let us learn from any mistakes that we may make, place value on our differences, recognize our individuality, and appreciate our diversity. May we keep a positive can do attitude and believe that with your help anything is possible. We pray that you protect all of the men and women of our armed forces who daily place themselves in harm's way so that we may be safe and live free. May they all safely return home to their families and friends. We ask this in your name, Amen."

Mr. Kusnierz said the next item on the agenda is a presentation. He is pleased to report that Congressman Paul Tonko is with us this afternoon. He represents the 20th Congressional District including the communities of Albany, Schenectady, Troy, Saratoga Springs, and Amsterdam. He is currently serving in his sixth term after being sworn into Congress in 2009. Presently, the Congressman serves on the Energy and Commerce Committee, which is the oldest Standing Committee in the house and was created in December of 1975. And he is the first Upstate New York Democratic member to serve on the committee since Leo O'Brian resigned the post in October of 1966. He was elected by his peers in the 116th Congress to Chair the Subcommittee on Environment and Climate Change. He was also selected to continue his service on the Science, Space and Technology Committee as well as on Natural Resources Committee. He has previously served on the education Labor Committee, as well as the Budget Committee. Mr. Tonko represents the towns of Boston, Charlton, Clifton Park, Halfmoon, Malta Mechanicville, Saratoga Springs and Waterford. So with that, Congressman, we would like to open it up for an opportunity to address the Board of Supervisors. Congressman.

Congressman Tonko thanked Chairman Kusnierz, the members of the Board, Mr. Bulger and staff. He said he was able to cast what he believed was a historic vote for the American Rescue Plan Act, which was signed into law this past March 11. This Lifeline Law will help to crush the Covid 19 pandemic and lay a foundation for America's economic and personal recovery. Among many things, the law puts vaccines in arms by establishing the National COVID-19 vaccinating program that addresses PPE, tracing, testing, enhanced manufacturing of vaccines, and a strategic plan for vaccination. It puts people back in jobs with the EIDL Grant Program, the Economic Injury Disaster Loan Program, receiving \$15 billion in expansion of the Paycheck Protection Program and invest some \$28.6 billion in the restaurant, food, and beverage establishment industry because they have been so hard hit with unemployment and furloughs. The American Rescue Plan also provides a \$10 billion appropriation to the states and that will cover the cost of capital projects like broadband infrastructure. It also works to put children back into school safely. By investing \$130 billion in state and local reopening efforts. I believe some \$440 million will come in direct Federal relief to the capital region. It will enable schools to repair and retrofit ventilating systems, reduce class size to make social distancing easier for students, allowed for

purchasing of PPE, COVID testing and other education expenses that come their way. American rescue plan also addresses local needs. So state and local governments, services, essential services that must continue in order to advance and respond to the quality of life components of our communities. That means \$360 billion in emergency funding for our states or localities, our territorial and tribal governments. In a rough outline, and again, these are not hard numbers, there are forecasts, but it looks like some \$400 million for the 20th Congressional District and about \$44.5 to \$45 million for Saratoga County. Our Bipartisan Cares Act passed in December, created the Landmark Paycheck Protection Program. And it delivered low interest loans to struggling small businesses. The Rescue Plan, signed in March invests an additional \$7.25 billion towards the PTT program so that we can address those small businesses that were hardest hit in our community. As mentioned, a \$28.6 billion restaurant revitalization funds, which has been very favorably received by our restaurant industry. Then there is a Save Our Stages Act which is now referred to us the Shuttered Venue Operators Grant that speaks to the arts components in our communities. They will be able to file for assistance based on revenue loss from 2019 to 2020, or from the year beginning to year-end through COVID. We also built upon the Coronavirus Food Assistance Program that came out of the USDA that was providing relief to farmers impacted by COVID-19. We had another \$3.6 billion dollars to respond to disruptions in the food supply chain and to provide for debt relief to socially disadvantaged farmers. These funds are a step in the right direction. We must work to ensure that they are distributed equitably. He has been actively pushing both the Biden Administration and before that the Trump Administration on this issue. He wants our local small farms to get a lot of the assistance. If you saw anything in the TU of late, it talked of that on Sunday about the inequity of how the farms were receiving this that went to a lot of large corporate farms. Also, we're building on an actual nationwide vaccination system to provide existing lifelines for our farmers as small businesses so that we can get some of those struggling families back on their feet. In short, the American Rescue Plan is our down payment on a sustainable energetic American recovery. Make no mistake about it this work remains unfinished. Congress is in the process of turning our attention to the President's recently unveiled American Jobs Plan that deals with infrastructure, including our aging public water systems, our expanding broadband Internet access needs, fixing our crumbling roads and bridges, and developing priorities that will help us deal with some of the disruptions that have come into everyday life. We have seen that some of the water issues addressed in Flint, Michigan, Newburgh, New York and in our neighborhood of Hoosick Falls, and knowing firsthand what the toll of that failure means to local businesses, local economies and governments and certainly to the families. In the Infrastructure Bill, the President has included a \$50 billion appropriation for the National Science Foundation, including a reported \$37 billion for the United States semiconductor industry. The spending that could be that could lead to a new computer chip factory in Saratoga County, and could lead to federal semiconductor research work done in Albany. He is looking forward to working with the administration and my colleagues in Congress and both Houses, both parties to promote America's global competitiveness in the global semiconductor industry. He has continued to push additional COVID Rescue Legislation beyond the Rescue Plan, and beyond the American Jobs Plan. His one Bill deals with the Mental Health Research Act he authored, that would jumpstart a nationwide assessment of the mental health impacts of the pandemic, especially on children and frontliners, who we see are suffering uniquely. Our efforts will be to get a blueprint on how best to use the mental health dollars in the rescue package and apply those dollars in the most effective, most meaningful manner. He also has a Bill that he's promoting, that is the Mainstream Addiction Treatment Act, the MAD Act, and the Medicaid Reentry Act both of which provide significant expansion in health care and substance use disorder treatment with the opioid epidemic, which was beginning to plateau, if not dip somewhat. It went from 77,000, up to 80,000 to 85,000, with COVID. Many are forecasting it will surpass 100,000 in terms of lives taken cause of that epidemic. He will continue to push for more community health providers to be able to provide vaccines for more of our New York farms and small businesses to be able to access vital rescue funding to bridge the gap, and to make certain that we survive and grow our economy in the post COVID environment. So with that, that's a quick rundown. He apologized for being somewhat quick in that review. But we're just starting about and he is trying to commit to the work that he promised here with Saratoga. He said he is open to any questions any of the Supervisors might have.

Mr. Kusnierz thanked the Congressman for that update on Congress. He asked if there were any questions from Supervisors. He called on Supervisor Lawler.

Mr. Lawler said he has a couple quick question relative to the federal funds that were allocated. Do you have any idea when we can expect to see clarity and detailed guidance from the Department of Treasury?

Mr. Tonko said they were fine-tuning in terms of the exact amount of money and then the available use is coming. He hears very soon down the road because the effort was to get it out there as quickly as possible. He did not have a date per se but would try to get an update.

Mr. Kusnierz asked if there were any other questions for the Congressman. He called on Supervisor Gaston.

Ms. Gaston said she was just wondering if the Congressman had any idea on what we were looking at for a timeline for any approval for vaccines for younger children. She said we all want our schools to be fully open and all the kids to be able to go safely. And she think that's a part that a lot of people are looking for.

Mr. Tonko said he thought that, within the limit, or the age threshold coming down to 16, they seem to be going in batches of most vulnerable. He thinks the next step would be to make the opportunity for vaccinations to below the 16th level in the near future. He said he knew that recommendations were coming for opening school safely, that they were encouraging teacher vaccinations and social distancing for students.

Mr. Kusnierz thanked the Congressman and asked if there were any more questions. There were none. Mr. Kusnierz thanked the Congressman for taking time out of his busy schedule to be on the phone with an update.

Mr. Kusnierz said the next item on the agenda was public input. There is one person signed up to speak. He called Ms. McGraw to speak.

Ms. McGraw thanked the Chairman and the Board for giving her the time to speak. She said she would like to see a merge of the Saratoga County Public Health Programs and would like the name of the Mental Health Clinic changed. She suggested Behavior Health rather than Mental Health. She wanted to address the fact that our "mental health system" has been lacking, especially during this pandemic. Some have gone into the legal system. They have gone into the system of homeless because they did not get appropriate care. Nobody was checking in on them physically and now they're going up into the criminal justice system. She wanted to address that in the fact that programs are around Skidmore College and Route 50. The County doesn't seem to have much outside as far as access to the buses. On a positive note, she wanted to say thank you very much for giving her a chance to speak and she appreciates what the County has done now, during their pandemic, where we can come to speak. Thank you.

Mr. Kusnierz said thank you very much, Miss McGraw and well said. He said he could say that her points are well taken. He is committed and is working with the Chairwoman of Health and Human Services, Supervisor Gaston that as we move through this year, we will be looking to provide additional assistance for the mental health issues that our County faces. That remains a priority.

On a motion by Mr. Barrett, seconded by Mr. Lant the minutes of the March 16, 2021 Board meeting was unanimously approved.

WHEREAS, Resolution 330-82 adopted a manual of Policies and Procedures for the conduct of Saratoga County government; and

WHEREAS, since adoption, the Board of Supervisors has enacted several amendments to the Manual; and

WHEREAS, the County entered into existing minor contracts with Ashley Hubbard dated December 18, 2020, Caroline Regales dated October 9, 2020 and Matthew Prock dated November 16, 2020 for contact tracer services to rapidly interview positive COVID-19 patients; identify their close contacts; interview and alert those contacts to the risk of infection; instruct the contacts to quarantine or isolate for 14 days and monitor those in quarantine or isolation to ensure their compliance and to ascertain if they are showing any symptoms of COVID-19; and

WHEREAS, as there continues to be cases of COVID-19, it is imperative to maintain the services of quality contractors to perform essential contact tracing services; and

WHEREAS, Ashley Hubbard has been a dependable contact tracer who is a college graduate who is able to work full time; and

WHEREAS, Caroline Regales, who is a college graduate, is available to perform contact tracing services on a part-time basis; and

WHEREAS, Matthew Prock, a college graduate, is available to perform the duties of contact tracer on a full-time basis; and

WHEREAS, the cost of services performed by Ashley, Caroline and Matthew have met or exceeded their minor contract limits of \$15,000; and

WHEREAS, our Health and Social Services Committee and Commissioner of Health have recommended that the County enter into new one year agreements with the following contact tracers, effective at the signing of said contracts: 1) Ashley Hubbard, at a rate of \$25.00 per hour, for a maximum of 40 hours per week, with the total contract amount not to exceed the sum of \$52,000; 2) Caroline Regales, at a rate of \$25.00 per hour, for a maximum of 30 hours per week, with the total contract amount not to exceed the sum of \$39,000; and 3) Matthew Prock at a rate of \$25.00 per hours, for a maximum of 35 hours per week, with the total contract amount not to exceed the sum of \$45,500; and

WHEREAS, pursuant to Resolution 201-2020, this Board accepted a New York State Department of Health grant administered by Health Research, Inc. that includes \$478,215 for temporary and contracted employees that are hired exclusively for COVID-19 response activities, which grant funds will be used to cover the cost of these three contact tracing agreements; now, therefore, be it

BUDGET IMPACT STATEMENT: No budget impact.

Mr. Peck said he was unfamiliar with this firm. The first "whereas" talks about the specialized legal services for converting to a full health department. He asked if they have general experience or if they had worked with another county.

Mr. Hartnett said Saratoga County is the first county in approximately 20 years to be endeavoring this. It is unique legal expertise and this firm has done regulatory work and interfaced with the Department of Health. Specifically, it's once in a generation project, so to speak of, that's why that firm was procured under professional services. They've been doing some exploratory work under a minor contract. We've been very pleased with the services rendered.

Mr. Peck thanked Mr. Hartnett for the clarification. The second "whereas" talks about a need for ongoing legal representation related to the emergency rental assistance. He thought we heard last week, the states could have done that. So maybe that's not appropriate within the mass vaccination site. He was just wondering, and he thought the general consensus was we probably won't need to continue with that regard. He would make note of that. In general, we often go from minor contracts to major contracts. He was curious, looking at the background, this was the supporting documentation a week ago, they were first level engagement on January 13. Minor contract

on the 26th of January. They were amended on March 19, expand the services and April 5 updated for letter of agreement. He asked because the contract is going to a major contract, how far over the minor contract have we gone. He was just trying to get a sense of how much outside legal counsel we are paying for.

Mr. Hartnett said it was his understanding that there are invoices for approximately, at this juncture, \$7,000. We are we are anticipating that given the ramp up of that transition, that it's going to rapidly approach the \$15,000 cap. This was an anticipatory resolution.

Mr. Peck said that later on in the resolution it talks about contract review and grant administration. The only reason he is asking is that he knows generally this is done in house. He doesn't expect that we can do everything in house. This is taxpayer dollars and we should do as much as we can in house and then contract out for the expertise that we need. We have a highly qualified law department. You have excellent people up there. He wanted to be sure that we're continuing to utilize them as much as possible. That's all.

Ms. Gaston said theoretically, she would also say those are some of the questions originally brought forward to her. Public Health becoming a full service Department of Health is going to be a significant amount of time. And one of the reasons is not only the advice on the equation, but also to support some of those issues, both in the legal department and in public health that will need to be focused in other areas as we do this expansion. She has requested that they will report to the Committee on a regular basis, they will know what's taking place and how much money is being spent. Because she agree with Mr. Peck. It's important that we spend our money wisely. But she does agree that there's been some preliminary steps to see how well they could do with this work, and what they could do. And she was pleased with what they were able to accomplish especially since many of the people who've done this the last time are no longer in State government. So we're having to find a lot of things that haven't existed before. But she agree with Mr. Peck's point that we need to make sure that we're doing this in a cost effective manner. And she believes the Chairman is going to be taking some action with regards to committee in the near future to make sure that there is some more oversight than that debate. Thank you.

Mr. Lawler asked if there was a sense of the length of this engagement. It looks like this is open-ended which makes him a little nervous when there is an open ended professional contract. The contract appears to be working on specific matters. Is there any idea how long this will take?

Mr. Hartnett said it is a bit open ended on purpose because the nature of this project and the scope of this project seems to be expanding as we get into it and dig our teeth into it. The way he understands the resolution to read is that right now would be for a two-year window of time. And the idea behind that is that he can't give a definitive answer about what would be an ending, other than when the County is fully transitioned to a, what's called an Article 340 District, and also having full Environmental Health Services up and running, which is a substantial undertaking. This is why he worded it as a two-year window.

Mr. Lawler said his second question is, often on contracts like this, we have a not to exceed sum. This has no limit. But it would be good to know that there is a top figure out there that would require coming back to this board to extend that contract further, and not only in terms of duration, but in terms of costs. He is wondering if anybody had any idea of how much money this could eventually cost us? Is there an alternative way to get that information and that service?

Mr. Kusnierz said that this transition to a full service, Public Health Department, the required transition is going to be very expensive. There's no question about it. We believe and we're hopeful that we'll be able to leverage Federal dollars for that process. Legal expenses will be a component of that process. But no one knows what that figure is going to be.

Mr. Lawler said he could accept that. He didn't think that was an unreasonable answer. He understands that people might not even know how much it would cost. You don't know how long it's going to go in. It's an hourly based contract. He asked if we could agree informally that the expense of this contract, could we have a general understanding that expenses associated with this contract would be reported to the Health Committee so that they become just part of the record for the other supervisors to be aware of. So we all don't wake up one day and go, how did we get here and how have we spent that much money? He would ask if that could be incorporated not necessarily in to the resolution but in to the implementation.

Mr. Kusnierz said to that point he would be naming basically an Advisory Committee that will comprise be comprised of a couple supervisors, and individuals who have been involved in these transitions before, as well as Dr. Kuhles as our Commissioner. They will be making those recommendations for the full Board before we take additional actions, especially financial ones. It is his intent that the Board be kept apprised of that effort every step of the way beginning with that advisory group.

Ms. Gaston said "ditto". She thinks that is important because it is something that we are required to do and therefore need to be aware of the progress. The progress for accounting and what is going forward. She would make that commitment on the record that that will happen.

Mr. Barrett said this sounds like a good measure but isn't it also a fact that we need to act with expediency in this matter, based on the State and their expectations? We are running late on this conversion, is that correct?

Mr. Kusnierz said he could tell you that the County has received correspondence a year or two ago; which was not acted upon from New York State Department of Health. So yes, to answer your question there is expediency that is now required in this effort. But again, that Advisory Group reporting to the full Board will keep us apprised of every step of the way, and what the costs are going to be so we can anticipate, as we put the next year's budget together and other actions.

Mr. Barrett said he didn't know if there's any penalties involved or any additional action that the State may take. But he thought we should focus on moving as quickly as possible on this endeavor. It sounds as though we are behind as an organization, following through on this commitment and directive.

Mr. Hartnett said he would like to supplement Supervisor Barrett's statement. He would completely agree that there is some expediency behind it and the State is pushing. And this endeavor has started in earnest recently and we're very keen to it. We've had ongoing discussions with the State Department of Health about what this is going to look like to establish a timeline. And it's going to be a large process that is going to involve the budget process. It will require PR to get this concept out there that this has been on the State's radar for the better part of a decade. And we're up and running on it. And so this is an important component. And they're looking for good faith efforts towards what we've done, and working with us to establish a workable timeline, very cognizant of the fact that we're in the middle of a pandemic. So this is one of those components and why it was warranted as a resolution in anticipation of going to a major so to continue to hit the ground running.

Mr. Kusnierz if he could just add that it's actually a result of Saratoga County is a victim of its own success. And with the growth that we're experiencing, the DOH regional office out of Glens Falls does not have the ability to continue to service all the projects and growth that's happening in the County. And of course, you have the population increase, which is also a triggering mechanism. So we're doing everything right, we just had, unfortunately, we're very good at making Saratoga County an ideal place to live and work. And so now we have to take the next step to serve our residents, because the State won't be doing that shortly. Any other discussion on that?

Mr. Peck he would just make a couple comments to make the public is aware. Under the State law, the requirement is once your population hits 250,000. The State and like a lot of things, tried to push more work or more expenses down to the County and local levels. So they have been trying to do this for the better part of a decade. But we really didn't meet the statutory requirements to go there. Those discussions were ongoing, that when our former Public Health Director Cathy Duncan was retiring, they want us to seek out a medical doctor to run the department, Dr. Kuhles and to assist in that transition. So as the Chairman said we are detrimental because of our own success. But he didn't want anybody in the public to think that the County sat on their hands for 10 years. We think the County stood its ground that we were trying not to take on the expense that was that was really due the County or the State was required to cover. So as we transition, it's going to be a big project, a big process, an expensive one. We are very thankful we have Dr. Kuhles leading the effort there.

Ms. Gaston said for the most part, yeah. With regard to that, however, there are some portions of the services that are provided are not subject to that path. And the State has made it clear that they will be withdrawing their performance of some of their services despite the fact that we have not met the cap. So while we are not quite at

the 250,000 population, it is a necessity that we do move quickly on this because they are withdrawing some of the services that they can in short order. She has reviewed that we are not at the cap at this point but there is still some serious urgency.

On a motion by Mr. Richardson, seconded by Ms. Gaston, Resolution 130 was adopted by a unanimous vote.

WHEREAS, as a result of the ongoing COVID-19 Pandemic there has been a need for ongoing legal representation of the county related to special projects such as Emergency Rental Assistance grant programs and Mass Vaccination site contracting; and

WHEREAS, the County has entered into a minor contract with Wladis Law Firm. PLLC for professional legal services related to specialized and general matters including the County Public Health Services transition to a full-service health department, projects related COVID-19 Pandemic response including Emergency Rental Assistance grant programs and Mass Vaccination site projects; and

WHEREAS, the Wladis Law Firm, PLLC has demonstrated exceptional quality of legal services rendered; and

WHEREAS, the Wladis Law Firm has submitted a Letter of Engagement dated April 5, 2021, for additional legal services to provide legal counsel related to general and specialized legal matters, including, but not limited to assisting the County's Public Health Services with its transition to a Full-Service Public Health Department; general legal services relative to COVID-19 Pandemic Response including contract review, grant administration (e.g., Federal Rental Emergency Assistance Program); and other subject matters as needed and requested by the County Attorney's Office for the term April 21, 2021 through April 21, 2023 at the rate of \$325 per hour for services provided by firm partners, \$250 per hour for services provided by firm associates and \$125 per hour for services provided by paralegal staff; reimbursement for mileage and tolls; with standard hourly rates to be adjusted yearly; and

WHEREAS, the Law & Finance Committee and County Attorney have recommended that the County enter into an agreement with Wladis Law Firm, PLLC for professional legal services; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Wladis Law Firm, PLLC of Syracuse, New York, for professional legal services related to general and specialized legal matters, including, but not limited to assisting the County's Public Health Services with its transition to a Full-Service Public Health Department; general legal services relative to COVID-19 Pandemic Response including contract review, grant administration (e.g., Federal Rental Emergency Assistance Program); and other subject matters as needed and requested by the County Attorney's Office for the term of two (2) years commencing April 21, 2021 and continuing through April 21, 2023 at the rate of \$325 per hour for services provided by firm partners; \$250 per hour for services provided by firm associates; \$125 per hour for services provided by paralegal staff; and reimbursement for mileage and tolls; with standard hourly rates to be adjusted yearly; and, be it further

RESOLVED, that the form and content of such an agreement shall be subject to the approval of the County Attorney.

BUDGET IMPACT STATEMENT: None. Anticipated expenditures are included in the 2021 budget.

Mr. Richardson said he was just looking for some sort of idea when this money may be coming out to the landlords and renters and what type of information, we'll have to get to the State or to the County to receive the funds.

Mr. Kusnierz said he asked for resolutions 131 132 133 to be included in a separate vote this afternoon. And the reason being for that is because we received unfortunate news that he would like the County Administrator to discuss with the entire Board.

Mr. Bulger said these three Resolutions 131, 132, and 133 are all interrelated. He would go through them to provide a quick overview. The Emergency Rental Program that we've been hearing about, these Federal funds were sent to the County in February, where it was anticipated the County would be overseeing their distribution to eligible renters and landlords impacted by the COVID pandemic. The new State budget, however, dramatically changes this situation. New York State now is taking over control of almost all aspects of the program, including setting up a portal for applicants, handling all funds and disbursements, handling all application approvals, denials, and appeals and taking responsibility for all reporting and usage requirements with the Department of Treasury. In short, this is no longer a Saratoga County program. It is strictly a State program that we are providing limited assistance. Supervisor Richardson to your question when these funds might be available. We are waiting to hear when the State will open the portal to start accepting applications. We were told in February that it should be in March. We were told in March, it should be early to mid-April. He heard someone speaking yesterday, and they're not sure when it's going to be now. So all the counties across the State are now going to have to go through the State system. We are all waiting now for the state to open that up. And then once that opens, they're going to be responsible for taking in the applications, determining who gets funded, how much and getting the money out to them. So we have really been cut out of the whole thing. He wanted to go through these resolutions just very quickly, too. We do have a roll here through Department of Social Services, which he wanted to cover. But in terms of the resolution 131 there's actually three components to this resolution. The first is we are accepting the Federal money into our system that they actually sent us back in February. The money has been sitting in an account. We did not want to accept it until we knew what was going on with it. Now, we are accepting into our treasury, we are then turning around and sending it back to the State, all \$6.8 million and change. And the third component of resolution 131 is we are signing the agreement with the State of New York, that we will participate in the program under their terms. So that's resolution 131. Resolution 132 is amending the compensation schedule to create positions under Department of Social Services and authorizing an amendment of the 2021 budget. So as part of this program, we're supposedly going to get up to \$680,000 in administrative fees; 10% of the money goes to administrative fees. The State has told us that for up to that amount, any administrative costs that we bear, they will reimburse us at some point. We have to take them at their word that they will do that. We feel confident they will and we've been assured by leadership at the State that this will happen. So the key for us right now is Commissioner Potter's team. They want to hire two people to work on this project to assist all of the renters and landlords that are going to want to apply for this program. So Tina's group has put together a proposal that will do that. We're hiring these two people and it's really just for the length of the funding. And by the way, we are told now there, in addition to that 6.8 million, there could be another 5 million coming sometime later this year. So it could be up to \$11 or \$12 million going to renters and landlords here in Saratoga County, which is great. And the program could run up to 2024 or 2025, at least three or four years to get the whole thing out. So we are hiring a couple people through DSS that will be paid with the administrative funds that we're getting on this to meet that need. The third component, which is resolution 133, will authorize the Chairman to enter in agreement with Shelters of Saratoga. And that is through an RFP process. Shelters of Saratoga was determined to be the best fit to do outreach to our low income communities across the County and to renters and landlords. They will make sure they are aware of the program and advise them to go on the State portal to register. Basically just assist them and make them aware of the program and get them registered in the State system once that opens up. So kind of a quick overview of three resolutions. They all do tie together. Hopefully that answer Supervisor Richardson's questions.

Mr. Richardson said yes, thank you. He asked when this all begins to happen, when the people can start to register, will the Supervisors be notified.

Mr. Bulger said absolutely. Commissioner Potter's team are gearing up right now. We will make sure that all Supervisors and really everybody in the County know. We're going to be getting questions on this from everybody. We want to be sure everybody's aware of where they have to go and what they have to do to apply for this program. Mr. Richardson thanked Mr. Bulger.

Ms. Gaston thanked Supervisor Richardson for that question. She does want to say that these resolutions are actually to allow Commissioner Potter and the County team to move forward in setting everything up so that once

the State gets the portal out, we can act immediately. She thanked Commissioner Potter for making sure that we're ready to go. She didn't think any of us enjoy waiting on the State any longer than we have to but she does appreciate that we're taking some steps ahead of time so that some of it they're ready.

On a motion by Mr. Richardson, seconded by Ms. Gaston Resolution #131 was adopted by a unanimous vote.

Mr. Kusnierz just wanted to point out before we vote on this, Saratoga County, under the leadership of our Planning Department, and some Supervisors in this room are setting the standard with this resolution, which is going to be adopted by other counties across the state. So once again, Saratoga County is leading in another category. He thanked the Planning Department and the County Attorney's office for all the good work that has been put into that. He knows Mr. Hartnett did a yeoman's work on that on your behalf. And DEC was also instrumental in making sure this this effort came to fruition. This has been a long time coming. He knows that when He worked in the Legislature, this was something that was a priority for many communities across the State

that just never came to fruition. And, as a matter of fact, New York State is the last state to take this up and adopted which, you know, we're dead last in that category. Anyway, Saratoga County is leading the effort on this. This will be the standard, as he indicated, other counties are going to adopt for resolution.

INTRODUCING A PROPOSED LOCAL LAW IDENTIFIED AS INTRODUCTORY NO. 3, PRINT NO. 1 OF 2021, ADOPTING A PILOT YOUTH DEER HUNTING PROGRAM, AND SETTING A DATE FOR A PUBLIC HEARING THEREON

WHEREAS, Environmental Conservation Law §11-0935, establishes a pilot program wherein a hunting license holder who is 12 or 13 years of age may hunt deer with a crossbow, rifle, shotgun or muzzle loading firearm in areas where and during the hunting season in which such implements may be used; and

WHEREAS, Environmental Conservation Law §11-0935 requires that in order to be an "eligible area", a county must pass a local law authorizing participation in the pilot program; and

WHEREAS, according to a 2011 U.S. Fish and Wildlife Service study, the community spends approximately \$4.95 billion per year in the State of New York in pursuit of sporting activities, and sporting activities are responsible for the support of approximately 56,000 jobs across New York State; and

WHEREAS, sporting activities have a positive impact on the local and statewide economy; and

WHEREAS, public interest and participation in sporting activities, including deer hunting, has significantly increased, including the number of individuals completing hunter education programs and purchasing hunting and other sporting licenses; and

WHEREAS, the universal hunting age of 12 is supported by the 2012 - 2016 NYS Deer Management Plan and the draft 2021 - 2025 NYS Deer Management Plan; and

WHEREAS, prior to the adoption of Environmental Conservation Law §11-0935, 49 out of 50 States with New York being the exception, permitted 12 and 13 year olds to participate in hunting under varying circumstances; and

WHEREAS, hunting with youth provides quality time for parents, guardians and other mentor figures to bond with their children, other family members and friends in an outdoor setting and presents an excellent opportunity to introduce youth to nature, stewardship, conservation, and responsible wildlife management; and

WHEREAS, hunting with youth provides an opportunity to mentor and instruct youth hunters regarding safe and responsible hunting; and

WHEREAS, this Board supports Saratoga County opting-in to the provisions of Environmental Conservation Law §11-0935; now, therefore, be it

RESOLVED, that a proposed Local Law, identified as Introductory No. 3 of 2021, Print No. 1 of 2021, entitled "A LOCAL LAW ADOPTING A PILOT YOUTH DEER HUNTING PROGRAM", is hereby introduced before the Saratoga County Board of Supervisors, and the Board of Supervisors shall hold a Public Hearing on May 18, 2021 at 3:30 p.m. in the Meeting Room of the Saratoga County Board of Supervisors at 40 McMaster Street, Ballston Spa, New York 12020, on the matter of the adoption of such proposed Local Law, and the Clerk of this Board of Supervisors be and she hereby is directed to give notice of such Public Hearing in the manner prescribed by law.

COUNTY OF SARATOGA LOCAL LAW NO. [_] OF 2021 BE IT ENACTED by the Saratoga County Board of Supervisors as follows:

SECTION 1. Title

This Local Law shall be known as "A Local Law Adopting a Pilot Youth Deer Hunting Program."

SECTION 2. Purpose

Consistent with the provisions of Environmental Conservation Law section 11-0935, this Local Law is adopted to authorize the expansion of youth hunting and allow licensed hunters ages 12 or 13 to hunt deer with a crossbow, rifle, shotgun or muzzle-loading firearm when accompanied by a parent, legal guardian, or mentor.

SECTION 3. Authority

This Local Law is adopted under the authority granted by:

- 1. Article IX of the New York State Constitution, § 2[c];
- 2. New York Municipal Home Rule Law, § 10; and
- 3. New York Environmental Conservation Law § 11-0935.

SECTION 4. Definitions

- 1. "Eligible area" means any county within the State of New York that has enacted a local law authorizing participation in a youth hunting pilot program, and has notified the New York State Department of Environmental Conservation of such participation.
- 2. "Hunting license holder" means a person who has successfully completed a hunter education/safety course, and currently holds a valid hunting license issued by the New York State Department of Environmental Conservation.
- 3. "Legal guardian" means a person legally responsible for a minor participating in the Pilot Youth Deer Hunting Program who currently holds a valid hunting license issued by the New York State Department of Environmental Conservation and has at least three years of prior experience hunting deer as a hunting license holder.
- 4. "Mentor" means a person who (a) currently holds a valid hunting license issued by the New York State Department of Environmental Conservation, (b) is twenty-one years of age or older, (c) has at least three years of prior experience hunting deer as a hunting license holder, and (d) has been designated in writing by a minor's parent or legal guardian on a form prescribed by the New York State Department of Environmental Conservation to serve as a mentor to said minor for purposes of the Pilot Youth Deer Hunting Program.
- 5. "Minor" means a youth twelve or thirteen years of age who currently holds a valid hunting license issued by the New York State Department of Environmental Conservation to hunt deer with a crossbow, rifle, shotgun, or muzzle-loading firearm within an eligible area.
- 6. "Parent" means a person who currently holds a valid hunting license issued by the New York State Department of Environmental Conservation, has at least three years of prior experience hunting deer as a hunting license holder, and is the parent of the minor participating in the Pilot Youth Deer Hunting Program.
- 7. "Physical control" means that the physical proximity of a minor to a parent, legal guardian or mentor and is such that the parent, legal guardian or mentor is (a) reasonably able to issue verbal directions and instructions, (b) maintain constant visual contact, and (c) otherwise able to provide guidance and supervision to the minor.

SECTION 5. Opt-In Authorization

The youth hunting opportunities authorized by Environmental Conservation Law section 11-0935 shall be applicable within the boundaries of the County of Saratoga upon (a) the adoption of this Local Law by the Board of Supervisors for the County of Saratoga, State of New York, and (b) notice provided to the New York State Department of Environmental Conservation of the adoption of this Local Law.

Saratoga County hereby elects to participate in a Pilot Youth Deer Hunting Program to allow minors ages 12 or 13 to hunt deer with a crossbow, rifle, shotgun or muzzle-loading firearm when accompanied by a parent, legal guardian or mentor.

SECTION 6. Eligibility and Requirements.

- 1. A minor aged 12 or 13 may hunt deer with a crossbow, rifle, shotgun, or muzzle-loading firearm within the County of Saratoga when accompanied by, and is under the physical control of, a parent, legal guardian or mentor as those terms are defined by Section 4 of this Local Law.
- 2. A minor participating in the Pilot Youth Deer Hunting Program in an eligible area must be in possession of a valid New York State hunting license and valid tags, as appropriate, while afield at all times. The accompanying parent, legal guardian or mentor must also be in possession of a valid New York State hunting license at all times when supervising a minor participating in the Pilot Youth Deer Hunting Program.
- 3. A minor and the accompanying parent, legal guardian or mentor must display either a minimum total of two hundred fifty square inches of solid fluorescent orange or pink or patterned fluorescent orange or pink consisting of no less than fifty percent fluorescent orange or pink material worn above the waist and visible from all directions, or a hat or cap with no less than fifty percent of the exterior consisting of solid fluorescent orange or pink material and visible from all directions.
- 4. A minor aged 12 or 13 participating in the Pilot Youth Deer Hunting Program must remain at ground level at all times when hunting deer with a crossbow, rifle, shotgun, or muzzle-loading firearm.
- 5. A minor participating in the Pilot Youth Deer Hunting Program must remain within the physical proximity of a parent, legal guardian or mentor which means they must be capable of receiving verbal directions and instructions, and be in constant visual contact with the supervising parent, legal guardian or mentor at all times.
- 6. A minor participating in the Pilot Youth Deer Hunting Program must abide by all other federal, state and local laws, rules and regulations applicable to hunting including, but not limited to, manner of take, bag limits, hunting hours, geographical or general implement restrictions, hunting seasons, tagging, transporting and reporting requirements.

SECTION 8. Filing

In accordance with ECL § 11-0935.2, a copy of this Local Law shall be filed with the New York State Department of Environmental Conservation. And in accordance with Municipal Home Rule § 27, a copy shall be filed with the New York State Department of State.

SECTION 9. Severability

Should any provision of this Local Law be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of this Local Law as a whole or any part thereof other than the part so determined to be unconstitutional or invalid.

SECTION 10. Repeal

All Ordinances, Local Laws and parts thereof inconsistent with this Local Law are hereby repealed.

SECTION 11. Effective Date

This Local Law shall be effective upon its filing with the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

Ms. Gaston said she would like to say that this morning Supervisor Raymond, Supervisor Winney, and myself along with County staff, my intern Lily Rosen, launched the Saratoga County Women in Government Program. And we have a lot of good reception from it. Our state elected were there and some made remarks. Lieutenant Governor Kathy Hogan was in support of it. And the goal is to encourage more women to be engaged in local government. And to be aware of it, we've had an excellent reception as well from our department heads and other county staff who are interested in getting involved, serving as mentors or otherwise engaging with these high school young women. The way that the program is being set up, applications will come in, they will be stripped

of their personal information so that no names or anything are shared and they will go to the Supervisor that oversees where their residence is. And we understand they were are villages and towns we're working on that but everybody will have some applications that each Supervisor will pick who they believe to be the participants for their municipality. And that way, we have a distribution throughout the county and they will participate in a program that's being developed with the Soroptimist International of the county about leadership, governance and our department heads and staff will be engaged with it to apply those lessons to local government. So she appreciate all the support of her colleagues especially appreciate Supervisors Winney and Raymond, who were willing to come up and give some remarks this morning as well. The video is on the Facebook page. And we have a lot of interests. And she thinks this will be an excellent opportunity to continue to show that we're ahead of the game. And in that vein the New York State Association of Counties is supporting them with the potential as a pilot to be shared with other counties around the work state. No other county for analysis has this sort of program that focuses on bringing in young women in local government and engaging and educating them in connection with it. She thanked the members of the Board and hope they check out the video. Applications will be live on Monday. In connection with that, she wanted to bring up a proposed resolution this needs to be read in full, correct. But first she needs to move it to have it added to the agenda. Then she will read it in full. This just a resolution in recognition of Soroptimist International the 100th anniversary, they are a partner of this program. And unfortunately, she missed the law and finance deadline to submit a resolution. So she is bringing it from the floor here. She moved that. Seconded by Supervisor Veitch.

Mr. Kusnierz commended Supervisor Gaston for her leadership in bringing this pilot program forward and the efforts of Supervisors Winney and Raymond and the department heads that were actively involved. He knows it took a lot of work to put this together and it is an important program.

Mr. Schopf apologized for not being able to make the morning announcement as he was at a previously committed press event for Donate Life. He thanked all involved with this program. He thinks the opportunity to get young people involved in local government and seeing what goes on here is huge.

WHEREAS, on April 8, 2021, the Saratoga County Board of Supervisors was served with the Notice of Claim of Spencer Hellwig, dated April 6, 2021, said Notice of Claim naming the County of Saratoga, New York, Saratoga County Board of Supervisors, Phil Barrett, Eric Connolly, Tara Gaston, Theodore "Todd" Kusnierz, John Lant, Darren O'Connor, Jonathan G. Schopf, Kevin Tollisen, and Matthew Veitch as Respondents; and

WHEREAS, pursuant to Local Law 4-1984, this Board adopted and conferred the benefits of Public Officers Law §18 upon the employees of Saratoga County, including any commissioner, member of a public board or commission, officer or any other person holding position by election, appointment or employment in the service of Saratoga County; and

WHEREAS, Local Law 4-1984 provides that Saratoga County shall provide for the defense of the employee in any civil action or proceeding, state or federal, arising out of any alleged act or omission which occurred or allegedly occurred while the employee was acting within the scope of their public employment or duties; and

WHEREAS, pursuant to Local Law 4-1984, an employee shall be entitled to private counsel of his or her choice in any civil action or proceeding whenever the County Attorney determines that a conflict of interest exists and that the employee is entitled to counsel of their own choosing, and reasonable attorney's fees and litigation expenses shall be paid by Saratoga County to such private counsel from time to time during the pendency of the civil action or proceeding with the approval of the Saratoga County Board of Supervisors; and

WHEREAS, the County Attorney has determined that relative to the aforementioned Notice of Claim, a conflict of interest exits as it relates to the County Board of Supervisors and Supervisors Barrett, Connolly, Gaston, Kusnierz, Lant, O'Connor, Schopf, Tollisen and Veitch, who were captioned individually by name; and, now, therefore, be it

RESOLVED, that Saratoga County will provide for the defense and indemnification of Supervisors Barrett, Connolly, Gaston, Kusnierz, Lant, O'Connor, Schopf, Tollisen and Veitch as provided in Local Law 4-1984; and be it further

RESOLVED, that Supervisors Barrett, Connolly, Gaston, Kusnierz, Lant, O'Connor, Schopf, Tollisen and Veitch, are authorized to retain private counsel of their own choosing as it relates to the aforementioned civil action and any subsequently filed civil action related to and based upon the same alleged facts and circumstances as the foregoing Notice of Claim entitled "Spencer Hellwig v. Saratoga County, et al.", dated April 6, 2021; and be it further

RESOLVED, that reasonable attorney's fees and litigation expenses shall be paid by Saratoga County to such retained private counsel from time to time during the pendency of the civil action or proceeding with the approval of this Board, and for purposes of this resolution the term "reasonable attorney's fees" shall mean current prevailing industry standards, not to exceed an amount of \$300 per hour; and it is further

RESOLVED, that any Supervisor requesting application of the above indemnification must comply with the "Notification" requirements of Local Law 4-1984, codified as County Code §24-5, requiring written notice requesting defense be provided to the County Attorney or Chair of the Board of Supervisors as well as providing a copy of any summons, complaint, process, notice, demand or pleading within 10 days after being served.
