REPORTS OF COMMITTEE

Mr. Wright reported that the four towns of Hadley, Corinth, Day and Edinburg has used part of the grant funding from the Economic Development Committee grant program on a commission report written by Behan Communications, through the Saratoga County Prosperity Partnership. A copy of this report entitled "Building Communities Attracting Residents To Saratoga's Adirondacks" has been placed in each of the Supervisors mail boxes. Mr. Wright thanked the Prosperity Partnership for their assistance with the report.

Mr. Zlotnick reported that the Racing and Gaming Committee met earlier this month with a representative from NYRA to discuss attendance requirements and limits at the Track. A letter to the Governor has been drafted with the assistance of the County Attorney. Mr. Zlotnick requested that it be mailed to the Governor. Mr. Kusnierz agreed to signing the letter without objection from the body.

Ms. Gaston said that she had requested Commissioner Kuhles to give a rundown of the Governor's new guidance regarding masks, etc. However since the guidance has been spoken and not written that this point, Ms. Gaston believes it is inappropriate to comment further. Ms. Gaston thanked the Public Health Department and the County School Districts for their prior planning of POD's, especially for the aged 12-15 group. Planning was done prior to both federal and state approval.

Mr. Kusnierz pointed out that this afternoon there are a significant number of resolutions for consideration. He would like to, without objection, waive the reading of the resolved paragraphs and have the Clerk and Deputy Clerk read the titles of the resolutions and the budget impact statements.

AMENDING RESOLUTION 112-2021 TO REFLECT CORRECT ITEMIZED PREMIUM AMOUNTS FOR THE COUNTY'S INSURANCE COVERAGES AND TO AUTHORIZE AN ADDITIONAL INSURANCE PREMIUM OF \$45,216 FOR CYBER LIABILITY INSURANCE COVERAGE

WHEREAS, pursuant to Resolution 112-2021, this Board authorized the award of the County's insurance coverages for the policy period May 8, 2021 through May 8, 2022; and

WHEREAS, the total amount of insurance premiums reflected in Resolution 112-2021 was correctly listed, however the itemized premium amounts need to be corrected to facilitate payment thereof; and

WHEREAS, our insurance agent, Arthur J. Gallagher & Co., formerly Cool Insuring Agency, Inc. ("Gallagher") has procured Cyber Liability coverage through The North River Insurance Company under Crum & Forster Insurance ("North River") effective May 8, 2021 through May 8, 2022, which policy includes a limit of \$1M in coverage and \$100,000 deductible for an additional premium of \$45,216; and

WHEREAS, it is necessary to amend Resolution 112-2021 to add Cyber Liability coverage and to authorize payment to North River for the additional premium of \$45,216; now, therefore, be it

RESOLVED, that Resolution 112-2021 is hereby amended to correct the itemized premium amounts and add Cyber Liability coverage to the County's 2021 insurance coverages for the additional premium of \$45,216, making the total for all 2021 insurance premiums \$963,609; and, be it further

WHEREAS, our Human Resources and Insurance Committee, the Director of Human Resources and the Director of the Youth Bureau have recommended that Rebecca Robarge be provided a stipend in the amount of \$1,500 per month from June 1, 2021 through December 31, 2021 to compensate her for the additional duties that she will be performing; now, therefore, be it

AUTHORIZING CONTACT TRACING SERVICES AGREEMENTS WITH KYLE ABDELLATIF, KAYLA ASCHMUTAT AND SUZANNE KWASNIEWSKI

WHEREAS, pursuant to Resolution 111-2020, as amended by Resolution 281-2020, this Board authorized the County Administrator to execute up to Seventy Five (75) minor contracts with individuals identified by Saratoga County Public Health Services as willing to serve and complete the required training to work as contact tracers on an as needed basis, at a rate of compensation of \$25.00 per hour; and

WHEREAS, the County entered into existing minor contracts with Kyle Abdellatif dated January 7, 2021, Kayla Aschmutat dated January 5, 2021 and Suzanne Kwasniewski dated December 21, 2020 for contact tracer services to rapidly interview positive COVID-19 patients; identify their close contacts; interview and alert those contacts to the risk of infection; instruct the contacts to quarantine or isolate for 14 days and monitor those in quarantine or isolation to ensure their compliance and to ascertain if they are showing any symptoms of COVID-19; and

WHEREAS, as there continues to be cases of COVID-19, it is imperative to maintain the services of quality contractors to perform essential contact tracing services; and

WHEREAS, the cost of services performed by Kyle, Kayla and Suzanne have met or exceeded their minor contract limits of \$15,000; and

WHEREAS, our Health and Human Services Committee and Commissioner of Health have recommended that the County enter into new one year agreements with the following contact tracers, effective at the signing of said contracts: 1) Kyle Abdellatif, at a rate of \$25.00 per hour, for a maximum of 35 hours per week, with the total contract amount not to exceed the sum of \$45,500; 2) Kayla Aschmutat, at a rate of \$25.00 per hour, for a maximum of 30 hours per week, with the total contract amount not to exceed the sum of \$39,000; and 3) Suzanne Kwasniewski at a rate of \$25.00 per hours, for a maximum of 30 hours per week, with the total contract amount not to exceed the sum of \$39,000; and

WHEREAS, pursuant to Resolution 201-2020, this Board accepted a New York State Department of Health grant administered by Health Research, Inc. that includes \$478,215 for temporary and contracted employees that are hired exclusively for COVID-19 response activities, which grant funds will be used to cover the cost of these three contact tracing agreements; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute one year agreements with the following contact tracers, effective at the signing of said contracts: 1) Kyle Abdellatif, at a rate of \$25.00 per hour, for a maximum of 35 hours per week, with the total contract amount not to exceed the sum of \$45,500; 2) Kayla Aschmutat, at a rate of \$25.00 per hour, for a maximum of 30 hours per week, with the total contract amount not to exceed the sum of \$39,000; and 3) Suzanne Kwasniewski at a rate of \$25.00 per hours, for a maximum of 30 hours per week, with the total contract amount not to exceed the sum of \$39,000; and, be it further

WHEREAS, the appraised value of the development rights for Smassanow Farm are lower than expected creating a cost savings recognized by vendors and resulting in the actual total project costs of \$152,994; and

WHEREAS, due to the actual total cost of the project being lower than the original 2019 grant award, the required 50% match and grant award is reduced to \$76,497; and

WHEREAS, the actual grant award is greater than the maximum permitted 10% adjustment and therefore requires authorization to amend Resolution 258-2019; now, therefore, be it

A LOCAL LAW AUTHORIZING THE SALE OF REAL PROPERTY OF THE COUNTY OF SARATOGA TO SYNERGY PARK, LLC

BE IT ENACTED by the Saratoga County Board of Supervisors as follows:

SECTION 1. TITLE

This Local Law shall be known as "A Local Law Authorizing the Sale of Real Property of the County of Saratoga to Synergy Park, LLC".

SECTION 2. LEGISLATIVE FINDINGS AND INTENT

- a. The County of Saratoga is the owner of real property located in the Town of Halfmoon which is known as the "Robert's Lane Bridge" which consists of a 30 foot clear-span aluminum arch bridge over the Dwaas Kill, and is also known as the "County Bridge 2202580-260" located on the former Town of Halfmoon roadway "Robert's Lane;"
- b. Pursuant to Highway Law §231, County ownership of Robert's Lane Bridge was formalized by Saratoga County Board of Supervisors Resolution 76-1999.
- c. Robert's Lane Bridge is situated on privately owned property and is entirely encompassed by property owned by Synergy Park, LLC.
- d. The Town of Halfmoon abandoned Robert's Lane by resolution in 2020.
- e. Synergy Park, LLC desires to purchase Robert's Lane Bridge which consists of a 30 foot clear-span aluminum arch bridge over the Dwaas Kill, and is also known as the "County Bridge 2202580-260" located on the former Town of Halfmoon roadway "Robert's Lane."
- f. The Commissioner of Public Works has determined that the Robert's Lane Bridge is no longer needed for any public use and does not serve any public interest.

- g. The Saratoga County Board of Supervisors hereby finds and determines that said Robert's Lane Bridge, which is more fully described in Section 3 below, is no longer needed for the County's public use.
- h. The Commissioner of Public Works has determined the fair market value of the Bridge to be of negative value (\$0.00) based on an assessment of liabilities and access restrictions.
- i. The Saratoga County Board of Supervisors hereby finds and determines that the agreed upon sale value of \$1000.00 is fair and adequate consideration for the sale and conveyance of the Robert's Lane Bridge.

SECTION 3. LEGAL DESCRIPTION OF PARCEL TO BE CONVEYED

The property to be conveyed by the County of Saratoga to Synergy Park, LLC is more particularly described as follows:

All that property situate in the Town of Halfmoon, Saratoga County, NY, described as follows:

"Robert's Lane Bridge which consists of a 30 foot clear-span aluminum arch bridge over the Dwaas Kill, and is also known as the "County Bridge 2202580-260" located on the former Town of Halfmoon roadway "Robert's Lane" located on property owned by Synergy Park, LLC depicted by Saratoga County tax map parcel #260.-1-49"

SECTION 4. AUTHORIZATION TO SELL AND CONVEY COUNTY REAL PROPERTY TO SYNERGY PARK, LLC

Notwithstanding the provisions of Section two hundred fifteen of the County Law, or any other law of the State of New York, the Saratoga County Board of Supervisors hereby authorizes the sale of the property of the County of Saratoga described in Section 3 of this Local Law to Synergy Park, LLC for the sum of \$1,000, and further hereby authorizes the Chairman of the Saratoga County Board of Supervisors to execute a contract, deed and any other required documents needed to convey a fee interest in said property to Synergy Park, LLC. Said contract, deed and related documents are to be subject to the approval of the County Attorney.

SECTION 5. PERMISSIVE REFERENDUM

This Local Law is subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law.

SECTION 6. SEVERABILITY

If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, or business shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this law, or in its specific application.

SECTION 7. EFFECTIVE DATE

This Local Law shall take effect after it is filed as provided in Section 27 of the Municipal Home Rule Law.

WHEREAS, it is necessary to amend the 2021 Saratoga County Budget to effect a transfer of \$700,000 from Fund Balance to Saratoga County Public Health Services in order to allow Public Health Services to hire additional temporary staffing, procure needed supplies and equipment, help to meet the needs of those individuals in the community subject to mandatory or precautionary quarantine, offset inmate displacement costs, and to promote and effectuate vaccine distribution; now, therefore be it

COUNTY OF SARATOGA LOCAL LAW NO. [3] OF 2021

A LOCAL LAW ADOPTING A PILOT YOUTH DEER HUNTING PROGRAM

BE IT ENACTED by the Saratoga County Board of Supervisors as follows:

SECTION 1. Title

This Local Law shall be known as "A Local Law Adopting a Pilot Youth Deer Hunting Program."

SECTION 2. Purpose

Consistent with the provisions of Environmental Conservation Law section 11-0935, this Local Law is adopted to authorize the expansion of youth hunting and allow licensed hunters ages 12 or 13 to hunt deer with a crossbow, rifle, shotgun or muzzle-loading firearm when accompanied by a parent, legal guardian, or mentor.

SECTION 3. Authority

This Local Law is adopted under the authority granted by:

- 1. Article IX of the New York State Constitution, § 2[c];
- 2. New York Municipal Home Rule Law, § 10; and
- 3. New York Environmental Conservation Law § 11-0935.

SECTION 4. Definitions

- 1. "Eligible area" means any county within the State of New York that has enacted a local law authorizing participation in a youth hunting pilot program, and has notified the New York State Department of Environmental Conservation of such participation.
- 2. "Hunting license holder" means a person who has successfully completed a hunter education/safety course, and currently holds a valid hunting license issued by the New York State Department of Environmental Conservation.
- 3. "Legal guardian" means a person legally responsible for a minor participating in the Pilot Youth Deer Hunting Program who currently holds a valid hunting license issued by the New York State Department of Environmental Conservation and has at least three years of prior experience hunting deer as a hunting license holder.
- 4. "Mentor" means a person who (a) currently holds a valid hunting license issued by the New York State Department of Environmental Conservation, (b) is twenty-one years of age or older, (c) has at least three years of prior experience hunting deer as a hunting license holder, and (d) has been designated in writing by a minor's parent or legal guardian on a form prescribed by the New York State Department of Environmental Conservation to serve as a mentor to said minor for purposes of the Pilot Youth Deer Hunting Program.
- 5. "Minor" means a youth twelve or thirteen years of age who currently holds a valid hunting license issued by the New York State Department of Environmental Conservation to hunt deer with a crossbow, rifle, shotgun, or muzzle-loading firearm within an eligible area.
- 6. "Parent" means a person who currently holds a valid hunting license issued by the New York State Department of Environmental Conservation, has at least three years of prior experience hunting deer as a hunting license holder, and is the parent of the minor participating in the Pilot Youth Deer Hunting Program.
- 7. "Physical control" means that the physical proximity of a minor to a parent, legal guardian or mentor and is such that the parent, legal guardian or mentor is (a) reasonably able to issue verbal directions and instructions, (b) maintain constant visual contact, and (c) otherwise able to provide guidance and supervision to the minor.

SECTION 5. Opt-In Authorization

The youth hunting opportunities authorized by Environmental Conservation Law section 11-0935 shall be applicable within the boundaries of the County of Saratoga upon (a) the adoption of this Local Law by the Board of Supervisors for the County of Saratoga, State of New York, and (b) notice provided to the New York State Department of Environmental Conservation of the adoption of this Local Law.

Saratoga County hereby elects to participate in a Pilot Youth Deer Hunting Program to allow minors ages 12 or 13 to hunt deer with a crossbow, rifle, shotgun or muzzle-loading firearm when accompanied by a parent, legal guardian or mentor.

SECTION 6. Eligibility and Requirements.

- 1. A minor aged 12 or 13 may hunt deer with a crossbow, rifle, shotgun, or muzzle-loading firearm within the County of Saratoga when accompanied by, and is under the physical control of, a parent, legal guardian or mentor as those terms are defined by Section 4 of this Local Law.
- 2. A minor participating in the Pilot Youth Deer Hunting Program in an eligible area must be in possession of a valid New York State hunting license and valid tags, as appropriate, while afield at all times. The accompanying parent, legal guardian or mentor must also be in possession of a valid New York State hunting license at all times when supervising a minor participating in the Pilot Youth Deer Hunting Program.
- 3. A minor and the accompanying parent, legal guardian or mentor must display either a minimum total of two hundred fifty square inches of solid fluorescent orange or pink or patterned fluorescent orange or pink consisting of no less than fifty percent fluorescent orange or pink material worn above the waist and visible from all directions, or a hat or cap with no less than fifty percent of the exterior consisting of solid fluorescent orange or pink material and visible from all directions.
- 4. A minor aged 12 or 13 participating in the Pilot Youth Deer Hunting Program must remain at ground level at all times when hunting deer with a crossbow, rifle, shotgun, or muzzle-loading firearm.
- 5. A minor participating in the Pilot Youth Deer Hunting Program must remain within the physical proximity of a parent, legal guardian or mentor which means they must be capable of receiving verbal directions and instructions, and be in constant visual contact with the supervising parent, legal guardian or mentor at all times.
- 6. A minor participating in the Pilot Youth Deer Hunting Program must abide by all other federal, state and local laws, rules and regulations applicable to hunting including, but not limited to, manner of take, bag limits, hunting hours, geographical or general implement restrictions, hunting seasons, tagging, transporting and reporting requirements.

SECTION 8. Filing

In accordance with ECL § 11-0935.2, a copy of this Local Law shall be filed with the New York State Department of Environmental Conservation. And in accordance with Municipal Home Rule § 27, a copy shall be filed with the New York State Department of State.

SECTION 9. Severability

Should any provision of this Local Law be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of this Local Law as a whole or any part thereof other than the part so determined to be unconstitutional or invalid.

SECTION 10. Repeal

All Ordinances, Local Laws and parts thereof inconsistent with this Local Law are hereby repealed.

SECTION 11. Effective Date

This Local Law shall be effective upon its filing with the New York State Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

WHEREAS, it is appropriate to amend the existing agreement with Tyler Technologies, Inc. to allow for the installation of the new SQL servers, and for related services, at a cost not to exceed \$5,000; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute an amendment to the agreement with Tyler Technologies, Inc. of Troy, Michigan, for the installation of new SQL Servers, and for related services, at an additional cost not to exceed \$5,000; and, be it further

RESOLVED, that the form and content of such amendment shall be subject to the approval of the County Attorney.

WHEREAS, pursuant to Resolution 135-2017, this Board authorized the Chairman to execute a cooperative agreement with the County of Albany, on behalf of the Albany County Water Purification District, to retain the services of a qualified professional engineering firm to perform a feasibility study for the construction of a regional biosolids digester facility that would dispose of biosolids from both the Albany County Water Purification District ("ACWPD") and Saratoga County Sewer District No. 1 ("SCSD1"), and to share the costs of such regional study in the following percentages: NYSERDA-50%, ACWPD-25% and SCSD1-25%, which feasibility study was performed by Arcadis; and

WHEREAS, Resolution 98-2018 authorized the execution of an intermunicipal cooperative agreement pursuant to General Municipal Law §11 between the County of Albany, on behalf of the Albany County Water Purification District, and the County of Saratoga, providing for the joint construction, financing, operation and governance of the regional biosolids handling facility; and

WHEREAS, pursuant to Resolution 79-2019, the County of Saratoga and the County of Albany entered into an agreement with Arcadis of New York, Inc. ("Arcadis") to provide design, construction administration and construction inspection services relative to the construction of a regional biosolids digester facility, at a cost not to exceed \$5,806,200 to be paid by each County in equal shares not to exceed \$2,903,100; and

WHEREAS, subsequent to the execution of the intermunicipal cooperative agreement with ACWPD, the County of Albany submitted a letter to the County evidencing intent to withdraw from the Intermunicipal Agreement; and

WHEREAS, SCSD1 has received a letter of proposal from Arcadis to commence the conceptual engineering and economic analysis of several viable alternatives to handle and reduce sludge volumes at the Saratoga County Wastewater Treatment Plant which proposal involves reassigning tasks within the agreement with no additional cost; and

WHEREAS, the Law & Finance Committee, the Saratoga County Sewer District No. 1 Sewer Commission, and the Executive Director of Saratoga County Sewer District No. 1 have recommended that the proposal of Arcadis to amend their agreement with the County to study options for the construction of a biosolids digester facility at the Saratoga County Wastewater Treatment Plant be accepted; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute an amendment to the agreement with Arcadis of New York, Inc. of Clifton Park, New York, for the provision of services to study options to construct a biosolids facility at the Saratoga County Wastewater Treatment Plant, which amendment shall not include any additional cost; and

RESOLVED, that the form and content of such amendment shall be subject to the approval of the County Attorney.

WHEREAS, in September 2015, Couch White, LLP commenced litigation in the Supreme Court of the State of New York, County of Saratoga, under Index No. 2015-2969, on behalf of the County and the Sewer District against certain defendants involved in the design and construction of the Treatment Plant expansion, including, but not limited to, Delaware Engineering, D.P.C., North Country Engineering, P.C., and David M. Klein, P.E.; and

WHEREAS, defendant David M. Klein, P.E. died a resident of the State of Florida during the pendency of this lawsuit, and the attorneys representing the Estate of David M. Klein, P.E. have requested the Estate be included in any settlement; and

WHEREAS, following extensive negotiations between the attorneys for the County Couch White, LLP, Delaware Engineering, D.P.C., North Country Engineering, P.C., and the Estate of David M. Klein, P.E., a settlement has been agreed to in principal that requires Delaware Engineering, D.P.C. and North Country, P.C. to jointly pay the County of Saratoga and the Saratoga County Sewer District No. 1 the sum of five hundred thousand (\$500,000.00) U.S. dollars to settle and discontinue the litigation; and

WHEREAS, it is in the best interests of the County to resolve and settle this litigation in the manner proposed by counsel for the County; and

WHEREAS, the Saratoga County Sewer District Commission has recommended that the settlement negotiated by special counsel Couch White, LLP be approved; and

WHEREAS, our Law and Finance Committee and the County Attorney have recommended that the settlement negotiated by special counsel, providing for Delaware Engineering, D.P.C. and North Country Engineering, P.C. to pay \$500,000.00 U.S. dollars to the County and the Sewer District be approved; now, therefore, be it

RESOLVED, that this Board of Supervisors authorizes the settlement of all claims and demands made by the County of Saratoga and Saratoga County Sewer District No. 1 against Delaware Engineering, D.P.C. and North Country Engineering, P.C., the Estate of David M. Klein, P.E. and any other party involved in the action commenced in the Supreme Court of the State of New York, County of Saratoga, under Index No. 2015-2969, for the amount of \$500,000.00 U.S. dollars; and be it further

RESOLVED, that the Chair of the Board, special counsel Couch White, LLP and/or the County Attorney are hereby authorized to execute an appropriate release and any related paperwork needed to settle and conclude the litigation commenced by the County of Saratoga and Saratoga County Sewer District No. 1 against Delaware Engineering, D.P.C., and North Country Engineering, P.C. in the action commenced in the Supreme Court of the State of New York, County of Saratoga, under Index No. 2015-2969.

WHEREAS, more than ninety-five (95) public safety agencies in New York use the Lexipol Policy Content and Knowledge Management System; and

WHEREAS, pursuant to Resolution 88-2021, this Board adopted and implemented the Executive Order 203 Compliance Group January 2021 Report which provided recommendations that the Saratoga County Sheriff take any steps necessary to maintain compliance with the New York State Law Enforcement Accreditation Program and to maintain policies consistent with the model policies as provided by the New York State Municipal Police Training Council; and

WHEREAS, Lexipol, LLC provides policy, accreditation and training development consistent with the New York State Law Enforcement Accreditation Program and in conformance with the New York State Municipal Police Training Council; and

WHEREAS, the Public Safety Committee, and the Sheriff have recommended that a contract be awarded to Lexipol, LLC for specialized software and management services for policy development, accreditation and training development at a total cost of \$38,019; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute an agreement with Lexipol, LLC of Frisco, Texas for specialized software and management services for policy development, accreditation and training development at a cost not to exceed \$38,019; and it is further

RESOLVED, that the form and content of said agreement is subject to the approval of the County Attorney and Saratoga County Sheriff.
