The Saratoga, Warren, Washington Workforce Development Board has been focused on restructuring, reorganizing, modernizing, and on sucession planning. The current structure of the board is not in line with the other 32 WDBs in NYS and in order to remain competitive and effective, investments need to be made. Budget increases for PY21 are reflected in salaries and benefits for the Executive Director and the addition of an administrative staff support. This more accurately represents similar compensation for our regional boards Executive Directors. The meetings and marketing lines have increased in order for the board to obtain additional virtual resources and to update and modernize the boards website. The last increase is in the One Stop Operator line. This is a duty required by the Federal WIOA legislation and years of procurement at the previous rate has yielded no candiates. This rate again, is on target with the allocations of other boards around New York State. The entire Workforce Development Board budget is shared by Saratoga, Warren, and Washington Counties as a portion of our Federal Workforce Innovation and Opportunity Act funding.
