WHEREAS, the Rejha Group, Inc. has therefore requested an amendment changing the 2021-2022 School Year and 2022 Summer session transportation rate from a per child per day rate of \$69.86 to a per bus per day rate of \$390, with the rate of \$95.90 per aide per day to remain unchanged; and

Mr. Zlotnick said that he requested to be reappointed in January since the Town of Milton has over 700 acres of County Property. Mr. Zlotnick said that this spring he also brought forward a letter from residents concerning noise and the airport issue but nothing was done. Mr. Zlotnick said that he was informed today that a video from McFarland Johnson was on YouTube, with an artist's rendering of how grant funds would be spent if awarded. As Supervisor of the Town of Milton he was not notified that this video was created or distributed. He would like to know how the video got out there. Mr. Zlotnick added that regarding the Citizens Committee, as the Supervisor, he fully expects to be on the committee and at any meeting of the committee should it move forward. Mr. Kusnierz said that he will take this under advisement. Mr. Kusnierz said that Committee assignments are Chairman's appointments. They were made based on having what he felt were the best individuals to serve on those committees. Mr. Kusnierz said that all Supervisors have access to agendas prior to the meetings, and they are entitled to participate in those meetings.

Mr. Richardson said that he was in the presence of Superintendent of Schools Bruce Potter last week. Mr. Potter highly commended Dr. Kuhles for all of the information and direction being provided to them weekly. Ms. Gaston said that she sits on the Public Health and Mental Health Committee for NYSAC. At a recent NYSAC conference, representatives from around the State spoke very highly of both Dr. Kuhles and Dr. Prezioso and their respective departments for the work they have done, particularly during the COVID crisis.

Mr. Richardson said that as of yesterday, CDTA Flex Rides is now in Mechanicville. Two CDTA vans will now provide transportation for people not just in the City of Mechanicville, but through Route 146 into Clifton Park and Halfmoon. This will provide a much needed service and Mr. Richardson thanked CDTA CEO Carm Basile and Assemblywoman Carrie Woerner for their help with providing this service.

On a motion by Mr. Richardson, seconded by Mr. Lant the meeting was adjourned by a unanimous vote.
