I live at 617 Sunny Lane and Ballston Spa, I'd like to present a letter I wrote in reference to the Saratoga County Airport, dated today's date September 21 2021. It reads as follows. Dear Chairman Kusnierz, I'm writing to ask for yours and the Board of Supervisors assistance in helping my

fellow Town of Milton residents who live near the Saratoga County Airport. I've had many conversations with the residents in the neighborhoods near and around the airport, who are increasingly concerned with the noise and activity levels that come from the airport. This includes a growing number of helicopter flights, particularly in the evening and nighttime hours, which can be very disruptive to the neighbors and the surrounding areas. A particular concern to many of us are plans being discussed at the County level for possible purchase of additional properties, bordering the Saratoga County Airport, along with the potential upgrades of the existing facilities there, though there are as of yet no specific plans to expand the airport runways. We fear that these plans to increase the buffer zone between the homes and the runways is a prelude to eventual airport expansion, which would be not only pose a threat to dozens of homes surrounding the property, but also an increase in the associated problems of noise and traffic to the community. To that end, I would humbly request that you Chairman appoint a Milton Airport Citizens Advisory Committee that will enable taxpayers and citizens who live in nearby towns to provide the Board of Supervisors with relevant information and feedback to what is occurring at the airport now and in the future. And have an effective voice and input to any changes that are being considered. Such a Citizens Committee would be a welcome step for us here in Milton. As we insist that our concerns are heard, and our viewpoints are taken seriously in any airport decision makings that occur in the future. Sincerely, Scott Ostrander. Thank you for your time.

I think given the fact that we have outstanding Federal funds that we have not yet allocated, and we have not, to the public discussed the financial status lost revenue, I know that we have some, and other items, I don't think it's appropriate to be giving retroactive increases at this time. I would like to see us more fully explain to the public what our lost revenue was, what the costs are and what we're going to do with ARPA funding before we pass something like this. I'm not opposed to the increases by nature, but I don't think that now is the time. So I'll be voting no. Thank you.

I can understand Supervisor Gaston's point, but I think people have waited a significant amount of time. And we do know that the financial condition of the County, and we've been briefed on this, as the

County is in a stable financial condition. And certainly the Federal funds for COVID, which I think are \$45 million. I think that those funds are more than enough, by a magnitude of many, many times to replace any revenue that was lost as a result of COVID, any shortfall in sales tax. And my understanding of the uses of those funds, that is one of the permitted uses is to recover lost revenue as a result of COVID. So I think we are made whole by this. It's not a significant expense to the County, given our financial condition. And people, not just these people, but a lot of people in this country set themselves aside, were willing to sacrifice for a while for the greater good. I commend our people for that. And I think now here we are in late September. And I think it's certainly time to reward people with the cost of living raises. This is this is not a spending power increase. This is simply representing the cost of living as it's gone up. And it's gonna go up a lot more, we all have seen, at least I assume we've all seen reports that inflation is moving quickly in the wrong direction. So I think it's important to keep our employees whole. I think, you know, we're not giving away the store here. We're simply providing people with the means to keep their income consistent with what it's been. So while I appreciate your concerns, Supervisor Gaston, I think we are in a good spot here revenue wise to go ahead and do this. Thank you.

Additionally, there are a lot of nonprofits, a lot of housing, medical expenses, family expenses that have come to the County as well. And I just, again, it's nothing against any of the people on here, I fully support them. I just would have liked to us been able to more broadly explain our financial status, what we're spending our money, etc., before any increases are allocated. So I agree with you. I absolutely want our people made whole, but I know that there are a number of County employees that have still not yet been made whole that aren't going to be solved by this resolution. So I would like to see a more complete process. That's all. It's absolutely no disagreement with the actual item itself. Thank you.

I was seeking the Department requests, budget submissions from each department, just for my own information review. So I'm assuming that they're on digital format. Benny Zlotnick

With respect to the airport issue, I was not reappointed to the Buildings and Grounds committee this year. I remember in January respectfully asking to be reappointed to that committee since the Town of Milton is the single largest municipality in the County that has over 700 acres of County property on it. That request was not fulfilled. I then came back earlier this Spring with a letter from residents asking again, for something to be done about the noise and the airport issue, nothing was done. I was told if I, when an issue was brought up to Buildings & Grounds, I would be at least notified of it. I found out

today that there was a video on YouTube, very briefly by McFarland Johnson, with artist's rendering of how we were going to spend our grant if we were to get it, again, not notified this video was even done. I'm getting calls from residents. I think, as I stated, as a Supervisor in the Town of Milton that has the airport in it, I could have at least been notified that this video was even created or distributed. I was having a phone conversation today with another Supervisor and they have no idea how that video got out there. I would like to find out from someone how that video got out there. And with regards to this Citizens Committee as the Supervisor for the Town of Milton, I fully expect to be on that committee and at any meeting that if this committee goes forward, happens, thank you.

Thank you, Supervisor, I'll take that under advisement. As you're well aware Committee assignments are Chairman's appointment. I made them based on having what I feel are the best individuals to serve on those committees. However, any Supervisor has access to the agenda prior to the meetings, and they're certainly entitled to participate in those meetings. So while you may not have gotten an individual invitation, you're sure you're welcome to attend those meetings. Any other business? I'm sorry, Supervisor Gaston.

My only comment is I would like to second what Supervisor Peck said and I would also appreciate, I have been part of one budget meeting that my Technology and Resiliency Committee oversees, but I was also not provided with any requests until the meeting in hardcopy. So, as a Supervisor, I would appreciate having those requests. I think it lends to better discussions when we're not trying to flip through and ask questions off the cuff. It certainly does for me. So I'd just like to second that request. And perhaps if it's available, all Supervisors could have access to it, I think, for anyone who wants to look at it, and if you don't, thank you.

I have two quick items. One, I was in the presence of Superintendent of Schools, Bruce Potter last week. He could not say enough good things about our Doctor Kuhles. From what he's telling me, our Superintendents in Saratoga County are getting a tremendous amount of information and a tremendous amount of direction. And they're very, very happy about the meetings that he holds with them each Friday morning. He also mentioned that he knows Superintendents from counties that surround us. And they aren't getting nearly what Dr. Kuhles is giving to our Superintendents here in Saratoga County. So I just wanted to commend Dr. Kuhles and all the great work that he's doing. The next thing I'd like to mention is in Mechanicville. You may have seen it on Spectrum news this week. As of yesterday, Mechanicville has Flex Rides. I've been working with the Capital District Transportation Authority, their CEO Carm Bazile for several years now along with Assemblywoman Carrie Woerner. And we've brought, CDTA has brought two vans to Mechanicville, brand new vans that are driven by CDTA drivers. And they're there to transport people not just in the City of Mechanicsville, but out through Route 146 out into Clifton Park and Halfmoon. And so this bus service is something that's much needed for the City of Mechanicville and residents and I think it's going to be a great service bringing

people back and forth to Halfmoon and Clifton Park. It will go from Route 146 all the way out just short of Schenendehowa High School. And so, people will be able to go out to work, or out to shop, or out to a doctor's office or dentist's office, all of the facilities that are in Clifton Park, all of the urgent cares that are out there. And so, it just started yesterday. And so, Mechanicville is mobile once again, as we were about 40 years ago. So, I just wanted to thank CEO Carm Bazile for his help. And certainly, Assemblywoman Carrie Woerner for helping Mechanicville get our population on the move again. Thank you.

Thank you, Supervisor Richardson for bringing that up. I did want to say I was at the New York State Association of Counties conference last week. I sit on the Public Health and Mental Health Committee. And much like Supervisor Richardson said, I will say that there were representatives from around the State that spoke very highly of both Dr. Kuhles and Dr. Prezioso and the work that our Public Health and Mental Health Departments have done particularly during the COVID crisis. And so, the work that they're being done as Supervisor Richardson said is definitely being recognized in the County but also throughout the State. So, thank you both of you.
