My only question is it's my understanding from the discussion that took place, that there was supposed to be a time limit of perhaps the first quarter for the report out for interagency transfers, and I just wanted to move to amend it so that the Administrator shall submit a written report to the Law and Finance committee by the end of the first quarter of 2022.

Yes. So that you're absolutely correct, that discussion did take place. And if you read the resolution, it is open ended. And it can take place by that period of time. But I know County Administrator would like to provide his input on that.

Steve Bulger

So we did a little homework after Law and Finance on that. And thank you to the Clerk of the Board there for looking at and finding some information that there are some transfers that do go into April. And since I wasn't, this is my first year. I wasn't aware of that. I think I spoke a little too soon with the March 31 date. So I'd like to. We didn't see anything beyond April, that we were able to..

Jack Lawler

I'm happy to withdraw that and move for May 1st. I just I would like there to be a more precise deadline then the year 2022, especially since that was discussed in there and I think it would May 1 meet the requirements that you've seen historically?

Steve Bulger

I think so. Yes.

Theodore Kusnierz

So for discussion, have you withdrawn your amendment?

Jack Lawler

So I've withdrawn the amendment that says first quarter or amended the amendment? County Attorney help.

Michael Hartnett

Withdrawn your first motion?

Is it your intent that the report is just for the committee or for it to be sent out to the entire board? By that date.

I mean, I think the entire Board should have it. But I think if it's made to the Law and Finance committee, the entire Board would have access to it. That detail, I'm happy to leave whatever is easiest.

They mentioned that they didn't notice anything going past the end of April. But as you probably are aware of there's always something that falls through the cracks. And something may show up a month or two later than that. So I would suggest we continue to leave it as open ended.

Theodore Kusnierz

Any further discussion?

Jack Lawler

Mr. Chairman, I would suggest rather than commit the County Administrator to file an actual hard report that he update this Board. If we know we're going into April to do this, then, at the April board meeting, the Administrator deliver a report. Yes, I can file it. No, I still have these couple of transfers to consider I'm waiting for more information, whatever the case might be. I think it's personally speaking just for myself, obviously, I think I would like to know what's going on. But I don't see any reason to, I mean we're trusting the Administrator with a hell of a lot more information and ability than delivering a report by a specific date. So but I do think and agree with the Supervisors from Saratoga Springs that it shouldn't be just sitting out there open ended. So I would say just commit to the County Administrator to give us a report on the status of closing out those those line items, by the the April Board meeting, just to give a report,

That gives him the flexibility he needs, but also gives a date out there that the Board can feel comfortable that there is going to be a response coming,

Tara Gaston

I would say it was certainly not my intention to force the County Administrator to do something he is not capable of doing. And I don't mean that. Because if your abilities I mean, if something can't be closed out, it can't be closed out. It just says submit a written report. It doesn't say, solve all of our problems. If you can do that, I'm willing to take that by May the first as well. Um, but that was appreciate that Supervisor Lawler. That was certainly my intended a report by that time. And if anything is outstanding, it's outstanding.

Yeah, the only thing I would add to this, and this is quite an interesting discussion. But I mean, the other option we could do is table it and refer it to the Government Review Committee and to come up with something that works. If we have three or four different ideas coming up in a meeting. You know, I don't personally like to do it this way. If we can have something that's a resolution that makes sense. Do it that way instead. I mean, it's kind of a ridiculous thing to do. But hey, we're having a discussion here. So I'm almost thinking maybe we take it under advisement and bring it up next month.

Any other discussion? I would just add that I'm comfortable with the County Administrator verbally committing to getting that information in a timely fashion to our colleagues. I think he's willing to do that. I don't think you need to have it carved in stone. That's my two cents. Any other discussion? So the the vote would be on the motion to amend the resolution.
