SARATOGA COUNTY OFFICE OF EMERGENCY SERVICES REMINDS RESIDENTS TO "LEARN THE SOUNDS OF FIRE SAFETY™" IN RECOGNITION OF FIRE PREVENTION WEEK™

BALLSTON SPA, NY – The Saratoga County Office of Emergency Services (OES) is teaming up with local fire departments and the National Fire Protection Association[®] (NFPA[®])—the official sponsor of Fire Prevention Week for more than 90 years—to promote this year's Fire Prevention Week[™] campaign, "Learn the Sounds of Fire Safety[™]." This year's campaign, October 3-9th, works to educate everyone about simple but important actions they can take to keep themselves and those around them safe.

"What do the sounds mean? Is there a beep or a chirp coming out of your smoke or carbon monoxide alarm? Knowing the difference can save you, your home, and your family," said Lorraine Carli, vice-president of outreach and advocacy at NFPA.

The Saratoga County OES encourages all residents to embrace the 2021 Fire Prevention Week theme.

"It's important to learn the different sounds of smoke and carbon monoxide alarms. When an alarm makes noise—a beeping sound or a chirping sound—you must take action," said Carl Zeilman, Commissioner of Saratoga County OES. "Make sure everyone in the home understands the sounds of the alarms and knows how to respond. To learn the sounds of your specific smoke and carbon monoxide alarms, check the manufacturer's instructions that came in the box or search the brand and model online."

Saratoga County OES shares safety tips to help you "Learn the Sounds of Fire Safety":

- A continuous set of three loud beeps—beep, beep, beep—means smoke or fire. Get out, call 9-1-1, and stay out.
- A single chirp every 30 or 60 seconds means the battery is low and must be changed.
- All smoke alarms must be replaced 10 years from date of manufacture.
- Chirping that continues after the battery has been replaced means the alarm is at the end of its life and the unit must be replaced.
- Make sure your smoke and CO alarms meet the needs of all your family members, including those with sensory or physical disabilities.
- Fire Prevention should be a practiced YEAR ROUND!
