Good afternoon. You have before you a request for a resolution authorizing the Chairman of the Board or the Sheriff to enter into a five year agreement with AXON Enterprise Incorporated for body worn and in car cameras. This will include our Taser and evidence.com equipment services and web hosting the software. First, I want to thank the County Administrator's office, the members of this committee and the County Attorney's office for all their work with us on trying to get together a contract on this. So this is a five year agreement. We're coming to the board now looking for approval to get this started. The funds have been included in the tentative 2022 budget so this would be dependent upon the acceptance of the, or final passage of the budget prior to the meeting. First year cost of the program for 2022 is \$741,911.69 and the five year cost \$3,000,075 500 I'm sorry 3,075,541 and 23 cents.

I just have one question. And I'm not real familiar with what the service offers, but does this include the, all of the required materials being used, stored and kept? And I know that that was a real big issue when we first began to talk about how you keep it and what has to happen to anything.

This includes full cloud based storage for everything. So there's no hardware costs on our end, other than the initial purchase, and some of the equipment

And will you be the one to have access to it if it's required? Or do we have to go through the service to get access to it?

They actually will not have access to our records, we have, only we have access to them, but through their service.

Agreement with LEFTA Systems for access their hosted SHIELD Internal Affairs and Training Software platform. **Rick Castle** So we're, again, we're seeking a resolution authorizing the Chairman of the Board or the Sheriff to enter into a three year agreement with LEFTA systems for use of their SHIELD internal affairs and training system platform. This is a digital platform, as follows along with the plan that came out of the executive order review with the addition of a professional standards unit within the sheriff's office, to track all internal affairs and training records. To be a broken record, I too would like to thank everybody for their support this past year and the new budget process was nice to see. So the contract with the CDM, we had put some repair into the burn

building. There was some issues as far as the increase, we had originally a minor contract that was issued, which usually would have been more than enough but with the increased price of steel, we had our ceiling panels which were \$100 more than they were in a previous and also the prevailing wage went up \$13 an hour. So it brought the contract over like 16, 16,16 one I think it was. We originally, with the old rate, it would have been like under right around 14 but the like I said, the increased hourly rate.
