If not, I do not need nor does the County need at this time the executive session unless anyone else needs one? If not, we'll move to agenda item 15, other business. Seeing no request for other business. We will now entertain and listen to public input. And the first individual that has signed up is Peter Martin of Saratoga Springs and would like to speak on the Saratoga County bike map.

Peter Martin

Thank you. And I'd like to thank and congratulate the entire Board of Supervisors, as well as Commissioner Kemper for today's resolution authorizing the official bike route map for Saratoga County. This is a great start. I've taken many day trips that have included just about every part of the mapped route. And I think it's an excellent map, excellent routes. This is a start for both improving the health and quality of life benefits that we bring to our residents, as well as the potential for tourism dollars. And that's what I'd like to talk about today. I asked that the Board of Supervisors whenever possible add to and improve on these bike routes to increase the potential for cycling tourist spending in our County. New York State has completed the Empire State bike trail through towns and city in Saratoga County, represented by Supervisors Lawler and Tollisen, Richardson, Kinowski, and Wood. This provides great access for bikers and bike tour directors into all of the communities in our county. Many states have annual biking tours with large positive economic impacts for their communities. Colorado has several tours ranging from three days to a week. I've had the pleasure of riding several times on one of these tours, it's called Ride the Rockies. It's currently in its 38th year, it's limited to only 2,500 riders, it's a six day 500 mile road trip. It's estimated to generate \$1/4M in additional revenue per day for the towns and villages that it travels through. The biggest annual bicycle road tour in America is lowa. The RAGBRAI through lowa is in its 47th year and it draws 15,000 cyclists to a seven day 500

mile trip. The economic impact in 2021 was estimated to be \$25 million in direct spending in the cities and towns that that tour runs through. If we continue actions like you took today, this will bring these revenue opportunities to the restaurants, hotels and merchants in our county. I thank you for your action today. Thank you.

Thank you very much for your comments and input Mr. Martin. Next individual is Ed Lindner.

Ed Lindner

Thank you, Supervisor and thank you all for your time. My name is Ed Lindner. I live in Saratoga Springs. I am the advocacy chair for Bikeatoga, which is a local nonprofit that repairs and recycles bikes and gets them back to families in the community. If any Supervisor knows of a family that needs a bike, you can check out our website because we have our holiday kids bike giveaway on December 11. I'm also the spokesman for the Saratoga Safe Cycling Coalition, which is a group of 24 businesses and nonprofits including Saratoga hospital, the regional YMCA, Skidmore College, the Library, 20 other businesses and nonprofits who all support investment in safe bicycling, bicycling infrastructure, because that promotes healthy bodies, and it promotes a healthy economy. One of the advantages of going second is that Peter Martin has already made most of the points that I wanted to make, but I would echo that. You have a real opportunity here. Our county roads are a real resource. I've ridden RAGBRAI in Iowa, have ridden it twice. 15,000 to 20,000 riders, little towns with 500 people with 15,000 riders who are able to buy, you know, every pie, every corncob, everything that every Girl Scout troop, and Boy Scout troop and firehouse has to sell. Those are the kinds of things that we can have here. So I congratulate you and thank you for this beginning. It's an important step, you need to build on it. And I know that there's a commitment as you repave and maintain these roadways to improve the signage, to improve the shoulders, to get the striping out there. Cyclists notice this thing 1000s 1000s and 1000s of cyclists go to Vermont in Western Massachusetts every year to ride on their country roads. I've written those roads, and I've ridden our roads and they should be coming here. So thank you, and good luck. Keep it up.
