Thank you. Agenda Item 13 is unfinished business and new proposals. Hearing no requests. We have executive session listed on there. Unless Counsel deems it's necessary. I don't believe there is a need for it this afternoon? Other business? Supervisor Gaston.

Tara Gaston

Thank you. I would like to make a, just a brief statement regarding this. Um as of midday today, Saratoga County has documented the loss of 248 residents to COVID-19. Some of them are parents, children, business owners, members of our community and some of them who died alone and unremarked upon, there will never be a true and accurate count of the number of non-fatal losses. The businesses that we've seen in all of our Towns, the domestic violence that our Sheriff and the DA have seen, that DSS has seen. The increase in substance use disorders and suicide. The long term physical effects have COVID and the impact of extended isolation, virtual school, economic insecurity. And I think we can all add to the list of the problems that we've seen over the past two years. There could also never be a true and accurate accounting of the time, money, blood, sweat and tears poured into responding to the pandemic by our Public Health and medical professionals in Saratoga County. In just the past year, our Public Health department has done more work than probably the department itself thought was possible. They've outperformed departments many times their size with many times the personnel and the budget. It is incredibly, it is awe inspiring work that the department has done over the past in the pandemic. And our County has seen the results. We have seen fewer numbers of deaths. We've seen higher rates of vaccination. We've been the talk of Public Health departments, we've been the talk of national committees on health and wellness and COVID-19. That's because we listened to Public Health. I know I may be in the minority on many things here. And I know that there are many issues with mask mandates. It puts our business owners at risk. It puts our employees at risk. It's uncomfortable. I know that there are a lot of long term effects from it. And it should not be the priority of our Public Health Department to enforce such a mandate. That may not be expected for me, but it cannot be and it should not be they are doing work that is far more important than enforcing that. But it should not be the work of this Board of Supervisors to issue by any member or the Board as a whole. A statement that is inflammatory, indicates that the mandate or the law of the State will not be held in this County. The number of calls and emails I've received from business owners across the county, from parents whose children are too young to be vaccinated, from people who want to know can we enforce it in our in our business or can we not? What do we do? This has added our County into a mode of crisis and confusion, and it wasn't there before. And we should do better. It is all well and good to say that we cannot make that a priority. And that is fine with me. It should not be, but it is not well and good for this County that has done so much. So much good work and our people have seen the results, to toss that away and waste, the lives lost, the businesses lost. The work that our County staff has done. I'm not asking for anything to be done, because I know damn well that I'm not going to get a second on a Resolution to make another statement. I know I'm not going to get that. But the number of parents that I've had to talk to today that were crying, the number of business owners that were angry about what was going on, about the tone, not the content, not that it's not something that can be a priority, the tone of the statement that was released by the Chairman. I felt that some statement needed to be made if nothing else. And I apologize to the public. Yesterday our major hospital in Saratoga County, the CEO and President released a statement. The hospital is overwhelmed. It's the first time he's released something saying we're underwater, we can't do this. Our beds are full, our ER is full, our rooms are full. Our staff is trying to do as much as they can. People are dying. They're dying because they can't get preventative care. And they're dying of COVID. And the two things that he asked were to get vaccinated, which includes a booster, which is incredibly important. And to wear a mask. While you're inside regardless of vaccination status.

Theodore Kusnierz

Supervisor, be respectful of your time you have 25 seconds remaining.

Tara Gaston

Thank you. Getting vaccinated, including a booster and wearing a mask are the two things that he asked. And those are the two things that I will ask on whatever small podium I may hold. Thank you.

Theodore Kusnierz

Thank you very much Supervisor. I would just like to add for the record as of 4pm this afternoon, there are now 31 counties that are aligned with Saratoga County, which has made combatting COVID-19 our top priority for 2021. We have had many firsts where we lead the State not only in vaccinations, booster shots, programs that benefit our children by keeping them in schools, assisting our School Districts. So we have not shirked our responsibilities in any way, shape, or form. And quite honestly, you can still wear mask. We're just not going to go out and fine people \$1,000 for not wearing a mask or following the unenforceable, using the words of our own Governor, policy, which some can debate whether it was legally promulgated by the Department of Health, but that we will save for another debate. But I have the utmost confidence that Saratoga County will continue to lead in getting our residents vaccinated. Yes, masks benefit our residents, but there's nothing that can protect our residents more than getting vaccinated and getting your booster shots. And we have not wavered from that position, nor will we waver from it. And we'll continue to work to do what is right, not only on behalf of our residents, but what is right in the public health arena. So thank you for your comments. Any other business? Hearing none, I do have a couple items. The first one I'd like to speak on is employee recognition. We have employees that work for the County that have reached the milestones of serving our residents, Supervisors Department heads for milestones of 25 years, and 30 years, which is incredible to have that level of commitment and dedication in one position, especially today, where many people don't stay in one particular job for a very long period. So I'll be offering each and every one of those individuals a proclamation and I'd like to read the proclamation into the record. And this is from the Saratoga County Board of Supervisors.

Theodore Kusnierz

Whereas, a major factor in the superior quality of life in Saratoga County is the delivery of high quality municipal services to county residents by the various departments of the Saratoga County government; and

Whereas, it is the efficiency, dedication and hard work of the employees of Saratoga County that is responsible for the smooth, efficient and effective delivery of municipal services in Saratoga County; and

Whereas, those of our employees who have been in county service for many years are the keys to successful government due to their experience, expertise and loyalty; and Whereas, it is appropriate to recognize, honor and thank our employees who have served the county and its residents for many years, now, therefore, it is hereby, Proclaimed, that the Board of Supervisors of the County of Saratoga hereby recognizes, honors and commends and each individual employee will be listed on a proclamation and the amount of time that they have served Saratoga County.

And the Board of Supervisors further expresses its own deep gratitude, and that of the residents of Saratoga County for the loyalty, dedication and hard work, which has had such a positive impact on the delivery of quality service to the public. Signed this 15th day of December 2021 on behalf of Saratoga County Board of Supervisors.

And the Department of Social Services, we have Kelly Lloyd with 30 years, and also John Renzi with 25 years of service. In the Planning Department, we have Michael Valentine with 25 years. In the Probation department, we have Michael Mahoney with 25 years. And the Sewer District Department we have Richard Schultz with 25 years.
