Well, first of all good afternoon and Happy New Year to everyone. I'd like to welcome our returning Supervisors back to the Board of Supervisors and looking forward to working with each and every one of you. I'd also like to welcome our newly elected Supervisors and congratulate each of you on your victories. We have Supervisor Eric Butler from the Town of Corinth. Would you like to stand so everybody knows who you are in the audience? We have a Supervisor Diana Edwards from the Town of Day. We have Supervisor Mark Hammond who's on the phone from the Town of Wilton I'm sorry, Milton, No, Malta. All these M's.

Thank you very much, and we look forward to collaborating with you as we work to meet the needs of our county residents. I first off want to start by thanking our Clerk of the board, Therese Connolly for opening the meeting and Supervisor Tollisen for accepting the role of temporary Chairman. And also I'd like to thank Supervisor Wood for offering the prayer at the beginning of the organizational meeting. I'd also like to especially thank Supervisor Schopf and Lant for their nominations for Chairman of the Board of Supervisors. Thank you to my colleagues for the opportunity to continue to serve as your Chairman of the Board of Supervisors. It's a distinct honor and pleasure and a responsibility that I do not take lightly. I also want to thank the residents of the Town of Moreau who re-elected me to the Town Board for the seventh time, third time as Supervisor. And most importantly, I would like to thank my family, I have my mom, Ann in the back of the room, I have my wife, Mary Ellen, and our daughter, Jacqueline, and our son Ted, unfortunately could not be with us today. And I also have two sisters. I have my sister Adele Kurtz, and my sister Rachel Zimmerman, who is here with her son, my nephew, Will Zimmerman who is also my campaign chair. So all my victories are credit to Will. At this time, I'd also like to recognize our County elected officials that are with us. We have our County Sheriff Michael Zurlo. We have our District Attorney Karen Heggen. And we have our County Clerk Craig Hayner. And County Treasurer, Drew Jarosh. So thank you for being with us this afternoon. Last year at this time, I stood before you and committed to ensuring that we would hone our focus on the COVID 19 pandemic crisis and put forth an action plan that would mobilize all aspects of county government. Not only did we do that, our employees rose to the occasion, and they have done an incredible job under the leadership of our County Administrator Steve Bulger. So thank you for that, Steve. We also affirm to Commissioner, Dr. Dan Kuhles, I believe he's on the line as we speak, that he would receive whatever manpower, financial assistance, or tools he would need to best protect the residents and meet whatever new public health challenges may arise in 2021. True to form, Saratoga County became a leader in the public health arena in New York State. With Dr. Kuhles knowledge, his skills and tireless efforts as a trained epidemiologist, over the past year, Saratoga County has held 262 vaccine clinics across the county, and we have provided over 40,000 vaccines to our county residents. And that doesn't take into account our public private partnerships that we have throughout the county. As a

result, we are now one of the top three counties in New York State for the highest percentage of individuals that are fully vaccinated and have received the booster vaccine. So I think they all deserve a round of applause for that.

We also partnered with the Syracuse based Quadrant Biosciences to open the large scale COVID testing site for symptomatic individuals that is centrally located in the county off of Exit 12 of the Northway in the Town of Malta. And our Public Health Department led the State in other initiatives to slow the transmission of COVID-19. We were the first county to vaccinate 90% of our teachers. Were the first county to provide in-home vaccinations to homebound individuals throughout Saratoga County. We were also the first county to create a high risk sports protocol so our students would get back to playing sports. And we're also the first county to offer a science based option to reduce the length of quarantine by partnering with the Centers for Disease Control and Prevention, to offer a test to stay program for K through 12, to keep healthy children in our schools learning. All these initiatives are those which became templates across New York State, and I'd like to thank Dr. Kuhles for his hand in that. He's a leader in public health in our State and we're fortunate to have him on our staff. So a round of applause for Dr. Kuhles.

With the release of the 2020 census figures the numbers confirmed what we already know here in this room, Saratoga County is a great place to live and raise a family. We're the fastest growing County in upstate New York. Since 1980 our population has increased by 53%. As a matter of fact, in the last Newsday rankings, Saratoga County is rated number one for social and economic indicators out of every county in New York State. And these include factors such as education, employment, income, family and social support, and community safety. And with that, I have to give a shout out to our Sheriff Michael Zurlo. We are one of the safest counties in New York State. And just as an aside, we talk about all of our departments that are playing a role in ensuring that our residents are protected especially with COVID-19. The Sheriff's Department, County Administrator Steve Bulger, and Carl Zeilman's Office, Office of Emergency Services. When we received our individual screening tests yesterday at noon, within an hour they were being distributed to all the Towns in the county. They got it done by three o'clock. So our hats are off to you and like to applaud the Sheriff and everything for that.

We also have the lowest property tax rate of any other county in New York State and the lowest county sales tax rate. What this translates to is that the work of this legislative body is critically important to

ensuring that Saratoga County's business friendly climate that creates jobs continues and that our county remains a great place to live and raise our families. However, this phenomenal success comes with greater needs. In working with my colleagues, the County adopted a \$381 million budget this fall for 2022 that not only meets the needs of our residents, but also plans for the future here in Saratoga County. Some of the highlights of that budget include a slight decrease in the property tax rate, we did not exceed the State's property tax cap. The budget includes nearly \$5 million dollars in community support grants, of which \$2 million is earmarked for nonprofit grant program. We will be making \$4 million in new investments in the Sheriff's office and the District Attorney's office for body cameras to meet the requirements of the judicial discovery laws that include funding for officer training and mandated jail programs. And we have earmarked \$3 million to support key health and human services initiatives to assist the County's Public Health Departments transition to a full service Department of Health office. And that is another State mandate that we don't receive funding for, but they expect us to get it done. And it's going to be an arduous task, it's gonna take several millions of dollars to get it done. They want us to do it in a year, we're gonna try and do it maybe a couple years, two or three years. In addition, the budget includes a Capital Facilities Bond, with approximately \$11.4 million in proposed capital investments to spread the county's cost of long term capital projects over a 10 year span. We've also made allocations for infrastructure investments, including needed upgrades to Saratoga County's first responders' communication network, residential broadband expansion, and other facilities improvements. Also included in the budget, we made investments in open space preservation and conservation, including increased outlays for open space preservation and trail and forestland maintenance, as well as the next extension of the Zim Smith Trail. And finally, the 2022 budget provides for \$1.1 million in economic development funding, as well as funding for tourism. All this was accomplished by the incredible team that we have assembled here, and all of our departments at the County, with direct input from the elected officials whom they work for. And we all have the common goal of serving our residents in the best ability that we have. So with an immense sense of gratitude, I like to thank each of you, and every one of you, and I look forward to working with you and the upcoming year. Thank you very much.
