#### **RESOLUTION 55 - 2022**

CANCELLING DELINQUENT TAXES IN THE TOWNS OF CLIFTON PARK, SARATOGA, MOREAU, CORINTH AND GREENFIELD

WHEREAS, pursuant to Real Property Tax Law 1138(6), a taxing district may cancel a delinquent tax lien if the taxing district determines that there is no practical method to enforce the collection of the delinquent tax lien and that a supplementary proceeding to enforce collection of the tax would not be effective; and

WHEREAS, from time to time parcels of taxable real property in Saratoga County which are in fact private roads or rights of way which serve as access to multiple adjoining parcels are included in the tax foreclosure proceeding for unpaid taxes; and

WHEREAS, the lack of proper construction, maintenance and repair of these roads create potential liability substantially in excess of the amount that could be recovered by enforcing the tax lien; and

WHEREAS, amounts bid at auction sales of these private road parcels in the past have been significantly less than the unpaid taxes, and in many cases the purchasers of these parcels at auction later default in payment of taxes, causing the parcel to return to tax lien foreclosure; and

WHEREAS, there is no practical method of enforcing the collection of delinquent tax liens on road parcels without incurring the potentially liability of ownership of the roads; and

WHEREAS, parcel 269.10-1-25 in the Town of Clifton Park has delinquent taxes for the years 2010 – 2021 outstanding in the amount of \$2,634.00. Said parcel is a private road servicing multiple residents over which there is a common right of way; and

WHEREAS, parcel 180.18-1-23 in the Town of Saratoga has delinquent taxes for the years 2001 – 2021 totaling \$3,102.08, said parcel being a private road servicing multiple residents over which there is a common right of way; and

WHEREAS, parcel 76.-3-20 in the Town of Moreau has delinquent taxes for the year 2010 totaling \$37.09 as a result of an unpaid water charge. Parcel 76.-3-20 is owned by the State of New York and is coded as a highway garage; and

WHEREAS, parcel 85.-1-24.2 in the Town of Corinth has delinquent taxes for the years 2016 & 2017 totaling \$218.42 as a result of an unpaid fire district charge. A fire tower is located on parcel 85.-1-24.2 and is owned by the State of New York; and

WHEREAS, parcel 300.-1-3 in the Town of Greenfield has delinquent taxes for the year 2013 totaling \$197.98 as a result of an unpaid school tax bill. Parcel 300.-1-3 is owned by the State of New York; and

WHEREAS, the Tax Enforcement Officer has determined there is no practical method to enforce the collection of delinquent tax liens on the aforementioned properties and a supplementary proceeding to collect the taxes would be ineffective; and

WHEREAS, Real Property Tax Law §1138(6) allows the County to cancel the tax liens, both current and prospective on these parcels; now, therefore, be it

RESOLVED, that the following delinquent tax liens on the following parcels are hereby cancelled pursuant to Real Property Tax Law §1138

AUTHORIZING AGREEMENTS WITH THE NEW YORK ENVIRONMENTAL PROTECTION AND SPILL COMPENSATION FUND AND THE TOWN OF BALLSTON REGARDING A CERTAIN TAX DELINQUENT PARCEL IN THE TOWN OF BALLSTON

WHEREAS, with the assistance of Gary S. Bowitch, Esq., Saratoga County through the County Attorney's Office and County Treasurer's Office, have worked to identify tax delinquent parcels throughout the County that are potentially environmentally impacted and in need of remediation; and

WHEREAS, the County commenced an action against a property due to tax delinquency by initiating a tax foreclosure proceeding on September 30, 2021, for unpaid 2018 property taxes with respect to the following property located in the County of Saratoga (hereinafter the "Magnum Site"):

WHEREAS, the Magnum Site in the Town of Ballston was previously used as a gas station and auto mechanic shop and is comprised of a singular tax map parcel and was identified as requiring environmental remediation before it could be conveyed at auction or otherwise sold; and

WHEREAS, the New York Environmental Protection and Spill Fund (the "Fund") was created by NYS Navigation Law §179 and pursuant to Navigation Law §180, the Administrator of the Fund is authorized to settle claims on behalf of the Fund and to make additional expenditures for cleanup of any potential petroleum contaminated sites; and

WHEREAS, any agreement between the Fund and the County would require the State of New York to perform environmental remediation of the Magnum Site, as deemed necessary by the Department of Environmental Conservation, after the County acquires title to the Magnum Site through tax foreclosure at a cost to be solely borne by the State of New York; and

WHEREAS, in order to facilitate environmental remediation, eliminate the blight associated with vacant buildings, and enable future public use of the Magnum Site, the County wishes to enter into an agreement with the Fund wherein in exchange for \$7,000, the Fund would release its potential claims against the County, for past and future cleanup and removal costs incurred by the State, including interest thereon, and applicable penalties, prior to the County taking title to the Magnum Site through tax foreclosure; and

WHEREAS, any release provided by the Fund to the County shall extend to the successors or assigns of the County with respect to the Magnum Site; however, such release shall not extend, nor can it be transferred, to any successors or assigns of the County at the Magnum Site if such successors in title are persons deemed legally responsible for the discharge of petroleum at Magnum Site, respectively; and

WHEREAS, in order to facilitate environmental remediation, eliminate the blight associated with vacant buildings, and enable future use of the Magnum Site, the Town of Ballston wishes to enter into an agreement with the County wherein the County would convey the Magnum Site to the Town of Ballston in exchange for \$7,000, after the County takes title to the Magnum Site through tax foreclosure; and

WHEREAS, our Real Property Tax Committee, the County Attorney, and the County Treasurer as Tax Enforcement Officer, have recommended that the County enter into agreements with the Fund and the Town of Ballston to facilitate the environmental remediation, elimination of the blight associated with vacant buildings, and enabling future public use of the Magnum Site while protecting the County from liability under the applicable provisions of the NYS Navigation Law; now, therefore, be it

RESOLVED, that the Chair of the Board is authorized to execute any necessary agreements with the Fund to facilitate the environmental remediation of the Magnum Site after the County acquires title to the Magnum Site through tax foreclosure at a cost to be solely borne by the State of New York, in exchange for reimbursement of \$7,000 to the Fund from the County; and it is further

RESOLVED, that the Chair of the Board is authorized to execute any necessary agreements with the Town of Ballston to facilitate the environmental remediation of the Magnum Site through the conveyance of the Magnum Site to the Town of Ballston, after the County acquires title to the Magnum Site through tax foreclosure, in exchange for \$7,000; and it is further

RESOLVED, that the form and content of such agreements shall be subject to the approval of the County Attorney; and it is further

RESOLVED, that this Resolution shall take effect immediately.

WHEREAS, this Board of Supervisors has received a petition from Wendy Zwijacz, landowner in the Town of Wilton, to include  $106.17 \pm acres$  of predominately viable agricultural land located on West Lane, identified as Tax Parcel #128.-1-83.11, which parcel is dedicated to hay and corn crop production with aspirations of raising livestock on the land in the future, within the boundaries of Saratoga County's Consolidated Agricultural District #1; and

WHEREAS, this Board of Supervisors has received a petition from David A. Anusesky, in the Town of Stillwater, Tax Parcel #: 243.-1-43.2 to include 38 ± acres located on Colonial Road, which parcel is dedicated to firewood production and adjacent to Mr. Anusesky's father's land which is

already part of the agricultural district, within the boundaries of Saratoga County's Consolidated Agricultural District #1; and

REQUESTING HOME RULE LEGISLATION TO AMEND SECTION 131 OF THE FAMILY COURT ACT TO PROVIDE FOR AN ADDITIONAL FAMILY COURT JUDGE IN SARATOGA COUNTY

WHEREAS, Family Court Act §131 designates the number of Family Court Judges of each county outside the city of New York; and

WHEREAS, by Resolution 22-1967, this Board requested Home Rule Legislation to amend the Family Court Act to "establish the office of the family court judge in Saratoga County;" and

WHEREAS, by Chapter 987 of the Laws of 1968, the New York State legislature amended Family Court Act §131, by adding twenty-five Family Court Judge positions across the State to include one Family Court Judge in Saratoga County; and

WHEREAS, by Resolution 72-1983, this Board requested Home Rule Legislation to amend the Family Court Act to provide for a second Family Court Judge in Saratoga County; and

WHEREAS, by Chapter 572 of the Laws of 1984 the New York State Legislature amended Family Court Act §131(g), to provide "[i]n the county of Saratoga there shall be an additional family court judge and the number of such judges now existing in such county is hereby increased accordingly"; and

WHEREAS, since the early 1980's Saratoga County has seen a tremendous increase in population with the preliminary 2020 Federal Census being 235,509 as compared to the 1980 Federal Census being 153,759, representing an increase of 54% in population; and

WHEREAS, the number of cases being filed and adjudicated in Saratoga County Family Court having increased, with 2,492 cases having been commenced in 2021, which included 8,172 appearances; and

WHEREAS, within the Capital District, the County of Albany presently has four (4) Family Court Judges; and the County of Schenectady has three (3) Family Court Judges despite having a smaller population than Saratoga County; and

WHEREAS, the present caseload of the Saratoga County Family Court is so high that if a trial of issues is required, a trial date cannot be scheduled for at least six (6) months; and

WHEREAS, the Board of Supervisors is concerned over the possible delays and associated problems which occur from the excessively high ration of cases which must be dealt with by two (2) Family Court Judges; and

WHEREAS, our Law and Finance Committee has recommended the adoption of a Resolution seeking home rule legislation to amend Section 131 of the Family Court Act to provide for an additional Family Court Judge in Saratoga County; now, therefore, be it

RESOLVED, that the Board of Supervisors of the County of Saratoga hereby requests and urges the enactment of state legislation amending Section 131 of the Family Court Act which would create a third Judge for the Saratoga County Family Court; and is further

RESOLVED, that the Clerk of the Board is directed to forward certified copies of this Resolution to Chief Judge Janet DiFiore, Chief Administrative Judge Lawrence Marks, Administrative Judge Felix Catena, Governor Kathleen Hochul, Senator Daphne Jordan, Senator James Tedisco, Assemblyman John McDonald, III, Assemblywoman Carrie Woerner, Assemblywoman MaryBeth Walsh, and Assemblyman Matthew Simpson.

BOND RESOLUTION AUTHORIZING THE ISSUANCE OF \$29,800,000 BONDS OF THE COUNTY OF SARATOGA, OR SO MUCH THEREOF AS MAY BE NECESSARY, TO FINANCE THE COST OF THE REHABILITATION AND IMPROVEMENT OF THE SEWER INTERCEPTOR AND RELATED FACILITIES BY SARATOGA COUNTY SEWER DISTRICT NO. 1; STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$29,800,000, STATING THE PLAN OF FINANCING; PROVIDING FOR A TAX TO PAY THE PRINCIPAL OF AND INTEREST ON SAID BONDS; AND PROVIDING FOR REIMBURSEMENT BY SARATOGA COUNTY SEWER DISTRICT NO. 1 TO SAID COUNTY

WHEREAS, pursuant to proceedings had and taken in accordance with the provisions of Article 5A of the County Law and more particularly Resolution 245-2020 of this Board of Supervisors, an increase and improvement of facilities of Saratoga County Sewer District No. 1 (the "District"), consisting of the rehabilitation and improvement of the sewer interceptor and related facilities (the "Project") has been approved at a total estimated maximum cost of \$29,800,000 to the County of Saratoga and the District; now, therefore, be it

RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF SARATOGA, NEW YORK (by the affirmative vote of not less than two thirds of the voting strength of said Board), AS FOLLOWS:

Section 1. The County of Saratoga, New York (herein called "County"), is hereby authorized to undertake the reconstruction of the Saratoga County Sewer District No. 1 sewer system, including the rehabilitation and improvement of the sewer interceptor and related facilities, acquisition of land or rights in land and acquisition of original furnishings, equipment, machinery or apparatus required in connection therewith, at a maximum estimated cost of \$29,800,000. The plan of financing shall consist of the issuance of not to exceed \$29,800,000 aggregate principal amount of bonds of the County authorized to be issued pursuant to this resolution. Any federal or state grant funds received by the County for the specific objects or purposes described in this resolution shall be applied to pay the principal of and interest on the bonds or any bond anticipation notes issued in anticipation of the bonds or, to the extent obligations shall not have been issued under this resolution, to reduce the maximum principal amount to be borrowed for such specific objects or purposes.

<u>Section 2.</u> Bonds of the County in the principal amount of \$29,800,000, or so much thereof as may be necessary, are hereby authorized to be issued pursuant to the provisions of the Local Finance Law, constituting Chapter 33-a of the Consolidated Laws of the State of New York (herein called the "Law") to finance the County's total estimated cost.

Section 3. The period of probable usefulness for the specific object or purpose for which said \$29,800,000 bonds herein authorized are to be issued, within the limitations of §11.00 a. 4 of the Law, is forty (40) years.

Section 4. Current funds are not required to be provided as a down payment prior to the issuance of the bonds authorized herein, or any bond anticipation notes issued in anticipation thereof, pursuant to Section 107.00 d. 3. of said Law.

Section 5. The County intends to finance, and the County Treasurer is hereby authorized to advance such amounts as are necessary to pay the costs of said improvements, prior to the issuance of the bonds or bond anticipation notes herein authorized, out of any available funds of the County on an interim basis, which respective amounts are reasonably expected to be reimbursed with the proceeds of debt to be incurred by the County pursuant to this Resolution, in the respective maximum amounts of bonds herein authorized. This Resolution is a declaration of official intent adopted pursuant to the requirements of Treasury Regulation Section 1.150-2.

Section 6. Subject to the provisions of this Resolution and of the Law, and pursuant to the provisions of §21.00 relative to the issuance of bonds having substantially level or declining annual debt service, §30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals thereof, and of §\$50.00, 56.00 to 60.00 and 168.00 of said Law, the powers and duties of the Board of Supervisors relative to authorizing the issuance of any notes in anticipation of the sale of the

respective amounts of bonds herein authorized, or the renewals thereof, relative to providing for substantially level or declining annual debt service, relative to prescribing the terms, form and contents and as to the sale and issuance of the respective amounts of bonds herein authorized, and of any notes issued in anticipation of the sale of said bonds or the renewals of said notes, and relative to executing agreements for credit enhancement, are hereby delegated to the County Treasurer, as the chief fiscal officer of the County.

<u>Section 7.</u> Each of the bonds authorized by this Resolution and any bond anticipation notes issued in anticipation of the sale thereof shall contain the recital of validity prescribed by §52.00 of said Local Finance Law and said bonds and any notes issued in anticipation of said bonds shall be general obligations of the County of Saratoga. The faith and credit of the County are hereby irrevocably pledged to the punctual payment of the principal of and interest on said bonds and any notes issued in anticipation of the sale of said bonds or the renewals of said notes. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be assessed and levied upon the real property of users connected to the District's sewer system, in accordance with the District's annual scale of charges for the collection, conveyance, treatment and disposal of sewage and wastewater from public corporations, improvement districts, commercial and industrial users and individuals, as such scale of charges currently exists and as it will be amended and adopted on an annual basis, an amount sufficient to pay the principal of and interest on such obligations as the same become due and payable, but if not paid from such source, all the taxable real property in the County shall be subject to the levy of ad valorem taxes without limitation as to rate or amount sufficient to pay the principal and interest on such obligations when due.

<u>Section 8.</u> The validity of the bonds authorized by this Resolution and of any notes issued in anticipation of the sale of said bonds, may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the County is not authorized to expend money, or
- (b) the provisions of law which should be complied with at the date of the publication of this Resolution are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty days after the date of such publication, or
- (c) such obligations are authorized in violation of the provisions of the Constitution.

Section 9. The Clerk of the Board of Supervisors is hereby directed to publish the foregoing bond resolution, in summary, in "The Saratogian;" "Saratoga Today;" "The Post Star;" and in "The Daily Gazette", newspapers having a general circulation in said County and hereby designated the official newspapers of said County for such publication, together with a notice in substantially the form prescribed in Section 81.00 of the Local Finance Law of the State of New York.

Section 10. The County Board of Supervisors hereby determines that the provisions of the State Environmental Quality Review Act and the regulations thereunder have previously been satisfied with respect to the Project authorized by this resolution.

Section 11. This Resolution shall take effect immediately.

WHEREAS, pursuant to Resolution 139-2019, the County entered into an agreement with Chazen Engineering, Land Surveying & Landscape Architecture Co., D.P.C. to provide design, construction administration, and construction inspection services relative to the planned upgrades to Saratoga County Sewer District No. 1's Knox Woods and Riverside #1 pump stations, at a cost not to exceed \$110,000; and

WHEREAS, pursuant to Resolution 244-2020, the County entered into an amended agreement with Chazen Companies Engineering, D.P.C., for evaluation and design services for inflow and infiltration projects related to the planned upgrades to Saratoga County Sewer District No. 1's Riverside #1 pump station, at an additional cost of \$83,500, thereby increasing the total contract to not exceed \$193,500; and

WHEREAS, an amendment of the agreement with Chazen Companies Engineering, D.P.C. to include construction inspection services is needed to complete the planned upgrades to the Riverside #1 pump station; and

WHEREAS, our Law and Finance Committee, the Saratoga County Sewer District No. 1 Sewer Commission, and the Executive Director of the Sewer District have recommended that the County execute an amendment to the agreement with Chazen Companies Engineering, D.P.C. for the provision of construction inspection services for the planned upgrades to the Riverside #1 pump station at an additional cost of \$33,763; now, therefore, be it

RESOLVED, that the Chair of the Board is hereby authorized to execute an amendment to the agreement with Chazen Companies Engineering, D.P.C. of Poughkeepsie, New York, for the provision of construction inspection services for the planned upgrade of the Riverside #1 pump station in the Town of Stillwater, at an additional cost of \$33,763, thereby increasing the total contract to the not to exceed amount of \$227,263; and it is further

RESOLVED, that the form and content of such amendment shall be subject to the approval of the County Attorney; and it is further

RESOLVED, that this Resolution shall take effect immediately.

**RESOLUTION 100 - 2022**

AUTHORIZING A COMMITMENT OF \$2,000,000 IN AMERICAN RESCUE PLAN ACT FUNDING FOR THE EXTENSION OF SEWER INFRASTRUCTURE TO THE TOWNS OF MOREAU AND WILTON

WHEREAS, by Resolution 235-2004, Saratoga County Sewer District No. 1 was expanded to include the Town of Wilton; and

WHEREAS, by Resolution 198-2012 Saratoga County Sewer District No. 1 was expanded to include additional municipalities including the Town of Moreau; and

WHEREAS, the Towns of Moreau and Wilton have made substantial investment into the expansion of access to sewer infrastructure which will continue to both benefit the entire county through economic development, and benefit Saratoga County Sewer District No. 1 through an increase in user base; and

WHEREAS, on March 11, 2021, the Federal Government passed the American Rescue Plan Act of 2021 (ARPA), which is a \$11.9 Trillion economic stimulus package intended to assist the United States recovery from the economic and health effects of the COVID-19 Pandemic and the ongoing recession; and

WHEREAS, the U.S. Department of Treasury has issued guidance and rules relative to ARPA funding, including the Coronavirus Local Fiscal Recovery Fund Award Terms and Conditions, and such guidance has provided that an approved use for the funding includes the expansion and/or improvements to infrastructure including wastewater treatment; and

WHEREAS, Saratoga County was directly awarded \$22,324,096.50 in 2021 funding and is projected to receive another \$22,324,096.50 in 2022; and

WHEREAS, in order to connect additional users in the Town of Wilton and Town of Moreau to the sewer infrastructure maintained by Saratoga County Sewer District No. 1., it will require additional engineering and surveying studies and installation and/or improvements of additional sewer infrastructure such as force mains, manholes and pump stations at an initial projected total cost of \$9.3 million; and

WHEREAS, the County's ARPA consultant, Vanesky and Company, has advised that the proposed expenditure is a qualifying expense under the U.S. Treasury guidelines and rules for ARPA expenditures; and

WHEREAS, our Law and Finance Committee, the Saratoga County Sewer District No. 1 Commission, and the Executive Director of the Sewer District, have recommended that the County commit ARPA funding for the extension of the Sewer District into the Towns of Moreau and Wilton; now, therefore, be it

RESOLVED, that the Saratoga County Board of Supervisors hereby approves the funding for the proposed project extending sewer infrastructure maintained by Saratoga County Sewer District No. 1 to the Towns of Moreau and Wilton; and it is further

RESOLVED, that the Board acknowledges and authorizes a commitment of \$2,000,000, of the allotment of 2021 American Rescue Plan Act funding received in 2021, towards the Saratoga County Sewer District No. 1 sewer extension project to the Towns of Moreau and Wilton; and it is further

RESOLVED, that this Resolution shall take effect immediately.

BUDGET IMPACT STATEMENT: No Budget Impact.

Ms. Gaston requested a separate vote on Resolution 90.

Mr. Hammond said that the HVCC project will bring great access to affordable higher education to the residents in Saratoga County. Although located in the Town of Malta, it will be beneficial for all of Saratoga County to have this institution enhance their presence in the County, through establishment of HVCC North. HVCC North presents new opportunities for our young people and those looking to earn new skills in high demand programs in health care, STEM and skilled trades. This will attract workers and keep them local to help meet the needs of our local businesses and community. It will help strengthen the shrinking middle class. It is a smart investment that he believes will have a positive impact on the community for years to come. Mr. Hammond encouraged his colleagues to offer unanimous support of this funding allocation.

Ms. Gaston said that the reason for her request for separate vote was not to do with the content of the resolution itself, or the work of HVCC. It is actually to comment on the process. Ms. Gaston expressed concern regarding the amount of money being spent by a resolution outside of the budget process. Ms. Gaston said that organizations that have requested funding has been asked to go through either the nonprofit program or the regular budget process. Ms. Gaston said that there was a letter on the record indicating that prior to the budget being passed last year, HVCC was advised the amount of funding would likely be available to them. Ms. Gaston said that she hopes the Board in future follows it's own rules and guidelines.

Mr. Barrett commended Dr. Ramsammy and his team for their leadership and doing a great job for their students and the entire region. Mr. Barrett fervently supports this allocation of funds to further educational and training activities here in Saratoga County and look forward to a long and prosperous partnership with HVCC.

On a motion by Mr. Barrett, seconded by Ms. Gaston, Resolution #90 was adopted by a unanimous vote.

WHEREAS, Hudson Valley Community College ("HVCC") has approached this Board to request assistance with funding for the expansion of the north campus in the Town of Malta; and

WHEREAS, in 2010, Hudson Valley Community College opened the Training and Education Center for Semiconductor Manufacturing and Alternative and Renewable Technologies ("TEC-SMART") in the Town of Malta adjacent to GlobalFoundries Fab 8 facility which supports the training and education needs of the area's growing semiconductor technology sector; and

WHEREAS, HVCC through the TEC-SMART facility provides the Clean Technologies Early College High School program, a partnership with Ballston Spa Central School District, which impacted more than 300 students in grades 9 – 12 from more than 20 districts in five surrounding counties; and

WHEREAS, TEC-SMART is home to industry-specific workforce training programs and currently serves approximately 1,200 Hudson Valley Community College and Early College High School students in a variety of programs; and

WHEREAS, Hudson Valley Community College has proposed the construction of a new twostory building at the north campus in the Town of Malta with plans for included program specific labs, classrooms, and educational support spaces; and

WHEREAS, the proposed expansion and new construction will allow Hudson Valley to increase enrollment in high demand programs by 10-20% and create opportunities for more graduates to enter the healthcare, STEM and skilled trade fields more quickly; and

WHEREAS, the proposed expansion of services and increased enrollment in the industry specific programs offered by Hudson Valley Community College will assist with supporting the growing regional semiconductor and technology sectors, provide additional job opportunities, and create positive economic impacts throughout the County; and

WHEREAS, the Board of Supervisors supports the planned expansion of the HVCC north campus in the Town of Malta, and wishes to appropriate \$1,500,000 to support the proposed new construction; and

WHEREAS, pursuant to County Law §224, a written agreement with Hudson Valley Community College and an amendment of the 2022 County Budget is necessary to expend such appropriations; now, therefore be it

RESOLVED, that the Saratoga County Board of Supervisors expresses support of the proposed new construction and expansion of the HVCC north campus in the Town of Malta; and it is further

RESOLVED, that the Chair of the Board is authorized to execute an agreement with Hudson Valley Community College for the expansion and new construction of the HVCC north campus in the Town of Malta, to facilitate economic development and the provision of educational services in the County, in an amount not to exceed \$1,500,000; and it is further

RESOLVED, that the agreement shall be subject to the following provisions pursuant to County Law §224; (a) that payments shall be made to the organization's disbursing officer at such times as determined by the County Administrator; and (b) payments shall only be made upon the submission of a duly certified properly documented County voucher; and (c) the documentation for the organization's initial voucher shall include copies of its current budget, financial statement, and compensation schedule; and (d) that the organization shall refund any unused portion of the its appropriation; and it is further

COUNTY OF SARATOGA LOCAL LAW 1 - 2022

A LOCAL LAW TO AMEND LOCAL LAW NO. 2 OF 1968, AS LAST AMENDED BY LOCAL LAW NO. 5 OF 2011, TO INCREASE THE POPULATION THRESHOLD FOR AN ADDITIONAL COUNTY SUPERVISOR

BE IT ENACTED by the Saratoga County Board of Supervisors as follows:

<u>SECTION 1.</u> That paragraphs a.) and b.) of Section 2 of Local Law No. 2 of 1968, as last amended by Local Law 5 of 2011, be amended as follows:

"SECTION 2. Such system of weighted voting shall be as follows:

- a.) Each municipality shall elect one (1) Supervisor where its population is less than 27,500 according to the latest decennial census and each Supervisor shall cast one (1) vote for each person in their district according to such census.
- b.) Where any such municipality shall have a population of 27,500 one additional Supervisor shall be elected therefrom and one additional thereafter as each whole multiple of 27,500 is attained. Such Supervisors shall each cast that number of votes arrived at by dividing the total population of each municipality by the number of its Supervisors."

<u>SECTION 2.</u> That SECTION 3. of said Local Law No. 2 of 1968, as last amended by Local Law No. 5 of 2011, be further amended as follows:

"SECTION 3. The composition of the Saratoga County Board of Supervisors shall consist of twenty-three (23) Supervisors, with two (2) Supervisors each from the City of Saratoga Springs and the Town of Clifton Park, and one (1) Supervisor each from the City of Mechanicville and the remaining Towns of the County of Saratoga, and, hereafter, such number shall automatically increase by the addition of an additional Supervisor from each Town or City as its population, based on a County-wide Official Federal Census, shall reach 27,500 or whole multiples thereof."

<u>SECTION 3</u>. This Local Law is subject to a permissive referendum as provided in Section 24 of the Municipal Home Rule Law.

<u>SECTION 4.</u> This Local Law shall take effect after it is filed as provided in Section 27 of the Municipal Home Rule Law.
