Thank you very much Supervisor Wood. Agenda item five is listed as a presentation. It's our employee recognition. It gives me the distinct pleasure to read a recommendation on County letterhead that was put together by our County Attorney Michael Hartnett. And it was directed to Supervisor Tollisen, Chair of the Human Resources and Insurance Committee, Tina Potter Commissioner of the Department of Social Services, and Scott Chamberlain, Director of the County Human Resources Department. And Susan Hoefer is a caseworker in the Department of Social Services. And this is in reference to a particular case, Isaac YY a child under 18 years of age alleged to be neglected by Arielle YY the

respondent. This was in the Appellate Division Third department. I won't list all the appeal numbers, but I will, I would like to read into the record the letter that Attorney Hartnett provided to my colleagues. It says Dear Supervisor Tollisen, Commissioner Potter and Director Chamberlain, in response to the recent call for submissions of employee recognition, I wish to submit my observations of outstanding effort and conduct from a County employee with the Department of Social Services Susan Hoefer. Caseworker Hoefer is currently an investigative Caseworker assigned to the Adult Protective Services Unit of the Department of Social Services. Previously, Ms. Hoefer was a Caseworker within the Foster Care Unit of the Department of Social Services, where she was responsible for monitoring the well-being and safety of children placed in foster care and assisting in the rehabilitation and reunification of families when children are placed outside their homes through Court proceedings.

Recently, the above-referenced case – In the Matter of Isaac YY. – finally concluded the appeal process, which has prompted me to submit this long-overdue letter of recognition. The underlying case involved over five years of litigation, multiple hearings, and appeals including a multi-day Neglect trial in 2017 and an eight-day Termination of Parental Rights trial that spanned several months in the summer of 2019. Throughout the extensive litigation, Caseworker Hoefer played an integral part in the process of preparing the case for Family Court and was also responsible for providing testimony on multiple occasions.

Beginning in early 2016, Isaac was placed in foster care as a result of actions taken by Child Protective Services to protect his safety. Caseworker Hoefer was almost immediately assigned to Isaac's case and maintained responsibility for the foster care case until 2021 when Isaac was freed for adoption. Ms. Hoefer was exhaustive in her efforts to attempt to effectuate positive changes and reunify the family. Throughout her assignment, Ms. Hoefer was regularly subjected to vitriol, verbal abuse and constantly acrimonious behavior by the Respondent in the case. Despite those barriers, Ms. Hoefer remained steadfast, objective and respectful in taking all the appropriate steps to continue to ensure Isaac's safety and well-being. When reunification became untenable, Caseworker Hoefer then took all the necessary steps to enable the Department of Social Services to obtain Court Orders which ensured Isaac's safety and provided for his best interest.

I have personally handled thousands of foster care cases in Family Courts throughout New York State in my experience representing Child Protective agencies in all types of abuse and neglect cases. During that experience, I have interacted with hundreds of Caseworkers and other Child Welfare staff. I can say unequivocally that Ms. Hoefer's conduct was some of the most effective, reverent, and impactful casework that I have observed. Not only did each of the attorneys involved in the court proceeding comment on her casework, the presiding Family Court Judge specifically referenced and acknowledged her positive work in rendering the Court's decision.

It is rather unfortunate we live in a world where effective social work and social programming is substantially under-appreciated as a whole. It is my opinion that Child Welfare staff are the unsung heroes that carry the immense burden of keeping some of our most vulnerable population safe. In the public domain, Child Protective Services and Foster Care often only make the headlines when something goes wrong or when the system fails – and when a case is successful, it generally goes entirely unnoticed by the public. In that vein, I am compelled in this scenario to highlight and take note when an individual has surpassed all expectations in their efforts to help families in our community. Not only does this reinforce those positive attributes, but it helps to recognize just how critically effective work in this field can be in helping families and our community as a whole. Not only did Ms. Hoefer go "above and beyond" in working with this family, she then doubled down on her good work by providing

remarkably effective testimony which enabled the Department of Social Services to obtain Court Orders which contributed to a positive outcome in the related Court proceeding.

In summary, I believe that Ms. Hoefer should be commended for her valuable and effective work on this case which directly and significantly contributed to a positive outcome through the Family Court proceeding and subsequent appeals. In doing so, she provided an excellent and praiseworthy example of everything that our County workforce strives to provide our community. Most importantly though, Caseworker Hoefer made an immensely positive impact on the trajectory of a child's life – and for that she should be applauded. Tara Gaston

Thank you Chair. I just as I indicated in the Committee meeting, while I support a cybersecurity assessment, and the development of new policies, that was something that I'd hoped to do previously, but now they're in Buildings and Grounds Committee. I appreciate that. However, I don't think at this time that setting aside \$100,000 for that purpose is a wise financial move, given the fact that there is a government agency, a federal agency that will do these things for free, they will do a full cybersecurity assessment. They will do pin testing, they will provide us with policies, and they will tie our weaknesses and our strengths to the NIST framework, which is what's used for cybersecurity throughout the world. And so my preference would be that before any money is spent on that area that we utilize the free resources that we have available to us. And then should any monies need to be applied in order to meet any criteria for security. I would absolutely support that. But I don't support a contract with an outside agency. That's not that's going to cost this much when we could get the same thing and and use our money for responding to that and said, Thank you.

Theodore Kusnierz

Thank you Supervisor Gaston. I don't believe it is accurate. That is a free resource and I would ask County Administrator Bulger to clarify.

Steve Bulger

Thank you, Chairman. Yes. In talking with the IT department, they believe that this is services that CISA cannot provide. And they feel very strongly that they have already taken advantage of a lot of federal and state free government assessments and services, they continue to do that. But that this cybersecurity proposal and contract they're looking to do is very specific would require a lot of training. And it's something that they don't believe can be done for free. So that's the IT Department's take on this.

Tara Gaston

With respect CISA is the cybersecurity infrastructure security agency by the federal government, they maintain security for our nation's government, in addition to many others, and I did speak directly with one of the directors of the office which is located in Halfmoon. There's also an MSAC, which is located in Queensbury, which provides different services and they did assure me that they are all free, and that they were able to perform these. In addition, during the meeting, I did ask whether contact had been made with CISA to determine what they could perform or not. And I was advised that that had not been done. So thank you.

Thank you. I'm just, cybersecurity is deadly serious business here. I don't have any issue with our IT department making recommendation to retain a consultant to assist with cybersecurity. But I am wondering why couldn't we do both? I mean if we have a federal agency that's offering to provide certain services for cybersecurity, and they are offering to do it for free. Doesn't it make some sense to take advantage of that, but still engage a consultant for the specific work that our IT Department thinks they're better suited for? I just wonder why wouldn't we take advantage of a free service in conjunction with the consultants? Thank you.

Thank you, Supervisor. Eileen, would you like to address that comment?

Eileen Bennett

We have used several of the free services through MI-ISAC, through Homeland Security through several different agencies. All those are fractured for me and my department. And UTC provides an umbrella over the top of my department, on top of the network in all of our cyber security. I don't have the expertise within my department, we're a very small department that take care of 30 different departments. And I'm asking for assistance from someone that is certified under NSIT framework. And that was my proposal for my budget for 2022.

Theodore Kusnierz

Thank you Chairman, Eileen, thank you. And I'm not suggesting you shouldn't get the consultant that you want. I think you should I think cybersecurity is so serious a matter especially with the Russian Ukraine war, raging and Russia's threats to engage in cyber attacks throughout the United States. So I'm not at all suggesting that we not give you exactly what you're asking for. But I think it's important that we do give you exactly what you're asking for. I guess I was just wondering why if there is a federal agency that specializes in cybersecurity, and they can provide, whether it's an analysis or review or an overview, whatever, if that is made available to us for free. It just seems like it would be something that would make sense to do and not in any way to reduce what you're asking for. I just wonder if the two couldn't give us a better overview of our cybersecurity risk and the solutions that they would propose. So not at all opposed to what you want to what you want to do here. It just seems to me that if there's a federal agency that has this expertise, and they're offering to provide it for free, it might make sense to take a look at that. That's not at the exclusion of not doing what you want to do. I mean, I don't want to beat this because obviously that's not the motion that's on the floors. To approve or disapprove of the cybersecurity consultant, which I'm all in favor of. But it would just seem to me to make some sense to consider taking the federal government's offer up of a free cybersecurity services. I just think that makes sense. So you can, you can get the thing and you can, if you don't like it, you can toss it in the garbage. But whenever the federal government says that they'd like to provide their level of expertise, and they must have some because those are the folks who are also in charge of protecting the United

States government, in terms of cybersecurity threats, so they must bring something to the table. But I again, I'll defer to the IT folks, Eileen and her folks as to, as to what is the best course to do. It was just a simple question why we couldn't do both. Thank you for your indulgence.

Thank you, supervisor. Any other comments, I would just add, having been Supervisor in 2020 Christmas morning and having the Town of Moreau, the victim of a cyber attacked attack. We did work with a federal agency, the FBI, to try and fix it. And we were very fortunate enough to have a town board member who is heavily involved in IT, and we were able to get our data back. But it was clear after my conversations with the FBI, that, you know, this is a daily occurrence across the US they target municipalities. Some municipalities end up having to pay so, to Supervisors point, it is deadly serious, and you know, anything that we can do to get a jump on it move forward and make sure that we're adequately protected, we should do that. Any other comments? Supervisor Gaston?

Chairman, I appreciate your comment. That is important. And for anyone who's interested, in fact, I'll just send it to the Board. The individual who is the contact at CISA did indicate that they were available to offer the same services to any municipality as well as to our Water Authority and the Sewer District. If you were interested in taking them up on that, so I can send that out as well.

I'm a little, so this looks like we're signing two years at \$90,000 a year plus mileage for an agency that's in Washington, DC. So are they getting mileage and transportation when they're coming here? Or are they not coming here?

Theodore Kusnierz

County Administrator address.

Steve Bulger

Yes. They have offices in Washington and Albany, they have four people working at Albany? About nine or 10 down in Washington.

Tara Gaston

Okay, and is there any reason that we did not choose to hire an employee who would perform these services instead relying on the contractors?

Steve Bulger

Yes, we felt this was a better option to get a full service firm that cannot only research the grants, evaluate the grants, write the grants, submit the grants, and very importantly, advocate for the grants. A grant writer can only do part of that. It is our belief, and in the budget process we went through this, that a full service firm gives us a better option to go after the grants the larger grants that we're really looking for and achieve them.

Tara Gaston

So this is not just a grant acquisition but also lobbying.

Steve Bulger

Correct.

Thank you. So if they're lobbying or they are registered lobbying firm?

Steve Bulger

They are registered in both Washington and Albany.

Jack Lawler

That's good. That's very important, obviously. But I guess is there, usually a contract like this, especially in terms of grant writing, most of us in this room have been involved with grant writers at some point or another. Sometimes it's a percentage of the grant, I guess, what is the, is there an ability for the County to terminate this? Let's say we're a year down the road, and we haven't had any grants, but we have spent \$90,000 or whatever 7500 times 12 is, we have spent, it is \$90,000. But we have spent, we have spent \$90,000 but we have nothing in return for it. If these folks can deliver the goods, that's great. But can somebody speak to our ability to walk away from this if this, if this doesn't produce tangible results? Why two years, as opposed to a one year contract with an option to renew.

Steve Bulger

Yeah, when we put it out to bid, we determined two years was better because the grant cycles, what we wanted to do was go beyond just 2022. We knew this was not going to be approved. Starting in January, it looks like it's not going to start until April. Grant cycles typically are anywhere from 6 to 10 or 12 months. So we wanted to make sure we had a contract that went beyond just this fiscal year. So that's why we decided to make it for everybody to apply for a two year term.

Jack Lawler

I'm sorry, did you say you put this out to bid?

Steve Bulger

Yes. Yeah, there were five respondents to the bid. And Envision was the unanimous selection of our bid review team.

Jack Lawler

I think you mean RFP though, Right. Steve? Not.

Steve Bulger

Oh, okay. Yeah. I'm sorry. Yeah. RFP. Yes.

Jack Lawler

Okay. There were five responses. And this was the one that Alright, folks that this is the way to go.

Right.

I do have one item and this individual doesn't know we're going to talk about him. So he'll be a little surprised. But this is actually a constituent of mine, who is retiring I believe today is his last day, Steve Bayle. For the past nine years, Steven has served Saratoga County in the role of Director of Probation with honor and distinction. While we've been extremely fortunate to have him here in Saratoga County for nearly the past decade. His commitment to Criminal Justice goes back nearly 30 years having previously served with the Warren County Probation Department and as a New York State Correction officer. Steve also served as President in New York State Council Probation Administrators from 2019 to 2021. And he currently serves as a member of the Board of Directors at a Capital District Youth Center Incorporated, which oversees operation of the Albany, New York secure juvenile detention center. As the Director of Probation Steve's many accomplishments include the following: Number one, overhauling the organization's structure and updating policies and procedures resulting in more efficient operations, including the Department's move to the new Public Safety Building, overseeing the Department's conversion to electronic records with more than 17,000 probationer files. This transition

has made it easier for probation officers to view files and respond to calls from victims, courts and law enforcement while they're in the field. Also supervising the implementation of caseload explore financial restitution system, which replaced the Department's antiquated and labor intensive prior system. This highly automated, state of the art financial management system is a great investigative tool that helps staff find and make victims whole. And finally, he was instrumental in providing guidance and direction to the department and the recent raise the age and bail reform legislation. Outside of working for Saratoga County, Steve is a proud husband to Emily, father of two sons, John and Ben, and especially proud grandfather to the newest addition of his family, granddaughter, Marin Anneliese. Steve, we wish to thank you for your dedication and service to all of us here in Saratoga County. We will miss your leadership, your dry sense of humor, and we wish you well in all your future endeavors. So if you please come forward, I'd like to recognize you with a plaque.

And under when Supervisor Tolleson was Chair in January 2019. We submitted to the then Governor Cuomo, a list of names and we were never informed what happened with those list of names. Surprise yesterday we were informed by the CDTA board that in June 2021 the Governor did select and appoint our representative. So Peter Wohl is now also in addition to Georgie Nugent, serving on the CDTA Board for Saratoga County. Surprise. The former governor is no longer in office for me to have a discussion with him about that. And here's hoping that remains so. The second item on my agenda, I'm sorry that the Sheriff is not here, but I see the Under Sheriff here. While we're congratulating people, we were just at the New York State Association of Counties. I'm a member of the Public Health and Mental Health Committee. And one of the items that we discussed was First Aid and Youth Mental Health. And many of the county representatives who were there indicated that they were concerned about SROs, having treat training to deal with Youth Mental Health. And as I was one of the few counties, there are one of the Representatives representing a county where the SROs actually do get training above and beyond including in Youth Mental Health and Services, they asked that I help create a resolution that would

help support for the other counties. So I wanted to I just wanted the Sheriff's Department to know that their work was recognized and got me more homework. So thank you very much for that. But it was nice to be able to say the work that our Sheriff's Department is already putting in, in that area above and beyond what is required by New York State law. Because for anyone who doesn't know SROs are not required to obtain any training, in addition to their law enforcement training, in order to be a School Resource Officer within the school. Whereas our Sheriff's Department took upon himself when the program began in Saratoga County to get additional SRO training in youth mental health in particular. So I just wanted to say thank you. That's recognized and thanks for the homework.
