AUTHORIZING THE RENEWAL OF CONTRACTS FOR THE EXPANDED IN-HOME SERVICES FOR THE ELDERLY PROGRAM (EISEP)

WHEREAS, Resolution 67-2020 authorized contracts with various entities for the provision of Expanded In Home Services for the Elderly Program ("EISEP") services under the Office for the Aging's Annual Implementation Plan, and said contracts are set to expire on March 31, 2021 and need to be renewed; and

WHEREAS, Resolution 234-2019 approved the 2020-2021 Annual Implementation Plan for the Saratoga County Office for the Aging, which Plan includes the continuation of the provision of EISEP services; and as detailed un the document "Four year plan for older Unestablished United Ali [20-3]31|24, and
