Yeah. Today is the first day in some time that children are not mandated, and staff not mandated to wear masks in schools.

Right. So it's the first day of the rest of their lives, I guess. Right? At this point. So is there have they lifted, I forgot to look this up earlier? Did they lift the vaccination mandates in the City? Or are those still in place? There was some talk about it, but I don't know that they did that again.

Daniel Kuhles

Could you be more, there are a number of, there have been a number of mandates. So if you could just clarify. Do you mean New York City? They did not lift, in terms of schools, they have not changed the mandate that staff that are not vaccinated or not fully vaccinated, submit to weekly testing.

Okay. So I know with sports, with some sports the vaccination mandates have gotten in the way of certain people playing and everything I just remembered hearing something about they were going to lift those mandates, so I just thought that was interesting.

Daniel Kuhles

You have, that's the New York City and the player was it Kyrie Irving?

Phil Barrett

Yes. Some guy on one of the NBA teams he can't play in the home games.

Daniel Kuhles

Yeah, I think that's Kyrie Irving used to be a Celtic.

Phil Barrett

Yea, he can only play in the in the away games, which is pretty amazing. But any anything else?

Daniel Kuhles

No, you know, I think the schools have done a great job of getting the world out to families even while awaiting written confirmation from the State Health Department. That is very strong partnership. Not only that, I think that the partnership amongst the schools in the County and with Public Health, the group itself is, is very, very strong and resilient. And we remain fully committed to supporting kids. COVID has had a tremendous effect on mental health, social emotional learning. And we remain fully committed to our schools, parents and families. The masks may be done, but the impact of COVID is certainly not.

Yeah. Well, I do want to thank you and your staff for working so closely with the schools right throughout. I know myself and many other Supervisors received tremendous feedback over the pandemic, about the support that our schools were receiving from County Public Health, in many ways,

many different facets of trying to maintain kids in school, in the classroom. And in doing it safely. So thank you. And I had written an op-ed that was in the Saratogian on Sunday that spoke to how the County led by Public Health was a leader in so many different ways throughout the pandemic. So, great job by you and your staff.

And I'm so thankful, on behalf of our team for the County Administration and the Board of Supervisors for giving us the resources and the tools to do that work. I don't know of any one of my counterparts that have had the support that you've given us, so many thanks.
