Re: Required 8-year Review of Saratoga County Consolidated Agricultural District #2

Dear Supervisors and Mayor:

The Saratoga County Board of Supervisors received a 300-day notice, from New York State Department of Agriculture & Markets, indicating that the required 8-year review of the Saratoga County Consolidated Agricultural District #2 is to commence on January 21, 2022 and to be completed by November 17, 2022. This letter is to inform you that your municipality will be included in this review as your municipality contains certified parcels within Saratoga County Consolidated Agricultural District #2.

Enclosed with this letter is the Legal Notice that was posted in the *Daily Gazette*, *Post Star*, *Saratoga Today* and the *Saratogian* newspapers on February 7, 2022 notifying the public that NYS Agriculture and Market Law Article 25-AA, Section 303-a (2)(a) 30-day review period for Saratoga County's Consolidated Agricultural District #2 will begin on February 21, 2022. You will also find enclosed the Saratoga County's Agricultural District #2's boundary maps to further assist the public's review.

Kindly, please post this Legal Notice in a conspicuous place within your Town Hall in order for the public to be able to access. If there are other locations in your community where it would be beneficial to post the Legal Notice, please notify me so I can post this information where need be (contact information below).
