It's split between Probation and Employment and Training. Probation gets \$16,371 for pretrial services, and \$9,853 up it goes to Employment and Training for community service hours. They oversee those when people are sentenced to do community service hours. Runs June 1 or July 1 through June 30 this year. Any questions?
