### **RESOLUTION 135 - 2022**

**Introduced by Legislative and Gaming: Supervisors Raymond, Lawler, Peck, Smith and Wright**

#### **REQUESTING THAT NEW YORK STATE ENACT LEGISLATION RELATED TO SNOWMOBILE REGISTRATION FEES**

**WHEREAS**, thousands of snowmobile enthusiasts depend on the approximately 186 miles of snowmobile trails in Saratoga County for the enjoyment of snowmobile riding with friends and family within a reasonable distance from their homes and rely on those trails for connections to trails in Warren County, Fulton County, Tugg Hill and Vermont; and

**WHEREAS**, the New York State Assembly (A7747A) and New York State Senate (S6711A) are considering legislation to increase the registration fees for snowmobiles and modify the snowmobile grant program; and

**WHEREAS**, the proposed increase in fees would provide an estimated \$2 million in revenue to the NYS Snowmobile Trail Development and Maintenance Fund with a portion of the funds going directly to snowmobile clubs in Saratoga County who are responsible for the maintenance and construction of trails throughout the County; and

**WHEREAS**, snowmobiling is estimated to contribute hundreds of millions of dollars to the winter economy, employing thousands in snowmobile related businesses and providing winter enjoyment for countless residents; and

**WHEREAS**, the New York State Snowmobile Association and the Saratoga County Association of Snowmobile Clubs has expressed support for the proposed legislation; now, therefore, it is

**RESOLVED**, that the Saratoga County Board of Supervisors supports the proposed legislation (A7747A/S6711A) increasing snowmobile registration fees and modifying the snowmobile grant program and requests that the State legislature enact such proposals and if approved, that Governor Hochul sign the legislation into law.

#### **AUTHORIZING A RENEWAL ENTERPRISE ENROLLMENT AGREEMENT WITH MICROSOFT THROUGH DELL MARKETING, L.P. FOR EMAIL HOSTING SERVICES**

**WHEREAS**, pursuant to Resolution 115-2019, the County entered into a renewal Enterprise Enrollment Agreement with Microsoft for the provision of Microsoft Exchange/Office email services through Dell Marketing, L.P. for the term June 30, 2019 through June 30, 2022; and

**WHEREAS**, the Enterprise Enrollment Agreement with Microsoft for the provision of email services through Dell, Inc. will expire on June 30, 2022; and

**WHEREAS**, Microsoft has submitted a proposed renewal Enterprise Enrollment Agreement for the provision of the County's Office 365, Audio Conferencing, Azure, and Exchange email accounts, based on the New York State Office of General Services Contract PS68202, for a renewal term of three (3) years at a cost not to exceed \$106,388.10 each year plus a contingency in the amount of \$3,611.90 per year for the second and third year for additional email account licenses for a total of \$110,000 per year for the second and third years; and

**WHEREAS**, the Microsoft Exchange/Office 365 solution is currently the only New York State approved email provider that satisfies current federal and state email security and encryption requirements and incorporates Health Insurance Portability and Accountability Act (HIPAA), Personally Identifiable Information (PII) and Criminal Justice Information Services (CJIS) compliance and certification; and

**WHEREAS**, our Buildings and Grounds Committee and the Director of Information Technology have recommended that the County enter into a three year renewal Enterprise Enrollment Agreement with Microsoft through Dell Marketing, L.P. for the term July 1, 2022 through June 30, 2025 at a cost not to exceed \$106,388.10 the first year, and \$106,388.10, plus a contingency for additional licenses in the amount of \$3,611.90 per year in the second and third years, for a total of \$110,000.00 per year for the second and third years; now, therefore, be it

**RESOLVED**, that the Chair of the Board and/or the Director of Information Technology are authorized to execute an Enterprise Enrollment Agreement with Microsoft for the provision of Microsoft Exchange/Office email services through Dell Marketing, L.P., of Round Rock, Texas, for the term July 1, 2022 through June 30, 2025 at a cost not to exceed \$106,388.10 each year plus a contingency in the amount of \$3,611.90 per year for the second and third year for additional email account licenses for a total of \$110,000 per year for the second and third years; and be it further

**RESOLVED**, that the form and content of such agreement to be subject to the approval of the County Attorney; and, be it further

**RESOLVED**, that this Resolution shall take effect immediately.

#### **AUTHORIZING AN AMENDED AGREEMENT WITH MCFARLAND JOHNSON, INC. FOR ENGINEERING SERVICES ASSOCIATED WITH THE DESIGN AND CONSTRUCTION OF A SIX UNIT T-HANGAR AT THE SARATOGA COUNTY AIRPORT**

**WHEREAS**, pursuant to Resolution 136 - 2015, this Board authorized the acceptance of a 2014 AIR'99 New York State Department of Transportation ("NYSDOT") grant (PIN 1902.16) for the construction of a six bay T-hangar at the Saratoga County Airport, and appropriated \$70,000 in local match funds for the project; and

**WHEREAS**, pursuant to Resolution 137-2015, the County entered into an agreement with McFarland Johnson, Inc. for engineering services associated with the design and construction of the T-hanger at a cost not to exceed \$104,000; and

**WHEREAS**, the project was designed and put out to bid in 2017, but bid prices exceeded the NYSDOT grant amount for the project, causing the project to be postponed; and

**WHEREAS**, McFarland Johnson, Inc. has submitted a proposal for the provision of additional engineering services for the preparation of updated construction documents needed to re-bid the construction project in the amount of \$19,959; and

**WHEREAS**, our Buildings and Grounds Committee and the Commissioner of Public Works have recommended the County's agreement with McFarland Johnson, Inc. be amended to include additional engineering services to update the construction documents for the purpose of putting the project back out to bid; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute an amended agreement with McFarland Johnson, Inc. of Binghamton, New York, to provide additional engineering services necessary to update the construction documents for re-bidding the construction of the six bay T-hangar construction project at the Saratoga County Airport, at a total project cost not to exceed \$123,959; and it is further

**RESOLVED**, that the form and content of said amended agreement is subject to the approval of the County Attorney; and it is further

**RESOLVED**, that this Resolution shall take effect immediately.

#### **AUTHORIZING AN AMENDED AGREEMENT WITH MCFARLAND JOHNSON, INC. FOR ENGINEERING SERVICES RELATED TO THE CONSTRUCTION OF AN AIRPORT SNOW REMOVAL EQUIPMENT BUILDING**

**WHEREAS**, pursuant to Resolution 150-2019, this Board approved a proposed project for the construction of a Snow Removal Equipment Storage Building at the Saratoga County Airport, and accepted a 2018 Aviation Capital Grant in the amount of \$719,489 from the New York State Department of Transportation for the project (PIN 1902.17); and

**WHEREAS**, pursuant to Resolution 255-2019, the County entered into an agreement with McFarland Johnson, Inc. for design, construction administration and construction inspection services related to the construction of a new Snow Removal Equipment Storage Building at the Saratoga County Airport, at a cost not to exceed \$83,333; and

**WHEREAS**, bid prices in 2020 for the construction of the building exceeded engineering estimates, due in large part to the escalating costs of construction, causing the project to be postponed; and

**WHEREAS**, McFarland Johnson, Inc. has submitted a proposal for the provision of additional engineering services for the preparation of updated construction documents needed to re-bid the construction project in the amount of \$29,858; and

**WHEREAS**, our Buildings and Grounds Committee and the Commissioner of Public Works have recommended the County's agreement with McFarland Johnson, Inc. be amended to include additional engineering services to update the construction documents for the purpose of putting the project back out to bid; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute an amendment to the agreement with McFarland Johnson, Inc. of Binghamton, New York, to provide additional engineering services necessary to update the construction documents for re-bidding the construction of the Snow Removal Equipment Storage Building at the Saratoga County Airport, at a cost not to exceed \$113,191; and it is further

**RESOLVED**, that the form and content of said amendment is subject to the approval of the County Attorney; and it is further

**RESOLVED**, that this Resolution shall take effect immediately.

#### **AUTHORIZING AN AGREEMENT WITH CLARK PATTERSON LEE TO PERFORM A FACILITIES ASSESSMENT STUDY AND AMENDING THE 2022 COUNTY BUDGET IN RELATION THERETO**

**WHEREAS**, since 1980, the population of Saratoga County has grown approximately 53% and is the second fastest growing county in the state over the last 40 years; and

**WHEREAS**, Saratoga County has transformed from a primarily agricultural and resort area to a booming region with 235,509 residents that is best described as a great place to live, work and play; and

**WHEREAS**, there has been an increase in the need for additional facilities for the County workforce to continue provide a high level of constituent services to the growing population; and

**WHEREAS**, the County is in need of a comprehensive facilities assessment study of County owned and leased space to review condition and departmental space needs for the next twenty (20) years; and

**WHEREAS**, the County Administrators Office and Department of Public Works jointly solicited proposals for the provision of a comprehensive facilities assessment study; and

**WHEREAS**, our Buildings and Grounds Committee, the County Administrator, and the Commissioner of Public Works have recommended that the County enter into a professional services agreement with Clark Patterson Lee (CPL Architects, Engineers, Landscape Architect and Surveyor, D.P.C.), for a comprehensive facilities assessment study, at a cost not to exceed \$147,000; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute a professional services agreement with CPL Architects, Engineers, Landscape Architects and Surveyors, D.P.C., also known as Clark Patterson Lee, of Fairport, New York, for the provision of a comprehensive facilities assessment study, at a cost not to exceed \$147,000; and it is further

**RESOLVED**, that the form and content of such agreement shall be subject to the approval of the County Attorney; and it is further

**WHEREAS**, as part of the County's Emergency Radio System, the County constructed a radio communications tower on the site of the former Mt. McGregor State Correctional Facility located on Tax Parcel #88.-1-8 in the Town of Moreau; and

**WHEREAS**, pursuant to Resolution 62-2017 the County entered into a Tower License Agreement with Capital District Transportation Authority ("CDTA") for the placement, operation and maintenance of communications equipment at the County's Mt. McGregor Radio Communications Tower in the Town of Moreau, for a term of five (5) years commencing April 1, 2017, subject to renewal for an additional term of five (5) years upon the written mutual agreement of the parties, at a cost to the CDTA of \$20,500 per year for the initial five (5) year term, and at a cost of \$22,550 per year during the renewal term; and

**WHEREAS**, our Public Safety Committee and the Director of Emergency Management have recommended that the County enter into a renewal license agreement with CDTA for the placement, operation and maintenance of communications equipment on the County's Mt. McGregor Radio Communications Tower for a term of five (5) years commencing April 1, 2022 at a cost to CDTA of \$22,500 per year; now, therefore, be it

**RESOLVED**, that the Chair of the Board is hereby authorized to execute a renewal Tower License Agreement with the Capital District Transportation Authority of Albany, New York, granting a license to the CDTA authorizing the placement, operation and maintenance of communications equipment at the County's Mt. McGregor Radio Communications Tower in the Town of Moreau, for a term of five (5) years commencing April 1, 2022 at a cost to the Capital District Transportation Authority of \$22,500 per year; and, be it further

**RESOLVED**, that the form and content of such agreement shall be subject to the approval of the County Attorney; and, be it further

**RESOLVED**, that this Resolution shall take effect immediately.

The balance of the project costs to be paid by a combination of contributions and in-kind donations from the landowner, Saratoga PLAN and/or the Town; and

**WHEREAS**, the appraised value of the development rights for Bolesh Farm are lower than expected creating a cost savings, resulting in the actual total project costs of \$218,010; and

**WHEREAS**, the actual total project cost is greater than the 10% adjustment maximum, thereby requiring an amendment to Resolution 258-2019; and

**WHEREAS**, the Land Preservation Committee approved the original application on October 2, 2019, and

The balance of the project costs is to be paid by a combination of contributions and in-kind donations from the landowner, Saratoga PLAN and/or the Town; and, be it further

**WHEREAS**, the federal Epidemiology and Lab Capacity (ELC) Reopening Schools Grant, supported through the American Rescue Plan Act of 2021, provides grant funding for the purchase and/or reimbursement of costs associated with supporting safe in-person instruction and expanded testing for COVID-19; and

**WHEREAS**, the primary objective of the federal Epidemiology and Lab Capacity (ELC) Reopening Schools Grant is to curtail the spread of COVID-19 by providing resources for screening and testing programs, prevention efforts, and the implementation of data collection and reporting; and

**WHEREAS**, the federal Epidemiology and Lab Capacity (ELC) Reopening Schools Grant is being administered through the NYS Department of Health; and

**WHEREAS**, this Board remains committed to supporting families and children throughout Saratoga County by, amongst other efforts, taking necessary steps to support open school environments to enable students to attend school in-person which provides educational, social, and emotional benefits; and

**WHEREAS**, the Saratoga County Department of Public Health Services has received ELC Grant funding, and the Commissioner of Health has recommended that the remaining unexpended ELC Grant funds be provided to public and private K-12 schools throughout the County, for approved uses, on a per-pupil allocation of up to \$85.50; and

**WHEREAS**, any proposed expense or request for reimbursement will be approved by the NYS Department of Health; and

**WHEREAS**, pursuant to General Municipal Law Article 5-G, municipal entities such as school districts and counties have the power to enter into agreements for the performance of their respective functions, powers, and duties on a cooperative or contract basis for the provision of a joint service; and

**WHEREAS**, our Health and Human Services Committee and the Commissioner of Health have recommended that the County enter into cooperative agreements with local school districts in Saratoga County for the utilization of federal Epidemiology and Lab Capacity (ELC) Reopening Schools Grant funds; now, therefore, be it

**RESOLVED**, that the Chair of the Board is authorized to execute cooperative agreements with local school districts in Saratoga County to implement and utilize federal Epidemiology and Lab Capacity (ELC) Reopening Schools Grant funding; and it is further

**RESOLVED**, that the form and content of such agreements shall be subject to the approval of the County Attorney; and it is further

**RESOLVED**, that this Resolution shall take effect immediately.
